# PEDESTRIAN CROSSING - WESTWELLS ROAD, CORSHAM

# **Purpose of Report**

 To consider the comments received following the formal advertisement of the proposed PUFFIN Crossing.

## Relevance to the Council's Business Plan

- 2. The proposed Traffic Regulation Order (TRO) meets two of the priorities in the Council's Business Plan.
  - Outcome 2 People in Wiltshire work together to solve problems locally and participate in decisions that affect them.
  - Outcome 6 People are as protected from harm as possible and feel safe.

## **Background**

- 3. During the early 2000's, The Ministry of Defence (MoD) undertook a comprehensive redevelopment of its Basil Hill site in Corsham. This enabled them to amalgamate a number of services based in the area to a single site and has resulted in a significant number of employees being based at the site.
- 4. In 2015/16 representatives from the MoD submitted an issue to the Corsham Area Board outlining their concerns regarding the safety of their employees, as an increase in operations at the Basil Hill site had resulted in the campus expanding onto land on the opposite side of the road from its main site. The consequence of this is that a large number of employees are crossing between the two sites.
- 5. The Corsham Community Area Transport Group considered the issue at a meeting in Spring 2015 and supported the concern and recommended that Highway Officers undertake a full assessment in line with the Wiltshire Council Practice guide for Pedestrian Crossing.
- 6. This assessment took place during Autumn 2015, and identified a total of 743 crossing movements taking place. When this data was considered alongside the other collated information, it was considered that a formal pedestrian facility would be of benefit to those wishing to cross the road.

- 7. As the report was originally commissioned by the Community Area Transport Group, the recommendation was discussed and supported with the proviso that all cost associated with implementation should be underwritten by the MoD.
- 8. The MoD was informed of this support and the reports recommendation, and subsequently confirmed its commitment to developing a detailed design. Upon substantive completion of the detailed design and identification of the indicative installation costs, the MoD requested that implementation be progressed. This has resulted in the formal consultation for the controlled zone taking place in June/July 2017.

## **Main Considerations for the Council**

- 9. To consider the comments received during the consultation period. A summary of the issues raised and officer comments are included in **Appendix 1**. Details of the commentators are provided in **Appendix 2**.
- 10. Corsham Town Council's Planning and Amenity Committee has considered, and supported, the proposal. No response to the proposal has been received from the locally elected Wiltshire Council Member.

## **Overview and Scrutiny Involvement**

11. None has taken place.
