MANY PERSONS IN THIS AGE GROUP ARE LIVING ALONE, FRAIL OR DISABLED AND HAVE NO ACCESS TO PRIVATE OR PUBLIC TRANSPORT. THERE IS NO COMMUNITY/SOCIAL ACTIVITY FOR THESE PEOPLE IN THE VILLAGE AND THERE IS A FEELING, PARTICULARLY FOR THOSE WHO LIVE OUTSIDE THE ENVIRONS OF THE VILLAGE, THAT THEY ARE ISOLATED AND DISADVANTAGED. THE CLUB WAS SET UP AS THE RESULT OF A POLL OF PARISHIONERS WHICH INDICATED A NEED FOR A SOCIAL OUTLET FOR OLDER PERSONS. THE AIM HAS BEEN TO PROVIDE A SOCIAL GET-TOGETHER WHERE PEOPLE CAN MEET OTHERS, ENJOY REFRESHMENTS AND SOCIAL CHAT TOGETHER, DO QUIZZES, ENJOY SPEAKERS AND OUTINGS AND THUS FEEL INCLUDED IN THE LIFE OF THE VILLAGE. THE CLUB MEETS TWICE A MONTH FROM 1.45 - 4.00 PM AND THOSE WHO HAVE MOBILITY/TRANSPORT PROBLEMS (LACK OF PUBLIC TRANSPORT IS A SERIOUS ISSUE) ARE COLLECTED BY MEMBERS WHO HAVE TRANSPORT. AT PRESENT THERE ARE 30 MEMBERS AND THE COMMITTEE IS ACTIVELY PROMOTING THIS FACILITY WITHIN THE COMMUNITY. THE VENTURE HAS BEEN DEEMED A SUCCESS BY THOSE WHO ATTEND.
