The plans for the repair work were sent for List Building Consent but consent can only be given for a permanent repair, with detailed specifications including venting the floor and materials for the wooden floor covering. Both these requirements are improvements to the fabric of the hall and will provide greater sustainability. The floor coverings of wooden floor boarding & vents means that the Trust requires additional funding to carry out the work making the floor more sustainable. The floor boarding will give the complete finish to the work and extend the use of the hall. At the moment the floor covering is carpet & this limits the use and is very difficult to keep up to expected levels of cleanliness for health & safety.  The Hal is available for hire by any member of the community. It's the venue for the Community Day Centre for the Elderly 3 days a week, for Cricklade Band practice 2 evenings each week, training young musicians and storing its instruments & music and for reserved church use. It is also used weekly for lifestyle groups: Pilates & Weight Watchers, community social groups eg weekly Bingo and it is hired for a wide range of other uses eg Art Exhibitions, Educations Days, private parties & charitable fundraising events etc.  The Hall is used by approx 200 people each week. Funding raised from the Community will enable the remedial repair of the floor. The Hall was built in 1652 as a school for Cricklade and although its uses have changed over the years it has been used by the community for over 350 years. The Cricklade Jenner Hall Trust has only been managing the Hall from August 2007. In that time we have had an Energy Audit carried out and grants have been awarded for the priority recommendations for improvements in energy efficiency of the hall. This work will be carried out by March 2009. Also the courtyard has been enhanced by building planters & trellising and seating, so improving the ambiance of the Hall which is at the centre of Cricklade Conservation area. In additional to raising £5000 from the Cricklade Community for the repairs to the floors we have held fundraising activities for ring fenced funds towards match funding for the essential roof repairs and made application for grants for this major repair work.

The fundraising for the Hall us supported by a community Save It Club of over 170 people. In 2006 a survey was carried out and the results showed the support the Hall has as an important heritage community facility. It is supported by our 2 district councillors. Where possible improvements and repair work are carried out by volunteers from the community.

Additional funds are necessary so that the final finish, with the improvements to make it a permanent floor with better ventilation & wooden coverings can be achieved.
