<p>The current pedestrian entrance to the Bradstone Playing Fields and the Millenium Green is part of the Thames Path but it is on a blind bend on a narrow stretch of busy road at Rixon Gate. Apart from the safety issue, it does not afford good access for wheelchair and pushchair users and as a consequence there is some reluctance to use what is a valuable amenity not only for the villagers of Ashton Keynes but for others. The new entrance will provide a safe footpath leading from the junction of Kent End and Rixon Gate to the northwest corner of the playing fields so separating pedestrians from traffic. The entrance will be via a new footbridge over the Thames at a point that is currently used unofficially by children (saving the walk along a narrow portion of busy road). From an aesthetic oint of view the new entrance will be particularly attractive, crossing the Thames into a small stand of trees. The amenities are used by several hundred people regularly and most of these will benefit from the new entrance. It is planned to have the local school children suggest and implement a decorative sheme for the bridge. The new entrance will also attract people who would not ordinarily use the amenity because of the difficult existing access point</p>
