PUBLIC FOOTPATH WYLYE11 (GREEN LANE TO OLD A303)

This Order is made by Wiltshire County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the authority that the Definitive Map and Statement for the Salisbury & Wilton Rural District Council Area dated 1953 requires modification in consequence of the occurrence of an event specified in s.53(3)(C)(i), namely, *that a right of way which is not shown in the definitive map & statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.*

The Authority has consulted with every local authority whose area includes land to which the order relates. The Wiltshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 30th April 2008
2. The Definitive Map and Statement for the Salisbury & Wilton Rural District Council Area dated 1953 shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Wiltshire County Council [SHEET SU 03 NW] Rights of Way Modification Order No.5, 2008.

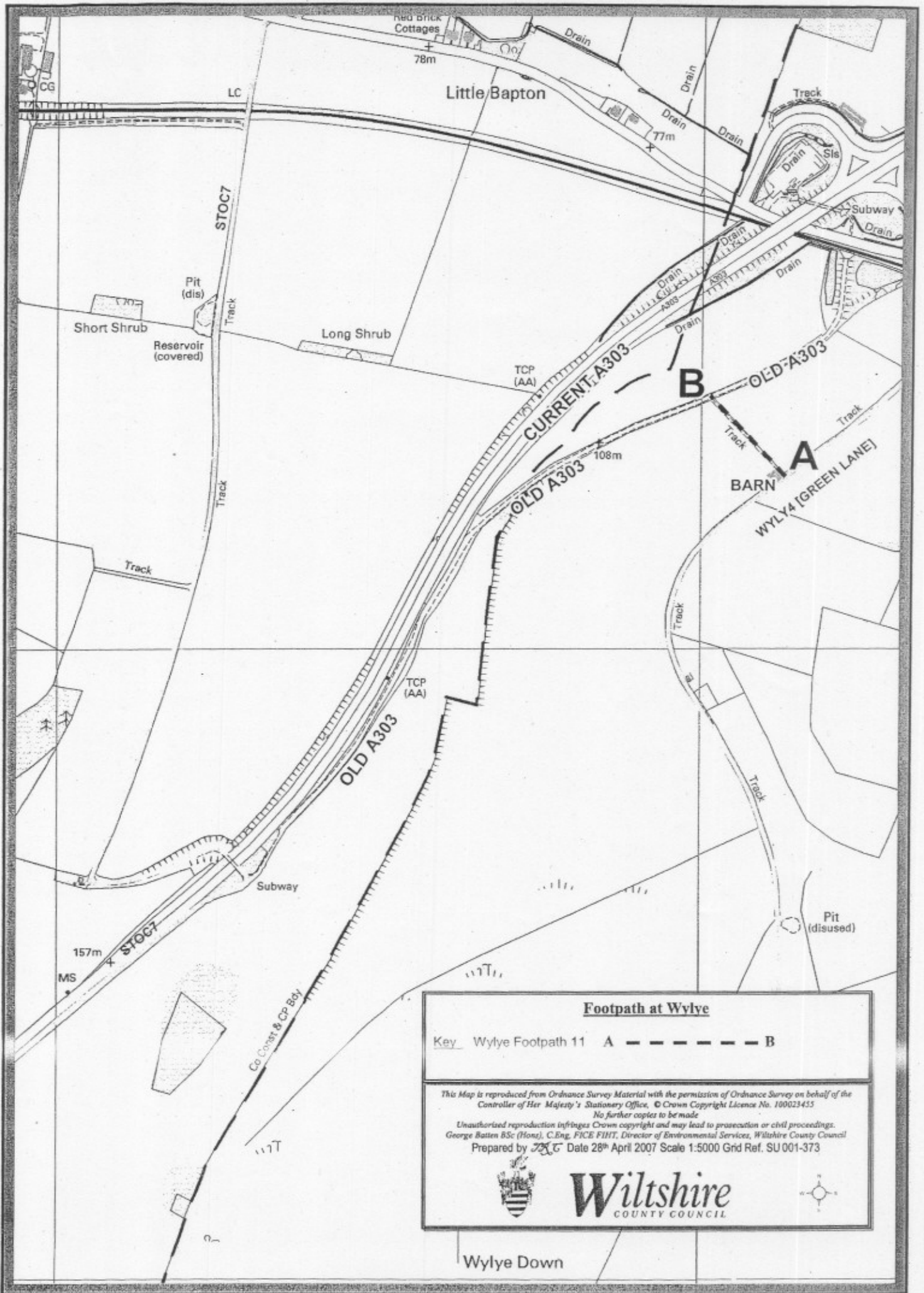

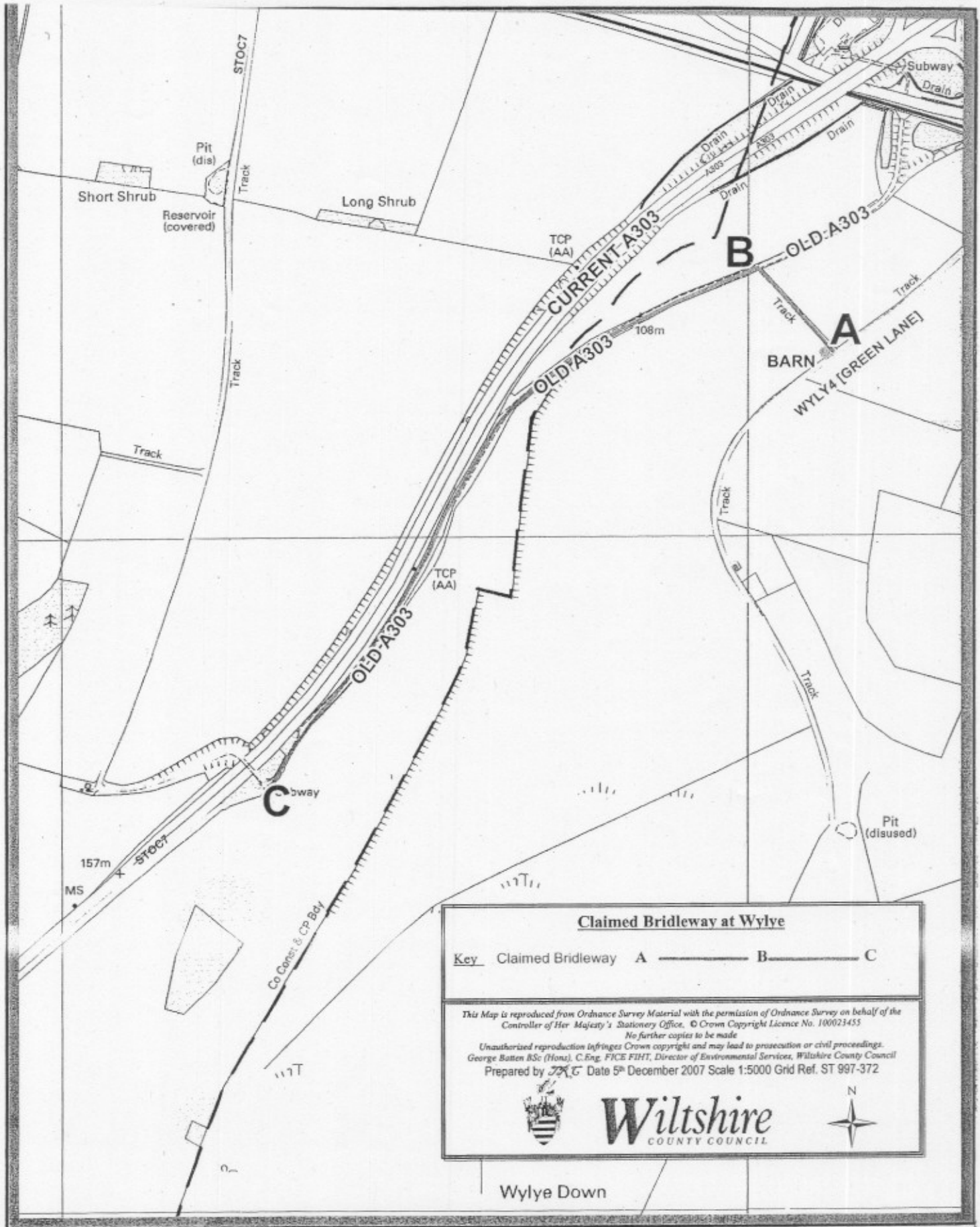
Footpath at Wylve
