1. Background Information

1.1 The District Council Ward boundaries changed with effect from the recent elections. This has the effect that some Wards now cross the Area Committee boundaries. In order for Ward Members and Parish Council representatives to be able to attend meetings of the Area Committees relating to their localities some changes to the composition of the Committees are required. The details of the suggested changes are set out below.

2. Proposed Changes to Area Committee Composition

- 2.1 The details of the suggested changes are given below:
 - (a) The Parishes of Oaksey and Minety now form part of the Minety and Purton Ward, the balance of the Parish Councils (Ashton Keynes, Leigh, Purton and Braydon) are in Area (2). It is recommended that the Oaksey and Minety Parish Councils remain in Area (1). The three Members for the Purton and Minety Ward would be able to attend and receive the papers for both Area Committees. Working on the basis of the number of electors in each Parish, (Ashton Keynes 1,128 Leigh 280, Braydon 38, Purton 3,269, Minety 1,157 and Oaksey 413) it is recommended that the Ward Members are entitled to two votes on the Area (2) Committee and one vote on the Area (1) Committee.
 - (b) The Parishes of Lyneham and Bradenstoke, Tockenham and Clyffe Pypard now form part of the Lyneham Ward and are in Area (2) and the Hilmarton Parish, also within this Ward is in Area (5). It is recommended that the two Members for the Lyneham Ward would be able to attend and receive the papers for both Area Committees but would be entitled to one vote on each.
 - (c) The whole of the Bremhill Ward be moved to the Calne Area (5) Committee as this fits in with the County Council Community Area Boundary. Part of this Ward was previously in Chippenham Area (3).

3. Environment and Community Implications

3.1 It is important that communities are able to take an active role in the most important Area Committee.
