1. Introduction

3. Background Information

- 3.1 As a result of a joint tender entered into by Kennet District Council, Salisbury District Council and North Wiltshire District Council the audit contract for Information technology audits was awarded to Deloitte.
- 3.2 As part of the 12 days the Council purchases in every year an audit of Project Management was undertaken by Deloitte.
- 3.3 Whilst the focus of the audit was around the arrangements in place for managing IT projects, the scope of the audit also included the wider project management arrangements in the Council.
- 3.4 Though the auditors were highly complimentary about a number of practices in place, and were generally pleased with the approach adopted by the ICT Team, they did raise concerns about the Council wide approach to project management and therefore awarded an assurance opinion of Limited (3).
- 3.5 The resulting action plan was discussed and agreed with the Audit Manager and the ICT Services Team Leader. A number of the recommendations require action to be taken by the Corporate Management Board, in terms of the corporate approach to be adopted by NWDC, and the Audit manager and ICT Services Team Leader are currently working together to prepare a report for CMB for their consideration.
