Summary of Report

To set the Council Tax for 2008-09.

Officer Recommendations

That the Council:

- 1. Note the final effect on its budget requirement for 2008-09 (excluding Parish & Town Council Precepts), as detailed at Annex A.
- 2. Adopt the Council Tax resolutions for 2008-09 as set out at Annex B.
- 3. Delegate authority to the Head of Finance and Resources (S151 Officer), in consultation with the relevant Managers, to make any technical presentational changes to the final published budget as deemed necessary to meet external reporting obligations.
- 4. Delegate authority to the Head of Finance and Resources (S151 Officer), or any officer designated by him, to deal with all matters relating to the Council Tax administration, billing, collection, recovery and administration of Council Tax benefits.
- 5. Delegate authority to the Head of Finance & Resources (S151 Officer) to meet estimated capital and revenue expenditure, in accordance with the approved estimates, including use of Earmarked and General Fund reserves for the purposes stated.

Other than those implications agreed with the relevant Officers and referred to below, there are no other implications associated with this report.

1 Introduction

The Council's Budget

- 1.1 Council, earlier in its Agenda, is expected to agree a net budget of £19,739,656 (adjusted). Requiring £6,650,857 be raised from Council Taxes, this would result in a Council Tax increase for its own purposes, for 2008-09, of 1.60%.
- 1.2 The report to the Executive at its meeting on 7 February 2008 set out the S151 officer's statement under section 25 of the Local Government Act 2003. This refers to the robustness of estimates and the adequacy of reserves and is part of the Budget setting papers elsewhere on this agenda.

Local Precepting Authorities

1.3 The Parish Precepts for 2008-09 total £4,638,698. These are detailed, on a Band D equivalent basis, at Annex B, Schedule B.

Major Precepting Authorities

- 1.4 The Wiltshire County Council met on the 12 February 2008 to agree its precept requirement for 2008-09. The Wiltshire County Council approved a net budget of £179,448,465 and will precept £52,241,902. The Band D equivalent is £1020.59, an increase of 4.80%.
- 1.5 The Wiltshire Police Authority wrote on the 7th of February 2008 in respect of their precept requirement for 2008-09. The Wiltshire Police Authority approved a net budget of £98,205,500 and will precept £7,439,660. The Band D equivalent is £145.34, an increase of 4.30%.
- 1.6 The Wiltshire & Swindon Fire Authority wrote on the 8th February 2008 in respect of their precept requirement for 2008-09. The Wiltshire & Swindon Fire Authority will precept £2,955,795. The Band D equivalent is £57.74, an increase of 4.07%.

Special Items

1.7 Sections 34 and 35 of the Local Government Act 1992 require Parish precepts to be determined by the Council as special items. This is reflected in the Council Tax resolution (Annex B). The individual parish precepts on a Band D basis are detailed at Annex B.

Setting the Council Tax

1.8 If the recommendations above are approved, the average Council Tax increase for North Wilts District Council services, will be as set out at Annex B. After taking account of the Parishes, the County Council, the Police Authority, and the Fire Authority, the average increase in North Wilts District' tax levels will vary depending on the relevant area's tax charge. The details behind these increases are set out at Annex B. Table 1 below details the average Band D Council Tax figure for 2008-09.

1.9 In order to set the Council Tax legally, the Council must agree the resolutions shown at Annex B. These resolutions build up from the Council's budget requirement including Parish precepts, through deducting formula grant and collection fund surpluses (or adding a deficit) to arrive at a basic Council Tax including and excluding Parish precepts. To that is added the precepts for the County, Fire and Police Authorities to arrive at a total Council Tax by Parish and by Council Tax Band.

2 Legal Implications

2.1 The Council is required to set its Council Tax level before 11 March 2008. The legal requirements in relation to the setting of the Council Tax are noted against the relevant resolutions in **Annex B**.

2. - 3. Note that (in accordance with regulations made under Section 33(5) of the Local Government Finance Act 1992) the Council has calculated the following amounts:

(d) £8,450,101 (Total of Revenue Support Grant, share of National Non Domestic Rating Pool and Estimated Balance on the Collection Fund to be refunded to council tax payers)

being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates and revenue support grant and increased by the amount of any sum which the Council estimates will be transferred from its collection fund to its general fund pursuant to the Collection Fund (Community Charges) (England) Directions 1994 under section 98(4) of the Local Government Finance Act 1988.

(e) £220.55 (North Wiltshire Band D tax plus average town/parish councils Band D Tax)

being the amount at 3(c) above less the amount at 3(d) above, all divided by the amount at 2(a) above, calculated by the Council, in accordance with section 33(1) of the Act, as the basic amount of its council tax for the year

(f) £4,638,698 (Aggregate of parish and town council precepts)

being the aggregate amount of all special items referred to in section 34(1) of the Act

(g) £129.93 (Band D tax for North Wiltshire purposes only)

being the amount at 3(e) above less the result given by dividing the amount at 3(f) above by the amount at 2(a) above, calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its council tax for the year for dwellings in those parts of its area to which no special item relates

(h) Part of the Council's Area (Town/Parish Band D tax)

being the amounts in Annex B, Schedule A, Column 4. Being the amounts of the

special item or items relating to dwellings in those parts of the council's area mentioned above divided in each case by the amount in Column 2 of Schedule A Annex B, calculated by the council in accordance with Section 34(3) of the Act as the basic amounts of its council tax for the year for dwellings in those parts of its area to which one or more special items relate.

(i) Part of the Council's Area

(North Wiltshire and Town/Parish Council taxes in Bands A to H for each Town/Parish)

the amounts in Annex B, Schedule B, being the amounts given by multiplying the aggregate of the amounts at 4(g) and 4(h) above by the number which, in the proportion set out in Section 5(1) of the Act, is applicable to dwellings listed in a particular valuation band divided by the number which in that proportion is applicable to dwellings listed in valuation band D, calculated by the Council, in accordance with Section 36(1) of the Act, as the amounts to be taken into account for the year in respect of categories of dwellings listed in different valuation bands.
