What community benefits will your project provide and, who are the beneficiaries (e.g. numbers of people, age, gender, particular groups)

The current 'wet pour' play surface at Broadwell was installed in approx 1992, and is now showing major signs of wear and decay. As well as areas where the 'wet pour' has broken down and holes have appeared, over time the edges have shrunk back some distance from their original position. Despite attempts by the Parish Council to repair the edges of the play surface, shrinkage continues to be a problem, to the point where the edges are now causing a severe trip hazard. For this reason the Parish Council has made the decision to close the Play Area for safety reasons until the safety surface can be replaced. Similarly, some of the equipment in the Play Area is now showing signs of age, and has gone beyond the point of repair. The Parish Council are therefore also looking to replace two smaller pieces of equipment in the Play Area.

The Play Area at Broadwell is the primary play area for children under the age of eight in the village, and the surrounding cluster villages, and its location in the centre of the village means it is a vital part of community life. It provides young children and their families/carers with the opportunity to meet and interact socially and physically. Children attending the local 'Mums & Chums' toddler group, rainbows group, and local primary school who are able to use the facility as an additional resource, will also benefit from the project. Since the Play Area has been closed the Parish Council have received numerous enquiries from villagers enquiring as to when it is likely to be re-opened. There can be no doubt therefore that the Play Area is a valuable community resource that needs to be re-opened as soon as is practically possible.

## Wiltshire Council will be unable to meet the ongoing costs of your project. Please describe, therefore, how you will ensure the financial sustainability of your project beyond the period of this grant (if successful)?

The Parish Council will be responsible for the sustainability of the project once completed. It will ensure that regular weekly safety checks are carried out in the Play Area by the Parish Council handyman to identify any maintenance issues, so they can be dealt with as soon as they occur. An appropriate annual external Safety Inspection contract is already in place for the Play Area, as well as the annual Safety Inspection carried out internally by the Parish Council. A suitable amount will be budgeted into the Parish Council's yearly precept to cover future possible maintenance costs.

As indicated, this project looks to partly re-furbish the Play Area at Broadwell, and as a result will benefit all the younger children and their families/carers in the village and surrounding areas, by providing them with a safe and more stimulating play environment.

Currently the Play Area has had to be closed by the Parish Council until it can be made safe. In terms of the success of the project, based on the number of enquiries already received by the Parish Council since the area has been closed, it is clear the improvements to the area will make a difference to the community. Specifically the Parish Council could monitor how much the Play Area is then used when the project has been completed, and also ask for feedback from residents through the Parish Magazine, and at Parish Council meetings.
