Trowbridge Museum, working with volunteers from the Friends of Trowbridge Museum organises a number of activities during the school holidays, mainly based around learning about our local heritage. A series of 10 art, craft and performance activities for children and young people and families themed on the museum's collections and exhibitions, as well as calendar events and festivals. The activities will take place over the October Holiday (3 activities), Christmas (2 activities) and the February holidays (5 workshops).

Using experienced freelancers we will encourage children and young people to learn and develop a range of art and craft skills, and support them as they create their own art and craft pieces. We would hold one workshop in a community centre (Longfield or Studley Green), to encourage children and families who might not usually come to the museum.

These would benefit approximately 600 children and young people. We would advertise the activities using flyers delivered to Trowbridge's primary schools, specifically targeting those in deprived areas (Studley Green, Longmeadow, Bellefield), posters displayed around the town and via the e-newsletter service we operate.
