The Club is going to target 5 - 7 year olds in Year 1 with a view of attracting up to 30 children into regular activity which will take place during a 12 month period. The club will involve local people in the delivery of the sport and plans to train up at least 6 adults and 3 young leaders to enable them to deliver the high quality, low child:adult ratio that will enable the children to get maximum enjoyment out of their involvement. The benefit of the project is in providing young children with a chance to get active on a regular basis at an age when there are very few other opportunities available. The club will aim to develop and provide regular coaching whilst encouraging children to feel part of a sociable, healthy lifestyle. It will also give them an identity within the club and both parents and children the chance to be a part of something special.
