Cherhill Scout Group is a thriving and expanding organisation involving young people from predominantly the Cherhill and Calne Without Parish. It caters for young people between the ages of 6 and 18. Currently the Group has 16 in the Beavers Section, 25 in the Cubs Section and 20 in the Scouts and Explorer Scouts Section. This is an increase of 60% since 2007 and demonstrates the attraction and worthwhile nature of the Scout Group to the community. The acquisition of canoe equipment will allow the Scout Group to widen the range of activities available to the leaders, increasing the interest to the membership and allowing them to experience a challenging and testing form of activity in a safe and controlled environment. The Scout Group has already one leader trained to conduct canoe activity and will be undertaking to train 2 others upon successfully receiving funding for the equipment.

Cherhill Scout Group are fully integrated into the life and ethos of the village, taking 2 evenings a week at the Village Hall, supporting numerous village activities such as the Pantomime and Amateur Dramatics as well as receiving significant support from the community when undertaking fund raising activities such as car washes and seasonal fair. It also adds weight at important events such as Remembrance Sunday and St Georges Day instilling a sense of respect and pride amongst its young people for the achievement of those past and present residents. Cherhill Scout Group is the major youth organisation present in the village and provides a significant and popular focus for the village youth.
