Putting a footpath in will allow wheel chair access from our disabled section of the car park, through to the disabled toilets and then onto a position where viewing of either the football or cricket can be easily achieved. We have several members who are disabled and are unable to watch sport other than from disabled parking spaces situated on the car park or on the concreted area outside the changing rooms. These people have said they would benefit from closer viewing. In addition members who are injured are also unable to view satisfactorily. Families with young children in prams/pushchairs would be able to gain access from RWB lake and the town itself on properly constituted paths. Also, elderly people with mobility issues(walking sticks, and people without transport would also benefit as they would be able to access facilities on foot from RWB. By providing access from the town car park to the sporting areas, viewing sport will become more accessible and will encourage more people to become more active. This will develop more inclusion in our sporting community.

By speaking to spectators who use the path and assessing their responses. There will be increased usage of the facilities and we will monitor that alongside sporting organisations who use Ballards Ash
