



Agenda Item No.	Summary of Issues Discussed and Decision
1.	Chairman's Welcome and Introductions
	The Chairman welcomed those present to the meeting, including Mark Boden, Corporate Director of Neighbourhood Planning. He thanked Renate Malton, Project Officer, for the display stands available to view before the meeting regarding feedback from the community flooding consultation.
2.	Apologies for Absence
	Apologies for absence were received from Sergeant Martin Alvis (Wiltshire Police), Catherine Doody (Malmesbury Town Council), Roger Lee (St Paul Malmesbury Without Parish Council), Terry Mockler (Hankerton Parish Council), John Parmiter (Lea and Cleverton Parish Council), John Tremayne (Easton Grey Parish Council), Jenny Woodcock and Andrew Woodcock (Malmesbury Town Council).
3.	<u>Minutes</u>
	The minutes of the meeting held on 16 March 2011 were approved and signed as a correct record.
4.	Declarations of Interest
	There were no declarations of interest.
5.	Chairman's Announcements
	The Chairman drew attention to the written announcements included in the agenda pack. Three late announcements had also been received.
	The public were invited to attend an evening seminar on Tuesday 22 March 2011 at 6.30 pm, with refreshments available from 6.00 pm, at Malmesbury Secondary School to look at the implications of the Government's Localism Bill now before Parliament and what this was likely to mean for public and voluntary services in the Malmesbury Community Area.
	The seminar would address how Wiltshire Council planned to develop its own local arrangements through the Area Boards, with new ways of involving people in decisions about services.
	It would also address how the Government was proposing to change the current planning system to give local people more of a say over the future development of the places where they live. The seminar would conclude with an update and discussion about the development of local planning policies (known as the Wiltshire Core Strategy) for the Malmesbury Community Area.

Information was provided about changes to bus services. As a result of significant reductions in local authority funding, Wiltshire Council has had to make difficult decisions in setting its budget for the 2011/12 financial year.

The intention behind the proposals was to minimise the impact on users as far as possible, by spreading the changes across the county and withdrawing services or journeys where alternatives were available, or which were relatively poorly used or expensive to run per passenger carried.

There were relatively few changes affecting the Malmesbury Community Area and the main change proposed was withdrawal of the Sunday journeys on service 51A (Cirencester – Ashton Keynes – Cricklade – Swindon).

Communities had the opportunity to respond via their Town or Parish Council if they were aware of particular difficulties that would result. A letter had been sent to all Town and Parish Councils explaining the proposed changes, and asking for feedback. Responses were requested by 1 May 2011. Replies should be sent to ian.white@wiltshire.gov.uk in Wiltshire Council's Passenger Transport Unit.

Energy monitors would be available from Malmesbury library from Monday April 4 2011. Members of the public would be able to hire a monitor for free for a period of three weeks, which could be used to monitor the energy used by electrical items in the home. A booklet including energy saving advice would be given out with the energy monitor that could be kept for future reference. The initiative to provide energy monitors in all Wiltshire libraries was funded by the Performance Reward Grant Scheme.

6. Partner Updates

The Chairman noted the written updates from partners included with the agenda pack. He invited partners to speak if they had further information for the meeting.

- a) The written update from Wiltshire Police was circulated at the meeting, please find attached to the minutes. The main issue in the Community Area was rural theft. Inspector Martin advised the meeting to secure property carefully and take details if suspicious behaviour had been noticed.
- b) The written update from Wiltshire Fire and Rescue Service was noted.
- c) The written update from NHS Wiltshire was noted.
- d) The written update from Malmesbury and the Villages Community Area Partnership (M&VCAP) was noted. Sid Jevons emphasised that the Partnership were always looking for volunteers who would like to become involved in their work.

e) Malcolm Carter from Ashton Keynes Parish Council introduced their new website. He described how the website was created to address people not knowing what was going on in the community, how it was designed using a website design template and the positive feedback it had received. The website could be accessed via the following link: www.akpc.org.uk.

Ellen Blacker explained that Community Speed Watch had been a real success story in Dauntsey and a prime example of 'The Big Society' in action.

The group attended the risk assessed site most mornings and afternoons when they had the device and had seen a significant drop in traffic speeds. When the project was started, the group recorded approximately 30 vehicles exceeding the limit per hour. This had dropped to 15-20, however unfortunately the effect was short-lived and when not visible on duty the traffic speed up. An overall lowering of traffic speed through the village was still noted.

Dauntsey Parish Council had invested in the wheelie bin stickers offered by Advanced Printing Services (UK) Ltd. The stickers helped to support the work of the Community Speedwatch scheme. Approximately 50% of homes in the 30mph zone had the stickers, enough to have effect. On bin day, the number of vehicles recorded exceeding the speed limit reduced from 15-20 per hour to 3-4 per hour.

Ellen thoroughly recommended these stickers as a method of reminding motorists to slow down.

Roger Baker from Leigh Parish Council raised concern about the proposed HM Revenues and Customs requirement for parish clerks to register to pay tax and national insurance contributions, given their low earnings. John Marsh, clerk to Ashton Keynes Parish Council, offered to provide support free of charge to Leigh Parish Council. The Chairman expressed his support for Roger's concern and advised parishes to write to their MP.

Wiltshire Council was talking to HM Revenues and Customs and the Wiltshire Association of Local Councils to see whether it would be possible for Wiltshire Council to run the payroll on behalf of Wiltshire Parish Councils. The Wiltshire Association of Local Councils could be contacted at:

7. Community Services Contract

Helen Bourner, Director of Business Development, provided information about the Great Western Hospital contract to run the community services currently run by Wiltshire Primary Care Trust.

A representative from the Great Western Hospital NHS Foundation Trust would return to a future Area Board meeting to provide further information about how changes would affect services provided in the Community Area.

Local Area Board Presentation

8. Community Issues Update

The Community Area Manager provided a summary of current community issues and the Area Board agreed those to be closed.

Decision

The Area Board would close the following issues:

Issue 1129 – speeding issues in Leigh would be managed through a Community Speed Watch scheme and in the meantime a Speed Indicator Device would be installed.

Issue 1363 – perceived night time speeding in Dark Lane, Malmesbury, was being passed to Wiltshire Police to monitor. To date no excessive speeds had been recorded.

Issue 1482 – the adoption of open space associated with specific properties at Abbey Height was a personal and not a community matter.

Issue 1443 – dog fouling in the Hudson Road/Glovers Court area of Malmesbury had and would continue to be monitored. Additional signage had been provided.

Decision

The Area Board would refer a further four issues to the Community Area Transport Group for consideration at their April meeting.

Decision

The Area Board would consider the issue of speed bumps at the meeting as item 9.

9. Speed Bumps Survey Update

Martin Rose, Principal Highways Engineer, responded to the speed bumps survey results and Town Council recommendations. He thanked the Town Council for their work. Martin commented that part of the issue was that the speed bumps were grey because they were in a historical town and this made them difficult to see. Vehicles had changed since the bumps were put in place and many larger vehicles were unaffected by them.

The Chairman had met with officers and asked them to look into removing the speed bumps, modifying the speed bumps and other options for slowing down traffic. Priorities for resurfacing roads in the Community Area were also under consideration. The Area Board would make decisions on this issue once the priorities for resurfacing were also available; following which it would be discussed at an Area Board meeting to take into account funding issues and legal requirements.

Decision

The Chairman would ask the Wiltshire Council officers concerned to meet with the Town Council to discuss options regarding the speed bumps in Malmesbury and to put up a display in the town.

10. <u>Cabinet Representative</u>

Councillor John Thomson explained how Cabinet members attended Area Board meetings across the county on a rota basis. He provided an overview about his role as Deputy Leader and Cabinet member for Adult Care, Community Services and Libraries. He explained this encompassed Area Boards.

Wiltshire Council was committed to retaining libraries and the mobile library service. Opening hours would be reassessed in the context of neighbouring local authorities closing libraries. Input from volunteers and partnership working would be needed in small communities to keep their libraries open. There had been fantastic levels of volunteering across the county.

Wiltshire was set to face a big increase in the number of older people in the county and had a ten year plan to improve services and provide joined up and flexible care. Wiltshire Council was investing in keeping people in their homes with support for as long as possible, the next stage would be extra care in home and the final stage if needed would be residential care.

Councillor Thomson hoped that more powers would shift to Area Boards with increased delegation of decisions and funding. Confidence had already been gained in the system through the work of Area Boards thus far.

11. End of Life Care

Alison Bell, Public Health Consultant for NHS Wiltshire, provided information about the End of Life Care Strategy that Wiltshire Council and NHS Wiltshire had adopted. The presentation covered the main subjects below:

- A definition of end of life care 'living well until you die'
- Sensitivity to death and dying
- The policy context
- The context in Wiltshire
- What NHS Wiltshire were already doing to improve end of life care
- What NHS Wiltshire planned to do to improve end of life care.

12. Outside Body Appointments Update

Updates from Councillor Soden and Councillor Killane regarding The Malmesbury Community Trust and The Activity Zone were circulated at the meeting, please find attached to the minutes.

Councillor Thomson provided a verbal update about the Community Area Young People's Issues Group. The group were working on a skateboard project and were applying for funding for a youth transport project. Gareth Brown was the new Youth Development Coordinator and was hoping to develop stronger bonds with the Area Board. The Youth Parliament had also appointed a new leader and Malmesbury Secondary School were bringing a group of sixth formers to the localism event on 22 March 2011.

Outside Body Review

13. Community Area Grants Scheme

Councillors were asked to consider the Community Area Grants report and make recommendations on the applications received.

Decision

Minety Village Hall were awarded £1,504 towards the refurbishment of toilets, conditional on the balance of funding being in place.

Reason

The application meets the 2010/11 grant criteria and would improve village hall facilities.

Members recommended that the applicant also seek support from Charities Information Bureau and Community First's Village Hall Officer in relation to their finances and ambitions for the hall.

Decision

Glovers Court Amenity Group were awarded £178 towards the purchase of blackout blinds, conditional on the balance of funding being in place.

Reason

The application meets the 2010/11 grant criteria and while Glovers Court was a residential facility in the town, the lounge, where the blinds were needed, was regularly used by other groups.

Decision

Malmesbury River Valleys Trust were awarded £120 towards the cost of providing educational materials.

Reason

The application meets the 2010/11 grant criteria and would reflect the values of both adults and young people who valued the rural nature of the area they lived in, as well as providing activities for young people.

	Decision To endorse £20 for room hire for ISWE (a pilot website based around the Malmesbury Community Area) training.
14.	Performance Reward Grant Scheme
	The Chairman was pleased to announce that the application made to the Performance Reward Grant Scheme from Malmesbury Boxing Club had been successful and the club received £20,000. The Eilmer Bridge application had been unsuccessful.
	Councillors were asked to consider an expression of interest that had been received by all 18 Area Boards on behalf of Wiltshire's Neighbourhood Watch Schemes, seeking funds for the purchase of UV scanning torches for issue to Police officers on operational duties.
	<u>Decision</u> The Area Board was minded not to support this expression of interest due to insufficient information.
	The Performance Reward Grant Scheme was currently being reviewed alongside funding arrangements for Wiltshire Council and partners, and may not continue in its current form beyond the end of the financial year. As a result of this, the Panel had decided that the deadline date for the sixth tranche of the current scheme would be extended until 31 March 2011. All bids received by this date would be considered under the current arrangements.
15.	Public Consultations
	The Chairman set out that information on public consultations was included in the agenda pack. This comprised the outcome of the library services review and the current child poverty consultation.
16.	Evaluation and Close
	In light of the time at 9.10 pm, the Chairman did not undertake evaluation of the meeting. He thanked everybody for coming to Ashton Keynes.

4. Performance and Other Local Issues

The area has seen a slight rise in thefts from rural locations although this rise appears to have stopped we are continuing to work with our departments within Wiltshire Police and our partners to tackle this issue. A recent arrest and charge of a well known rural crime offender has seen him imprisoned for a number of months. As always we urge the public to report suspicious matters immediately and don't leave it to later. Security of property is also very important and as part of an ongoing process we ask that you look around your properties and think 'If I were a thief, how easy would it be for me to pinch this'.

Anti social behavior in the town is low, although some mindless acts of vandalism have occurred involving smashed windows, those enquiries are ongoing.

Malmesbury Police have executed two drugs warrants in the town recently, resulting in a charge and several cautions. Information from the community is greatly received and action will be taken against reliable intelligence.

- 1. What is the purpose of the outside body to which you are appointed? Leisure provision for the whole Malmesbury community.

 We have been working with a number of Wiltshire Council departments to access

funding for activities. The two main projects we have been running are:

Free Time – Through the extended services department and schools we have been able to offer either places on courses or vouchers for children 16 and under whose parents may not otherwise be able to afford these.

Sports Unlimited – This is a Sport England initiative to get "non sporty" children taking part in some form of exercise. We have worked with the Wiltshire Council sports development team to deliver Cheerleading. Hopefully after the initial course we can make the sessions sustainable.

Other	new activities for children include:
	Discounted 1-2-1 swimming lessons for disabled children
	Extra swimming club session
	Street dance.

Regarding adult activities, in the last two months we have launched Zumba which is Latin-inspired dance-fitness program. This has proved to be very popular with our users and we are looking at how we can increase the classes we offer.

In March we are launching KETT FIT. This is a four week fitness program using our new kettle bells. Kettle bells are weights shaped like a cannonball with a handle. They are excellent for whole body training specifically legs, back and core.

The Fosse Way at Whitewalls Avon Crossing, Easton Grey Information Sheet

The Roman settlement at Fosse Way at Whitewalls Avon crossing is a significant Roman small town, one of five located in Wiltshire. It is a Scheduled Monument considered to be of national importance. There are also other remains that both pre and post date the Romans. There is also ecological importance at the site; the river is a spawning ground for trout and a family of otters live further along the bank.

There has been extensive misuse of this section of byway particularly by irresponsible 4x4 users driving in and out of the river and carving ruts and divots into the surface exposing and damaging the archaeological remains. There have been past attempts to prevent abuse at the site, including installation of barriers and bollards. However, these defences have always been winched out of the way by the irresponsible 4x4 drivers, allowing the river to be used like a vehicular playground once again.

Wiltshire Council is looking to work with all parties with an interest in the Fosse Way to find a workable solution that will be supported and implemented jointly by all parties which will include Wiltshire Council, English Heritage, local Parish and Town Councils, Wiltshire Police, Landowners and users groups. The Fosse Way is used and enjoyed by many people and groups with differing interests, which has meant that a simple solution has not been possible and that compromises must be made.

Proposed Actions

Information and interpretation signs

Education about the significance of the site will be a major part of the solution. Currently people using the location as a vehicular playground do not know that they are contributing to the destruction of a major historical site. Education could also result in more interest in the site as a tourist destination.

2 Traffic Regulation Orders

- 1. Permanent TRO restricting the highway to the main track leading over the bridge. Prohibition of driving of any motor vehicle or accompanied horse from the areas of highway identified on the plan attached (i.e. confining use by motorcycles and accompanied horses to the main track).
- 2. Permanent TRO prohibition of driving any motor vehicle other than a solo motorcycle from the full extent of the byway.

Ground work protecting the site

Installation of gates/barriers to prevent 4x4 access to the byway open to all traffic.

Ground work reinstating the site

English Heritage and Wiltshire Council to work jointly to reinstate the north and south of the river crossing to existing levels and to restore the site.

Camera Surveillance

Wiltshire Police to provide and maintain surveillance cameras at the northern end of the route once a TRO is in place.

Digital Inclusion

Wiltshire Council's business plan for 2011-15 has prioritised a number of areas for investment, of which Digital Inclusion and supporting the rollout of superfast broadband for both business and home users is a key area. The Council has set the ambitious target of enabling 85% of all premises to be able to access superfast broadband (possibly 95% with additional funding) and for all premises able to receive standard broadband by 2015.

To help understand existing coverage and the requirements for the future, Wiltshire Council will be launching a superfast broadband survey for home and business users between 26 April and 3 June. This will allow people to say what types of services they can currently access over internet and how well their service performs. The survey will also ask about their views for getting superfast broadband in their community in the future. This information will allow the Council to better understand the demand for this service and where it will need to prioritise investment.

The survey will have a link within it to an on-line speed checker so that you can check your current broadband speed, www.broadbandspeedchecker.co.uk.

The council is keen to get as many responses as possible to help inform its rollout plans over the next 4 years.

The survey will be available on-line and also available as a printed document. Details are available from:

The Fosse Way at Whitewalls Avon Crossing, Easton Grey

The Roman settlement at the Fosse Way at Whitewalls Avon crossing is a significant Scheduled Monument considered to be of national importance. The site is also of ecological importance.

The abuse of this section of byway open to all traffic is a consequence of irresponsible vehicular drivers using it to access the river and surrounding privately owned land. Past attempts to prevent misuse at the site have failed, barriers have been breached and the river crossing has continued to be used as a vehicular playground.

Wiltshire Council and other interested parties have been looking to find a workable solution to this issue.

The proposed actions include two permanent traffic regulation orders to be made to limit the use of the highway to the main track and away from the river and to prohibit motor vehicles, except for solo motorcyclist from the full extent of the byway. Whilst these orders are being processed temporary orders will be made. Gates and barriers will be placed on the route to prevent access with surveillance cameras at each closure point installed and maintained by Wiltshire Police. Information and interpretation signs will be provided to educate users about the significance of the site and English Heritage and Wiltshire Council will work jointly to restore the site.




Fires by Cause




Non-Fire incidents attended by WFRS




Number of False Alarm Incidents

Report for Malmesbury Area Board - March 2011

Fires

WFRS attended 15 accidental fires during the months of January and February 2011 involving a car, a roof, boxes of paper, a chip pan and an oven fire. The remaining incidents were chimney fires.

It is pleasing to report that we were not called to attend any deliberate fires during the same period. WFRS continue to work closely with the police and other partners to try and identify persons responsible for deliberate fire setting.

Injuries

There have been no fire related injuries during this period.

RTC'S

WFRS were not called to attend any Road Traffic Collisions within the Boards area during January or February 2011.

Co-Responder Calls

WFRS have responded to 13 co-responder calls over this period.

Community Safety

Wiltshire Fire & Rescue Service continues to remind people about the importance of getting chimneys swept after being called to several chimney fires during the winter period.

The Service's advice is to ensure that chimneys for wood burning fires are swept every three months when in use. If you burn bituminous coal, the chimney should be cleaned at least twice a year, and at least once a year when burning smokeless coal. An annual clean is sufficient for oil and gas fires. Other tips include:

- Have the chimney properly swept using a vacuum cleaner alone is not sufficient.
- Make sure your fire receives enough air to allow the fuel to burn properly.
- Only burn suitable fuels.
- Do not overload the grate or appliance.
- Maintain your appliance in accordance with the manufacturer's instructions.
- Use a fire or spark guard to prevent accidental fires.
- Inspect your chimney breast, particularly in the roof space. Make sure that it is sound and that the sparks or fumes cannot escape through cracks or broken bricks.
- Make sure you are not at risk from carbon monoxide poisoning by having appliances installed and serviced by competent engineers. Fit a carbon monoxide detector and never block air bricks, vents or flues.
- Extinguish the fire before going to bed or leaving the house.

NHS Update - April 2011

Management cost reductions

NHS Wiltshire has been successful in reducing the number of posts originally identified as being at risk of redundancy from 55 to 25. In addition, a further 19 people have already chosen to leave, or are due to leave NHS employment through an NHS resignation scheme. This means that a total reduction of 44 posts will have been made by 31 March 2011, covering a combination of management and administrative roles.

Health and Wellbeing Boards lead the way in the South West

Care Services Minister Paul Burstow unveiled that all local authorities in the South West have signed up to be early implementers of new cross-working boards. This means patients and the public can expect a more joined-up service from the NHS and local councils in the future as part of broader plans to modernise the NHS. All 15 local authorities covering the South West have signed up to join a network of early implementers for health and wellbeing boards that will strip away divisions between the NHS and local authorities. This will give communities a greater say in the services needed to provide care for local people and to tackle the wider influencers of health such as transport, housing and leisure services.

Devizes Health Clinic

The decision to transfer services from Devizes Health Centre to Devizes Community Hospital was taken at NHS Wiltshire's Public Board Meeting in March 2010, as part of the PCT's long-standing plan for primary health care in Devizes.

Patients who use Devizes Health Clinic know that the building is in a certain state of disrepair; it therefore makes sense to dispose of the property so that we can keep and improve the ones that are sustainable to meet the needs of patients and staff. We plan to move the services from the Health Clinic to the hospital within the 2010/11 financial year and are currently planning the room configurations for services in the hospital so that services can be provided there from mid-April, located in the area which was previously used as the maternity wing.

All the services currently provided at the Health Clinic – the Health Visitor Service, the Emergency Dental Access service, podiatry, paediatric clinic and continence service - will move over to the hospital. There are no plans to begin marketing the Health Clinic site at any stage before the transfer of any service is complete. NHS Wiltshire will report any contract for the sale or lease of Devizes Health Clinic as a matter of public record in the usual way, which is through the Register of Sealings in its public Board Meetings.

GP Practice merger proposed

Plans for two Trowbridge GP practices - Bradford Road Medical Centre and Adcroft Surgery – to merge and co-locate in improved premises were announced at Trowbridge Area Board meeting on Thursday 17 March 2011.

The proposed GP-led Primary Care Development will provide flexible accommodation to enable GPs to provide a robust service with resources to deal with the future challenges of providing NHS care to patients.

Part of the development will be on land owned by NHS Wiltshire, which is currently used under licence by Trowbridge Cricket Club as a practice pitch. Outline planning permission was granted to the Primary Care Trust in February 2010 for the development of the land, and the area required for the Primary Care Development will now be sold to the GP practices in order for the new premises to be built.

The new building will consist of a two-story extension to the existing Adcroft Surgery premises, with additional car parking, an access road and a pharmacy building. Pedestrian access will also be possible from Adcroft Street through the Trowbridge Community Hospital site. The total premises size, including the existing Adcroft premises, will be approximately 1700 square meters. Car parking will be vastly improved, with a total of 108 spaces (30 existing, 78 new), and a new road from Seymour Road across the site will further improve access for patients.

Services offered at the development will include:

- A diagnostics 'pad', which will allow mobile units to provide breast screening and MRI screening
- An ambulance stand-by point in the car park
- An on-site pharmacy
- An on-site dental practice with an NHS dental contract

The development will be funded by the two practices, with an £87,500 annual investment from NHS Wiltshire.

Help for Adults with Eating Disorders in Wiltshire

NHS Wiltshire has commissioned a new Wiltshire service for Adults with Eating Disorders which will begin on 1st May 2011. The contract for the service, to be provided by Oxford Health NHS Foundation Trust, is for a period of three years.

Oxford Health NHS Foundation Trust has two specialist Eating Disorders Inpatient units – Cotswold House Oxford and Cotswold House Marlborough - the 12-bedded inpatient Unit based at Savernake Hospital. The new service will provide a full range of interventions, all based in Wiltshire so it is easier for patients to be treated closer to home. A website will offer guidance and advice for patients, carers and professionals and a multidisciplinary team will work with patients in the community. Those requiring treatment as day patients will be able to attend Cotswold House, Marlborough for one to seven days per week depending on their needs, which will help minimise disruption to employment, education or training. Inpatient treatment will be provided for the most unwell patients. The specialist unit based at Savernake Hospital has 12 en-suite bedrooms, day areas, a garden area and a suite of rooms for therapeutic activities. The inpatient team will working closely with community staff and inpatient teams will reduce emergency admissions to general hospitals. For patients with eating disorders who do require general hospital care for any reason, a specialist liaison service will be available.

Malmesbury & Villages Community Area Partnership (MVCAP) Claim for Core Funding 2011/2012

1. Purpose of the Report

1.1. To seek the Board's approval to core funding to MVCAP covering the financial year 2011/12 to be agreed at this meeting, 4 May, and the subsequent release of the first tranche (50%) of these funds.

2. Background

- 2.1. Officers are required to provide recommendations in a report, however the decision to support the community partnership and to what level, is made by Wiltshire Councillors on this Area Board.
- 2.2. There will be 2 tranches of funding to community partnerships during 2011/12 (up to 50% of their total projected costs in each tranche). The first is contained within this report, and the Partnership Development Officer will advise MVCAP that the second tranche can be requested at the 9 November, 2011 Board when evidence is received of how the first tranche has been spent.
- 2.3. Malmesbury Area Board has been allocated a 2011/2012 budget of £40,593 for community grants, community partnership core funding and councillor led initiatives.
- 2.4. Community Area Partnerships have been invited to apply for up to 20% of the area board budget. 20% of the Malmesbury Area Board budget 2011/12 is £8,118.53.

3. <u>Main Considerations</u>

- 3.1. Councillors will need to be satisfied that core costs awarded in the 2011/12 year are made to projects that can realistically proceed within a year of the award being made.
- 3.2. MVCAP were awarded £3,000 in 2010/2011. The balance of MVCAP funds as at 31 March, 2011 was £5,813. MVCAP has ring-fenced the figure of £3,234 for transport projects with the community area and will be rolling forward £1,795.24 into 2011/12 to be spent on activities in this coming

- financial year. This will leave MVCAP with little or no operational reserve for 2011/12.
- 3.3. All partnerships funded by Area Boards are required to sign a Community Area Partnership Agreement (CAPA), which will be countersigned by the Chair of the Area Board. The CAPA is to be signed by both parties at this meeting if MVCAP's core funding is awarded.
- 3.4. In order to show how the community area partnership aims to meet the commitments set out in the CAPA, MVCAP are required to complete a work plan. This work plan has been reviewed and endorsed by Wiltshire Council's Partnership Development Officer as a workable document.
- 3.5. Malmesbury & Villages Community Area Partnership has submitted a 2011/12 claim for £14,068.76 total core costs. This compares to the amount of £8,118 available to them in the Malmesbury Area Board's budget. 50% of this can be considered in the 1st tranche. The area board can therefore award up to £4,059 at this meeting to be paid immediately.

- 4.1.2 The community partnership contributes to the continuance and improvement of cultural, social and community activity and wellbeing in the community area, the extent and specifics of which will be dependent upon individual projects.
- 4.2. Financial Implications
- 4.2.1 Core costs awarded to the community partnership must fall within the Area Boards budget allocated to the Malmesbury Area Board.
- 4.3. Legal Implications
- 4.3.1 There are no specific Legal implications related to this report.

- 4.5. Equality and Diversity Implications
- 4.5.1 Community partnerships have agreed to the terms of the Community Area Partnership Agreement, which requires them to be fully inclusive.

 Membership of MVCAP is open to anyone with an interest in the community area, namely living or working in the Malmesbury Community Area.

5. **Recommendation**

The Partnership Development Officer recommends that the area board:

- approve the whole year's core funding of £8,118 with an agreement to release the 1st tranche of £4,059 immediately.
- agree to the release of the 2nd tranche in November 2011 as long as conditions set by the Partnership Development Officer and agreed by the Board, have been met.

Purpose of Report To provide information about: 1. The distribution of funding by Malmesbury area board in 2010/11. 2. The Community Area Grant Criteria for 2011/2012.

1. Background

- 1.1. Area Boards have authority to approve Area Grants under powers delegated to them by the Deputy Leader and Cabinet member for Community Services (15 April 2011). Under the Scheme of Delegation Area Boards must adhere to the Area Board Grants Guidance for funding.
- 1.2. In accordance with the Scheme of Delegation, any decision of an Area Board that is contrary to the funding criteria and/or the officer's recommendation would need to demonstrate that the application in question has a wider community benefit, and give specific reasons for why this should justify an exception to the criteria.
- 1.3. The emphasis in the Coalition Government's Localism agenda supports the ethos of volunteering and community involvement. With this in mind Community Area Grants should be encouraged from and awarded to community and voluntary groups.
- 1.4. Area boards will not consider applications from town and parish councils for purposes that relate to their statutory duties or powers that should be funded from the local town/parish precept. However this does not preclude bids from town/parish councils, encouraging community projects that provide new opportunities for local people or those functions that are not the sole responsibility of the town/parish council.
- 1.5. Officers are required to provide recommendations in their report, although the decision to support applications and to what level is made by Wiltshire Councillors on the Area Board.
- 1.6. Funding applications will be considered at every Area Board meeting.
- 1.7. All applicants are encouraged to contact Charities Information Bureau who is working on behalf of Wiltshire Council to support community and voluntary groups, town and parish councils to seek funding for community projects and schemes both from the Area Board and other local and national funding sources.
- 1.8. Paper copies of funding applications will no longer appear as part of the agenda in an attempt to reduce volume of paper used. However, the application forms will be available on the Wiltshire Council web site and hard copies available upon request.
- 1.9. The 2011/2012 funding criteria and application forms are available on the council's website (www.wiltshire.gov.uk/areaboards) or paper versions are available from the Community Area Manager.

1.10. All recipients of community area awards are expected to complete and return an evaluation form as soon as the project or activity has been completed and this should be accompanied by receipts and invoices, as well as photographs if possible. Failure to return the evaluation requested will preclude them from being considered for any future funding from the area board.

2. Main Considerations

- 2.1. It is disappointing that so few organisations who have received funding during 2010/11 have returned the evaluation form, a condition of their funding.
- 2.2. Malmesbury area board have given community area grants amounting to £24,493 during 2010/2011 and in so doing have helped lever in a further £26,601 to support community projects.
- 2.3. Malmesbury Area Board has been allocated a 2011/2012 budget of £40,593 for community grants, community partnership core funding and councillor led initiatives.
- 2.4. Following the 16 March 2011 area board, Crudwell Pre-school advised the area board they would not be taking up their award of £3,215 as they had been successful in obtaining funding from elsewhere.
- 2.5. The carry forward from the 2010/2011 budget is £9,717, resulting in a balance of £50,310 for distribution during 2011/2012.
- 2.6. Councillors will need to be satisfied that grants awarded in the 2011/2012 year are made to projects that can realistically proceed within a year of the award being made.
- 2.7. There are 6 funding rounds during 20011/12 however no applications were received for the first round. The remaining deadlines for receipt of applications and dates when they will be considered are as follows:
 - 13 May 2011 for consideration on 29 June 2011
 - 22 July 2011 for consideration on 7 September 2011
 - 26 September 2011 for consideration on 9 November 2011
 - 28 November 2011 for consideration on 18 January 2012
 - 23 January 2012 for consideration on 7 March 2012
