1	Chairman's Welcome and Introductions
	The Chairman opened the meeting and welcomed everyone in attendance.
2	Apologies for Absence
	Apologies had been received from:

3	Minutes
	The minutes of the previous meeting held 03 July 2013 were signed and agreed as a true and accurate.
4	Declarations of Interest
	No declarations of interest were made.
5	Chairman's Announcements
	The following announcements were made:
	a) Core Strategy Toby updated the meeting with changes to the Wiltshire Core Strategy. The strategy was outlined as being the document that summarises the planning policy framework for Wiltshire.
	Toby confirmed that following public examination of the document, the council published a Schedule of Proposed Modifications (August 2013) containing 'main' and 'minor' changes on the Council's website. Copies of which can also be found at main Council offices.
	The consultation period for this was said to remain open until Wednesday 9 October 2013 and would give all parties an opportunity to comment on the changes before the Inspector completes the report.
	b) Community Area Joint Strategic Assessments

The Chairman outlined that the current JSA for Wiltshire 2012-13 was due to be updated. Community Area JSA's were being updated, and plan to address gaps identified in the previous assessments. The new chapters include Leisure and Art and Culture. The results of the CAJSA's are expected to be published no later than April 2014 and the date of the community event would be announced shortly.

#### c) What Matters to you? Survey Launch

Simon updated the Area Board on the What Matters to You Survey that was launched at the beginning of September. Simon outlined that residents may receive a survey form if they are a People's Voice panellist, already on a council mailing list or could be randomly picked from council tax address lists. Paper copies would also be made available from Wiltshire council offices, libraries and GP surgeries. The survey also features on the council <u>website</u>, partner websites and some parish council sites.

Simon stated that the results gathered from the survey would be used (alongside existing local information) to help the council and its partners make decisions and target resources. The data would also be fed into the Community Area Joint Strategic Assessment, planned for early 2014, and so encouraged people to respond to the survey.

#### d) De-cluttering of Road Signs

The Chairman outlined that the Malmesbury CATG will be contacting town and parish councils asking that they compile a list of traffic signs and road markings that they would like to be considered for removal as part of a programme of ensuring that the country roads are not cluttered with un-necessary signs. This information will then be reviewed by officers who will make the decision about what can be removed or retained and the costs covered by the council's central budget.

In future most minor signage requests will be dealt with by the CATG with officer support. The Chairman noted that the community issues process should be used to make a request in future.

#### e) Free Poppy Seeds from Malmesbury & Villages Great War Project

The Chairman then outlined the Malmesbury and the Villages Great War Project that is being run in partnership with Malmesbury and the Villages Community Area Partnership (MVCAP) who aim to run events across 2014 - 2019.

The first project is to get poppies blooming across the community area to mark the centenary of the start of the war in 1914. To do this they are giving away one thousand packets of poppy seeds, but asking that you donate something to the Royal British Legion if you can afford to do so. The area Board extended its support to the project and congratulated MVCAP on the initiative.

Poppy seeds were available on the night, and are available from MVCAP

	f) News from the Operational Flood Working Group (North)
	Toby outlined the Severe Weather Emergency Seminar being held for flood wardens and parish council representatives on Wednesday 9 October 10am-1pm at Wootton Bassett Salt Depot.
	This will be a practical and informative session and will cover road closures, severe weather, snow plans, riparian ownership, ditch clearance and more. There will be a selection of equipment on display and also practical demonstrations such as sandbag and gel sac wall building.
	Numbers for this event are limited so please contact: renate.malton@wiltshire.gov.uk if you would like to attend this seminar.
	In addition Toby outlined the Annual Flood Warden meeting which would be an evening session for new and existing flood wardens to be held on Wednesday 23 October from 7-9pm (venue to be confirmed). This is to provide an opportunity for networking, updating on current flood information, and practical information to assist in the role.

6	Partner Updates
	The following partner updates were made to the Area Board
7	Wiltshire Police and Crime Commissioner
	Kieran Kilgallen (Chief Executive to the Wiltshrie and Swindon Police and Crime Commissioner) was in attendance to present the PCC Public Opinion Survey. It was clarified that a number of the results that had not been categorised were said to not be statistically significant (that is, not having enough data to draw a confident conclusion from). As a result they could not be used as indicators of performance in these areas.
	Simon then questioned the surveys purpose and stated that the outcomes only reflected perceptions of crime, and that this could be skewed by a number of variables including age of respondents. Kieran responded by stating that a report would be made available on the Police and Crime Commissioners website, which highlighted the differences in age related perceptions of crime.
	Toby then questioned some of the questions construct and asked what the value was in asking about the standard of education and public transport services, and questioned if responses to some questions could be categorised as quantitative or qualitative issues. Kieran stated that not every question on the survey was used to obtain findings, some were merely 'pot boilers' designed to elicit

	responses.
	Kieran confirmed that there was positive correlation between perceptions of some crimes and the equivalent crime figures. Kieran confirmed that Malmesbury was statistically, one of the safest areas in Wiltshire.
8	Wiltshire Police
	Inspector Mark Thompson and Sgt. Martin Alvis were in attendance to present the Local Police report for the Malmesbury Area. Mark stated that a warrant had been executed for a property in the area which had led to the seizure of a number of stolen goods.
	Mark described the reduction in ASB incidents, which had fallen 18% over the past 12 months. Small rises were reported for vehicle crime and non dwelling burglaries.
	The Area Board discussed the rise in assaults that was reported, and received clarification from Mark about the number of domestic incidents included in the report.
	Toby then asked about the number of thefts relating to property in garden sheds. Mark stated that residents should secure property where possible, and mark items of value with a postcode or name to assist with the identification and recovery of stolen goods.
	Chuck then questioned the reporting of assaults that occur as a result of amateur sports fixtures, and how this can negatively impact crime figures for rural areas. Mark clarified that recording of incidents is governed by Home Office recording guidelines and that it is not possible to separately categorise these incidents.
9	Wiltshire Fire and Rescue Service
	No representative from Wiltshire Fire and Rescue was in attendance to present the report. The Area Board noted the content of the fire and rescue report that had been submitted.
10	Malmesbury and the Villages Community Area Partnership
	The Area Board noted the update from MVCAP which included the following:
	<b>Malmesbury Area Pathfinders:</b> New signage has been erected providing details of the Malmesbury Bridges walk. MVCAP expressed thanks to Wiltshire Council for the use of their display space.
	<b>PHEW! An Olympic Legacy:</b> Many of the projects around the area had been well attended and received, with nearly 60 events so far and hundreds of participants.

	<b>Malmesbury and the Villages Great War Project:</b> MVCAP were in attendance at the meeting with a stand outlining some of the details for the project. One such project plans to create a living memorial to mark the centenary of the First World War, and aims to get poppies blooming across the area.
	One thousand packets of poppy seeds are being made available free of charge, though donations to the Royal British Legion are requested where possible. Stalls will be available at future local events including Malmesbury Carnival's Petticoat Lane, on 14 September and Sherston's Pop-Up Village on 21 September.
	<b>AGM:</b> The MVCAP AGM will take place at 7:00pm on Wednesday 25th September at the meeting room in Malmesbury Fire Station. A motion will be tabled where the proposal will be for MVCAP to change into an incorporated registered charity. This suggested change will enable MVCAP to take advantage of new funding opportunities.
	<b>Community Safety Forum:</b> MVCAP will meet on Wednesday 25 Sep 2013 at 7:30pm at the Malmesbury Fire Station, with the Police and other safety bodies to discuss local safety issues and priorities. The public are welcome to attend or may pass on any issues to members of MVCAP.
11	Malmesbury Youth Advisory Group
	The following update was provided to the Area Board and was outlined by the Chair.
	Malmesbury Skatepark
	Malmesbury Skatepark would be formerly opened with a launch party on Saturday 7 September between 11am and 5pm. The YAG welcomes everyone to come along and see what a splendid facility has been provided for young people.
	There will be events and entertainment throughout the day including food, demos, competitions, music and much more.
12	Town and Parish Councils
	John Tremayne of Easton Grey Parish Council thanked the work of Steve Leonard, Wiltshire Council and Easton Grey Parish Council for their contribution to completing the bridge works at Easton Grey.
	John Gundry then outlined the new community space that is available In the Old School Room in the Town Hall. Two open days were taking place on 14 and 21 September to which community groups were invited. The town council were keen to hear from members of the community as to how they could support projects and/or provide community space, and encouraged any ideas that could

	support projects or community usage of the space.
	Simon congratulated the community partnership on behalf of the area board and praised the active support they have provided to community projects.
13	Community Operations Board
	Lucy Murray Brown, (Head of Campus & Operational Models) gave a Presentation to the Area Board on the development of Community Campus Facilities.
	Lucy explained that a campus for Malmesbury could provide services the local community needs in an accessible location. This would bring both social and economic benefits, whilst relieving some operational pressures. Core criteria to all campus buildings include shared reception, community space, accessible IT provision, personal care facilities and catering facilities.
	Some of the benefits that the Council hoped to achieve from the Campus programme included the empowerment of local people to directly influence the delivery of public services in the local area.
	Lucy then outlined the indicative sequence of events for developing a campus proposal, which included the appointment of representatives to a Shadow Community Operations Board. The Shadow COB would operate as a working group of the Area Board, and aid in the delivery of services, making recommendations to the Area Board and in turn, to Cabinet for consideration.
	Lucy answered questions on the membership of the Shadow COB, and outlined possible representative groups. Further information on the Malmesbury Campus programme can be found <u>here</u> on the Wiltshire Council website.
	John Cull (Lea and Cleverton PC) questioned the budget for the programme and how this would be formulated. Lucy stated that budgets would be set by Cabinet when a firm proposal for a Campus had been established.
	Chuck questioned how rural communities could benefit from a campus, and the outreach programmes that would ensure all residents could benefit from the plans. Lucy stated that local communities can be involved via the Shadow COB and can have a direct input into the management and decision making process. Lucy also outlined a number of community outreach programmes that had been suggested in other areas, and welcomed any suggestions from residents and councillors on how this could be extended.
	Kim Power (Malmesbury Town Council) questioned if the Campus programme would be delivered through the Neighbourhood Plan. Lucy stated that Neighbourhood Plans would identify any particular needs, and the Campus Programme could be delivered to meets the needs specified in plans. Simon stated that there is an overlap between the requirements of a Campus and the

	framework of a Neighbourhood plan, and suggested that both could be used to enhance and deliver what is best for the community.
	Simon Jefferson (Ashton Keynes PC) asked about the scale, size and format of a campus and how the COB could impact on this. A discussion was then had amongst Area Board members who outlined the possible construct of the COB and the role it could play in the delivery of a Campus and future decision making
	At the end of the discussion the Area Board invited nominations for representatives to sit on the Shadow COB, and stated that the deadline for nominations are to be received by Monday October 7 and can be sent to: Campus and Operational Delivery Programme, Wiltshire Council, County Hall, Bythesea Road, Trowbridge, Wiltshire, BA14 8JN or electronically to campusconsultation@wiltshire.gov.uk
14	Transport: Review of Local Bus Services and Alternative Transport Options
	Ian White (Head of Service - Passenger Transport) <u>gave a presentation</u> to the Area Board on the Bus Service review that is currently being undertaken.
	The presentation outlined the background and rationale behind the review and addressed the need for financially sustainable ways of meeting passenger needs.
	The current review of services was particularly relevant to Malmesbury as it affects all services in Malmesbury Community Area. These are numbers; 30, 31, 41, 50, 52, 75, 76, 91, 92, 93, and 95. A consultation period is currently underway and public representation is welcomed. The consultation invites suggestions for alternative proposals to bus services including alternative bus timetables, or could be more radical. The consultation closes on 7 October 2013, with any proposed changes likely to take effect from April 2014.
	Ian outlined the challenges in delivering a profitable county wide service and asked for residents to provide any ideas or suggestions about how services could be more cost-effective and still meet local needs.
	Alan Truscott from Community First <u>gave a presentation</u> on Community Transport. Alan outlined a number of community link schemes for the Malmesbury area, and also detailed a number of voluntary services including the Malmesbury and Cartmell Community buses.
	Alan outlined the benefits of these schemes and outlined funding of up to £20k available through the Wiltshire Community Transport Development Fund, which aims to provide new community transport schemes and initiatives.
	Alan stressed the benefits of Car sharing, and directed residents to the <u>Wiltshire</u> <u>Car Sharing Portal</u> which currently has over 550,000 users.

	Community First can provide help and assistance on setting up, funding and assistance with the delivery of Community Transport schemes. Any questions can be directed to Alan, Liam or Helen on <a href="mailto:transport@communityfirst.org.uk">transport@communityfirst.org.uk</a> or 01380 732816.
	Chuck then asked if there was any possibility for Community Transport schemes to collaborate between commercial and public services, such as seat exchange on schools busses etc. It was clarified that school buses would not be able to take members of the public.
	A question was then asked by the Local Bus Users Network around the proposed changes to services. Ian asked residents to direct concerns and comments on proposed changes to services through the consultation avenue to ensure that they would be considered in the review.
	Simon then questioned the funding available to schools for bus transport, and questioned if such funding was means tested. Ian stated that transport is available to around 9000 pupils, who receive the transport as they are either too far to travel, or the walking route to school is not safe. Simon also stressed the importance of reviewing linkages to services to allow vulnerable people access to key public services.
	The Area Board invited ideas for community transport initiatives and stated that community grant applications would be welcomed for CT initiaitves, providing they met the key criteria.
15	Community Issues Update
	Miranda Gilmour (Community Area Manager) introduced the report on pages 31- 36. Following discussion the Area Board decided to:

16	Neighbourhood Planning
	Simon made a <u>short presentation</u> to the Area Board on Neighbourhood Planning.
	Simon made reference to the <u>Wiltshire Council Guidance on Neighbourhood</u> <u>Plans</u> , which is the document available to town and Parish Councils to assist in creating a Neighbourhood Plans.

	Simon then outlined some of the frequently asked questions which can be found <u>here</u> on the Wiltshire Council website.
	Toby then added that that Neighbourhood Plans can benefit areas with regard to planning needs, but highlighted that plans often take substantial input and consultation. Town and Parish Councils can seek officer assistance with plans, and can deliver plans in accordance with the Wiltshire Core Strategy.
17	Community Area Transport Group
	Miranda Gilmour presented the CATG report detailed on pages 37-48 of the Agenda. Following discussion it was decided:
	Decision
	The Area Board approved the following recommendations from the Community Area Transport Group:
	1.1.1. Pedestrian safety work in Sherston High Street is currently underway
	1.1.2. It has been mutually agreed between CATG and the parish council not to proceed with a footway in Ashton Keynes.
	1.1.3. The town council has agreed to contribute £847 towards the completion of pedestrian safety works near Tetbury Hill/Filands junction and Tetbury Hill/Avenue de Gien mini roundabout.
	1.1.4. CATG are of the opinion that any action related to improving vehicular access to Malmesbury Primary Care Centre would be disproportionate to the benefits. The matter would be closed.
	1.1.5. Project costs for signs at Dark Lane had increased due to the cost of accessing electricity. There is a legal requirement that the sign is lit. The project now costs $\pounds4,000$ . At the same time the Mill Lane signage had reduced to $\pounds1,000$ . It was felt that the gains made at Mill Lane could help off-set the additional costs at Dark Lane, where the CATG would still be required to contribute a further $\pounds1,000$ to complete the project.
	1.1.6. SID sites would need to be reviewed at the October CATG meeting as Callow Hill, Brinkworth was eligible for a SID. The figures here would be considered with the other sites, already agreed this year.

Wiltshire Council's Pest Control team are pleased to be able to visit the area board meetings to offer advice on the services available to the general public, local businesses and parish and town councils. The pest control team covers the whole of Wiltshire with all officers fully trained to deal with a wide variety of public health pests.

A recent study by the Chartered Institute of Environmental Health<sup>1</sup> asking residents their views on pest control found that 85% of those questioned believe that their pest control department is an important part of public health protection in their area.

The pest control team provides treatments for rats, mice, wasps, fleas, bedbugs, clusterflies, carpet moths, squirrels, and cockroaches. In order to ensure the service is accessible to all the community discounts of up to 50% are offered for certain means tested benefits.

To give you an idea of the number of pests we deal with during the winter of 2012/13 we treated just fewer than 1000 rodent problems and in August 2013 we treated 514 wasp nests affecting homes and businesses in Wiltshire.

Pest control officers work closely with Environmental Health Officers often identifying vulnerable residents who may require further assistance and referring the customer to other services.

- 1.1. One of the key roles of the area board is to help local people find solutions to things that are complex or non-routine which affect the community as a whole; not simply a few individuals.

The majority of routine problems can be dealt with by the council faster through direct contact and to help local people do this, the section of the area board web page has been updated to allow logging of simple issues direct with a person who can help them e.g. Lost and stray dogs and Common road and highway problems (CLARENCE). Where a problem does not fit into any of these categories or if the matter is causing widespread concern in the community, it should be reported to the Malmesbury area board via the <u>online community issue form</u>.
- 1.3. At the time of writing (17 October 2013), a total of 155 community issues have been received, of which 138 have been closed and 17 are currently in progress.
- 1.4. If the area board approve the recommendations to close issues there will be 15 issues to progress by the area board, although some remain active but the responsibility of the Malmesbury Community Area Transport Group (CATG).

#### **Purpose of Report**

- 1. To ask the area board to consider and approve the recommendations from the Malmesbury Community Area Transport Group (CATG) outlined in this report and appendices.
- 2. Note the adoption of the new Speed Indicator Devices (SID) schedule and process for 2013/14.

#### 1. Background

- 1.1. In 2013/2014 Malmesbury area board was allocated a discretionary budget of £13,360 to involve them in the assessment and selection of small scale transport schemes to be progressed in their community area.
- 1.2. This funding allocation is for capital funding and can only be used to provide new and improved infrastructure. It is suitable for schemes that improve safety, increase accessibility and sustainability by promoting walking; cycling and public transport and improve traffic management. It cannot be used to fund maintenance schemes or to pay for revenue functions such as passenger transport.
- 1.3. Malmesbury area board agreed to the establishment of a Community Area Transport Group (CATG) to consider issues /schemes with the support of highways officers and make recommendations to the area board. The means by which the public and parishes can identify issues for consideration to the Malmesbury CATG is primarily via the <u>area board community issues process</u>
- 1.4. The current membership of the Malmesbury CATG comprises of Malmesbury area board councillors and a nominated parish council representative from each electoral division. Membership for 2013/14 is as follows:

- 1.6. Parish councils and individuals who have submitted issues being discussed by the CATG are also invited to attend CATG meetings.
- 1.7. Malmesbury CATG last met on 15 October and will next meet on 11 February 2014.

#### 2. Recommendations from CATG and other information

- 2.1. Actions and outcomes of the Malmesbury CATG are contained notes of the CATG meeting held on 15 October 2013 (see Appendix 1). Also available from the <u>Malmesbury area board pages</u> of the council's website.
- 2.2. The area board is asked to note and approve actions and recommendations of the Malmesbury CATG as follows:
- The current CATG budget balance for 2013/14 (see Appendix 2) is £21,300.
- Pedestrian safety work in Sherston High Street is near completion and local residents are very pleased with the work.
- Pedestrian safety work on Tetbury Hill/Filands junction and Tetbury Hill/Avenue de Gien mini roundabout will be undertaken in November following a financial contribution being received from the town council.
- Since the CATG meeting was held Minety parish council have confirmed that they do not wish to proceed with gateway treatment to the village in an attempt to slow traffic speed.
- GreenSquare have agreed to contribute to a parking scheme in Leigh in 2014/15 and the CATG is in broad support, but await the response from the parish council and wider community (since as with all schemes a financial contribution is expected) as to whether they proceed.
- The Traffic regulation Orders are now in place in Dark Lane and Mill Lane, with electric to be completed by the end of October.
- Signing at the Blicks Hill/Holloway junction will be completed during November, however there is no date for re-surfacing and lining.
- HGV and speed concerns on Callow Hill and School Hill and being addressed through Community Speedwatch and ad hoc police enforcement.
- CATG considered the results of the C class road reviews undertaken last year (C70 Ashton Keynes to B4553 Packhorse Lane junction and C1 County boundary north of B4040 at Easton Grey to A429) and the possibility of undertaking a review of C68 Foxley Road) and agreed that any changes were unlikely to have significant impact on reducing accidents, so no further action would be taken.

They felt that rather than undertaking reviews of C roads, in future, they should ask any parishes with concerns to raise the specific issue via the area board community issues process.

- Speed monitoring on Gloucester Road and part of Tetbury Hill shown 85<sup>th</sup> percentile figures of 24mph and 26mph respectively.
- Concerns about poor communication between Network Rail and the community would be investigated.
- It was not possible to add to 'road closed' sign how far up the road was closed, however details of road closure were on the councils website and the Malmesbury Our Community Matters website.
- 'Children playing' signs at Newnton Grove would be investigated.
- The zebra crossing required re-whitening by the Market Cross, Malmesbury. We have since heard that this will be undertaken shortly.
- Parish/town councils were requested to respond to the 'De-cluttering of Signs' request no later than 31 December 2013.
- 2.3. Malmesbury CATG wished to remind parish councils that a condition of progressing schemes relied on parish councils consulting locally and demonstrating community support for schemes. They are also asked for a contribution of 25% towards the cost of schemes. Town/parish councils are asked to consider this when setting their precept for 2014/15.
- 2.4. SID programme and process for 2013/14.
  - From the end of October 2013 some changes will be adopted to ensure a more efficient installation system of the equipment.
  - SIDs will continue to be deployed on a 3 monthly cycle as outlines in Appendix 3.
- Should parishes experience any problems with the installed equipment they should contact Clarence on 0800 23 23 23 as soon as possible.

#### 3. Environmental & Community Implications

3.1. Environmental and community implications were considered by the CATG during their deliberations. The funding of projects will contribute to the continuance and/or improvement of environmental, social and community wellbeing in the community area, the extent and specifics of which will be dependent upon the individual project.

#### 4. Financial Implications

- 4.1. All decisions must fall within the funding allocated to Malmesbury Area Board.
- 4.2. Following financial reconciliations the balance of the CATG budget for 2013/2014 is **£21,300.**

#### Purpose of Report

To ask councillors to consider the following officer recommendations:

- 1. Sherston Magna Cricket Club award £5,000 capital towards the installation of twin bay full length synthetic grass outdoor cricket training nets, conditional on the balance of funding being in place.
- 2. 1st Malmesbury Scout Group award £483 capital towards loft insulation at St Mary's Hall, Malmesbury.
- Community First consider an application seeking £2,002 revenue towards an additional service to be provided by the local Good Neighbour Co-ordinator designed to help older vulnerable people stay warm, well and safe during the winter months.
- 4. The area board consider a councillor led project application requesting £4,000 capital to enable topographical surveys to be undertaken of Station Yard and Cross Hayes car parks.
- 5. To approve officer delegated authority of £415 revenue funding to pay for Health & Safety training for volunteers to help run the Skater Kids Club for primary school aged children from across the community area .
- 6. To launch a Young People's Intergenerational Project 2013/14, making £5,000 available for projects.

#### 1. Background

- 1.1. Area Boards have authority to approve Area Grants under powers delegated to them by the Deputy Leader and Cabinet member for Adult Care, Communities and Housing (5 April 2013). Under the Scheme of Delegation Area Boards must adhere to the <u>Area Board Grants Guidance 2013/2014</u>.
- 1.2. In accordance with the Scheme of Delegation, any decision of an Area Board that is contrary to the funding criteria and/or the officer's recommendation would need to demonstrate that the application in question has a wider community benefit, and give specific reasons for why this should justify an exception to the criteria.

- 1.3. The Localism agenda supports the ethos of volunteering and community involvement and the nurturing of resilient communities. With this in mind Community Area Grants (CAGs) should be encouraged from and awarded to community and voluntary groups.
- 1.4. The area board may wish to link funding to local priorities, including those identified in their Community Plan, Local Area Joint Strategic Assessment and any other community based consultative work.
- 1.5. In 2013/14 Malmesbury Area Board was allocated a budget of **£53,138** for community area grants, digital literacy grants, community partnership core funding, area board operational funding and area board/councillor led initiatives. In 2013/14 only capital funding is available for community area and digital literacy grants.
- 1.6. In addition to CAGs and digital literacy grants councillors can submit an Area Board/Councillor Led Initiative. This enables area boards to tackle sticky community issues and/or community identified priorities. Cabinet have emphasised that they do not wish these to be used to avoid complying with Community Area Grant criteria or for filling gaps where there are council service shortfalls.
- 1.7. Applications of up to and including £500 can be made for a Community Area Grant, which do not require matched funding. Amounts of £501 £5,000 will be required to find matched funding. The area board will rarely award more than £5,000.
- 1.8. A ring-fenced budget of £1,500 has been provided specifically for Digital Literacy Grants, although the area board may spend more. Up to £500 per project is available for capital projects.
- 1.9. New for 2013/14 is a single on-line application process for Community Area Grants (CAG) and Digital Literacy grants, introduced to provide an easy step by step application process. The application process and funding criteria can be found <u>here.</u>
- 1.10. Area boards will not consider CAG applications from town and parish councils for purposes that relate to their statutory duties or powers that should be funded from the local town/parish precept. However this does not preclude bids from town/parish councils, encouraging community projects that provide new opportunities for local people or those functions that are not the sole responsibility of the town/parish council.
- 1.11. Officers provide recommendations, however the decision to support applications is made by Malmesbury area board councillors.
- 1.12. Funding applications will be considered at every Area Board meeting whilst there is money available.

1.13. All recipients of area board funding are expected to complete an evaluation form as soon as the project has been completed and provide receipts if requested. Groups are encouraged to up-load information and photographs about their project on to the <u>Malmesbury & Villages – Our Community Matters</u> <u>blogsite</u>. Failure to evaluate projects will preclude applicants/organisations being considered for future funding.

#### 2. Main Considerations

- 2.1. At the 3 July 2013 area board £8,118 revenue funding was allocated to the Malmesbury & Villages Community Area Partnership and £5,000 capital awarded to Minety Village hall, leaving a total balance of **£40,020** to be allocated through Community Area Grants, Digital Literacy Grants and Area Board/Councillor Led Initiatives
- 2.2. At the 4 September area board £418 capital was awarded to Little Somerford Short Mat Bowls Club and £3,154 revenue was returned to the area board, leaving a capital budget of **£34,743**, (plus a further £1,500 for digital literacy grants) and a revenue balance of **£9,513** (includes £3,000 ring fenced legacy funding).
- 2.3. Councillors must ensure that the distribution of funding is in accordance with the Scheme of Delegation outlined in Section 1 of this report.
- 2.4. Councillors will need to be satisfied that grants awarded in 2013/2014 are made to projects that can realistically proceed within a year of the award being made.
- 2.5. There are 2 funding rounds remaining in 2013/14. Deadlines for receipt of funding applications are as follows:
  - 22 November 2013 for consideration at 15 January 2014
  - 24 January 2014 for consideration at 5 March 2014

#### 3. Environmental & Community Implications

3.1. Area Board Grants contribute to the continuance and/or improvement of

cultural, social and community activity and wellbeing in the community area, the extent and specifics of which will be dependent upon the individual project.

#### 4. Financial Implications

- 4.1. Awards must fall within the Area Boards budget allocated to the Malmesbury Area Board.
- 4.2. If funding is awarded in accordance with officer recommendations Malmesbury area board will have £25,260 capital (excluding the digital literacy grant) and £2,096 revenue.
- 4.3. If the area board agree to fund Community First's, 'A Winter's Journey' project, it will mean that some of the ring-fenced revenue MVCAP Legacy funding will be used.

#### 5. Legal Implications

5.1. There are no specific legal implications related to this report.

#### 6. HR Implications

6.1. There are no specific HR implications related to this report.

#### 7. Equality and Inclusion Implications

- 7.1. Community Area Grants and Small Grants will give local community and voluntary groups, town and parish council's equal opportunity to receive funding towards community based projects and schemes, where they meet the funding criteria.

- 8.1.1. Officers recommend that Sherston Magna Cricket Club is awarded £5,000 capital funding towards the cost of installing twin bay full length synthetic grass outdoor cricket training nets, conditional on the balance of funding being in place.
- 8.1.2. This application meets grant criteria 2013/14.

- 8.1.3. The applicant is requesting less than 25% of the total cost of the project from the area board, contributing approximately 50% from their own funds/fundraising and applying elsewhere for the balance.
- 8.1.4. The Malmesbury and the Villages Community Plan 2009-2013 lists the need to have affordable activities for young adults and families, engagement of young people in community life/activities, while young people stated they wanted more activities for teenagers especially in the villages.
- 8.1.5. The training nets would particularly help the junior sections of the club and new members, especially those returning to the game, as well as retaining current members. It is hoped that these new facilities will help the club grow to its full potential and harness the enthusiasm that appears to blossoming throughout all levels.
- 8.1.6. Sherston Magna CC provides the cricketing focus for Sherston and 10 villages including Luckington, Sopworth, Didmarton, Badminton, Hullavington, Norton, Shipton Moyne, Grittleton, Alderton, Westonbirt and Leighterton; four of which fall within the Malmesbury community area. These villages have limited access to cricket facilities and Sherston is the major focal point for cricket in this area.
- 8.1.7. The club is flourishing with a Saturday and Sunday sides, a junior section with over 50 members and a burgeoning ladies side. The U13 team had their first league season this year and next year the club aims to enter an U11 and U15 team as well. Two coaches (one an ex England International) have helped to increase membership and provide a strategic direction for the club.

8.2.	1st Malmesbury Scout Group	Loft insulation at St Mary's Hall, Malmesbury.	£483

- 8.2.1. Officers recommend that 1st Malmesbury Scout Group is awarded £483 capital towards loft insulation at St Mary's Hall, Malmesbury.
- 8.2.2. This application meets grant criteria 2013/14.
- 8.2.3. The Malmesbury and the Villages Community Plan 2009-2013 lists the need to provide facilities other than the town hall for events and activities.
- 8.2.4. The hall is used by a wide variety of community (most children's) groups and charges modest hire charges.
- 8.2.5. The hall is very cold in the winter and heating bills substantial. In an attempt to improve the situation additional insulation of 200mm is to be installed by volunteers to supplement the 100mm currently in place. This action will help to reduce carbon emissions by saving fuel, while at the same time making the

hall a more comfortable environment for its many user groups.

- 8.3.1. Community First consider awarding £2,002 revenue towards an additional service to be provided by the local Good Neighbour Coordinator, designed to help older vulnerable people stay warm, well and safe during the winter months across the Malmesbury community area.
- 8.3.2. This application does not meet the grant criteria 2013/14 as it is providing a salary to increase the role of the local Good Neighbour Coordinator between November 2013 and March 2014.
- 8.3.3. The Malmesbury and the Villages Community Plan 2009-2013 lists the need to provide support for the elderly and vulnerable people to be cared for in their own homes.
- 8.3.4. The project will support about 200 older people through presentations and publicity with intensive support to an additional 15 older, vulnerable people in the area to ensure that they can stay warm, healthy and engaged at a time when they are at their most vulnerable.
- 8.3.5. Practical support will be provided which might include how they can save money on their energy bills including giving plenty of practical energy saving tips for around the house. Regular follow up is provided which might include essential shopping during bad weather and organising transport for medical appointments.
- 8.3.6. Promotional activity throughout the community area will highlight the importance of staying warm, well and active which will be targeted specifically to the over 60's. Through a combination of presentations at local clubs and events and articles in local publications, information and advice about staying warm and healthy and who to contact for additional support will be provided.
- 8.3.7. The ability to be able to fund this project only arises because revenue funding was returned to the area board in September for a project which did not take place.

- 8.4.1. The area board to consider a councillor led project requesting £4,000 capital to undertake topographical surveys of Station Yard and Cross Hayes car parks.
- 8.4.2. A topographical survey provides an accurate electronic model of exactly what is on the ground, picking up kerb lines, drainage gullies, street furniture etc. It will also give level and contour information of the ground itself. The value of the survey is that it will ensure what is subsequently designed will work in practice. The survey for Station Yard car park will also include the approach road.
- 8.4.3. Councillor led funding applications are designed to address 'sticky issues' identified through the area board community issues process or where there is a significant community need identified. This proposal meets these criteria addressing the desire to see how the Cross Hayes car park might be reconfigured to accommodate more vehicles and the Station Yard car park may be examined to find ways in which it and the approach road might be redesigned to discourage anti-social behaviour.

- 8.5.1. To approve officer delegated authority of £415 revenue funding to pay for Health & Safety training for volunteers to help run the Skater Kids Club for primary school aged children from across the community area .
- 8.5.2. Officer Delegation was approved by Malmesbury area Board on 10 November 2010).
- 8.5.3. At the Malmesbury skatepark opening there was a demand from primary school aged children to use the skatepark. It was agreed that as this fell outside the remit and capacity of the Youth Development Service to provide, (plus the need to separate larger and smaller children), this could go ahead where volunteers could be found to run the sessions.
- 8.5.4. To date parents of primary aged children are sought to help deliver this programme. The Youth Development Service has agreed to manage the CRB checks, while area board members felt they could assist by providing the Health & Safety training.

- 8.6.1. Officers recommend the launch of the 2013/14 Young People's Intergenerational Project fund which invites projects up to £2,000 to be received no later than 7 February 2014, for consideration at the 5 March 2014 area board.
- 8.6.2. Following the approach adopted last year when young people were encouraged to take the project lead but involve adults, as supporters, helpers, educators or beneficiaries; the area board feel they would like to repeat this style in 2013/14.
- 8.6.3. Those applicants meeting the funding criteria will be invited to present their project proposals to the area board on 5 March and using a participative budgeting approach the community will vote for and chose the projects which will receive funding.
- 8.6.4. Funding packs will be available from the <u>Malmesbury area board webpage</u> as well as the Malmesbury Our Community Matters website following this meeting.

I would like to start by commenting on the non dwelling burglary figures that show a decrease of 25% which is good news however in recent weeks we have seen a few more burglaries occur on the east side of Malmesbury in villages heading towards Swindon. The team are actively researching these and as always appeal for information from the community and to ask people to be on the lookout for anything suspicious.

Violence against the person has increased, all these assaults are very low level, many involving minor falling outs between children for example which are subsequently reported by their parents. In most cases assaults are committed by persons known to each other, it is rare to have a stranger related assault in our area.

Finally in line with our community consultation and the results of the recent Police and Crime Commissioner survey that was reported on at the last area board, our Policing priority for this current quarter is speeding and traffic related matters.

#### Local managers report:

The 4 accidental fires attended in September involved a BBQ, garden shed, a field and farm machinery and a tea towel. The incident with the tea towel could have so easily caused significantly more damage to the house if it hadn't had been for the smoke alarm providing early warning. The 3 co-responder calls demonstrate our diversity in training and response to the local community, fire crews provided early medical intervention to 3 members of our community who were suffering from chest pains and problems with their breathing.

Home fire safety visits have been carried out across the area for those people identified through our prevention work or referred to us by our partner organisations. These visits continue to ensure the most vulnerable members of our community are provided with essential fire prevention advice in addition to ensuring a working smoke alarm is fitted in their property.

Our proactive work in reducing false alarms continues to drive down our need to respond to properties where the fire alarms have activated due to reasons other than fire. This reduces costs both in the running and maintenance of vehicles and reduces the risk of unnecessary blue light responses.

The profile of each station in Wiltshire Fire & Rescue Service is displayed on our web page, here you can look at fire statistics, station crewing and establishment, response times and a timeline of incidents attended by that station.

#### Chimney Fires:

With the onset of autumn and the colder weather those with open fires; solid fuel or wood burning stoves should start making arrangement for chimneys and flues to be cleaned.

Chimneys for wood burning fires should be swept every three months when in use. If you burn smokeless fuels or bituminous coal, the chimney should be cleaned at least once a year. An annual clean is sufficient for oil and gas fires.

Other safety tips include:

- Have the chimney properly swept using a vacuum cleaner alone is not sufficient.
- Make sure your fire receives enough air to allow the fuel to burn properly.
- Only burn suitable fuels.
- Do not overload the grate or appliance.
- Maintain your appliance in accordance with the manufacturer's instructions.
- Use a fire or spark guard to prevent accidental fires.
- Inspect your chimney breast, particularly in the roof space. Make sure that it is sound and that the sparks or fumes cannot escape through cracks or broken bricks.
- Make sure you are not at risk from carbon monoxide poisoning by having appliances installed and serviced by competent engineers. Fit a carbon monoxide detector and never block air bricks, vents or flues.
- Extinguish the fire before going to bed or leaving the house
