	The minutes of the meeting held on 23 July 2013 were presented for consideration and comment. It was,
	Resolved: That subject to the removal of the reference of Councillor Dennis Drewett as a member of Trowbridge Town Council in Minute 39 - Declarations of Interest - to approve the minutes as a true and correct record and be signed by the Chairman.
55	Declarations of Interest
	Councillors Graham Payne, Jeff Osborn, John Knight, Nick Blakemore and Helen Osborn all declared general, non-pecuniary interests in Trowbridge Town Council issues due to being members of the Town Council.
56	Chairman's Announcements
	i) Trowbridge Community Area School Travel Plans It was noted and stressed that the creation of School Travel Plans was the responsibility of each individual school, and the Board encourage all school to keep their travel plans up to date.
	ii) Trowbridge Birthing Centre  Attention was drawn to recent media statements from the NHS regarding the temporary closure of the Trowbridge Birthing Centre over the summer as a result of transfer of staff to cover a shortage at Bath RUH. The Board regretted once again there had been no local consultation, and acknowledged that the Leader of the Council had raised the issue with Great Western Hospitals, and wished to be kept updated to any new information.
	iii) Grass Cutting The recent concerns over grass cutting following the transfer of contract to the new council provider was noted, and it was noted that full Council had debated the matter for more than an hour on 9 July.

## iv) Agenda Order

With the consent of the Committee, Item 10 as listed in the agenda - *Visiting Cabinet Representative* - was moved forward to item 9.

## 57 Partner Updates

Updates from partners were received as follows:

## i. Wiltshire Police

The written update was noted. Inspector Lisette Harvey also urged people to be vigilant when leaving windows open as a result of the heatwave.

## ii. Wiltshire Fire and Rescue Service

The written update was noted. The draft public safety plan for 2013-16 was also stated to be in development, with an exhibition and consultation on 12 July, and the service invited people to make comments on the plan. There were also updates on the dangers of Chinese lanterns following recent news reports and the national and regional decline in fires in the past 5 years of around 48%.

## iii. Trowbridge Community Area Future (TCAF)

The written update was noted. Tracy Sullivan discussed the date of the neighbourhood partnership on 2 September, and the Annual General Meeting for TCAF on 7 October at Trowbridge Town Hall, with a theme to discuss of the environment, following comment from the Area Board.

## 58 Outside Body Updates

## i) Transforming Trowbridge

It was noted the body had not met since prior to the May Local Elections, and were in the process of producing the Trowbridge Masterplan.

## ii) Collaborative Schools

The written report was noted.

## iii) Shadow Community Operations Board (COB)

The written report was noted. It was stated the shadow COB had received 1700 completed questionnaires in its first round of consultation, and further responses were now being sought. A questionnaire is attached to these minutes.

The board considered a request to appoint a new member of the shadow COB.

## 59 Funding

The Area Board considered the following applications to the Community Area Grant Scheme 2013/14:

## i. West Wiltshire District Scout Association

The sum of £1500 was requested to purchase maintenance equipment and a secure store to keep it in and to improve accessibility at the Jubilee Wood Scout Camp Site and Community Youth Activity Centre.

## Decision

The Area Board awarded the sum of £1500 to West Wiltshire District Scout Association.

<u>Reason:</u> The application met the Community Area Grant Criteria 2013/14.

## Visiting Cabinet Representative - Leisure

The Cabinet Member for Communities, Campuses, Area Boards, Leisure, Libraries and Flooding, Councillor Jonathon Seed, was in attendance and discussed his responsibilities and vision for the deliverance of local governance of services with more limited resources in the future.

The Cabinet Member answered questions, particularly on the topic of leisure, and it was stressed that community input and direction was crucial moving forward, with details of the proposed campus and other plans in the town to come from the community to be approved by Cabinet.

The Area Board welcomed that additional youth funding the Council had received from central government had been ringfenced, and also sought further information on volunteering in Wiltshire, and it was stated that where necessary volunteers received DBS (formerly CRB) checks and appropriate training, in order to maintain libraries, leisure centres and other services that the Council could no longer afford to staff.

## 61 Trowbridge Census Data

Phil Morgan (Wiltshire Council – Census Liaison Manager) delivered a presentation, attached to these minutes, on trends and data for the Trowbridge Community Area arising from the 2011 National Census.

The high levels of recent immigration clustered in specific areas of Trowbridge was noted, to a far higher degree than other population centres in Wiltshire. The Area Board noted challenges arising from the trends given recent and historical issues of deprivation in parts of the Trowbridge Community Area, and discussed how the area could appropriately target support and resources for specific areas

in a time of high stresses on funding levels.

The possibility of Neighbourhood Budgets trialled in other parts of the country was raised, as a method of focusing funding for specific purposes and targeted much more closely on affected areas than previously.

After debate, it was,

## Resolved:

- 1) To thank Phil Morgan for his presentation;
- 2) To receive a report from Michael Hudson (Wiltshire Council: Service Director Finance) on Neighbourhood Budgets and potential options for the Trowbridge Community Area, at the next meeting of the Area Board on 12 September 2013.

## Museum and Cultural Development Update

Caroline Taylor (Museum Project Consultant) delivered a presentation, attached to these minutes, on the plans to move and update the Trowbridge Museum. It was stated funding had been applied for from national bodies, with the goal of taking advantage of the heritage assets in Trowbridge, such as Courtfield House, a Grade II\* listed building, and creating a regionally significant site among the history of textiles in the country.

The need to create partnerships and a cultural strategy in addition to the museum project proposal was emphasised, in order to create a cultural provision for Trowbridge, and permit it to better utilize its advantageous position close to regional hubs like Bath and Bristol.

The Board discussed the strategy and made several suggestions about moving forward.

At the conclusion of discussion, it was,

To support the development of the strategy and a commitment to consider the recommendations once that exercise had been completed.


## 63 <u>Streetscene and Highways Local Community Co-ordinators</u>




# Wiltshire's Diverse Population

## Second release

- The second data from the Census 2011 was released by ONS on 30th January 2013.
- Wiltshire's total census day population was 471,000 (its now nearer 477,000)
- The population has increased by 38,000 between 2001 and 2011, an increase of 8.8% which is larger than the overall increase in the South West and England.
- Wiltshire's growth rate was the fourth largest in the South west.
- Only the urban areas of Swindon, Bristol and Bournemouth have higher growth rates.






## Who lives in Wiltshire?

We have a long history of some minority communities, Polish in Westbury, Moroccan in Trowbridge (90), Gypsy traveller community in the south for example









The Wiltshire Core Strategy, which provides the planning policy framework for Wiltshire, recently underwent discussion at a public examination conducted by an independent Planning Inspector.

Following the examination hearing sessions the council has published a Schedule of Proposed Modifications (August 2013) containing 'main' and 'minor' changes to the Core Strategy to give all interested parties the opportunity to comment before the Inspector completes his report.

The consultation will take place for a six week period from **Tuesday 27 August to Wednesday 9 October 2013 inclusive**.

The council has produced an update to the Sustainability Appraisal (SA) and Habitats Regulation Assessment (HRA) based on the Schedule of Proposed Modifications. Comments can also be made on these updates.

The Inspector has also requested that the council invites comments on the implications that the two recent ministerial statements relating to wind farm development, and the recently published national planning practice guidance for renewable energy may have on the Wiltshire Core Strategy.

Details of where you can view the Core Strategy, Schedule of Proposed Modifications and associated documents (including the SA update, HRA update, ministerial statements and planning practice guidance document) will be available on the Wiltshire Council website from 27 August 2013: Core Strategy

### **Summary of announcement:**

The JSA for Wiltshire 2012-13 was published in late 2012 on behalf of the Public Services Board (PSB). You may recall this was made possible by the contributions made by each of the thematic delivery partnerships.

The value of local data and evidence meant we supplemented the JSA Wiltshire with 20 individual local community area assessments. The community area JSAs, first published in 2011, added to our local knowledge and helped us and communities focus on the real issues in their local area. As part of the JSA programme, the Community Area level assessments (CAJSAs) are in the process of being updated this year, these will provide updated data about our local communities across the ten chapters.

The CAJSAs have taken on board feedback from Councillors, officers, organisations and feedback from our community events (held in 2012) and will build on the existing document and include more information on changes; trends; qualitative survey data (such as the results from the What Matters to You survey 2013) and other primary research such as the Census 2011.

We also intend to address some gaps in the first community area JSAs by including two new chapter's one covering leisure, and a second chapter art and culture which aligns the CA JSAs with community plans. The assessment will follow a similar structure to the JSA Wiltshire 2012-13 version, and will include a chapter written by each thematic delivery partnership (TDP).

We aim to publish the CA JSAs at a second round of community events between January and April 2014 and have discussed these plans at the Chair of the Area Board meeting and also met with Area Board managers. We are currently in the process of agreeing dates for each community event. The date of the Trowbridge by invitation event has been agreed as 03 April 2014 – CAMs are listing event dates here - www.jsaevents2014.weebly.com

### Public opinion survey - Trowbridge - Trowbridge Section

The Office of the Police and Crime Commissioner (OPCC) commissioned M.E.L. Research to consult local residents. During 2012/13 4408 Wiltshire residents completed the survey. A minimum of 384 people took part in each of the eleven policing sectors<sup>i</sup> ensuring that the results for each sector were significant<sup>ii</sup>.

The aims of this survey are:

- o To measure public perception of Wiltshire Police and how communities are policed
- o To consult the public and enable the OPCC and Wiltshire Police to prepare policing plans
- To enhance the OPCC and Wiltshire Police's understanding of how policing influences people's sense of security and wellbeing

### **Perceptions of Crime and ASB**

Perceptions of Crime and ASB being a problem in the Trowbridge Sector are slightly above the average for the Wiltshire Police area.

- o The average perceived level of crime on a scale of 1 − 10 (with 1 being 'none' and 10 being 'a lot') is 3.39 for Wiltshire Police as a whole. For the Trowbridge Sector the average score is slightly above the force average at 3.57, the average score for the Trowbridge Section is slightly higher again at 3.82
- The average perceived level of ASB on a scale of 1 10 (with 1 being 'none' and 10 being 'a lot') is 3.34 for Wiltshire Police as a whole. For the Trowbridge Sector the average score is slightly higher than the force average at 3.42, with an increase to 3.73 for the Trowbridge Section.

The perceptions of low levels of crime and ASB are in line with the actual crime and ASB levels with both just above the force average.

- There were 52 crimes per 1000 population in the Trowbridge sector in 2012/13, this compares to a Wiltshire average of 46 crimes per 1000 population.
- There were 41 reported ASB incidents per 1000 population in the Trowbridge sector in 2012/13, in comparison to a Wiltshire average of 37 incidents.

<sup>&</sup>lt;sup>i</sup> Wiltshire Police is divided geographically into 11 local policing sectors. These sectors are then further divided into sections - these usually consist of a large town and the neighbouring villages or community areas.

Statistical significance; If the survey was completed using an alternative set of respondents there is a 95% chance that the result would fall within ±1.5% of the current result at force level. At sector level there is a 95% chance that the result would fall within ±5% of the current result.

### **Purpose of Report**

To ask Councillors to consider two funding applications to the community area grants fund:

- 1. Two applications seeking Community Area Grant Funding (appendix 1)
  - 1.1 Wiltshire Youth Marching Band to purchase new band instruments £500 requested
  - 1.2 Gloucester Road Allotment Association to create a paved pathway £2,850 requested

**Total Amount requested = £3,350** 

### 1. Background

- 1.1 Area Boards have authority to approve Area Grants under powers delegated to them by the Deputy Leader and Cabinet member for Adult Care, Communities and Housing (5 April 2013). Under the Scheme of Delegation Area Boards must adhere to the Area Board Grants Guidance 2013/2014. The emphasis in 2013/14 will be that the Area Board funding will support volunteering, community involvement and addressing community priorities.
- 1.2 Trowbridge Area Board has an increased budget for 2013/2014 budget of £111,127 for community area grants (CAGS), community area partnership (CAP) core funding and area board/councillor led initiatives. Pursuant to the budget approved by the Council, the Area Board has been provided with a budget allocation of £88,486 for CAGS/Councillor led projects; £21,141allocated funding for CAP funding & revenue/operational budget; £1,500 capital for Digital Literacy Fund grants. £19,736 has been allocated to date:
  - £15,556 TCAF CAP core funding
  - £2,680 TCAF Lights Camera Action CAG
  - £1,500 West Wiltshire Scouts Equipment & secure store CAG This leaves a remaining budget total of £91,391 to allocate in 2013/14.
- 1.3 Area Boards will be encouraged to develop ways of linking grant funding to locally agreed priorities emerging from the Joint Strategic Assessment, the local community plan or other relevant local evidence
- 1.4 An on-line funding application process has been introduced for all applicants.
- 1.5 In 2013/14 up to £500 unmatched funding will be available to support small local projects. All applications for projects exceeding £500 will be expected to provide match funding (either in cash or in kind) to the value of a minimum of 50% of the total requested
- 1.6 In 2013/14 applications specifically for Wiltshire Online, Digital Literacy will be considered, with £1,500 being allocated to each area board and distributed through the community area grants process.
- 1.7 In support of the Olympic and Paralympic legacy, in 2013/14 the Area Boards will particularly welcome applications that encourage young people and people with disabilities to become more actively involved in sports, outdoor activities, recreation, arts and volunteering.
- 1.8 Area Boards will not consider CAG applications from town and parish councils for purposes that relate to their statutory duties or powers that should be funded from the local town/parish precept. However this does not preclude bids from town/parish councils, encouraging community projects that provide new opportunities for local people or those functions that are not the sole responsibility of the town/parish council.
- 1.9 In accordance with the Scheme of Delegation, any decision of an Area Board that

- is contrary to the funding criteria would need to demonstrate that the application in question has a wider community benefit, and give specific reasons for why this should justify an exception to the criteria.
- 1.10 In addition to CAGs, Councillors can submit an Area Board/Councillor Led Initiative. This enables area boards to tackle sticky community issues and/or community identified priorities. Cabinet have emphasised that they do not wish these to be used to avoid complying with Community Area Grant criteria or for filling gaps where there are council service shortfalls.
- 1.11 Officers are required to provide recommendations in their funding reports (except in the case of Area Board/Councillor led initiatives), although the decision to support applications is made by Wiltshire Councillors on the Area Board.
- 1.12 Funding applications will be considered at every ordinary Area Board meeting.
- 1.13 Paper copies of funding applications no longer appear as part of the agenda in an attempt to reduce paper. They are however available to view on the Wiltshire Council web http://portal.wiltshire.gov.uk/areaboard\_grants/grants\_list.php
- 1.14 All recipients of area board funding are expected to complete and return an evaluation form as soon as the project or activity has been completed and this should be accompanied by receipts and invoices, as well as photographs if possible. Failure to return the evaluation requested will preclude them from being considered for any future funding from the area board. This applies to all grants made by the area board.

### **Trowbridge Shadow Community Operations Board**

### Report to Trowbridge Area Board on the second phase of the consultation

From the start of June to 26 July 2013 the Trowbridge Shadow COB carried out its second phase of consultation. A questionnaire approved by the Area board in April 2013 was used which set out the working proposal drawn up by the SCOB from the results of the first phase of carried out in 2012. The questionnaire was available in both paper and electronic form.

Thank you to everyone who has fed in their views. The total responses to the questionnaires were 1,134. A small number of responses were received after the deadline and although these have not been included within the presentation of the results, the COB will incorporate this feedback when analysing the results.

A summary of the consultation results is attached to this paper, as are all of the comments received in survey responses.

### How the consultation was carried out.

- A paper questionnaire was produced with an online version.
- Members of the SCOB supported by members of TCAF and Wiltshire Council's Campus Team spent eight mornings or afternoons in the Atrium at County Hall. This proved a particularly good place to get responses from members of the community.
- Specific presentations have been given to Trowbridge Town Council, Trowbridge Sports Forum, Trowbridge WI, Trowbridge Luncheon Club, St James' Church and Trowbridge Schools Collaborative.
- Members of the COB spent three evenings at Castle Place Leisure Centre and another two at Trowbridge Sports Centre canvassing opinion.
- The COB had a presence at a number of community events including the Sports and Play event, the Armed Forces Weekend and a number of school fetes.
- Most secondary and primary schools agreed to send the questionnaire home to parents either in paper or electronic form and published a short article about the Campus in their newsletters.
   Many schools also encouraged their pupils to complete the questionnaire, either at school or through sending the questionnaire home.
- Specific approaches were made by members of the SCOB to the Polish and Moroccan communities and other ethnic minorities in Trowbridge.
- Questionnaires were distributed through other organisations such as Trowbridge Town Council, Trowbridge in Bloom, Trowbridge Chamber of Commerce, The Trowbridge County town Initiative and Trowbridge Town Team.
- Questionnaires were given to Wiltshire College's Trowbridge site for students to complete.
- Some guestionnaires have been hand delivered.
- Copies of the questionnaire have been placed with and collected from the Tourist Information Centre, Library, Sports Centres, supermarkets and some local shops.
- There have been several articles in the Wiltshire Times.
- The Trowbridge Magazine July edition included a long editorial about the Campus and reproduced the questionnaire.

### **Feedback**

### 1. Analysis of the questionnaires

Based on the questionnaires the main findings are.

- Overwhelming support for the idea of a campus. 96.9%
- Overwhelming support for the proposed community facilities 95.5%
- Overwhelming support for the proposed sports and leisure facilities 96.6%
- Additional comments on the idea of a campus 319 comments
- Additional comments on community facilities 267 comments
- Additional comments on sports and leisure facilities 409 comments
- Some general comments
- Other facilities that were suggested

### 2. Oral responses and qualitative feedback

Most people were very enthusiastic about the proposal and in general conversations were more positive than in 2012. There were many additional ideas. Some concerns expressed were

- Access- it was important that there was adequate parking and good access from bus routes
- Pricing –it was important that prices were at a level to be affordable for the people of Trowbridge
- Governance and ownership concerns that it might be owned and run by a commercial organisation

A small number of people we spoke to expressed opposition to the campus but declined to complete a questionnaire. The main reasons given for not completing a questionnaire were because people felt;

- Nothing ever happens in Trowbridge so it will not happen
- The perception that the campus is going to be on the Bowyers site where people felt the cinema should have been
- It is the wrong time to spend money on this during a recession when people are being made redundant and services are being cut
- There are enough facilities in Trowbridge

### **Next Steps**

- The SCOB wishes to know if the Area Board are content that the consultation has been thorough and that the views of the community are reflected in the results,
- Once the SCOB has the Area board's approval it will then provide the information to the Campus Delivery and Operational Models Team to assess options for delivering the campus proposal to meet as much of the brief as possible.
- It is then a matter of the SCOB to await the outcome of this process. We hope for a positive outcome and will update the Area Board once more information is known. It is hoped that Wiltshire Council's Cabinet will be able to receive a proposal in the near future.

# Trowbridge Community Campus Survey – phase 2 consultation results summary

The information below formed part of the phase two consultation about the Trowbridge Community Campus during June and July 2013.

Dear member of the community,

Thank you if you took part in the first phase of consultation that we held from July to October 2012. We have carefully analysed the responses we received and we have drawn up a working proposal to create a community campus in Trowbridge based upon them.

The Trowbridge Shadow Community Operations Board (Shadow COB) would now like your views on this proposal. We can then take this proposal to Wiltshire Council and ask them to try and find a site that could deliver our working proposal for a campus, delivering as much of the working proposal as possible.

Strong views were expressed for the need for facilities like an ice rink which are outside our remit. We have passed these on to the appropriate bodies.

Please read the working proposal and then answer the key questions that follow.

Please also look out for meetings and events in the local area to come along and talk about the campus proposal.

All responses to the consultation must be received by; Friday 26th July 2013

#### **Working proposal**

If a site can be found to accommodate a campus for Trowbridge we would ask that it would deliver the following:

To create a new building combining community and leisure facilities and services on a central site in Trowbridge with adequate parking and good access for pedestrians, cyclists and those using public transport.

Every effort will be made to integrate the leisure and community facilities. The building would be completely accessible to those with learning or other disabilities.

The space will also be organised to enable artwork to be displayed in it.

It is not possible at this stage to consult about any specific site but this is likely to be informed by the consultation on the Master Plan for Trowbridge due to take place in July.

This proposal has been drawn up taking into account existing and proposed facilities such as the redevelopment of the Town Hall and is intended to complement these and not duplicate them.

The Trowbridge Shadow Community Operations Board is proposing that the council consider options for delivery of the following principles;

#### A) A community aspect with:

- -A single point of contact to provide information or signposting to the appropriate service
- -IT rooms equipped with computers and WFI that can be used for learning by adults and young people
- -Multi use rooms with adequate storage that can be used by young people, adults with learning difficulties or community groups
- -A kitchen where food can be prepared and eaten
- -A health and wellness centre including personal care rooms, a sensory room, rooms for quiet reflection and a medical room

- -Small rooms suitable for interviews and meetings
- -A café/catering facility linked to the leisure facilities
- -A space for music practice and recording
- B) A leisure aspect. capable as acting as a regional centre staging regional competitions and other regional events as well as encouraging increased participation, containing:

#### Water related activities

- -A 6 lane swimming pool that can be used for community swimming, water polo and canoeing, as well as competitions with spectator accommodation
- -A learner swimming pool
- -A leisure swimming pool with flume rides and other water features
- -A facility for diving that can also be used for synchronised swimming and sub agua
- -Sauna and Jacuzzi linked to the health and wellness centre

#### Dry activities

- -An 8 badminton court size sports hall that can be used for many activities including basketball, badminton, 5-aside football, archery, fencing, Tai Kwando with retractable seating for audiences.
- -A large fitness suite that can be used for a range of fitness activities.
- -Multi-purpose spaces with adequate storage that can be used for various activities including aerobics, dance or gymnastics.
- -Provision for squash which can also be used for other activities like Thai Chi or provide additional space for dance and aerobics
- -A climbing wall











### Trowbridge Campus Consultation – phase 2 – map of postcodes where survey responses were received



Subject: Land at former Peter Black site, Mortimer Street, Trowbridge.

#### **Purpose of Report**

1. To inform Members regarding the outcome of enforcement action to remedy the poor condition of the above site.

#### **Background**

 Members will recall that reports on this matter have been brought to previous Area Board meetings. The Council served an Untidy Site Notice under Section 215 of the Town and Country Planning Act 1990 on the owners of the site on 4<sup>th</sup> March 2013.

The Notice took effect on 4<sup>th</sup> April 2013 and required the following actions to be carried out within three months:

- 1) Cut back all soft landscaping on all boundaries of the Land (excluding formal trees) so that the soft landscaping is no greater than 2 metres in height when measured from natural ground level and is not overhanging the boundaries of the Land.
- 2) Cut back all soft landscape areas within the Land (excluding formal trees and formal grassed areas) so that the soft landscaping is no greater than 2 metres in height when measured from natural ground level.
- 3) Cut back all formal grassed areas within the Land.
- 4) Remove all weeds (including buddleia, brambles, creepers and self seeding trees) on all boundaries of the Land.
- 5) Remove all weeds (including buddleia, brambles, creepers and self seeding trees) within the Land and on all buildings within the Land.

- 6) Permanently remove to an authorised place of disposal all material resulting from steps 1, 2, 3, 4 & 5 above from the Land.
- 7) Permanently remove to an authorised place of disposal all rubbish, rubble and detritus from the Land.
- 8) Repair and secure all gates and fencing on the boundaries of the Land.
- 9) Remove all graffiti from the buildings within the Land or paint-out all graffiti from the buildings within the Land with a colour that matches the existing building colours.
- 10) Board up and paint all the windows of the office building on the western end of the Land with a colour that matches the existing building colour.
- 11) In addition to requirement 10 above, board up and paint all broken windows and all ground floor windows of all other buildings within the Land with a colour that matches the existing building colours.

An appeal to the Magistrates Court, which would have delayed the Notice coming into effect, was not made, so the works required by the Notice should be completed by no later than 4<sup>th</sup> July 2013.

#### **Update since previous report**

- 3. At the last meeting of the Area Board, the period for compliance had just expired however the owners had committed to carrying out the necessary work.
- 4. The required works were carried out by contractors acting for the owners by the end of the week ending 26<sup>th</sup> July 2013. Officers inspected the site at the time and confirmed that no further action pursuant to the Untidy Site Notice is now needed.
- 5. Following removal of the weeds and overgrown landscaping within the site, it was established that the remaining overgrown planting around the boundaries of the site was in fact on Council-owned /controlled land. The appropriate section of the Council have therefore been requested to undertake maintenance of this area, to improve its appearance and that of the overall setting of the site.

- 6. It is confirmed that the Council has instructed Balfour Beatty to cut back the land and remove the creepers from the Council side of the fence. The land is on the long term maintenance schedule.
- 7. Nevertheless it is recognised that the site retains its appearance as a disused industrial premises. In the event that the site's condition deteriorates further in the future, it will be necessary for the Council to consider whether a further Untidy Site Notice should be served.
