SPEED LIMIT REVIEW VARIOUS ROADS CORSLEY HEATH

Purpose of Report

To consider the comments received following the formal advertisement of speed limit changes on the C275 and various UC roads at Corsley Heath, and to recommend an appropriate way forward.

Consultation

The initial results of the review were disseminated to the relevant Town and Parish Councils who were invited to make comment on the recommendations and were given the opportunity to put forward their case, should they wish to see a different result from that proposed by the review. Following the initial consultation period a number of the affected Town and Parish Councils, as well as Wiltshire Councillors commented on the proposals.

Options Considered

To:

- (ii) Retain the existing speed restrictions and delete the proposal from the implementation programme.
- (iii) Amend the advertised changes in accordance with the comments made.

SPEED LIMIT REVIEW VARIOUS ROADS CORSLEY HEATH

Purpose of Report

 To consider the comments received following the formal advertisement of speed limit changes on the C275 and various UC roads at Corsley Heath, and to recommend an appropriate way forward.

Relevance to the Council's Business Plan

- 2. The proposed TRO meets two priorities of the Council's Business Plan.
 - Outcome 2 People in Wiltshire work together to solve problems locally and participate in decisions that affect them.
 - Outcome 6 People are as protected from harm as possible and feel safe.

Background

- 3. A review of a number of Wiltshire's C and UC roads was undertaken in 2013/14 in accordance with the adopted methodology set out in Cabinet Member report ref HT-027-11 and in accordance with Circular 01/13 and its supporting documents.
- 4. Following discussion and agreement at the relevant Community Area Transport Groups (CATG) a number of the recommended changes have progressed to the formal Traffic Regulation Order (TRO) advertisement stage. The TROs associated with the proposed changes for the C274 and various UC roads at Corsley Heath have recently been advertised.
- 5. During the advertisement period for the TRO, one letter of comment has been received. No comment was received was from an affected Wiltshire Council Member. A plan showing the proposed speed limit changes is included at **Appendix 1.**

Main Considerations for the Council

6. To consider the comment received during the consultation period. A summary of the issues raised and officer comments are included in **Appendix 2**. Details of the commentor are provided in **Appendix 3**.
