Scouts and Guide units run to support young people in their physical, mental and spiritual development, so that they can play constructive roles in modern society. It is also about having fun in a safe and supportive environment, whilst learning life skills. Activities range from cookery, crafts, music, building things and first aid. Thanks to twenty five wonderfully enthusiastic volunteer leaders Aldbourne Scout and Guide Units are an amazing asset to the village and the community. The Aldbourne Scout and Guide hut, in Goddard Lane that has been used by many hundreds of children over the years, is now 40 years old and needs some refurbishment to ensure it can continue to offer a safe and fun facility for another generation of children
