Proposed Prohibition Of Driving At Stonehenge World Heritage Site

Your Reference: KAD/TRO/AMES

I would like to raise my objection to your proposed Traffic Regulation Order on routes within the Stonehenge World Heritage Site.

As an English Heritage member for some years I place a great value on the maintenance of historic sites, such as Stonehenge, but I fail to see the true benefit of the proposed TRO closing the BOATs in the vicinity of Stonehenge to selected categories of vehicular traffic. As a member if the Wiltshire TRF I have enjoyed the freedom to use these BOATs to travel across the Wiltshire countryside in pursuit of my trail riding pleasure, since these provide a key safe link to a variety of trails in the area.

I fail to see any justifiable evidence for the proposed restrictions with the one statement of reason offered — "For preserving or improving the amenities of the area through which the road runs". The proposed restrictions will still allow access for maintenance vehicles and invalid carriages. Furthermore, the intent to allow access to horses, horse-drawn vehicles and cyclists indicates that there is no intent to downgrade these routes in terms of accessible capability, but that this is a simple case of biased discriminatory practice that will remove access for a minority class of trail vehicular users.

The proposal suggests that the TRO will 'bring substantial improvements to the landscape setting of the Stonehenge, reuniting the monument with its ancient avenue, and to the experience of visitors to the Stonehenge WHS.' However, the TRO offers no clarification on what these 'substantial' improvements might be. Considering the WHS borders the extremely busy A303 there can be no argument for limiting the use of the BOATs based upon noise, since there is significant noise pollution from the A303. Having visited the

Stonehenge site I have never experienced anything but the occasional motorised vehicle or these BOATs which are neither threatening nor intrusive.

What is more it would appear that you have decided that safety is no longer an important consideration since your proposals to route this light traffic via the A303 are extremely questionable in light of the available accident statistics. I note with interest that there has been a not insignificant 89 accidents between Dec 06 and Nov 09 in the vicinity of the junctions with the A345 and A360 in the locality of the WHS. Whilst I accept the majority (73) fall into the class of 'Slight', as a motorcyclist of over 20 years who has ridden the roads in the area on numerous occasions I am never surprised by the lack of attention from car drivers who are busy looking at the Stonehenge site rather than concentrating on the road. Add to this the fact there are often foreign drivers who are unfamiliar with British roads and the risk of the casualty figures of 127 increasing is highly likely. Your proposals to move all vehicular traffic onto these busy roads and junctions will put those of us riding small capacity trail motorcycles at a much increased risk and I can foresee the accident rate increasing as consequence; I trust you are comfortable with that possibility and that such issues have been duly considered, although there is no evidence that suggests this has been the case.

There may be some merit in 'improving the amenities' by restricting parking on the BOATs, without the draconian measure of closing them to all users. I strongly believe that this proposal lacks proper consultation with all users and seems to reflect the views of a 'select' group. Whilst I am all for maintaining the WHS I believe that this can be achieved without the necessity to curtail the rights of way on the BOATs which has so many negative side effects. In the absence of any detailed justification I would like to see a Public Enquiry which examines all the relevant facts and considers all viewpoints to enable an informed and considered decision to be made.



I am writing to you to formally object to plans for a TRO to be placed on the byway known as the West Track (Drove road) near the Stonehenge monument in Wiltshire, which will prohibit vehicular access to this area.

Sent: Thu 11/02/2010 16:14

I am a practising Pagan and am currently the Round Table Chalivorman of the Dolmen Grove, the south's leading Pagan organisation.

I use this byway to park my vehicle on when I visit Stonehenge and the surrounding areas outside of the English Heritage opening hours. My purpose for visiting the area is religious as I am a practising Pagan. The TRO will stop me from being able to access this area outside of normal opening times and during the open managed access events, where no vehicle parking (except on the summer solstice) is provided by English Heritage.

I have to drive from West Dorset to attend these events, and need the drove road to park on in readiness for waiting for the dawn for ritual purposes since there is no other alternative parking or public transport for the times of day I attend. Refusal of access for my vehicle on this byway will prohibit me from attending these religious ceremonies and therefore infringes on my human rights to celebrate my faith freely at monument of specific religious significance. Currently there is no where else to park and without the drove road acess to the area outside of English Heritages official cur park opening times will make this an impossible event.

I would like to know what provisions you will make for me and many people like me to be able to still continue to visit this area freely as you are in effect making it impossible for people to gather close by to the monument without English Heritage's involvement. Vehicular access is needed as there is no provision for public transport during the night or early hours of the morning which would make it difficult to access the dawn ceremonies. Also, without vehicles many people who are unable to make a mile long walk would be denied access since they need their vehicles to transport their ritual items and clothing and rest in after the ceremonies and rituals before safely moving onward.

People have been using this track for many many years now, who come from all over the world to take part in the religious ceremonies and rituals carried out there by the Pagan and druid community, of which I am a member. I have met many people over the years who have travelled specifically thousands of miles to attend a ceremony with avehicle, and a TRO on the truck will deny the global pagan community from being able to continue to take part in such ceremonies. Many make this pilgrimage here year after year for the 4 open managed access events, and often visit to contemplate the monument out of hours as per their beliefs. The west track/drove is a crucial area for the pagan and druid community to safely congregate before the centronies and rituals, allowing those with disabilities and mobility issues safe and tolerable access to the area in keeping with their human rights to freely practice their religious beliefs.

I urge you to reconsider your plans for a blanket TRO prohibiting vehicles on this small piece of land and to seriously consider the effects on the denial of human rights on religious grounds of those who use it.

I look forward to your reply.

I wish to object to the proposal above and in particular to the reason you give (stated below).

"For preserving or improving the amenities of the area through which the road runs."

As a keen walker and occasional motorcycle trail rider I'm dismayed that the needs of ALL users of our countryside are not being considered.

This proposal clearly discriminates against users of motorcycles who do not make up large volumes of traffic and cause less wear and tear that horses.

The amenity will not be improved by prohibiting small volumes of passing trail vehicles and indeed you present no evidence that banning vehicles will actually improve the amenity and have the desired effect

Byway vehicular use is insignificant the context of the volume of traffic on the A303 and the A344 (even after a section of it is closed)

To my mind, the biggest improvement to the amenity (without curtailing rights of way) would be to restrict parking on sections of the BOATS rather than banning through traffic.

A blanket ban on all vehicles on all routes is a complete overreaction to a problem (that in my mind does not exist) and that amenity improvements can be achieved by more selective and creative approach so as not to curtail access rights that you have a duty to protect. As a result of your proposal trail motorcycles may be forced onto major trunk roads that you suggested as alternate routes

Byways and their purpose (ie transport) have an historical value that should also be protected for future generations

In advance of the absence of a detailed justification of the TRO by yourselves I will be seeking a Public Enquiry 4/2/10

Thank you for your letter to Amesbury Town Council concerning the proposal to prohibit the use by motorised vehicles (with exceptions) of Part of the A344 and Byways 1.2.10.11 12 and 16.

Amesbury Town Council wishes to respond as follows:

A344. The Council wishes to object to this proposal at this time for the following reasons. The closure of this section of the A344 will almost certainly increase the traffic flow along the unclassified road known locally as the "Larkhill Packway" from its junction with the B3086 (to the west) to the A345 (to the east) Traffic wishing to carry on to the A303 or to Bulford Village, Bulford Garrison or Tidworth Garrison are likely to continue along the A3028. This road is due to be closed for a number of months to carry out essential repairs to the bridge in Bulford Village. This would create a good deal of additional traffic in the area and is likely to impact heavily on the A345/A303 junction at Countess Roundabout.

The Council are content that once the bridge work has been completed that the prohibition order for the A344 may be implemented.

Regarding the prohibition orders for the Byways open to all Traffic (Boats) the Council wishes to object to the following:

BOATs 1,2,11 and 16. BOATs 12 (from junction with A303 to connection with BOAT 1 Wilsford cum lake) BOAT 11 (from its junction with the A303 to connection with BOAT 2 Wilsford cum lake) for ease of reference that is all BOATs to the South of the A303.

Reasons for objection are that this will take away ancient rights of citizens to travel the Byways by whichever means of transport they so wish. Whilst accepting the Stonehenge Management Plans principles regarding traffic management, the main vehicle route the A303 remains a major problem.

In this context the BOATs listed above are insignificant. It has been established that very few motorised vehicles use these BOATs thus it is considered an extreme measure to implement the proposed order. It is also considered that such an order would be difficult to police and enforce.

Regarding BOAT 12 (from its junction with the A303 to its junction with the A344) And BOAT 10 (entire length) The Council raises no objection as this fits in well with the Stonehenge Management Plan and the proposed new Stonehenge Visitors Centre.

The Council is aware that several groups probably collectively known a Spiritual Groups are making representations to use the BOATs at the two solstices and the spring and autumn equinox for motorised vehicles. If this were allowed it could lead to representation by other groups wishing to do the same thus nullifying any prohibition orders.

I object to the above order for the following reasons.

Objection 1

The Council's sole reason for proposing to make the order "...for preserving or improving the amenities of the area through which the road runs" does not take into account all users. The exclusion of Trail Riders and other motorised users will not improve their experience of the area.

Where is the council's evidence that banning motorised users improves the amenity?

Objection 2

Safety. Appendix 2 of the Halcrow Group Ltd statement of reasons Version 5, Page 8 Sect 5.4, as found on the link given on the Council's consultation web site, suggests that there are other routes available via the A360 and A345. I know this area well with regard to rights of way for motorised vehicles and cannot think of any and therefore conclude that the A360 and A345 are the alternatives. Due to a Council's Temporary Traffice Regulation order in 2009 I was forced to use the A360 last year and consider it an experience that I would not like to repeat on my trail motorcycle. I have since obtained some accident statistics from Wilts Council for the A360 Airman's Cross south to Downbarn X roads and A345 Durrington Roundabout south to Old Sarum for the last 3 years. 36 accidents on the A360 and 75 accidents on the A345 confirm to me that these routes are dangerous.

Objection 3

Sect 5.4 above, also states "Balanced against this loss of amentity for recreational motorised vehicle users is a potential reduction in damage to the surfacing of the BOAT and a more tranquil experience for non motorised users and visitors to the WHS"

Fisrtly, as agricultural use is to be continued and that accounts for most 'wear and tear' upon byways it is

unlikely that there will be any reduction in so called damage to the BOAT and secondly the A303 will no doubt continue to be one of the most busiest roads in the area and the MOD will continue it's military use of Salisbury Plain with all the noise associated with such use.

Ojection 4

These routes are stategic to the area as they form a link between Salisbury Plain and the Byways to the South West and Sout East of the county.

NERCA 2006 took away approx. 20% (224 km) of RUPPS to restricted Byway in Wiltshire, this proposal is effectively another 1% lost not only to me but to future generations, and makes the remaining network so much more valuable as a right.

The whole process of this consultation seems to have an air of a 'done deal'. After reading the appendices that are linked on the web site I notice that no changes were made to the original proposal despite significant objection and suggested alternatives.

I therefore ask for a Public Enquiry

Safety. The suggested alternative routes are dangerous. Accident statistics from Wilts Council for the A360. Airman's Cross south to Downbarn X roads and A345 Durrington Roundabout south to Old Sarum for the last 3 years show that there were 36 accidents on the A360 and 75 accidents on the A345. I consider this to be particularly dangerous to the lower powered type of motor cycle that I use. I started to ride byways in Wiltshire upon my 50cc moped at the age of 16, 5 years ago and the safer aspect of byways was a major factor in my parent's consent to ride.

Objection 2

The Council's reason for proposing to make the order does not take into account all users. There is no evidence in the proposal that the exclusion of Trait Riders and other motorised users will improve the amenity of the area.

I would like to raise a formal objection to the proposed alterations around Stonehenge which will result in the closure of 7 No BOAT's. Whilst I understand that the site of Stonehenge needs to be protected, I cannot agree that the proposals tabled are the best way forward. The number of BOAT's being closed does not reflect the nature of the proposals to protect Stonehenge. The only section that could reasonably be justified is the section of Amesbury 12 between the A303 and the A344. The proposal to close the A344 is also misguided as the traffic which currently uses this major arterial route would be forced to use the A303 and the A360, significantly impacting the junction of the A303 and the A360 which would need to be addressed in order to prevent serious traffic congestion.

There are precious few BOAT's available that are not subject to some form of TRO and these proposals are calling for the closure of some which have no impact on the Stonehenge site, therefore one can reasonably conclude that the Stonehenge proposals are being used as a smokescreen to close other BOAT's and thus reduce the LEGAL access that motorised users currently have and the County Council are legally bound to maintain. By reducing their status to footpath the County Council has no legal duties to maintain them. I sincerely believe that the closures as proposed would suffer a legal challenge in the high court that would ultimately result in a waste of public money and likely overturning of any decision to close the said arterial road and byways.

OBJECTION TO PROPOSED TRAFFIC REGULATION ORDERS By Wiltshire County Council., entitled

Stonehenge World Heritage Site, Parishes of Amesbury, Berwick St James, Durrington, Wilsford cum Lake, Winterbourne Stoke and Woodford Prohibition of Driving Order 2010 to all motor vehicles.

Now aged 72 years and living in the Midlands I make use of the network of BOATS described in the order to make my way several times a year by light motorcycle on an extended journey from the Midlands to the South Coast and back. If these TROs were to be invoked they would cause a considerable, and I believe unnecessary, loss of amenity to myself and others like me which is not warranted.

Looking at the legislation associated with TROs (RTA84 and DoE circular 2/93) I would question whether the proposed actions are either necessary or whether the required tests have been carried out in an appropriate manner; or do they simply reflect a particular 'purist' standpoint from within the heritage lobby that reflects one extreme view rather than that of the general public in our relationship to the Henge?

With regard to the byway from Larkhall south across the A344 and A 303:

I specifically choose this route because it leads directly to Stonehenge which is part of my heritage and never fails to give me a thrill as I deliberately approach it along this old byway rather than by using one of the busy A roads. I wrote some years ago in a journal article (and long before this consultation) when describing this area 'I love coming towards Stonehenge from the North, it just comes up out of the ground as you ride towards it, the busy A344 remains out of view and one can retain the illusion until the last moment that it is just you, the Henge and our ancestors' and to remove this approach would be to decrease the range of aesthetic opportunities for people wishing to experiencing the site; not enhance it.

This route with its wide, yet firm, unmetalled surface is unobtrusive and fits well into the landscape: its existence as an ancient trackway leading to the Henge is entirely within the character of the site.

A few, I suspect knowledgeable local people, visiting may park on it for a short period to view the Stones, but this could easily be ameliorated by making it a No Parking Zone. Nor does the byway pose any kind of safety issue being straight and open with usage well within its capacity: this byway has no intrinsic danger associated with it what so ever.

By way of contrast the A roads I would of necessity be forced to take as a visitor to the Henge should the byway from Larkhall be closed to me, would pose a serious escalation in risk for a light motorcyclist amongst heavy lorries and fast moving high density traffic: the proposals suggested here would actually increase the danger of an accident.

With regard to the Byways to the South of the A303:

I use all of these on my journey; directly from the Henge towards the A360 when traveling south and, as a variation, on my return from Lake to the A303 when traveling northward.

As these are away from the Henge and to all intents and purposes out of sight of the visitor I can see no reason within the legislation pertaining to TROs to include them in the Wiltshire County Council proposal.

Now that the proposal to bury the A 303 in a tunnel has been scrapped, their intrusion by comparison to this great arterial road is completely insignificant. If anything, being ancient tracks leading to the Henge, they add to the natural fabric of the World Heritage Site: and they pose no danger to any kind of traffic using them.

They are well founded and in my observation over many years capable of carrying the traffic of the area, as self evidently they have not required repair.

Neither am I aware of the necessity for any management measures in the past, or in the absence of any evidence to the contrary, that the legitimate vehicular traffic associated with BOATS should, or could, be considered 'inappropriate'.

For the above objective observations and reasons I object to the TROs proposed by Wiltshire County Council.

Should this and other objections not be upheld then I would expect the legitimate way forward to be a Public Inquiry.

I am writing to you to formally object to plans for a TRO to be placed on the byway known as the West Track (Drove road) near the Stonehenge monument in Wiltshire, which will prohibit vehicular access to this area.

I use this byway to park my vehicle on when I visit Stonehenge and the surrounding areas outside of the English Heritage opening hours. My purpose for visiting the area is religious as I am a practising Pagan. The TRO will stop me from being able to access this area outside of normal opening times and during the open managed access events, where no vehicle parking (except on the summer solstice) is provided by English Heritage.

I have to drive from Mid Devon to attend these events, and need the drave road to park on in readiness for waiting for the dawn for ritual purposes since there is no other alternative parking or public transport for the times of day I attend. Refusal of access for my vehicle on this byway will prohibit me from attending these religious ceremonies and therefore infringes on my human rights to celebrate my faith freely at monument of specific religious significance. Currently there is no where else to park and without the drove road acess to the area outside of English Heritages official car park opening times will make this an impossible event.

I would like to know what provisions you will make for me and many people like me to be able to still continue to visit this area freely as you are in effect making it impossible for people to gather close by to the monument without English Heritage's involvement. Vehicular access is needed as there is no provision for public transport during the night or early hours of the morning which would make it difficult to access the dawn ceremonies. Also, without vehicles many people who are unable to make a mile long walk would be denied access since they need their vehicles to transport their ritual items and clothing and rest in after the ceremonies and rituals before safely moving onward.

Also this track is popular with dog walkers and bird watchers who will have their access denied to their

People have been using this track to rest upon with vehicles for many many years now, who come from all over the world to take part in the religious ceremonies and rituals carried out there by the Pagan and druid community, of which I am a member. I have met many people over the years who have travelled specifically thousands of miles to attend a ceremony with avehicle, and a TRO on the track will deny the global pagan community from being able to continue to take part in such ceremonies. Many make this pilgrimage here year after year for the 4 open managed access events, and often visit to contemplate the monument out of hours as per their beliefs. The west track/drove is a crucial area for the pagan and druid community to safely congregate before the ceremonies and rituals, allowing those with disabilities and mobility issues safe and tolerable access to the area in keeping with their human rights to freely practice their religious beliefs.

I urge you to reconsider your plans for a blanket TRO prohibiting vehicles on this small piece of land and to seriously consider the effects on the denial of human rights on religious grounds of those who use it.

http://www.bailii.org/ew/cases/EWHC/Admin/2009/1425.html and I wish to strongly Object on my own behalf citing the above precedent, and make representation by stating my own personal reasons for Objecting to permanent prohibition of parking on all BOATS in the WHS Stonehenge. The main Objection stems from the lack of disabled access, transport and facilities available during out of normal visiting hours during managed open access days and times specified and agreed with English Heritage for the purposes of sacred and holy ceremonial rituals.

As I am the Archdruidess of the Phoenix Order of Druids and Elder of Sacred Groves South I am concerned with the practicalities of access with the said application, many of our members and friends that attend stonehenge to celebrate on the open access days are registered disabled i cannot see that there has been any provision made for disabled access in the planning application.

Please note the specific H&S and Cultural reasons which I set out below, reserving the right to add or amend other reasons at any subsequent hearings or inspections:

H&S NEEDS EXAMPLE

To rest/take refreshment for a reasonable period of hours after travelling from Devon to Wiltshire in order to prepare for the dawn ceremonies.

To rest/take refreshment for a reasonable period of hours after the dawn ceremonies prior to preparing to drive home from [Wiltshire to Devon]

Disability access to transport, toilet facilities, etc during the hours of darkness from the Visitor Centre to the Stones and back.

CULTURAL NEEDS EXAMPLE

To exercise my rights under the Human Rights Act and its subsequent amendments to congregate in a form of worship, sacred ceremony, gathering or ritual at certain arranged times of the year with those who share the same or similar belief path or religion.

To enable my practice as a druid and duties as an Archdruidess of PODand Elder of the Sacred Grove south to be performed at the temple of Stonehenge which is widely viewed as the significant pagan temple in the UK and in the same high esteem as a UK based Christian might view Westminster Abbey or Winchester Cathedral.

Dear Kate Davey.

I am writing to you to formally object to plans for a TRO to be placed on the byway known as the West Track (Drove road) near the Stonehenge monument in Wiltshire, which will prohibit vehicular access to this area.

I use this byway to park my vehicle on when I visit Stonehenge and the surrounding areas outside of the English Heritage opening hours. My purpose for visiting the area is religious as I am a practising Pagan. The TRO will stop me from being able to access this area outside of normal opening times and during the open managed access events, where no vehicle parking (except on the summer solstice) is provided by English Heritage.

I have to drive from West Dorset to attend these events, and need the drove road to park on in readiness for waiting for the dawn for ritual purposes since there is no other alternative parking or public transport for the times of day I attend. Refusal of access for my vehicle on this byway will prohibit me from attending these religious ceremonies and therefore infringes on my human rights to celebrate my faith freely at monument of specific religious significance. Currently there is no where else to park and without the drove road access to the area outside of English Heritages official car park opening times will make this an impossible event.

I would like to know what provisions you will make for me and many people like me to be able to still continue to visit this area freely as you are in effect making it impossible for people to gather close by to the monument without English Heritage's involvement. Vehicular access is needed as there is no provision for public transport during the night or early hours of the morning which would make it difficult to access the dawn ceremonies. Also, without vehicles many people who are unable to make a mile long walk would be denied access since they need their vehicles to transport their ritual items and clothing and rest in after the ceremonies and rituals before safely moving onward. Also this track is popular with dog walkers and bird watchers who will have their access denied to their pursuits.

People have been using this track to rest upon with vehicles for many many years now, who come from all over the world to take part in the religious ceremonies and rituals carried out there by the Pagan and druid community, of which I am a member. I have met many people over the years who have travelled specifically thousands of miles to attend a ceremony with avehicle, and a TRO on the track will deny the global pagan community from being able to continue to take part in such ceremonies. Many make this pilgrimage here year after year for the 4 open managed access events, and often visit to contemplate the monument out of hours as per their beliefs. The west track/drove is a crucial area for the pagan and druid community to safely congregate before the ceremonies and rituals, allowing those with disabilities and mobility issues safe and tolerable access to the area in keeping with their human rights to freely practice their religious beliefs.

I urge you to reconsider your plans for a blanket TRO prohibiting vehicles on this small piece of land and to seriously consider the effects on the denial of human rights on religious grounds of those who use it.

Your Comments:

I wish to formally OBJECT to the above proposal.

I objected to the original proposal on the 6th November last year, but it seems that as these objections have not been passed along I am required to object again if I wish my opinion to count.

I understand the need to improve and maintain Stonehenge and the visitor centre facilities, but it seems to me that the TROs on so many surrounding byways have little or no relevance to this work. The impression I get is that the ban on MPV use of these byways is being pushed through regardless of any opinion to the contrary; the sign posts marking the byway were removed months ago giving the impression to anyone unfamiliar that these lanes are already closed. Of those that I am aware of that have complained to the original proposal it seems that only those who lived a distance from the site received any kind of confirmation or invitation to the meeting on the 20th January and despite all my efforts I couldn that find any reference to indicate where this public meeting might have been held.

While the A303 open and so close to the site, the volume of traffic using the byways has to have a negligible impact on the site. Reading the original objections and the recent proposal the plan

would appear to be to accommodate all the original objections apart from those placed by recreational MPV users of these byways. Do we not have a right to use these byways in a legal and reasonable fashion?

BOATs Bewick St., James 11, Wilsford Cum Lake 1, Amesbury 11, Wilsford Cum Lake 2, Woodford 16, South of the A303.

The proposal includes the closure of byways that are significantly beyond the area around Stonehenge, including byways that stretch south of the A303, a major route that in all likelihood would be widen in the future. I fail to see how the continued use of these routes would impact on the improvements to the visitors centre, which would be accessed by a new route along the old A344. The A303 will totally mask any use of the byways south of the sight both audibly and visually.

Responsible and sustainable access to our byway network is a legal right. The Council has a legal requirement to protect and preserve access rights of all users, including MPV users. Favoring one group of users over another is illegal and immoral.

This proposal might have had more support if there had been alternatives suggested, but a blanket TRO on such a large number of routes without any attempt to find a compromise and indeed what appears to be every attempt to find any way to make it actually happen is just not right!
