<p>We want to hire the open blue bus to run it as a young peoples drop in for 2 hours each Friday night in school term time on the lower sainsburys car park. We have a team of volunteers to run the sessions and have the support of the local police & sainsburys. The bus includes a kitchen area with café style tables, an electrical supply, heating, play stations and wii, board games and chat. The kitchen is used to provide hot chocolate drinks. The benefits to the community include: enabling young people to have somewhere warm and dry to meet and chat instead of being out on the street, volunteers to talk to, up to date games to play and a place to make new friends.</p>

The Calne Partnership of churches provides a team of volunteers (including 3 schools workers) to man the bus so that it is a safe and interesting environment for the young people. "Reach Out" regularly provide a volunteer to do preventative work related to substance abuse. Parents have commented that "It is a safe place for my children that they enjoy, making friends." We believe that anti social behaviour is reduced and the police like the bus to be in Calne saying "It is a good place to meet good adult role models". A lot of vulnerable children use the facility, they develop peer to peer friendships which combats their fears of bullying. Vulnerable young adults also benefit as younger people have developed more care & respect for them instead of the usual mocking and ridiculing. They have asked about their health and have had conversations with them. Non users of the bus have commented that they feel safer when the bus is present.
