We have also spoken to Paul Binder - a bandmaster from one of the leading Marching Bands in the country - Romford Drum & Trumpet Corps. He confirmed that many bands have ceased due to the lack of quality training. Other bands had been set up but haven't had the professional training from a military background to make their band successful. Our local community is very supportive of the idea of a marching band to represent Wiltshire. We performed at Trowbridge Carnival to a crowd of 13,000 people and here is a comment from a member of public: "Congratulations on your excellent display at Trowbridge Carnival.
