How did you discover there was a need for your project and how will your project benefit your local community?

In 2009, a group of people concerned about the environmental issues and keen to foster a more sustainable wayof life in Pewsey and its surrounding area came together to encourage local action. The group is growing monthly - from 6 members in September, we now have 36 members and this has predominantly been achieved through one event and word of mouth. Some of the activites planned will establish the need for further sub-groups' projects. The group will provide friendly practical activities for people to take part in, which will raise their awareness of environmental issues and the benefits of a sustainable lifestyle in a subtle, practical and inclusive way. Ultimately this will mean more people adopting environmentally friendly practices in their everyday lives. Once people are encouraged to adopt more sustainable ways of living, it will benefit the local community by making the area a more 'beautiful and pleasant natural environment with strong community spirit and plenty of local involvement' as expressed in the area plan. The ultimate aim and benefit is to make a contribution to the reduction locally of our impact on the world's resources.

PEAT is managed by a core group of 4 officers, 6 sub-group leaders and up to 3 co-opted members. Currently this includes two members of Pewsey Parish Council and someone with fundraising expertise. The sub-groups cover six areas of interest - food, natural world, energy, transport, waste and water. Each group's activities are aimed at encouraging people to think about their practices in relation to the group's theme. PEAT has set up a website, which will feature advice on different ways to reduce your carbon footprint. PEAT's first event was a film show attended by over 25 people, which highlighted Cuba's move to local food production. Summer activities being planned are a bread making morning, conservation work in the Scotchel, a nature walk, composting demonstrations, a home energy survey, and trialling lift sharing. Later events include an apple day and mapping renewable energy installations across the area. The group has already signed up to the 10:10 initiative.
