Important: Please do not type/write in paragraphs – This section is limited to 800 characters only (inclusive of spaces)	The Tidworth Joint Strategic Needs Assessment notes that Tidworth area has the second highest level of domestic abuse in Wiltshire and the second lowest score for child wellbeing. There is limited provision in Wiltshire for children aged 5-11 who have witnessed domestic violence. Domestic violence has a powerful, longer term impact on children's ability to develop and sustain adult healthy relationships and can have a life-long and profound effect on their own sense of self worth. Deployment to war, with its long separations, can put serious stress on military families. Studies have shown that recurrent deployments heighten the likelihood of combat trauma, which, in turn, increases the risk of domestic violence. We'll give children support to cope and develop strategies for resilience.

(Limited to a 1000 characters) Splitz (based in Trowbridge) has a long history of working with children who have been exposed to or witnessed domestic violence. We already work with children aged 11-17 and their parents across Wiltshire and will use this model in our new project. We have strong links with the Army Welfare Service and they're keen for us to develop this scheme. We know of no other organisations doing this type of work. The young people will be able to identify, come to terms with and overcome their personal difficulties; they will have an increased understanding of the causes of domestic abuse and its impact on them and their families, and its impact on their lives will be reduced. We hope the project will give us an opportunity to see what works and what we need to be changed so that we can then deliver a programme for this age group across Wiltshire.
