Supporting people through difficult periods of change when relationships may struggle to survive is at the heart of the counselling that we provide. Relate Mid Wiltshire has experienced a steep rise in the complexity of case work over the last two years. We expect that the austerity of the next few years will be particularly difficult for families and will increase the need for our services. Last year we supported 923 adults through relationship counselling and sex therapy, of which 118 were residents of Trowbridge. A significant feature of our case work is supporting victims of domestic abuse. Children and young people often feel the impact of difficulties in an adult relationship. In response we have also developed a family counselling complemented by an extensive young people's counselling service. Last year 83 families were supported, of which 9 were from Trowbridge. We provided counselling support to 931 children through our services in schools and our independent Talk Zone counselling service, the latter provided counselling to 23 residents from the town. This year we have seen a 60% increase in demand for our Talk Zone service, as a result of referrals from parents, local GPs and CAMHS. Encouraging healthy relationships through our supportive workshops is a growing service. We provide a course which last year helped 93 parents, of which 20 were Trowbridge residents, to understand their children's response to their divorce/separation. We also currently support carers and frontline school staff through our training service. People contact us in real distress, we can turn that round by listening to them and helping them find their own solutions. Recently a parent on a Parenting Information Programme fed back "I am now more aware of the impact that high conflict can have on children"; a mother in relationship counselling who reflected that: "it has changed my views on being a bad parent and in understanding the common difficulties of being a step family" and the young child who states "now I can relax and be a kid". The new premises will provide a welcoming and safe environment for children and families, ensure that we can meet the needs of people with disabilities, and offer a professional training and meeting facility in support of our services and the local community.

All our service provision is subject to client feedback, evaluation and regular monitoring. Reports are made to Trustees on a quarterly basis and major funders as required. As an organisation which has achieved PQASSO Level 2 we have recently reviewed all our monitoring and quality assurance processes.

The children will gain skills in cookery, food preparation and hygiene, working safely and sharing and appraising their creations. The children will follow the process of growing fruit and vegetables, turning them into a meal and how we can recycle peelings and packaging. We want to encourage the enjoyment of eating together and building social skills which may not always be part of home life. The practical element of cooking is a useful tool for teaching those children with special needs and we aim to use this regularly to benefit such children in our school. The school PTA will enjoy using the new facilities for our many events. We hold several each year and as well as fundraising we also aim to enhance the school community and wider community socially. The new kitchen area will provide attractive facilities for the local community as a venue for

outside events. We have a close link with the village and it is our intention to strengthen this through future projects involving world foods, foods through the ages and larger community celebrations.

The roof of the Church Hall needs to be completely replaced after failing during recent periods of stormy weather. Water is getting inside and is threatening the integrity of the underlying roofing structure, potentially causing a threat of collapse. Similar problems have been experienced in recent winters and a structural inspection and consultation with experts in early January have declared it beyond economic repair. Temporary patching is possible for a temporary period but we have been advised that the frequency of these periods will only increase - unless the roof is replaced permanently as it is well past its normal life - expectancy.
