We plan to extend the village hall kitchen to give room for a fridge, dishwasher and extra cooking facilities. These facilities are more and more frequently requested by our regular users. The management committee are receiving many requests from organisations who want to hold events where people want to cook on the premises rather than just heat up pre-prepared food, which is all that can be carried out in the current kitchen.

Urchfont Village Hall was extended about 5 years ago, but the kitchen has not been updated for about 20 years. There is an increasing demand for up to date facilities such as a fridge and dishwasher which will not fit into the existing kitchen. The friends of St. Michaels weekly 'Coffee and Cake' mornings are typical of users who would make use of these facilities. Since the closure of Urchfont Manor as an adult education college, the village hall has become the only venue in the area which can host dinners or parties for up to 90 people and consequently is more and more in demand. However the current kitchen is only suitable for warming pre-prepared meals. It needs extending and completely refitting to make it fit for the purpose of cooking meals for large parties. The events that have recently taken place which would benefit from these new facilities include the annual community bus drivers' dinner, charity dinner dance, sports club dinners, private parties, and wakes.

Some of the demand already exists, and this will help us to retain some of current users. We will be able to advertise the new facility and the booking secretary will be able to measure any extra bookings requiring these new appliances etc.

The project should be completed from this grant. Hopefully the village hall revenue will also increase once the work is complete.

Our proposal is to create a drop-in centre for students to access agencies that give support to the team 'around the child'. It will provide space for small meetings and individual sessions and could be used by any appropriate group. Such groups could include the school counsellor (currently in school two days a week), sexual health clinic, school nurse or Education Welfare Officer. The aim of the project is to improve our school community by building extra capacity to remove barriers to mostly vulnerable young people to help them access health, education and economic well-being.

The project is funded primarily by a grant of Â£40K from Wiltshire Council Extended Services and it has all been committed for the capital build of the Drop In Centre. The school is able to match fund the provision of the furniture and equipment from Pathfinder funds which originated from the Extended Services project. The school is not able to provide any General Annual Grant funds to this project because these are restricted funds and the project sits outside the school core offer.

Within the school catchment area there are three defined pockets of deprivation with vulnerable families where parents have low literacy skills or who abuse alcohol; this is significantly more common than the Wiltshire average. Young people from an area of

deprivation are more prone to a higher incidence of smoking, offending and teenage pregnancy. The health profile of Devizes School indicates that 13.6% of children live in poverty (Wiltshire figure 11.6%) and 10.5% of students are eligible for free school meals (Wiltshire average 6.4%). Academically the number of students starting Devizes School in Year 7 who have not achieved Level 4 (expectation for end of Key Stage 2) in English & Maths is increasing; the current Year 7 has 31% of students below Level 4. Students tell us, through consultation, that they will benefit because it gives access to services on the school site which are either not available or are difficult for them to access elsewhere in the immediate area. They are less likely to use local services embedded in their rural communities because such services are less likely to be anonymous so confidence in privacy may be reduced. By providing services in school we believe students will be more likely to access them and the level of confidence in such services will increase. This means that the services will be better used and have more impact. External agencies will benefit from this provision because they will have a suitable environment in which to carry out their work and they can be confident that security and confidentiality will be maintained. The agencies will have more ready access to young people and potentially families that may be considered "hard to reach". Finally, pastoral support services within the school will benefit because there will be a bespoke area available to deliver advice and assistance to young people. If young people have help in dealing with problems they are more likely to achieve academically and develop into good citizens, so the whole of the community will benefit.

**14. How will you monitor this?**

The project will be monitored by the number of referrals made by external agencies and evaluation of the work they do. The aim of the project is to reduce risk to young people and to increase their resilience. Whilst it is difficult to provide empirical evidence of the outcomes, because of the individual nature of students' needs, the extent to which the young people have used the services will be monitored. We will ask the young people to give us their views of the project and both the school and school nurse will monitor the provision through the NHS South West Young People Friendly Services Quality Assurance Criteria.

**15. If your project will continue after the Wiltshire Council funding runs out, how will you continue to fund it?**

The grant application is to help meet a shortfall in set up costs only. All running costs will be met by the school once the Centre is established. There is a possibility that the Centre could be let out during weekends and school holidays which could bring in some income.
