The D&DAD was formed in 1981 with the aim of making the whole Town disabled friendly with dropped kerbs, accessible shops etc. In 1984 a disused School Kitchen became available and was altered and extended to form the Nursteed Centre providing a meeting hall, kitchen, toilets specially designed for the disabled. The Nursteed Centre, now called the Nursteed Community Centre, provides a safe, accessible, affordable place for disabled people in the area. The Centre is used by 16 groups of people with various disabilities with approximately 250 disabled people using the Centre on a regular basis. The Centre allows equality by providing a meeting place for all people irrespective of disabilities. This project will bring the electrical system to modern safe standard whilst reducing some energy cost and also providing improved lighting in the Main Hall.

The D&DAD Management Committee includes a building surveyor and other business people with relevant experience of projects of this nature. The technical success of this project will be demonstrated by electrical tests and certificates on completion. The visual success of the new wall lights will be apparent with the improved lighting. The energy saving with the new LED floodlights will be shown by reduced electrical bills.

**6. Project summary:**

We wish to apply for funding to purchase a range of specialist equipment to enable us to open an Assistive Technology Resource Centre and run Assistive Technology workshops and drop-in sessions for people with sight-loss in Devizes over a 12 month period. The service would be free of charge and run by a trained Sight Advisor, supported by Volunteers. The sessions would teach visually impaired people how to use computers and assistive technology to help them manage many aspects of their lives, which sighted people may take for granted, such as managing their finances, look for work/voluntary roles, write a C.V, use the internet, shop online and communicate with friends. The equipment will be based at our Head Office in Devizes, in the heart of Wiltshire.

We will run 48 sessions at our offices in Devizes where visually impaired people can access a variety of equipment that they may not otherwise be able to. Each session will be run by a trained Sight Advisor and supported by Volunteers. We anticipate that 240 people of all ages, with sight-loss will benefit from these sessions (5 people per session), including those of working age, people currently in education and older people, who, in addition to their sight loss, may be financially and socially disadvantaged. People attending the sessions will learn how to use assistive technology to improve and manage many parts of their lives, e.g. to manage their finances, study, write a C.V, access written documents, use the internet and look for and apply for employment. Assistive Technology plays a vital role in breaking down barriers for individuals who have sight loss to fully participate in society. When a person loses their sight, they may not be able to use or afford a computer anymore and this can lead to many problems, including maintaining their job, education, confidence and independence. Our project will give those with sight loss: improved access to specialist equipment which they may not have been aware of, or able to afford, improved access to information and advice in relation to their sight loss, reduced isolation, improved mental health and the opportunity to maintain / regain their independence, at work, home and in education. By coming to our sessions, users will be more active, less isolated, more confident and have higher self-esteem. As a result, the quality of life will be improved for residents of Devizes and local communities will be stronger, more active and inclusive. Following the success of our Assistive Technology pilot schemes, we have identified a great need for this project. We are also aware from individual research carried out by the RNIB, The Thomas Pocklington Trust, via the Vision 2020 strategy and discussions with the Wiltshire County Council Hearing and Vision Team, that people affected by sight loss can be at a serious disadvantage to sighted people. Our project aims to address this and ensure that visually impaired people have equal chances in life. There are currently 15,350 people living with sight loss in

Wiltshire. By 2020 this is set to rise to 19,540 (RNIB figures 2014). There is currently no other project of this kind in Wiltshire, hence the need for our project.

**14. How will you monitor this?**

At the initial meeting between Service User and Sight Advisor, we will give Service-Users a Questionnaire, which will include questions about their: Emotional and Physical Wellbeing, Social Inclusion, Independence, Knowledge of Sight-loss Services/equipment and employment status/financial health. For each answer we will use a scale of 1-5 (with 1 being Poor and 5 being Good). After 12 months, we will give the attendees the same questionnaire. We will compare the final results with the initial results to identify improvements in scores and therefore the positive impact of the project. We will also use letters of feedback, focus groups, conversations and interviews to collect evidence to prove that the course has made a tangible difference to their lives.

The equipment will be a lasting legacy for the visually impaired people of Devizes and Wiltshire. We will continue to fund the support sessions using income from other sources, including; charitable trusts, private donations and community fundraising.
