ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF WILTSHIRE (FOLKESTONE ROAD, HOLLOWS CLOSE AND SAXON ROAD, SALISBURY) (PROHIBITION OF DRIVING) ORDER 2014

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 3 and 4 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

- 1. The County of Wiltshire (Saxon Road, Salisbury) (Prohibition of Driving) Order 2007 is hereby revoked.
- 2. Save as provided in Article 3 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden use, or cause or permit to be used, any motor vehicle in such a way that it proceeds along the lengths of road specified in the Schedule to this Order Monday to Friday.
- 3. Nothing in Article 2 of this Order shall apply so as to prevent any person from using or causing or permitting any motor vehicle to proceed on the lengths of road referred to in the Schedule if the vehicle is being used:
 - (i) in the service of the Local Authority in pursuance of statutory powers or duties or in the services of the Police Authority, the Fire and Rescue Authority, or Ambulance Service;
 - (ii) in connection with any building operation, or demolition in or adjacent to the road, the removal of any obstruction to traffic in the road, the maintenance, improvement or reconstruction of the road, or the laying, erection, alteration or repair in or adjacent to the road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984;
 - (iii) to enable the vehicle to be loaded or unloaded while it is in actual use in connection with the repair or maintenance of the properties served by the road;
 - (iv) Being used for or in connection with the conveyance of persons to or from any residential premises situated on or adjacent to the road;
 - Being used for or in connection with the conveyance of goods or merchandise to or from any premises situated on or adjacent to the road;
 - (vi) Displaying a valid permit issued by Wiltshire Council relating to the lengths of road specified in the schedule to this Order;
 - (vii) A bus being used in the operation as a school bus service in connection with Harnham Infant and Junior Schools;

- (viii) A taxi being used in the operation as a school service in connection with Harnham Infant and Junior Schools.
- 4. The Council of the County of Wiltshire is satisfied that for avoiding danger to persons or other traffic using the road to which the Order relates, it is requisite that Section 3(1) of the Act should not apply.
- 5. In this Order "Taxi" has the same meaning given by Regulation 4 of the Traffic Signs Regulations and General Directions 2002.
- 6. This Order shall come into operation on xxxxxx 2014 and may be cited as The County of Wiltshire (Folkestone Road, Hollow Close and Saxon Road, Salisbury) (Prohibition of Driving) Order 2014.

Hollow Close	The complete length
Saxon Road	From its junction with Parsonage Green to the southern end of the cul-de-sac



PERMIT DETAILS

Residents' Permits

These self-adhesive permits must be displayed whenever the vehicle is within the length of road controlled by the Order.

You are entitled to 1 permit for each vehicle registered at your address. You will need to provide proof of residence. This must be a Council Tax Demand, a current Utilities Bill, Tenancy Agreement or Official Rent Book showing your name and address.

Cost: £5 per permit.

Renewal: There is currently no charge for renewal of permits.

Visitors' Permits

These permits are laminated. They should be passed to your visitor if they are parking on the length of road subject to the Order and then collected from them when they leave. They should be displayed in a prominent position within the vehicle. Residents may purchase unlimited visitor permits. Permits must not be lent or sold to anyone else.

Cost: £5 per permit.

Renewal: £5 per permit.

Blue Badge Permits

These are for parents who are disabled or who have disabled children. You will need to provide proof that you have a blue badge and a letter from the school indicating that they approve the request.

Cost: £5 per permit.

Renewal: There is currently no charge for renewal of permits.
