Project Description:

To create a Remembrance Garden next to the churchyard at St James Church to provide a seating area looking out towards Piquet Hill giving a place for quiet reflection in this naturally beautiful valley.

We are creating a Remembrance Garden to provide a quiet outside space to sit for anyone visiting the St James Church and churchyard. It is open to everyone and should benefit not only local residents but also visitors to the area particularly those who have family and friends buried in the churchyard. It is hoped that the garden will provide a place of peace and comfort at a distressing time. We hope that the Remembrance Garden will enhance this naturally beautiful area providing a place to sit and reflect contributing to peoples spiritual well-being and mental health. The project aims to bring together the community. Any local resident may be buried in the churchyard. Following consultation with villagers who have loved ones buried in the churchyard the garden plan was drawn up.
