Calne Communities to determine a Shared Vision for their Neighbourhood

Over the last 2 years work has been taking place to revise the Calne Community Neighbourhood Plan to make it relevant for the coming years.

The plan is now in draft form and ready for consultation. This is an important document for our local communities in Calne Town and Calne Without Parish, as it helps us all develop a shared vision for the place in which we live and work, by influencing the planning priorities in the years to come.

The technical description of the current consultation work is the Regulation 14 Stage. This simply means that the plan is currently in draft and that responses to this consultation stage will help shape the final plan.

The consultation on the draft plan opens today [1 February] and lasts until midnight on Friday March 22nd.

Ed Jones, chair of the Neighbourhood Plan Steering Group said:

"I'd like to thank everyone who has taken the time to respond to our surveys over the last 2 years, what you told us has helped us create this revised Neighbourhood Plan.

While the Plan must work within National and Wiltshire policy, its success will depend upon it having the support of the local community. We can only achieve this if people help us again now by taking part in this consultation.

So please come and visit one of the events or look at the website and fill in the survey, letting us know what you think we've got right and what we still need to work on".

Calne Community Neighbourhood Plan

Summary of publicity for Regulation 14 Public Consultation (1/2/24 – 22/3/24)

Draft Plan - available along with the Design guide and all supporting documents online from the 1st February. Paper copies of the plan will be available in CTC offices, Calne library and at face to face events.

Promotional leaflet - c11,200 copies will be posted to residents and businesses in Calne and Calne Without from 5th February. Extra copies will be circulated in various locations around the plan area. The front cover will be used as a poster and put up in a number of locations.

Website – the Calne Community Neighbourhood Plan website (calnecommunityplan.com) will have a temporary home page for the survey, plan, design guide and all the supporting documents.

Press release - has been produced to publicise the consultation in local media.

Survey – an online survey will be live from the 1st February and paper copies will be available in the library and CTC offices.

Emails – emails will be sent to Councillors, interested parties e.g. local groups, schools etc. People will be encouraged to promote the completion of the survey with their contacts.
