70	<p><u>Welcome and Introductions</u></p> <p>The Chairman, Councillor Sven Hocking welcomed everyone to the joint themed meeting of the Salisbury Area Board and Salisbury City Council, to look at Climate Change in the City.</p>
71	<p><u>Apologies for Absence</u></p> <p>Apologies for absence had been received from:</p> <ul style="list-style-type: none"> • Station Manager Maggs – Dorset & Wiltshire Fire & Rescue
72	<p><u>Minutes</u></p> <p><u>Decision</u> The minutes of the meeting held on 26th September 2019 were agreed as a correct record and signed by the Chairman.</p>
73	<p><u>Declarations of Interest</u></p> <p>Cllr Atiqul Hoque declared an interest in Item 10 – Community Funding, Health & Wellbeing application from the Muslim Association, as he was the Treasurer.</p> <p>He clarified that the applicant was not the Muslim Association itself, but was acting as a facilitator to support the project. He did not take part in the vote for that application.</p>
74	<p><u>Chairman's Updates</u></p> <p><u>Bus Shelters</u> Since the last meeting the matter had been considered at CATG (report included with Item 9). There was a recommendation for funding to make modifications to the shelters to alleviate the amount of rain that currently came through the gap at the top.</p> <p>Comment: Mr Brown noted his dissatisfaction with the shelters which he felt were of poor design and a waste of money. He requested that the shelters were replaced with an improved design to provide adequate shelter.</p> <p><u>Household Recycling Centre (HRC)</u> Due to roadworks being undertaken on Stephenson Road between 18th October and 18th November, Salisbury HRC would be closed Saturday 9th and Sunday 10th November as there would be no vehicular access permitted.</p> <p>However, the site would open on Thursday 7th and Friday 8th November instead.</p>

	<p>All HRCs moved to their winter opening times from 1 November to 1 April: 10am to 4pm, and the Salisbury site is now normally closed on Thursdays and Fridays. The HRC in Amesbury is closed on a Tuesday and Wednesday.</p> <p><u>Salisbury Reds</u> Following a request at the last Board meeting, the Chairman had contacted Salisbury Reds to request financial support for bus stop replacements who had responded positively, and further communication was planned with them to take this forward.</p>
75	<p><u>Information items</u></p> <p>There had been a change to the previous format of Partner Updates. Partners were now invited to provide written updates or online links which were included in the agenda pack for information.</p> <p>The Board noted the information available in the agenda pack and circulated at the meeting.</p> <ul style="list-style-type: none"> • Salisbury City Council • Salisbury BID • Community Messaging • Healthwatch Wiltshire • Clinical Commissioning Group • Wiltshire Council • Police – attached to minutes
76	<p><u>Updates - Maltings and Central Car park, Central Area Framework, & High Street Fund</u></p> <p>Victoria Moloney, Head of South Wilts Economic Recovery gave updates to the Board:</p> <p><u>Future High Street Fund</u> An Economist had been appointed to help with the business case to support the bid.</p> <p>Central Government had moved the timescales and the full business case is now expected to be submitted around June 2020.</p> <p><u>Central Area Framework</u> The Second consultation would start in January 2020</p> <p><u>Maltings & Central Car park</u> Phase 1 demolition work had begun on site. Progress report and update going to Wiltshire Councils full Council meeting on the 26th November.</p>

	<p>It was noted that phase 1 is privately funded</p> <p><u>Government Community Governance Review – Update</u> Cllr Richard Clewer – Deputy Leader – Chairman of the Electoral Review Committee gave an update. A copy of the slides from his presentation are attached to these minutes. A decision is due to be made by Central Government in January 2020</p> <p>It was noted that Salisbury City Council, relevant Parish Councils and a number of residents in the West Harnham area would be consulted and that the recommendations will be approved by Central Government in January 2020.</p> <p>Information is also available Online</p>
77	<p><u>Climate Change</u></p> <p>The Chairman thanked everyone for coming for this themed event, and handed over to Councillor Richard Clewer, Deputy Leader of Wiltshire Council, for a presentation on Wiltshire Councils commitments and progress on tackling Climate Change.</p> <p><u>Key points of the presentation were: -</u></p> <p>In February 2019 Wiltshire Council resolved to:</p> <ul style="list-style-type: none"> • Acknowledge that there is a climate emergency • Seek to make the county of Wiltshire carbon neutral by 2030 • Establish carbon baseline and renewables baseline <p>Wiltshire Council Cabinet committed to make Wiltshire Council carbon neutral by 2030.</p> <p>A Global Warming and Climate Emergency task group has been established to consider: Renewable energy generation, energy use and efficiency in the following areas: -</p> <ul style="list-style-type: none"> • Planning • Transport and air quality • Waste • Land use • Business and industry • Carbon baseline and renewable energy baseline <p>Residents requested to consider a Green Pledge and act on some of the following:</p> <ul style="list-style-type: none"> • Leave the car at home and walk more

- Take shorter showers and turn off taps when brushing teeth
- Try and use as little single-use plastic as possible
- Use a reusable cup
- Use bags for life
- Recycle as much as you can
- Turn off lights when not using them
- Install a smart meter to help you manage energy use

The Chairman then introduced Cllr Jeremy Nettle, Leader of Salisbury City Council (SCC) gave a presentation on what SCC was doing to tackle Climate Change.

Key Points were: -

Cllr Nettle thanked all who had been involved with the Eco Fair prior to the Area Board and recognised those local groups supporting to include Salisbury Transition City, Salisbury LETS, Wiltshire Wildlife Trust, Co-Cars, Extinction Rebellion, Salisbury Area Greenspace Partnership, Salisbury Community Energy, The Pantry Partnership, Salisbury Repair Café, Wiltshire Warm & Safe, Wessex Water, Community Fridge and South Wilts Biodiversity Group.

- SCC declared a Climate Change Emergency at Full Council on 17 June 2019, budgeted £56,000 funding in support and resolved to:-
 - ✓ Work to make Salisbury as carbon neutral as possible by 2030
 - ✓ Work with partners to achieve “clean air” in Salisbury by 2022, in particular by taking action to reduce vehicle emissions, supporting public transport, cycling and walking
 - ✓ Replace or convert all council-owned or operated vehicles to electric powered vehicles as soon as is practically possible
 - ✓ Encourage the rapid phasing out of diesel-powered buses in the City by bus operators and their replacement by cleaner or non-polluting alternatives
 - ✓ Increase wherever possible the extent of pedestrianised areas within the City centre
 - ✓ Undertake a comprehensive programme of improvement of the insulation of all council-owned property,
 - ✓ Ensure that such property shall be fitted with solar panels wherever possible
 - ✓ Do everything within its power to ensure that such standards should also apply to any new buildings which are permitted within the City

- Use of mulch on flower beds to reduce watering frequencies
- Policy statement restricting the use of glyphosate weed killer
- Use of LED energy efficient lighting in Shopmobility refurbishment
- Paper recycling
- Introduction of plants in the office to improve air quality
- Home/flexible working
- IT systems in place to reduce paper usage
- Use upcycled materials for our art groups
- Recycling point for ink cartridges and phones
- Use social media whenever we can instead of printing leaflets
- All heating thermostatically controlled
- Updated IT suite using recycled equipment from Guildhall
- Motion sensitive lighting in Guildhall

A copy of the presentation slides are attached for information.

The Chairman then asked those present to work in groups in a round table exercise to come up with their top 5 climate change projects for Salisbury, which could be delivered over the next 12 to 18 months.

The project felt to be the most important from each table included: -

- Education - ask whole communities change their behaviour by educating the children.
- Food - more meat free options in schools.
- Transport – reduce parking capacity in the city centre and increase use of park and ride, improve the train station frontage, ban idling vehicles in the City centre especially trucks and buses, change / better bus routes to go where buses are needed, more car free days,
- Development - New planning applications should not be granted unless they include solar panels, grey water tanks, and are south facing to optimize solar energy.
- Air quality - pedestrianisation of large areas of the City
- More greenspace and use of electric maintenance vehicles.
- Tree planting
- Youth - Support for the strikes and the global impact and youth to be included in the conversation, public signage around climate change.
- Cycling - Improved cycle routes with better signage
- Food Wastage – open a “community fridge”
- Promote solar renewable energy and electric cars through a bulk buying scheme.

	<p>It was noted that: -</p> <p>Wiltshire Council was engaging with other local authorities.</p> <p>The public proposals would tell Central Government what the people were expecting</p> <p>The Chairman thanked all for coming, and noted that the lists of ideas would be collected after the meeting and collated into a report which would inform the direction of work moving forward and that the public would be updated of progress generally.</p>
78	<p><u>Community Area Transport Group (CATG)</u></p> <p>The Board considered the recommendations from the CATG as detailed in the Report attached to the Agenda.</p> <p><u>Decision</u> The Salisbury Area Board approved the following CATG funding:</p> <ul style="list-style-type: none"> • Issue 6204, Fly tipping Gradidge Lane - £300 • Foliage removal to Footway outside Prebendal House - £800 • Issue 7070, Milford Mill Bridge Community Lorry Watch signs - £260 • Replacement bus shelter amendments - £2000
79	<p><u>Community Funding</u></p> <p>The Board considered the following funding requests:</p> <p><u>Community Area Grant Scheme</u></p> <p>The Board considered two bids to the Community Area Grant Scheme.</p> <p><u>Five Rivers Indoor Bowls Club – requested £784</u></p> <p><u>Decision</u> Five Rivers Indoor Bowls was awarded £784 towards the purchase of a defibrillator. <u>Reason</u> – <i>The application met the Community Area Grants Criteria 2019/20</i></p> <p><u>Salisbury Street Name Initiative – requested £17,000</u></p> <p>Cllr Hocking proposed to continue the repaint / repair / renew project started in 2018 noting the request amount was above the usual £5,000 limit and that Salisbury residents were very supportive.</p> <p><u>Decision</u> Salisbury Street Name Plates Initiative was awarded £17,000 towards</p>

street nameplate repair/renew initiative.

Reason – The application met the Community Area Grants Criteria 2019/20

Youth Grants

The Board considered two bids for funding from the Youth Activities Budget. Applications were considered by the Youth Panel on 18th October.

Salisbury Museum – requested £2250. The recommendation from the Youth Panel was to award £1500

Decision

Salisbury Museum was awarded £1500 of Youth Funding towards Stone Age Long Board Project.

Salisbury 2020 – requested £5000. The recommendation from the Youth Panel was to award the full amount.

Decision

Salisbury 2020 was awarded £5000 of Youth funding towards the TechSTEM event.

Health & Wellbeing Funding

The Board considered three bids for funding from the Health & Wellbeing (HW) Fund. The HW Panel considered applications and made recommendations for funding on 15th October.

Salisbury Pride UK – requested £2000.

The recommendation from the HW Panel was to award £1000.

The motion to fund the project at the recommended amount of £1000 was made by Cllr Dalton. This was seconded by Cllr Rogers.

After discussion, Cllr Walsh requested an amendment to the motion, and asked that the Board award the original full request of £2000. This was accepted by Cllr Dalton, and seconded by Cllr Rogers.

The Board voted on the motion to award £2000. The motion failed.

Cllr Dean then moved the motion to award £1000, this was seconded by Cllr Brown.

The Board voted on the motion to award £1000.

80	<p><u>Close</u></p> <p>The Chairman thanked Salisbury City Council for hosting the meeting at the Guildhall, and noted that the next meeting of the Salisbury Area Board would be held on Thursday 23rd January 2020, 7.00pm at City Hall, Salisbury.</p>

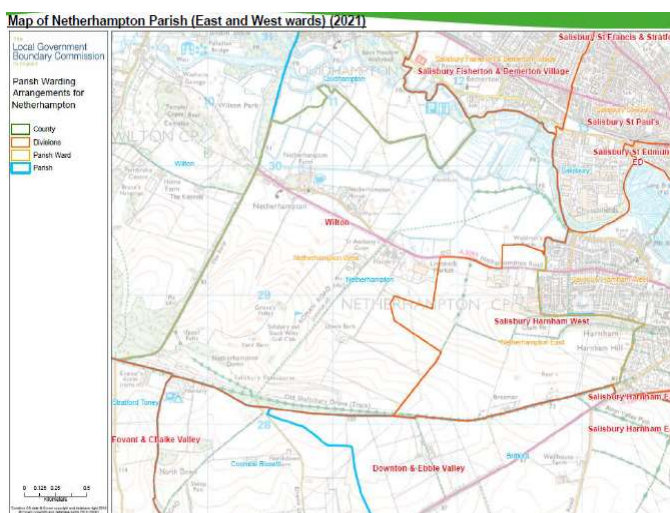

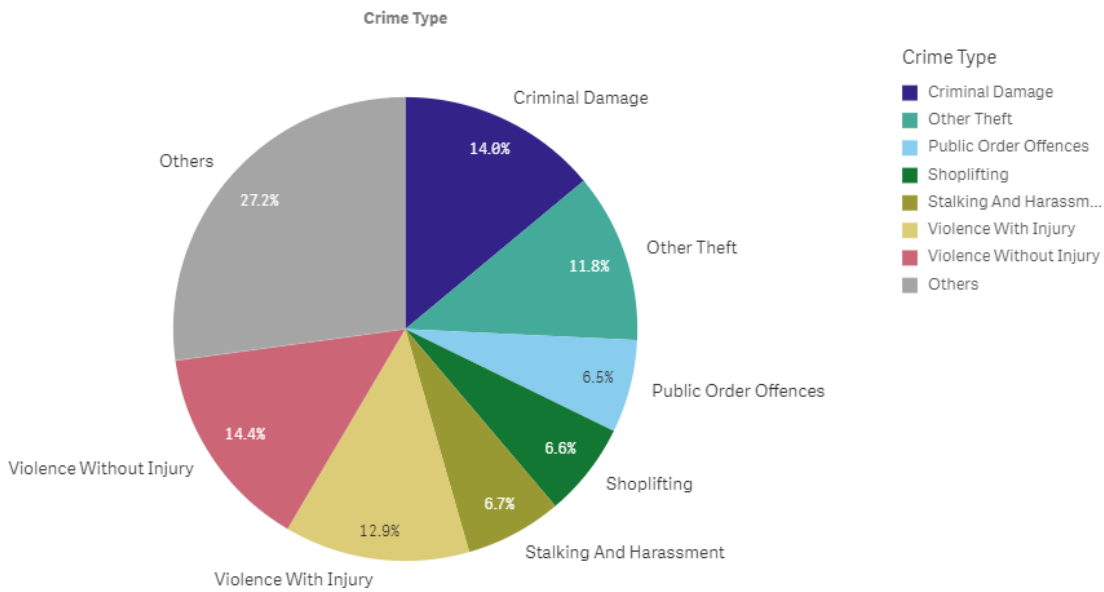

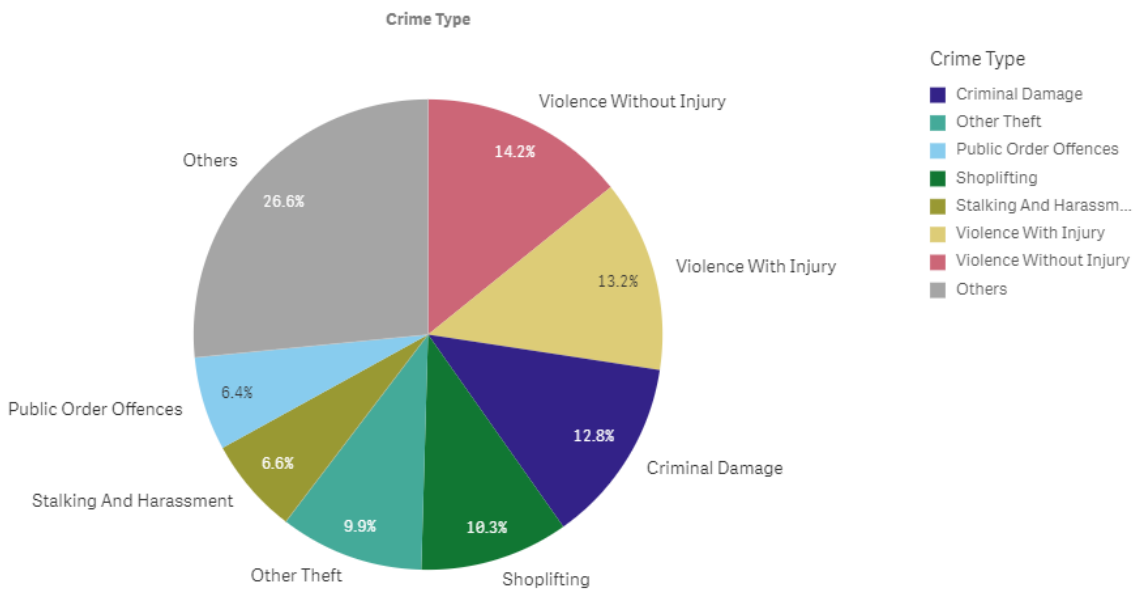

Force-wide

- Wiltshire Police has had an increase in the volume of recorded crime by 1% in the 12 months to September 19 and continues to have one of the lowest crime rates in the country.
- Our service delivery remains consistently good.
- In September, we received 8,312 999 calls which we answered within 6 seconds on average and 12,474 CRIB calls which we answered within 2 minutes 08 seconds on average.
- In September, we also attended 1,344 emergency incidents within 17 minutes and 00 seconds on average.
- Wiltshire Police has seen a 17% reduction in vehicle crime and 21 per cent in residential burglaries in the 12 months to September 2019.
- The Crime Survey of England & Wales recently ranked Wiltshire as one of the top forces (78.3%) nationally for public confidence. It covers the 12 months to March 2019. The publication can be found here: WWW.CRIMESURVEY.CO.UK

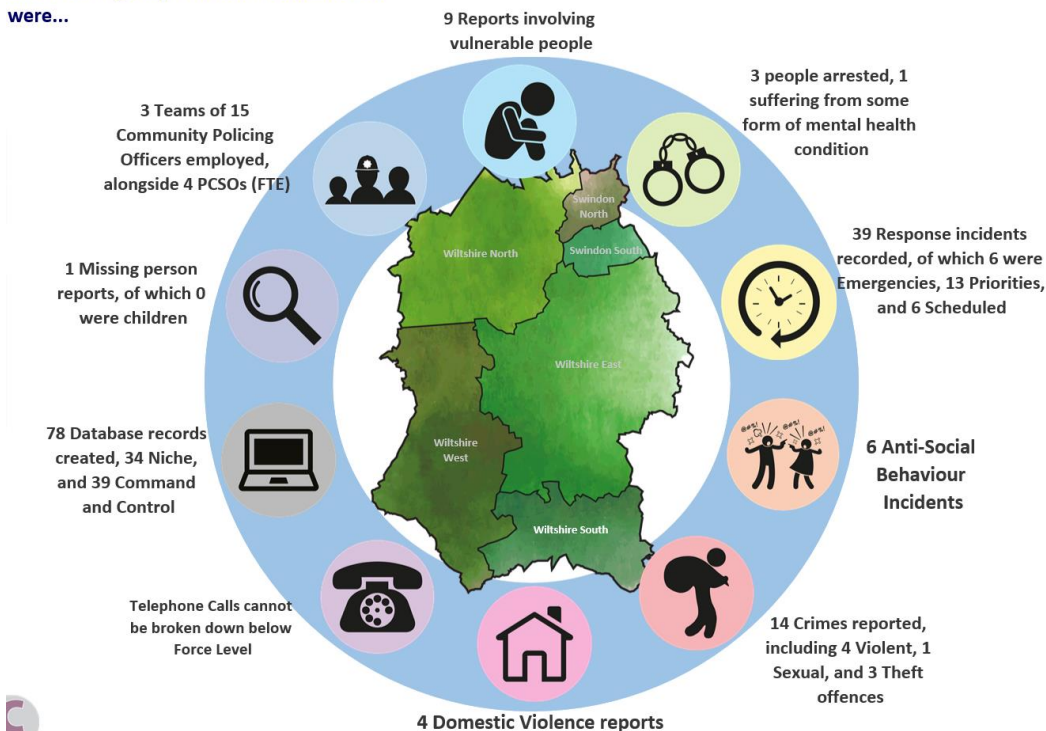

HIGH LEVEL CPT UPDATES:

- Downton Issues** - Over the past few weeks we have continued our efforts in deterring and detecting the issues in the Downton area with ASB and criminal behaviour associated with a small group of young people. Arrests have been made, catapults seized and persons have been placed on strict bail conditions in an effort to curb unruly behaviour. This approach is working and we continue to engage with our partners and the community to ensure that this positive trend continues.
- Rural Crime** – Lots of activity over recent weeks with prevention and detection at the top of the list. Officers have been on patrol with partners and the community in an effort to deter offences and this has produced some great results. Last week 5 persons were arrested following a short pursuit with police, having been chased off land and various items and the vehicle were seized. Officers have also been undertaking prevention patrols around fisheries and attended the NPCC week of action against rural crime meeting at the Livestock Market in Salisbury handing out leaflets and providing crime prevention advice to farmers. We have also visited our local scrapyards along with our partners in order to check and test that they are operating within the confines of the law and all operators were welcoming of the enforcement activity and were shown to be operating without any cause for concern.
- DDN's** – Work continues in our fight to detect and disrupt drug networks operating locally with some positive results, arrests and seizures in recent weeks. We will continue in these efforts and we encourage anyone with any information regarding suspicious activity that may be drug related to contact police asap.
- Events** - With summer well and truly behind us now, we are looking forward to a very busy policing period throughout late autumn in to early winter. Planning and preparation for policing activity is well underway for the series of events coming up including but limited too, Salisbury Fair, Salisbury Carnival, Halloween, Bonfire Night and Remembrance Sunday celebrations to name but a few!

PRIORITIES FOR WILTSHIRE SOUTH CPT

Priority 1:

Ongoing ASB issues in Downton

Priority 2:

Plan and Prepare for the Autumn season ahead, starting with the Salisbury Fair, Salisbury Carnival, Halloween, Bonfire Night and Remembrance Day.

Priority 3:

Rural Crime initiatives and ongoing action to detect, disrupt and deter offenders.

Priority 4:

Acquisitive crime, tool thefts and non- dwelling burglaries.

HIGH LEVEL PCC UPDATES

- **Recruitment** - Police officer recruitment continues with more than 500 applications received so far since the campaign launched on 23 September. Wiltshire Police is accepted applications until Sunday 13 October.
- **Community work** - In September PCC Angus Macpherson awarded a total of £22,500 from the Police Property Act to projects across the county which make a difference in their communities. Beneficiaries include a drop-in service for homeless people, a 12-week personal development course for unemployed young people and a pilot project using photography to engage with young people at risk of offending or

exploitation. Full details are available on our website.

- **Herbert Protocol** – The PCC was proud to join Wiltshire Police, Swindon Borough Council, healthcare partners, Swindon Carers Centre and the Alzheimer's Society at the launch of the Herbert Protocol last month. It comprises of a document in which carers, family and friends of vulnerable adults can fill out key details about the individual as a pre-emptive measure in case they later go missing. This will enable the police to start their initial enquiries sooner with the aim of finding the missing person safe and well.

HIGH LEVEL FORCE UPDATES

- **County Lines** – The issue of gangs transporting Class A drugs from major cities such as London and Manchester into rural counties, is one which is attracting significant media attention. Here in Wiltshire we are raising awareness of the problem, and specifically the impact these crimes have on the wider community, as they are often linked to modern slavery and organised crime, with children and vulnerable adults being exploited. Please look out for local media coverage, or go to our website for more information.
- **Domestic abuse** – This month we are highlighting the work Wiltshire Police is doing to tackle domestic abuse, including educating the public about the support that is available for victims. This campaign will include a young mother, who has been the victim of domestic violence, speaking out about her story in the hope that she can encourage other victims to come forward and get support.
- **Rural crime** - During the beginning of October we are taking part in a national week of action targeting rural crime. Our work will include providing crime prevention advice and encouraging residents to report all incidents to the police, as well as having our Community Policing Teams and the Rural Crime Team out and about engaging with our rural communities.

Joint Salisbury City and Wiltshire Council Area Board 4th November 2019

Theme: Climate Change

Executive Summary

On the 4th November 2019 Wiltshire Council (WC) and Salisbury City Council (SCC) held their first joint Area Board themed around climate change. The event coincided with an SCC facilitated Eco Fair which attracted several local and national organisations involved with the environment generally.

The Area Board's (AB) brief was threefold: -

- 1) Listen to the views of residents and community groups on the priorities for both Councils to address climate change
- 2) Ask those attending what they could contribute as groups or individuals to these priorities
- 3) Start to compile a list of volunteers willing to help deliver agreed actions.

Approximately 130 people attended and through a round table discussion presented some 70 proposals reflecting those issues they deemed most important. The proposals were recorded by the AB and will be used to inform the development of WC and SCC environmental policies and to formulate a plan to focus the activities of those individuals who have volunteered their services

As a Salisbury based event, some proposals are Salisbury-specific, but many are also applicable county-wide.

This paper is intended as information only. It is expected that each Council will initiate its own course of action and that, where appropriate, WC as the primary authority will communicate the findings to central government as a clear indication of the priorities of the local population.

Table of Proposals

For clarity every proposal has been included. Where a similar proposal was made by several tables, the number of tables from which the proposal came has been identified to highlight the order of importance in the eyes of the contributors. Otherwise, proposals have been grouped under generic headings but in no order of priority.

Public Engagement

At the start and finish of the AB it was stressed to members of the public that it will not be possible for Councils to deliver on everything that had been suggested and that they as residents, either individually or through their community groups, would need to step up and play a part in taking some of their initiatives forward.

Since the AB meeting, some 20 individuals have made contact and expressed a willingness to become engaged and work is underway to identify potential projects with which they become involved and, crucially, of which they can take ownership.

Two examples of projects suggested to date are:

Food - Allotment holders who produce more than they can consume to be put in contact with a community fridge project rather than composting their surplus. A volunteer would be given an allotment patch, engage with the holders, collect the surplus and deliver to the community fridge.

Trees - Public to identify potential areas for tree planting, Councils fund the tree purchase, volunteers do the planting and take on the ongoing management, watering etc.

It is recognised there will be a level of detail to be addressed prior to commencement on some projects, and Councils will facilitate this as required. The expectation is that, once started, most projects will run with minimal or no Council oversight.

Next Steps

Recognise and increase public engagement through regular updates: at AB and City Council meetings, through press and social media, and by staging public events to highlight the work of volunteers and their projects.

Maintain and increase the volunteer base, generating more potential climate friendly projects.

Monitor the outcomes through presentations to the AB / SCC on those projects as they develop.
