70	<p><u>Welcome and Introductions</u></p> <p>The Chairman, Councillor Sven Hocking welcomed everyone to the joint themed meeting of the Salisbury Area Board and Salisbury City Council, to look at Climate Change in the City.</p>
71	<p><u>Apologies for Absence</u></p> <p>Apologies for absence had been received from:</p> <ul style="list-style-type: none"> • Station Manager Maggs – Dorset & Wiltshire Fire & Rescue
72	<p><u>Minutes</u></p> <p><u>Decision</u> The minutes of the meeting held on 26th September 2019 were agreed as a correct record and signed by the Chairman.</p>
73	<p><u>Declarations of Interest</u></p> <p>Cllr Atiqul Hoque declared an interest in Item 10 – Community Funding, Health & Wellbeing application from the Muslim Association, as he was the Treasurer.</p> <p>He clarified that the applicant was not the Muslim Association itself, but was acting as a facilitator to support the project. He did not take part in the vote for that application.</p>
74	<p><u>Chairman's Updates</u></p> <p><u>Bus Shelters</u> Since the last meeting the matter had been considered at CATG (report included with Item 9). There was a recommendation for funding to make modifications to the shelters to alleviate the amount of rain that currently came through the gap at the top.</p> <p>Comment: Mr Brown noted his dissatisfaction with the shelters which he felt were of poor design and a waste of money. He requested that the shelters were replaced with an improved design to provide adequate shelter.</p> <p><u>Household Recycling Centre (HRC)</u> Due to roadworks being undertaken on Stephenson Road between 18th October and 18th November, Salisbury HRC would be closed Saturday 9th and Sunday 10th November as there would be no vehicular access permitted.</p> <p>However, the site would open on Thursday 7th and Friday 8th November instead.</p>

	<p>All HRCs moved to their winter opening times from 1 November to 1 April: 10am to 4pm, and the Salisbury site is now normally closed on Thursdays and Fridays. The HRC in Amesbury is closed on a Tuesday and Wednesday.</p> <p><u>Salisbury Reds</u> Following a request at the last Board meeting, the Chairman had contacted Salisbury Reds to request financial support for bus stop replacements who had responded positively, and further communication was planned with them to take this forward.</p>
75	<p><u>Information items</u></p> <p>There had been a change to the previous format of Partner Updates. Partners were now invited to provide written updates or online links which were included in the agenda pack for information.</p> <p>The Board noted the information available in the agenda pack and circulated at the meeting.</p> <ul style="list-style-type: none"> • Salisbury City Council • Salisbury BID • Community Messaging • Healthwatch Wiltshire • Clinical Commissioning Group • Wiltshire Council • Police – attached to minutes
76	<p><u>Updates - Maltings and Central Car park, Central Area Framework, & High Street Fund</u></p> <p>Victoria Moloney, Head of South Wilts Economic Recovery gave updates to the Board:</p> <p><u>Future High Street Fund</u> An Economist had been appointed to help with the business case to support the bid.</p> <p>Central Government had moved the timescales and the full business case is now expected to be submitted around June 2020.</p> <p><u>Central Area Framework</u> The Second consultation would start in January 2020</p> <p><u>Maltings & Central Car park</u> Phase 1 demolition work had begun on site. Progress report and update going to Wiltshire Councils full Council meeting on the 26th November.</p>

	<p>It was noted that phase 1 is privately funded</p> <p><u>Government Community Governance Review – Update</u> Cllr Richard Clewer – Deputy Leader – Chairman of the Electoral Review Committee gave an update. A copy of the slides from his presentation are attached to these minutes. A decision is due to be made by Central Government in January 2020</p> <p>It was noted that Salisbury City Council, relevant Parish Councils and a number of residents in the West Harnham area would be consulted and that the recommendations will be approved by Central Government in January 2020.</p> <p>Information is also available Online</p>
77	<p><u>Climate Change</u></p> <p>The Chairman thanked everyone for coming for this themed event, and handed over to Councillor Richard Clewer, Deputy Leader of Wiltshire Council, for a presentation on Wiltshire Councils commitments and progress on tackling Climate Change.</p> <p><u>Key points of the presentation were: -</u></p> <p>In February 2019 Wiltshire Council resolved to:</p> <ul style="list-style-type: none"> • Acknowledge that there is a climate emergency • Seek to make the county of Wiltshire carbon neutral by 2030 • Establish carbon baseline and renewables baseline <p>Wiltshire Council Cabinet committed to make Wiltshire Council carbon neutral by 2030.</p> <p>A Global Warming and Climate Emergency task group has been established to consider: Renewable energy generation, energy use and efficiency in the following areas: -</p> <ul style="list-style-type: none"> • Planning • Transport and air quality • Waste • Land use • Business and industry • Carbon baseline and renewable energy baseline <p>Residents requested to consider a Green Pledge and act on some of the following:</p> <ul style="list-style-type: none"> • Leave the car at home and walk more

- Take shorter showers and turn off taps when brushing teeth
- Try and use as little single-use plastic as possible
- Use a reusable cup
- Use bags for life
- Recycle as much as you can
- Turn off lights when not using them
- Install a smart meter to help you manage energy use

The Chairman then introduced Cllr Jeremy Nettle, Leader of Salisbury City Council (SCC) gave a presentation on what SCC was doing to tackle Climate Change.

Key Points were: -

Cllr Nettle thanked all who had been involved with the Eco Fair prior to the Area Board and recognised those local groups supporting to include Salisbury Transition City, Salisbury LETS, Wiltshire Wildlife Trust, Co-Cars, Extinction Rebellion, Salisbury Area Greenspace Partnership, Salisbury Community Energy, The Pantry Partnership, Salisbury Repair Café, Wiltshire Warm & Safe, Wessex Water, Community Fridge and South Wilts Biodiversity Group.

- SCC declared a Climate Change Emergency at Full Council on 17 June 2019, budgeted £56,000 funding in support and resolved to:-
 - ✓ Work to make Salisbury as carbon neutral as possible by 2030
 - ✓ Work with partners to achieve “clean air” in Salisbury by 2022, in particular by taking action to reduce vehicle emissions, supporting public transport, cycling and walking
 - ✓ Replace or convert all council-owned or operated vehicles to electric powered vehicles as soon as is practically possible
 - ✓ Encourage the rapid phasing out of diesel-powered buses in the City by bus operators and their replacement by cleaner or non-polluting alternatives
 - ✓ Increase wherever possible the extent of pedestrianised areas within the City centre
 - ✓ Undertake a comprehensive programme of improvement of the insulation of all council-owned property,
 - ✓ Ensure that such property shall be fitted with solar panels wherever possible
 - ✓ Do everything within its power to ensure that such standards should also apply to any new buildings which are permitted within the City

Actions SCC had already taken:

- New recycling bin in the Market Square
- Recycling of domestic waste in kitchens/staffrooms
- Green waste recycling from our parks/open spaces
- Annual Tree planting programme

- Introduction of Wild Flower areas
- Installation of the bottle refill/drinking facility in the market square
- Promoter of the cycle to work scheme
- Staff using bikes to get around the city
- PV solar panels on roof of Guildhall
- Use of mulch on flower beds to reduce watering frequencies
- Policy statement restricting the use of glyphosate weed killer
- Use of LED energy efficient lighting in Shopmobility refurbishment
- Paper recycling
- Introduction of plants in the office to improve air quality
- Home/flexible working
- IT systems in place to reduce paper usage
- Use upcycled materials for our art groups
- Recycling point for ink cartridges and phones
- Use social media whenever we can instead of printing leaflets
- All heating thermostatically controlled
- Updated IT suite using recycled equipment from Guildhall
- Motion sensitive lighting in Guildhall

A copy of the presentation slides are attached for information.

The Chairman then asked those present to work in groups in a round table exercise to come up with their top 5 climate change projects for Salisbury, which could be delivered over the next 12 to 18 months.

The project felt to be the most important from each table included: -

- Education - ask whole communities change their behaviour by educating the children.
- Food - more meat free options in schools.
- Transport – reduce parking capacity in the city centre and increase use of park and ride, improve the train station frontage, ban idling vehicles in the City centre especially trucks and buses, change / better bus routes to go where buses are needed, more car free days,
- Development - New planning applications should not be granted unless they include solar panels, grey water tanks, and are south facing to optimize solar energy.
- Air quality - pedestrianisation of large areas of the City
- More greenspace and use of electric maintenance vehicles.
- Tree planting
- Youth - Support for the strikes and the global impact and youth to be included in the conversation, public signage around climate change.
- Cycling - Improved cycle routes with better signage
- Food Wastage – open a “community fridge”
- Promote solar renewable energy and electric cars through a bulk buying scheme.

	<p>It was noted that: -</p> <p>Wiltshire Council was engaging with other local authorities.</p> <p>The public proposals would tell Central Government what the people were expecting</p> <p>The Chairman thanked all for coming, and noted that the lists of ideas would be collected after the meeting and collated into a report which would inform the direction of work moving forward and that the public would be updated of progress generally.</p>

Salisbury Museum – requested £2250. The recommendation from the Youth Panel was to award £1500

Decision

Salisbury Museum was awarded £1500 of Youth Funding towards Stone Age Long Board Project.

Salisbury 2020 – requested £5000. The recommendation from the Youth Panel was to award the full amount.

Decision

Salisbury 2020 was awarded £5000 of Youth funding towards the TechSTEM event.

Health & Wellbeing Funding

The Board considered three bids for funding from the Health & Wellbeing (HW) Fund. The HW Panel considered applications and made recommendations for funding on 15th October.

Salisbury Pride UK – requested £2000.

The recommendation from the HW Panel was to award £1000.

The motion to fund the project at the recommended amount of £1000 was made by Cllr Dalton. This was seconded by Cllr Rogers.

After discussion, Cllr Walsh requested an amendment to the motion, and asked that the Board award the original full request of £2000. This was accepted by Cllr Dalton, and seconded by Cllr Rogers.

Motiv8 provide support services in Wiltshire for children and young people, up to their 18th birthday, with problematic substance use, and for children, young people and families affected by parental substance use. Its primary objective is to improve the health, welfare and life chances of those vulnerable to, or experiencing, substance misuse.

Motiv8 provide advice, guidance and one-to-one sessions for young people who are having problems with drugs and/or alcohol. The service is free and confidential, and aim to provide a flexible and non-judgemental space for young people to be open about the problems they are facing.

Background

The Community Area Joint Strategic Needs Assessment (JSNA) works to collaboratively set local area priorities, by combining service led data with local insight and opinion. This acts as a catalyst for community led action that helps meet local need and supports the delivery of the Wiltshire Council Business Plan. Through working with the area boards, Wiltshire Council is able to encourage and support communities to take action to sustainably meet their needs.

Aims of the JSNA

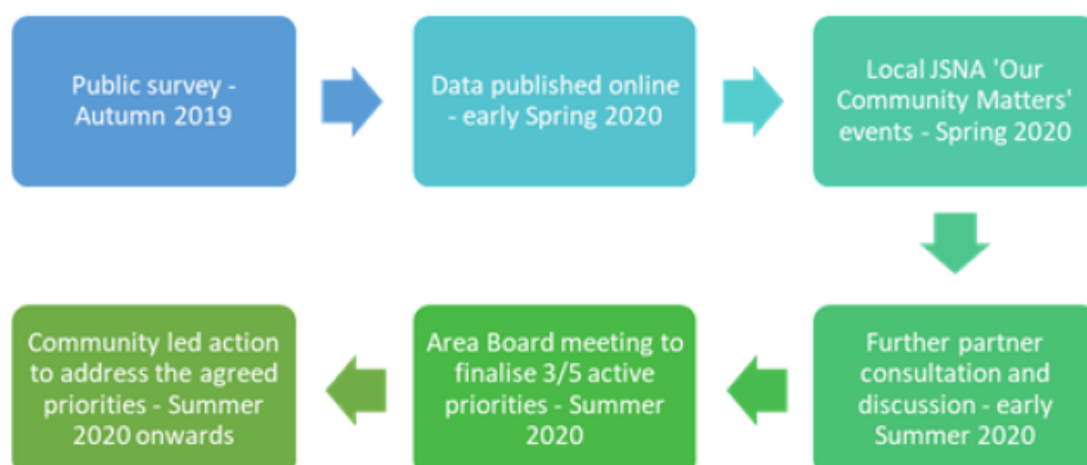
- To collaboratively set our local priorities for each community area by combining our service led data with local insight and opinion
- To facilitate community led action that addresses local priorities and supports the Wiltshire Council Business Plan.

2020 Delivery plan

The JSNA is refreshed every three years, with the next cycle due to be updated in 2020. There will be three key engagement stages to support the area board in hearing from their communities and identifying their active local priorities:

- Public JSNA survey (completed in Autumn 2019)
- A JSNA event (scheduled for Spring 2020)
- A resident and partner engagement exercise (scheduled for early summer 2020)

The flowchart shows the key milestones of the JSNA process with a more detailed description of the process below.



Wiltshire Council Information Item

Public survey – Autumn 2019

A public survey was delivered across the communities and 6,300 responses were received. Excel spreadsheets with the survey data are now available and full results from this survey will be published in due course at <https://www.wiltshireintelligence.org.uk/community-area/>

Data published online – early Spring 2020

Public Health analysts will work collaboratively across Wiltshire Council departments, partners and local services to collect and analyse data.

JSNA ‘Our Community Matters’ events – Spring 2020

The purpose of each event will be to bring together local people to share the results of the public survey, highlight the findings from the service data and discuss and set the local priorities. Each event will be used to identify the area’s top 12 priorities across the nine thematic areas:

- Arts, culture and leisure
- Children and young people
- Community safety
- Economy and employment
- Environment
- Health and wellbeing
- Highways and transport
- Housing
- Older people

Partner and resident engagement – early Summer 2020

Following this meeting, further local conversations will take place with residents and partners. The engagement aims to establish partner and community capacity, resource and preference for the priorities that have been identified.

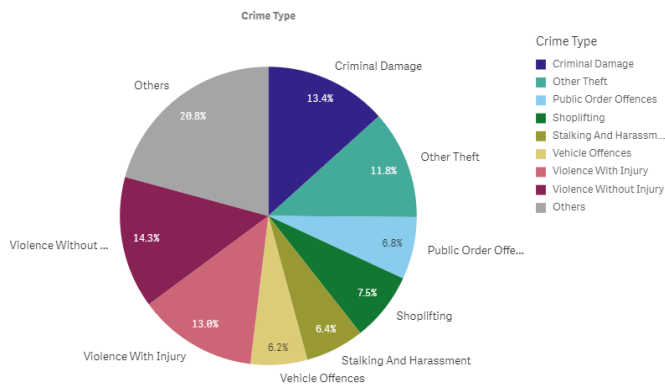

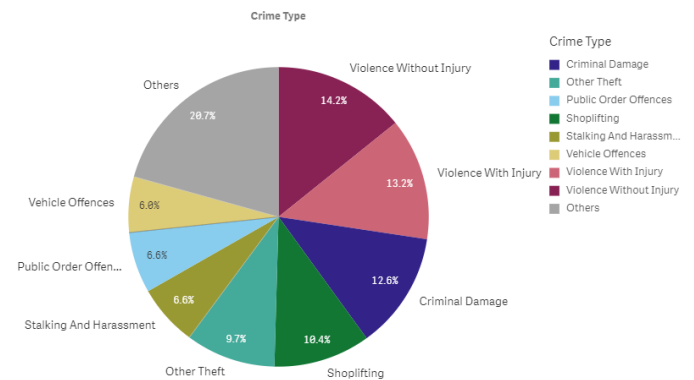

Force-wide

- Wiltshire Police has had an increase in the volume of recorded crime by 4.5% in the 12 months to November 19 and continues to have one of the lowest crime rates in the country.
- Our service delivery remains consistently good.
- In November, we received 8,234 999 calls which we answered within 5 seconds on average and 11,604 CRIB calls which we answered within 1 minutes 28 seconds on average.
- In November, we also attended 1,594 emergency incidents within 10 minutes and 30 seconds on average.
- Wiltshire Police has seen a 10% reduction in vehicle crime and 9% in residential burglaries in the 12 months to November 2019.
- The Crime Survey of England & Wales recently ranked Wiltshire as one of the top forces (78.3%) nationally for public confidence. It covers the 12 months to March 2019.

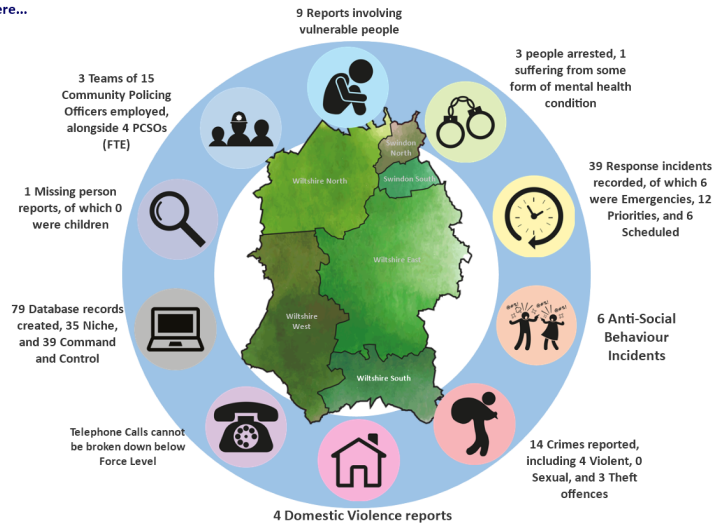

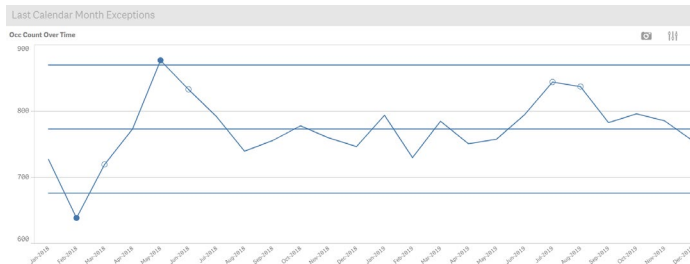

Wiltshire South / South East CPT Demand Overview – 12 months to November 2019

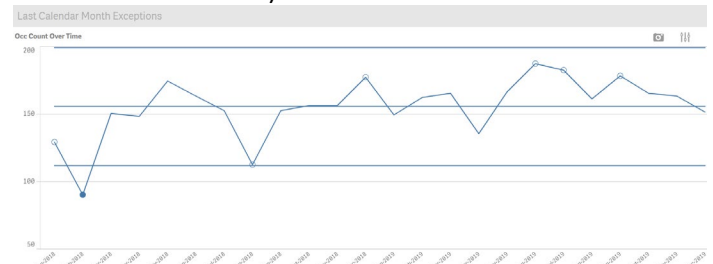
Salisbury CPT Demand over 2 years:

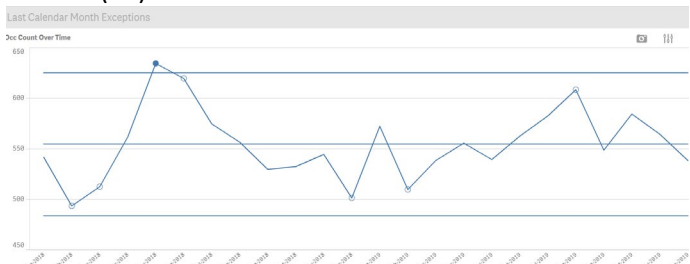
Southern Area Board Demand over 2 years:

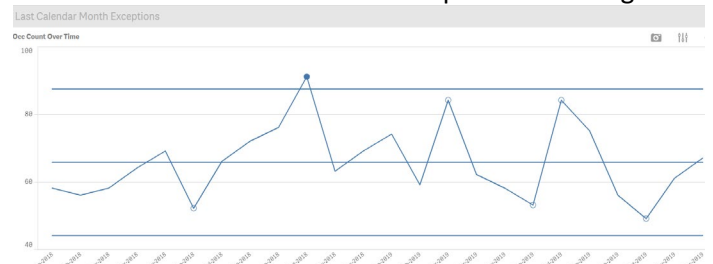

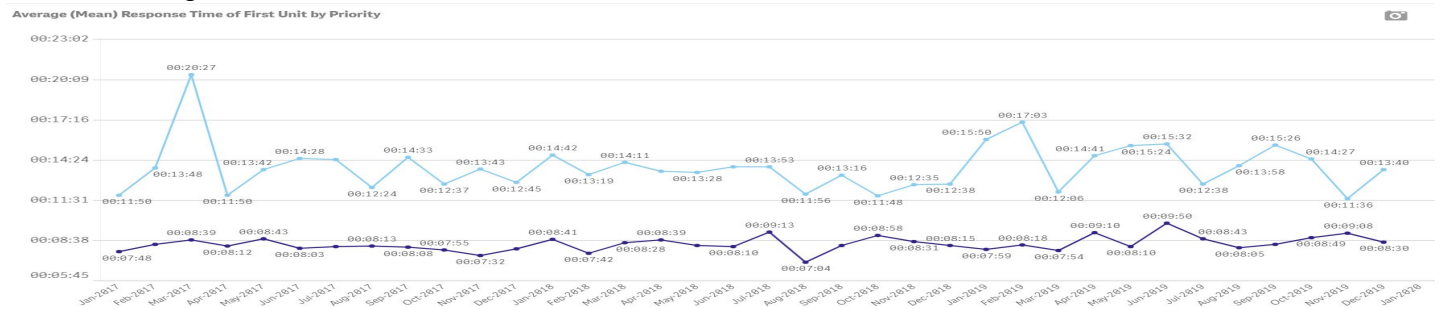

Immediate Urban (within 15 minutes standard)

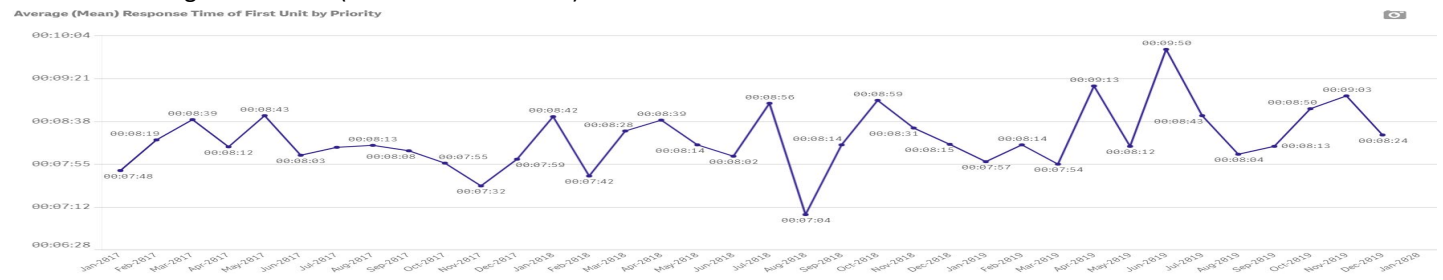

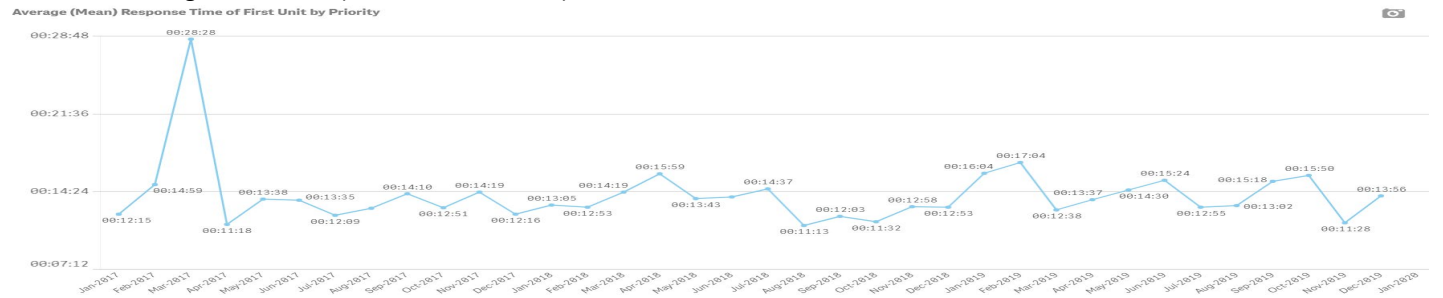

HIGH LEVEL CPT UPDATES:

Operation Uplift: Although we have yet to see the arrival of New Constables we have received 3 new PCSOs, Hannah Cranham, Grace Akers and Nicola Bird who are making themselves known on their new beat areas. Sadly, we have had to say goodbye to Kady Green who has relocated to start a new life outside of Policing and we will lose Harry Evans in February, who leaves to become a Constable. We look forward to watching his development.

Community Policing continues to evolve and we will build a team of Neighbourhood Officers, consisting of 2 Sgts, 4 PCs, and all our PCSOs. This team will continue to use our Problem Solving approach in order to analyse and identify concerns and resolve the matter, reducing demand across our communities. Details of the Team are below.

Operation Hamper: Recognising that Salisbury has a seasonal rise in reported theft and ASB, particularly around the City Centre, Op Hamper was introduced. This was intended to:

- Deny Space for offending – a high visible presence within the City
- Detect Offences at the time
- Deter Offenders from choosing to come to Salisbury to commit crime.

The operation relied upon Partnerships, making better use of the ShopWatch and PubWatch radio systems, linking the City CCTV and the Police to the Shops and Licenced Premises. Crime Prevention advice was key. Research shows that preventative measures used by shops before offences occur are far more effective than enforcement options after the event.

Result: We witnessed a rise in reported Shopliftings during November and early December, before a sharp fall in both Shoplifting and ASB during December. With 27 reported shopliftings in December (53 in November), only 2 had no recorded suspects making significantly higher detection rates.

This operation will continue in 2020 under the less seasonal name of **Op Vendor**.

Cat Thefts: We are experiencing an increase in catalytic converter theft/attempt thefts, particularly from 4x4 vehicles such as Landrover Freelanders and Honda CRVs. These vehicles are favoured as they provide easy clearance to get under the car, so some simple preventative advice can assist you:

Do not park with one wheel on the pavement.

If possible, park in a garage or off the road and in well-lit areas or under CCTV.

Use hard features, such as walls or fences to make it harder to get under your car.

Please report any suspicious people under vehicles to the police with as much detail as possible, including vehicles associated to them.

Burglary in West Gomeldon: Liam Lowrey (20) from Swindon was identified as the lookout for a burglary in June based on excellent CCTV images. Images on his own phone assisted with the identification, wearing the same clothes! At Swindon Crown Court on 17/12/19 he received 2 years detention in a Young Offenders Institution. We have yet to identify the other 3 offenders who entered the property.

Vulnerable Rough Sleeper:

Concerns were raised for the welfare of a vulnerable rough sleeper who has lived within the city for several years. Although previous engagement efforts had been met with resistance from the individual, it was evident that her health had deteriorated and that she was at risk of death or serious injury if left on the street during Winter. A multi-agency high risk behaviour meeting considered all the factors resulting in her admission to hospital against her consent and is now in a specialist placement that can support her needs.

Graffiti: Salisbury CCTV captured excellent images of youths graffitiing in the City earlier in 2019. Following circulating the images on social media, the parents of two youths brought them to the Police Station where they were interviewed and made a full admission. As a Community Resolution, they were brought back to the City under the supervision of a City Ranger and Police, where they assisted with cleaning graffiti from a shop window near the Poultry Cross. Although they were not responsible for all of this graffiti their remorse and willingness to do something positive is a better outcome than to have instantly criminalised the offenders.



Reward & Recognition:

- **PCC Volunteer of the Year - Police Cadet Andrew Foord.** Andrew has been a Cadet since 2016 and received his award for creating 2 videos aimed at the youth audience surrounding Knife Crime and County Line Drug Dealing.
- **Daniel Cooper Memorial Award for Outstanding Service to Members of the Public – Police Constable James Barrett.** James was recognised for his commitment to Policing in Salisbury, with particular mention towards rural crime, an investigation into an organised crime group and leading a national hunt and capture of a particularly violent burglar. He is commended for the high standards he sets and delivering exceptional levels of service to Wiltshire Police and the Communities he serves. James joins our Neighbourhood CPT in January.

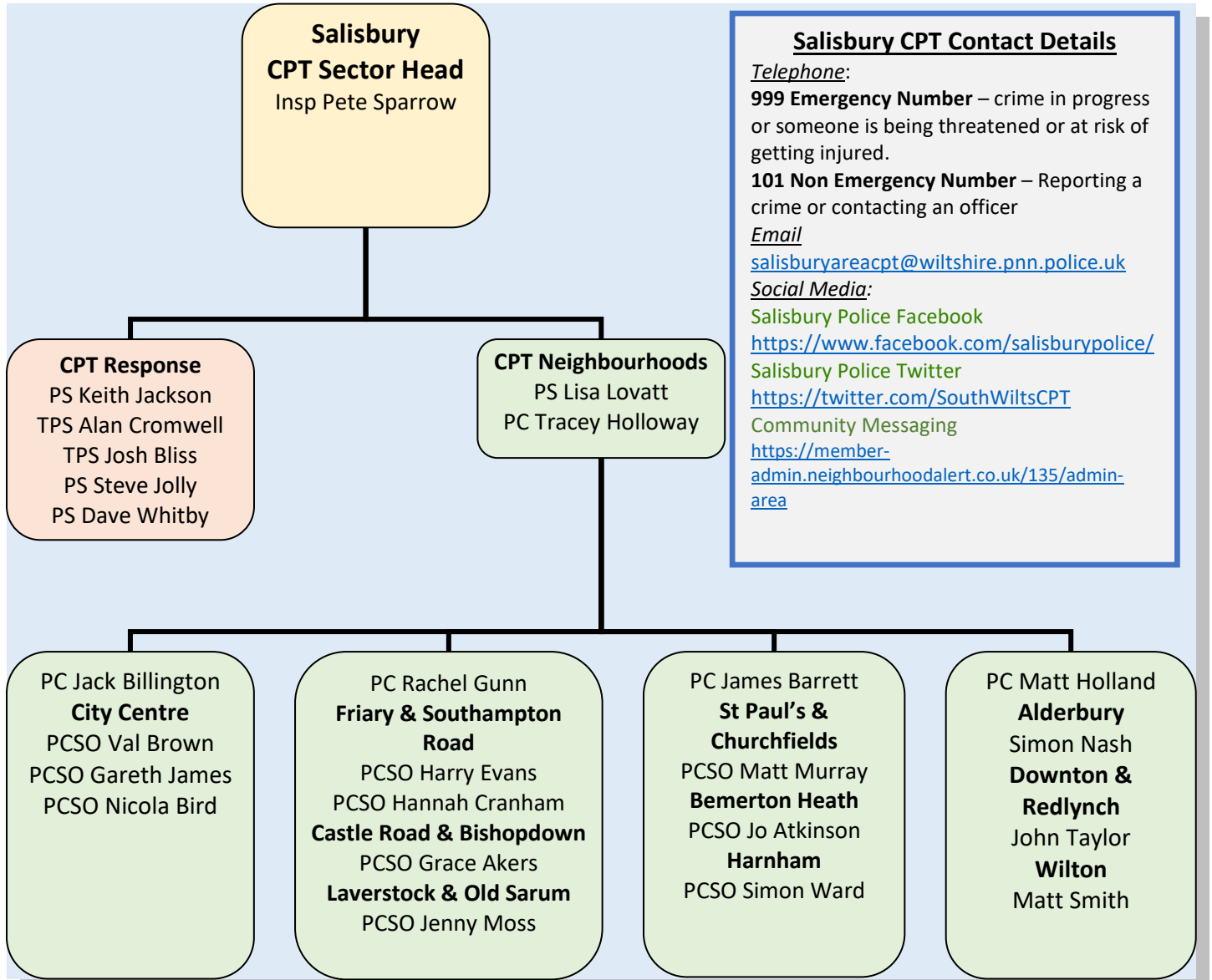

HIGH LEVEL PCC UPDATES

- **Precept Consultation** – From 6 January, I will be consulting with residents and businesses in Wiltshire and Swindon on what they would be prepared to pay as part of their council tax bill next year's towards local policing. I am still waiting for notification from the Home Office on what our settlement will be in Wiltshire for 2020/21 and hope to be in receipt of this soon. I strongly encourage you to [submit your feedback on my website](#).

HIGH LEVEL FORCE UPDATES

- We continue to implement **changes in our community policing teams** to better meet demand in our different patches. It is a phased approach and as of December the boundaries of our community policing teams changed with their names also changing to reflect the areas covered.

The new list is: Swindon Area CPT, Chippenham Area CPT, Royal Wootton Bassett Area CPT, Trowbridge Area CPT, Warminster Area CPT, Salisbury Area CPT, Devizes Area CPT and Amesbury Area CPT.

- **Changes to 101 system** – In mid-December the options available when members of the public call 101 have changed to allow for to be connected directly to some departments. They will also no longer be taking reports of shoplifting unless it is in progress, an offender is detained or there was violence to any members of the public or staff. Instead callers are encouraged to report the crime online and submit any available CCTV.

The key messages for a safer home

- **Ensure you have working smoke alarms installed on all levels of your home.** Working alarms can give you the vital time needed to escape in a fire. Test your smoke alarms regularly and never remove batteries!
- **Never leave cooking unattended.** The majority of fires start in the kitchen so this is a high-risk area. Many of us enjoy a merry tippie over the festive season but be sure to avoid cooking whilst under the influence of alcohol. Always turn off kitchen appliances when you have finished cooking.
- **Never leave burning candles unattended.** Keep candles out of the reach of children, and away from decorations, cards and wrapping paper, fires, lights and heaters.
- **Put your cigarette out, right out.** Make sure your cigarette is fully extinguished and take care when under the influence of alcohol or tired. It's very easy to fall asleep while your cigarette is still burning and set furniture alight.
- **Never use heaters to dry clothes.** Heaters can start fires when things are placed too close to them. Keep them well away from curtains, clothing and furniture.

- **Don't overload sockets.** Ensure only one plug per socket. Always turn off plugs when they are not in use, except those that are designed to be left on, like freezers.
- **Ensure you switch off fairy lights** and unplug them before you go to bed or leave the house. Check your Christmas tree lights conform to the British Standard (BS EN 60598) and are in good working order before use.
- **Always use an RCD (residual current device)** on outdoor electrical equipment. This safety device can save lives by instantly switching off the power if there is a fault and can be found in any DIY store.
- Make sure that everyone in your home knows what to do in a fire – **in the event of fire you should get out, stay out and call 999**

Our dedicated team of Safe & Well advisors can (at request) come to your home and discuss with you and your family how to maintain and regularly test you smoke alarms. They will also assist you in establishing a fire plan which will enable you to make a safe exit or go to a place of safety in the event of a fire in the home.

But this is not all the advisors do, they are also able provide you with information on how to make simple changes to enable us all to live a healthier life style. They can assist in organising support from organisations such as Age UK to assist our older relatives, arranging mental health support for those who maybe finding things just a little bit harder to deal with and, can also signpost with Safeguarding issues. All of which can bring together our partner agencies within the NHS, Council, Police and volunteer services who's aim is to enable those most vulnerable in our communities to be able to live in their own homes with the correct support.

DO YOU KNOW A CHARLIE

More than 6.5 million people in the UK are currently caring, unpaid, for a family member or friend who is older, disabled or seriously ill. Yet many people don't identify themselves as carers, they simply see themselves as spouses, partners, parents, children or friends.

A CHARLIE is a person whom meets at least one of the following criteria:

- **Care and support needs**
- **Hoarding and/or mental health issues**
- **Alcohol and medication use**
- **Reduced mobility**
- **Lives alone**
- **Inappropriate smoking**
- **Elderly and would benefit from support**

It only takes a few minutes to email or call us but can save a lifetime of heart ache for those who may suffer in silence, especially when they are cold in winter months or do not have the correct means to alert them to a fire in their home or to the dangers of carbon monoxide poisoning.

Hoarding



We all keep things we don't really need. Some of us have more possessions than we have storage for. But hoarding is a complex issue that goes far beyond untidiness or indecisiveness.

Hoarders can fill entire rooms from floor to ceiling, leaving themselves the minimum space in which to live. This retention of property presents a real fire risk and makes it far harder for firefighters to be able to tackle any blaze.

The Fire and Rescue Service can't solve the problem of hoarding; however, where we know there is an issue, we can work with other agencies to try and reduce the risk of fire.

Evidence from across the country shows that:

- In 90% of all residential fires, the fire itself is contained to the room where it started. However, that figure drops to 40% where there is hoarding – as this additional material fuels the fire and makes it spread more quickly.
- When there is a fire in a hoarder's home, there is a far greater risk that the individual and/or family members will find it difficult or impossible to escape.
- Common materials kept by hoarders include newspapers, magazines, books and soft furnishings – all of which are highly combustible.
- The presence of vast amounts of hoarded material creates a risk to firefighters, both in getting to the fire and through increased heat and smoke.

By offering Safe and Well visits, and installing smoke alarms, we can work with hoarders to try and make their homes more fire safe. If they want help in dealing with their hoarding compulsion, then we can refer them to other agencies for that support. However, we know that not every hoarder is ready to take that step and we want to ensure that they are as fire safe as possible, whatever the circumstances of their home.

As a predominately rural service, we are hugely reliant on those who live and work in the local community to support us by becoming an 'On Call Firefighter'. Some of our local stations often struggle to provide a fire appliance during the day and this is due to a lack of available crew members at the station who are able to provide us with cover during working daytime hours.

Are you or do you know someone who lives or works within 5 minutes of your local fire station and would like to become an On-Call firefighter? Are you an employer that is willing to release a member of your staff to join us? Without the willingness of those in the community to join us then we will continue to struggle to turn fire appliances out for emergencies.

We will provide full training which includes firefighting skills, first aid, driving skills for Cat C vehicles (if required) and fire prevention and protection skills. All these skills that we provide can assist in an individual's normal workplace making that a safer environment within which to work. We provide all the uniform and fire kit and can help with travelling so there should be no expense to an individual once they manage to get in.

Payment / salary is based on the number of hours an individual can provide us and we provide holiday leave entitlement and a pension.

Our appliances and stations are based in the community and we need you as the community to help staff them.

A Statement by Councillor Jeremy Nettle, the Leader of Salisbury City Council

As the Leader of the City Council, I am delighted to report footfall increased in the last month of last year in the City to exceed that in 2018 and against the National trend. This is due, I am confident, in part at least to the excellent Christmas Fayre and Ice Rink put on by the City Council with the support of Wiltshire Council and South Western Railways. This Fayre was voted the 3rd best in Europe by Ideal Homes.

The council has been active across the city with a program of capital investment. The Council new cemetery has now seen 10 burials and this is an important new facility for the city. The Coach Station toilets located in Millstream Approach have been refurbished as part of Salisbury City Council's Public Toilet Refurbishment Project, our attention will now turn to Lush House Car Park toilet where we hope to be able to install a Changes Places toilet.

In line with our Climate Change declaration, we have begun to invest in battery powered machines for use in our parks and open space, replacing diesel fuelled equipment. The City Council is pleased to report that a second water re-fill station is now available to use allowing locals and residents to refill their water bottle and limit the use of single use plastic bottles.

I meet recently with the Chairman of Laverstock and Ford Parish Council to discuss issues we have in common and I hope to carry on this liaison in the New Year.

And finally in December, the refurbished Shop Mobility office was officially opened by the Mayor. This space is now bright, light and up to date, providing a good environment for staff, our valuable volunteers and our customers.
