Subject:	New fly-tipping campaign: We're Targeting Fly-tippers

Wiltshire Council has launched a new reward campaign to prevent fly-tipping in the county.

The We're Targeting Fly-tippers (WTF) campaign aims to combat the scourge of fly-tipping by offering residents a reward of up to £200 in high street vouchers if they report information that leads to the successful prosecution of an offender or the payment of a Fixed Penalty Notice (FPN).

If anyone has any information about fly-tipping in Wiltshire, they are requested to report it using the My Wiltshire app with as much information as possible. If this information leads to a successful prosecution or payment of a Fixed Penalty Notice, the person who reported it will earn a voucher of up to £200.

We want residents to provide information as possible, such as where the fly-tip is, the registration and make or model of the vehicle they saw, plus any description or photographs of the alleged fly-tippers. However, it is essential that people do not attempt to confront anyone who is fly-tipping or put themselves in danger in any way. We also ask people not to try to rummage through or disturb the waste, as this could affect the scene and put people in danger.

Fly-tipping costs Wiltshire Council more than £180,000 each year, it is unsightly and it is a danger to people, wildlife and the environment.

In Wiltshire, most fly-tip reports are of a commercial nature, where waste is cleared for a fee and then dumped to avoid lawful disposal costs. Penalties for offenders include an unlimited fine and/or five years' imprisonment; a £50,000 fine and/or 12 months' imprisonment; or a FPN of £400 if they are caught fly-tipping small-scale waste.

Subject:	Warm and Safe Wiltshire – help available this winter

Warm and Safe Wiltshire is a single point of contact cold homes and energy saving advice service set up specifically to assist the health service in Wiltshire. The service is run by the Centre for Sustainable Energy (CSE), an independent charity, on behalf of Swindon Borough Council and Wiltshire Council.

The service provides a range of support both over the phone and through home visits. The telephone advice line is available to all residents and provides support which includes information about insulation and heating, guidance on heating systems, advice on understanding energy bills, help with ensuring a client is on the best energy deal, signing residents up to the Priority Services Register and fuel debt support.

Home visits are provided on a case-by-case basis and are especially useful where issues are challenging or difficult to discuss and support over the phone. As a guide, householders should have a vulnerability, such as an older occupant, low-income or health condition(s), to receive a home visit.

Wiltshire Community Foundation administer a Surviving Winter grant of £300 per person to help vulnerable residents pay for winter costs.

Warm and Safe and Age UK are the referral partners who can help clients complete the application form process and compile the necessary evidence for Wiltshire Community Foundation to make their decision.

The grant is administered on a first-come-first-served basis and it is in two rounds this winter. It should be noted that funds are limited.

- Round 1 opened 21 October and is open until 13 December 2019 (Please note Warm and Safe have allocated all grants in this round but are adding clients to a waiting list for round 2)
- Round 2 opens 13 January to 20 March 2020

Grant Funding will contribute to the continuance and/or improvement of cultural, social and community activity and wellbeing in the community area, the extent of which will be dependent upon the individual project.

4. Financial Implications

Financial provision had been made to cover this expenditure.

If all grants are awarded as below, Malmesbury Area Board will have a balance of £30,719.21 remaining in the 2019/20 Community Area Grants fund, and a balance of £4,030 remaining in the Health and Wellbeing fund.

Project description:

Flying Monk Community Projects is a Community Interest Company based in Malmesbury. They are applying to support Malmesbury Community Radio and Podcast Project 2020. They have run Community Radio since 2017 and each year the project has been expanded. In 2019 they worked with 210 participants and had 2450 listeners. In 2020 there will be 20 days of live broadcast and monthly podcasts. This inclusive community project brings people together to create programmes and to develop skills and self-esteem. Flying Monk Community Projects is applying to support the purchase of 2 vinyl turntables to be used by guest DJs in the studio shed.

Input from Community Engagement Manager:

This is an inclusive community project bringing together different potentially excluded groups, including disabled people, the elderly and marginalised young people, to create radio programmes and podcasts.

The project includes New Year Radio, May Day Radio and Carnival Radio. There will be 20 days of live broadcast with 5 live hours per day. All programmes will be hosted online and on the 'listen again' service and the project also releases monthly podcasts. The project will benefit participants from Malmesbury and the surrounding area by bringing them together with a shared purpose to develop both skills and self-esteem. They can be involved as DJs reporters, interviewers or creating spoken word.

Radio allows people to express their thoughts and views, discuss local events and builds confidence in public speaking. Listeners will benefit by hearing local news events and lots of music. The project will bring people from different backgrounds and ages together to create an exciting cultural project promoting and documenting community life.

In 2019, 210 people participated and 2450 listeners were reached. In 2020 the project aims to work with a wide cross-section of the community and increase numbers of listeners and participants.

This application is to support the purchase of 2 turntables to be used by DJs in the studio shed. Younger participants have expressed a preference for playing vinyl. DJ-ing is an exciting creative outlet and turntables will enable DJs to play a wide selection of music on record with ease and create high quality programmes that they feel proud of. Equipment purchased will be available for community use. The project has links with local groups including the Friday Group and Athelstan Museum and is happy to provide training. Equipment will be used throughout the year.

The total project cost is £1,630, the remainder of which is being provided by the project's own reserves, a grant from Malmesbury Carnival and a grant from The Jack Lane Charitable Trust.

Proposal
