87	<p><u>Welcome and Introductions</u></p> <p>The Chairman, Cllr Rich Rogers welcomed everyone to the meeting of the Southern Wiltshire Area Board.</p>
88	<p><u>Apologies</u></p> <p>Apologies for absence were received from:</p> <ul style="list-style-type: none"> • Chris Wood - Fire & Rescue
89	<p><u>Minutes</u></p> <p>Decision</p> <p>The minutes of the previous meeting which was opened and adjourned on Thursday 8 September and recommenced on 12 October 2022, were agreed as a correct record and signed by the Chairman.</p>
90	<p><u>Declarations of Interest</u></p> <p>There were none.</p>
91	<p><u>Chairman's Announcements</u></p> <p>Cost of Living Since last Area Board at a full council meeting members across the county affirmed their commitment to offer support to the cost-of-living challenges many will face over the coming months and to focus towards helping residents, businesses, schools and council staff.</p> <p>Already there had been the establishment of the Cost-of-living support hub, providing a one stop resources available, and the creation of an online interactive community directory to help people find the warm spaces and community food providers in the county. Both can be accessed through the council website – supporting you through the rising cost of living.</p> <p>The Chairman was keen for the Board to play a part in supporting its communities and had met to discuss how best to do so. Funds would be made available to support community led initiatives, with applications invited from parish councils, volunteer groups and individuals.</p> <p>Youth Outreach The Board had held another pop-up youth event in Winterslow. There was now a volunteer committee to take on the running of the Youth Zone Thanks were given to Katrina and Sam from Community First for their assistance.</p>

	<p>Underground Studios The Chairman had visited the Underground Studios at the Harnham Bunker, which had previously been awarded funding to support the creative activities, including music, computer coding and 3D printing.</p>
92	<p><u>To note the written reports and updates in the agenda pack or distributed on the night</u></p> <p>The Board noted the written information items, which included:</p> <ul style="list-style-type: none"> • Wiltshire Council Update - Wiltshire Council Grants for Electric Vehicle Chargers • Healthwatch Wiltshire • Integrated Care Board • Current consultations: https://wiltshire.objective.co.uk/portal/ <p>Cllr R Clewer noted that Integrated Care System’s Draft Strategy was being developed and was expected to be circulated in December for public feedback.</p>
93	<p><u>Celebrating Age</u></p> <p>Rebecca Seymour, Creative Producer of the Celebrating Age Programme, gave a presentation on the project, which had been funded by the Area Board in October 2022.</p> <p>With funding awarded by the Area board, Rebecca hoped to bring some creative events and support to the more vulnerable and isolated residents in the Southern Wiltshire community area.</p> <p>A video was shown which detailed some of the work across the county with different projects.</p> <p>A ‘Creative Conversations’ initiative which had begun on the telephone had recently progressed to include working with people who were house bound, to connect them up with support to be creative and build on their wellbeing.</p> <p>A ‘Noticing Nature’ initiative was also available for those with an interest in nature and the outdoors, which would tie in with visual art.</p> <p>Rebecca welcomed the support of the Area Board to guide her to those that were most in need of support.</p> <p>The first planned event would take place in Downton Memorial Hall on 15 December, from 2.00 – 4.00pm.</p>
94	<p><u>Healthy Schools project Update</u></p> <p>The Area Board has helped 7 new primary schools engage with Wiltshire’s</p>

	<p>Healthy Schools Programme. These were, Coombe Bissett, Longford, Old Sarum, St Andrews (Laverstock), St Nicholas (Porton), The New Forest, Winterslow.</p> <p>The project supported health eating, exercise, emotional literacy, mental health support and more.</p> <p>The Board noted the update on the Southern Wiltshire Area Board Healthy Schools Project and presented plaques to the qualifying schools, the New Forest School and St Nicholas School, Porton.</p>
95	<p><u>Cost of Living</u></p> <p>The Board receive an update on Wiltshire’s collective response to the cost-of-living crisis and heard from community led settings that had declared themselves Warm Spaces in the Southern Wiltshire Community Area.</p> <p>Interactive Directory</p> <p>The council has created a new online interactive community directory to help people find the warm spaces and community food providers in the county www.wiltshire.gov.uk/cost-of-living</p> <p>Those who have set up warm spaces or community food provider services were invited to fill out a short survey, so that their details can be included.</p> <p>People were urged to share the directory within their communities, as the resource contained a range of information and guidance on a variety of cost-of-living related topics such as energy, council tax and benefits, housing information, the support of local partner agencies, and advice on mental health.</p> <p>There was also a section dedicated to support and advice for businesses.</p> <p>Warm spaces within the community area</p> <p>Downton library would be providing a warm and friendly space throughout the winter offering energy and cost of living advice, and additional activities</p> <p>The Glebe Hall, Winterbourne Earls, had run a drop in café every other Wednesday afternoon since August 2021 for local residents to meet and chat, providing support to a lot of people who were quite lonely. Cakes and drinks were provided free, with voluntary donations to the Glebe Hall.</p> <p>Alderbury would also open its church hall one day a week and Pitton and Farley would extend the length of time they heat their church after toddlers group for people to make use of a warm space.</p> <p>Woodfalls ran a community café. They would be offering coffee and cake and soup and also an after school offer for parents to visit.</p>

	<p>Downton library would have warm drinks available and the Club Friday in Idmiston would be extending its current offer</p> <p>It was recognised that many clubs may need to recruit more volunteers as a consequence of offering out these facilities for extra periods or days.</p> <p>The Chairman welcomed new ideas for initiatives and urged people to come and engage with the Board.</p> <p>Cllr R Clewer noted how quickly the initiative was evolving, adding that Libraries would also be opening for longer for people to use. The ideas around bringing people together for coffee, were just one way to provide support, acknowledging that people would be motivated to set up what worked best for them.</p> <p>Comments and questions:</p> <ul style="list-style-type: none"> • Whilst warm spaces were needed there were also many people that could not leave their home, who may be feeling alone and cold. How would they be reached? <u>Answer:</u> It takes a lot of volunteer activity – attention was need to the link schemes which could be of use for those not able to leave their homes. • Peter Castle, Pastor in Landford – We are due to discuss the warm space initiative, who should we contact if we need further information? <u>Answer:</u> karen.linaker@wiltshire.gov.uk
96	<p><u>Matters of Community Wide Interest</u></p> <p><u>Parish Councils and Community groups</u> There were no updates at this meeting.</p> <p>Community Policing – local issues and priorities In addition to the written update provided as Supplement 1 to the agenda, Inspector Tina Osborn gave a verbal update, some of the main points included:</p> <p>There had been a successful implementation of a Public Space Protection Order (PSPO) in Downton, aimed to reduce the use of catapults. Since implementation, no further reports had been logged there for that type of offence, during the last two months.</p> <p>There had been reports relating to catapult use in Laverstock and Odstock, however tis was believed to have been by a different group. Pulse Patrols were being carried out in specific areas where issues we are happening. Police would stop and speak to people believed to be connected to the offenses. Ongoing work with partners to try and identify the culprits.</p> <p>During a successful late-night operation carried out in October, one individual had been arrested and sent to prison. As a result of the intelligence collected</p>

through the operation, 2 males had been arrested for a series of burglaries, and had been charged and remanded, awaiting sentence.

There had been three arrests in relation to the theft of high value motor vehicles. These individuals were currently on bail whilst the matter was investigated by CID.

Preventative work included the bike making events, which would continue around the community areas, and increased talks at schools on knife crime.

Comments and questions:

- Cllr Z Clewer – Thanked the Police for their work in Redlynch following a spate of rural crimes. She also urged communities to report all incidents, noted the youth version of Crime Stoppers called Fearless and the recruitment event aimed at school leavers which was due to take place later in the week.
- Cllr R Clewer stated that if there was evidence to support a PSPO for other areas then he supported this.
- Downton PC – There had been recent attendance of a Police Officer to the parish meeting, however that Officer was due to retire. Would he be replaced?
Answer: Recruitment was underway to recruit two more Officers to the Neighbourhood Police Team.

Fire & Rescue

In addition to the written update provided as Supplement 2 to the agenda, Jim Weston, Group Manager introduced himself and provided a verbal update, which included:

- Community Safety Plan link was provided in the report
- Prevention activity – keen to be involved with the warm spaces project and could identify people who need the assistance
- Safe and Well visits continued to be provided, these were free visit to those who were in need to assess the need for safety features at home.
- Expanding the Team with recruitment across the Wiltshire area, to ensure frontline services were robust and strong for communities.
- Experiencing some difficulties due to the recent weather, however the call rate for fires had dropped.
- There had been recent road traffic collisions which had resulted in life changing injuries and a fatality.
- High attendance at the first open day in 15 years, this event included partners attending with many stands to engage with the community

	<ul style="list-style-type: none"> • A recent donation of 3 of the former appliances had been made to Gambia • A new campaign focused on safety measures for the winter period had been launched. <p>Comments and questions included:</p> <ul style="list-style-type: none"> • What constituted a false alarm and how much resource does it use up to attend these? <u>Answer:</u> False alarms do make up a large part of our calls, we work through fire safety side with businesses to drive these down and there were ongoing plans to reduce the calls by working in partnership with agencies. They can be caused by building alarm systems, fumes in premises or a variety of other reasons. We do analyse the reasons to target our work. In addition there were the occasional hoax calls. • How strict was the on-call requirement to need to be able to access the fire station within the time frame set? <u>Answer:</u> Access to the station in previous years was set at a strict 5 minutes, however that time had been stretched to 7.5/8 minutes to ensure the right people were taken on and that appliances were fully manned. One trend identified in target failures was the traffic.
97	<p><u>Community Speedwatch</u></p> <p>The Board received a presentation by Kaylie Griffiths and Sarah Holden, Community Speed Watch Officers, Wiltshire Police on how the Community Speed Watch scheme was working in the Southern Wiltshire Community Area.</p> <p>The presentation slides are attached to these minutes.</p> <p>Some of the points raised were:</p> <ul style="list-style-type: none"> • There were over 1000 volunteers across Wiltshire • Data for the last 2 years showed 5875 first offence letters were sent out, 492 second letters and 129 third letters. • The data collated and input by the CSW volunteers created a Heatmap, which built a bigger picture for communities, both with and without the volunteer groups. • Duty sheets were completed by volunteers • Police were able to make visits to volunteer groups to provide a visual support • Kaylie Griffiths – Community Road Safety Officer had been in post since June, carrying out a range of work and working with other sections of the force. • Recent online drop-in sessions were held, these would be repeated over the course of the year. • Gearing up for the drink drive campaign with 100 new breathalysers available to most of the patrol cars. • 3 new Speed Enforcement Officers joined the team

	<p>Comments and questions:</p> <ul style="list-style-type: none"> • The PCC did recently keep his promise to send Speed Enforcement Officers down to the Ridge in Redlynch where 11 tickets were enforced. • Did the force have a position on the automatic speed devices? <u>Answer:</u> That was a matter for the OPCC. The Police did not endorse one product and we are unable to accept the heatmap data from those devices. • Jim Weston – The Fire Service is involved with partnership work on the Stay Alive initiative. This has Hotspots and data. If you are not linked in with our road safety partnership team, get in touch as we are developing a new model working on data. • Alderbury PC regularly uses the shared device, was there scope for more devices? <u>Answer:</u> That is a matter for the OPCC. They were currently carrying out research to establish how active teams were. That may enable them to take a decision on whether to invest in more equipment. • Winterslow had previously set up traffic surveys at various places, prior to the pandemic. One road met the threshold for speed watch. Nothing had happened since, who would take that up? <u>Answer:</u> The data needs to be less than 2 years old

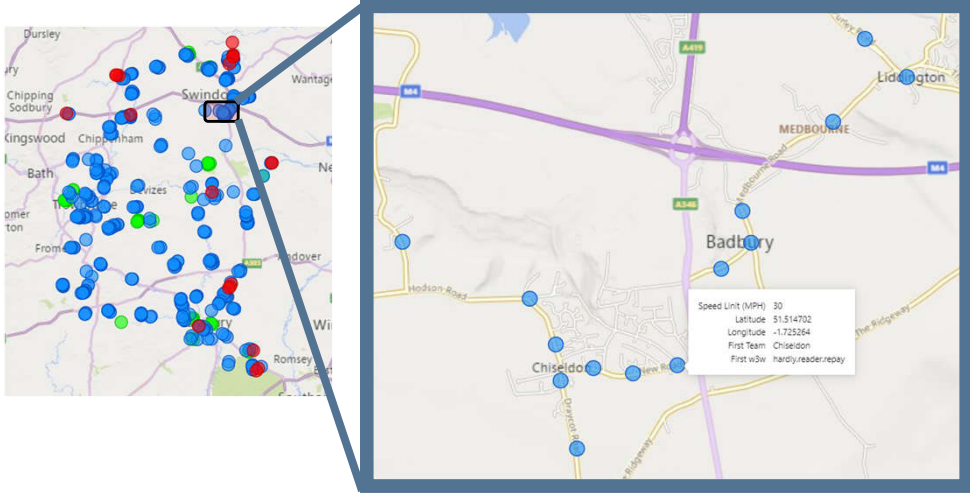

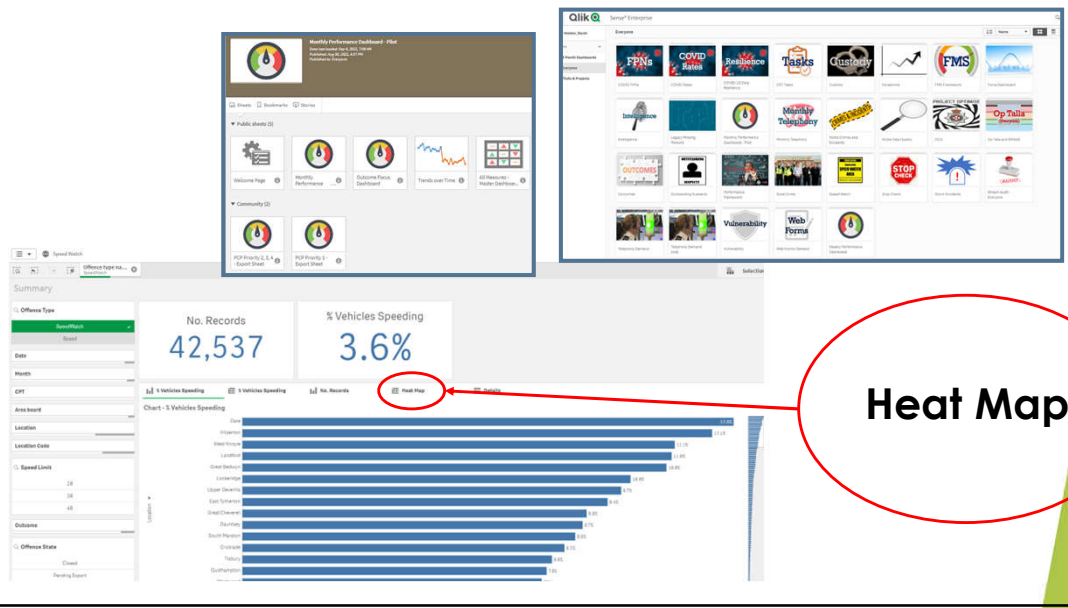

Cost of Living Update – February 2023

The following briefing note summaries sources of information and support, and actions that have been taken by the Council and partners.

For a summary of the resources and recent announcements, take a look at the Council's [dedicated Cost of Living page](#). This includes links to information for sources of national and local support.

The [interactive community directory](#) which helps people to search for warm spaces and community food providers in their area, also lists the easiest bus routes to help people find help more easily.

Free sims and mobile data from Wiltshire libraries

Wiltshire Libraries are working with the Good Things Foundation to distribute free SIMs and mobile data to people in need. The [National Databank scheme](#) is supported by UK mobile networks including Vodafone, O2 and Three.

The free SIMs and mobile data are available from Chippenham, Devizes, Salisbury, Trowbridge and Warminster libraries.

To be able to access the National Databank you must be 18+ years old and from a low-income household. One or more of the following must also be true:

- You have no or poor access to the internet at home.
- You have no or poor access to the internet away from home.
- You can't afford your existing monthly contract or top-up.

If you meet the criteria, [contact](#) Chippenham, Devizes, Salisbury, Trowbridge or Warminster libraries to find out more and to book an appointment.

Bus fare reductions over winter

Wiltshire bus users can now travel on most routes in the county for just £2 or less for a single fare until 31 March.

The fare price reduction has been funded by the Government and is aimed at getting more people to use buses across the country during the current cost of living challenges.

As part of the promotion, many single bus fares in Wiltshire have been capped at just £2 for both adults and concessions. If the single fare was originally less than £2, it will remain at the reduced price, and many day return tickets have also been reduced.

Vital help with energy bills for more homes – the Energy Bills Support Scheme (EBSS) Alternative Funding scheme

The EBSS Alternative Funding is a one-off £400 non-repayable discount to eligible households who have not received the main EBSS payment automatically to help with their energy bills between 1 October 2022 and 31 March 2023, but are still facing increased energy costs. Individuals will need to apply for the EBSS Alternative Funding via a Gov.UK portal which has yet to go live.

The Department for Energy Security and Net Zero (DESNZ) expects eligible households to include those with a commercial landlord or intermediary, such as park home residents and some housing association tenants. The EBSS Alternative Funding is expected to reach a significant number of vulnerable people, including self-funding residents in care homes. DESNZ is expecting approximately 900,000 households in Great Britain (around 3%) to be eligible for EBSS Alternative Funding. No household will be eligible for both the EBSS payment and an EBSS Alternative Funding payment.

Details of the scheme have yet to be published by the Government, and the Government portal is not yet live, but we expect it to be so in the last week of February. We will publish information on the website as soon as we know more.

Support for Council House Tenants and Housing Associations

The council's tenancy sustainment team has been supporting tenants through the ongoing cost-of-living crisis by assisting them to get access to more than £600,000 in new and backdated benefits, external grants and third-party debt cleared.

In addition, following funding received from the Government's Green Homes Grant, the Council has been improving the energy efficiency of 100 properties. This work has been received well by those who have benefited from it, particularly the fact that homes are being made more energy efficient amid the ongoing cost-of-living crisis. The council is currently focussing the project on those with the greatest potential increase in energy efficiency.

The Household Support Fund has also allocated funding to the Housing Service for outreach work to rough sleepers, and to support Council House tenants to combat hardship through the allocation of vouchers. This is building on the strong engagement work of this team, who under the people they work with well to provide the most effective support.

Through partnership working, and the sharing of information, we are highlighting to housing associations how their tenants can access support. We are confident that their tenants have been able to access services as, for example, Housing Association tenants made up 42% those being supported in the Wiltshire Installs project with 16% being Wiltshire Council tenants, Owner Occupier 28% and Privately rented 14% .

Households to get new cost-of-living payments from spring 2023

The Department for Work and Pensions (DWP) announced on the 3rd of January, more detail on the payment schedule for the next round of cost-of-living support unveiled in the Chancellor's Autumn Statement on 17 November.

The £900 payment for over eight million eligible means-tested benefits claimants (including those on Universal Credit, Pension Credit, and tax credits) starts in spring. Payments will go directly to bank accounts in three payments over the course of the financial year. There will also be a separate £150 for over six million disabled people and £300 for over eight million pensioners on top of their winter fuel payment.

Payments will be made automatically if individuals are eligible and there will be no need to apply. Claimants who are eligible for any of the cost-of-living payments and receive tax credits, and no other means-tested benefits, will receive payment from HM Revenue and Customs shortly after DWP payments are issued.

Exact payment windows will be announced closer to the time but are spread across a longer period to ensure a consistent support offering throughout the year. They will be broadly as follows:

- **£301** – First Cost of Living Payment – **during Spring 2023**
- **£150** – Disability Cost of Living Payment – **during Summer 2023**
- **£300** – Second Cost of Living Payment – **during Autumn 2023**
- **£300** – Pensioner Cost of Living Payment – **during Winter 2023/4**
- **£299** – Third Cost of Living Payment – **during Spring 2024**

Those eligible will be paid automatically, and there will be no need to apply. For more information, please visit [GOV.UK](https://www.gov.uk).

Winter Fuel Payment videos

Most of those eligible do not have to claim their Winter Fuel Payment, as it is awarded automatically.

People who have not been paid by 13 January 2023 are encouraged to check their bank account before contacting the Department's [Winter Fuel Payment Centre](#).

Energy support for businesses

The **Energy Bill Relief Scheme** launched in under Liz Truss and Jacob Rees-Mogg was Business and Energy Secretary for an initial period of 6 months end at the end

of March. On January 9, Government announced plans to replace the scheme, from the start of April, with a new **Energy Bill Discount Scheme (EBDS)**.

While the old scheme capped energy prices in a blanket fashion, businesses can only benefit from the new scheme when prices are at or above £107 per MWH for gas and £302 per MWh for electricity.

At this point, bills will automatically be reduced. This reduction applies to businesses, charities and public sector bodies and is less generous than previous support provided.

Higher discounts are on offer for energy-intensive businesses such as steelmakers and manufacturers. The threshold at which the discount kicks in is also lower for these firms

The EBDS will run for 12 months from 1 April 2023 to 31 March 2024

Warm & Safe Support

Wiltshire Council's friendly library staff are continuing to play their part too, by working with Warm and Safe Wiltshire and The Rural Communities Energy Support Network, to assist residents seeking basic energy advice and make referrals to experienced energy advisors in all but its smallest libraries. All libraries can signpost people to community partners and agencies that can support people through the rising cost of living. Libraries are also collection points for Warm Packs, which includes a hot water bottle and blanket, for anyone who would benefit from some free essentials. In all but the smallest libraries there are at least two energy champions who are trained to offer advice and support people to access help.

There are no criteria for anyone who might need to use the library as a warm space, staff and volunteers will be friendly and welcoming so that people feel as comfortable as possible. There are also opportunities to spend more time in the library to take part in board games, colouring, jigsaws and tea and chat where these are part of a local library programme.

Rural Communities Energy Support Network

The Rural Communities Energy Support Network, delivered as a partnership between the Council and the Centre for Sustainable Energy, is looking to recruit people from local communities would like to be able to offer people in their community more support around staying warm and keeping the bills down

Volunteers would gain access to training and resources so they can offer energy saving advice.

Warm and Safe advice service

The service has continued to play a prominent role in Wiltshire's cost of living support to low-income households, by providing energy, debt, bill advice, small grants, insulation advice and referrals. Since the beginning of October, the service has received **1009 enquires**, made **144 heating and insulation referrals**, **87 Priority Service Register sign ups** and provided **£26,000 in food and fuel vouchers** and distributed **£30,328 of Surviving Winter Grant** to Wiltshire households.

Boater Support

Public Health working alongside Economic Development secured UK Shared Prosperity Funding (UKSPF) to support the boater community, who find themselves disproportionately affected by the cost-of-living crisis. The funding has allowed Public Health to mobilise an outreach programme with Julian House to support our boating community with emergency fuel and food vouchers, within an extremely tight timescale to ensure the boaters secured the funding at a time of great need. The project was delivered throughout the 3-week cold period in December and helped **71 Boaters and 4 Roadside Travellers** with both fuel and food vouchers. Households were identified by Julian House based on eligibility criteria: low income, health condition, single parent and children with health condition.

Wiltshire Installs project

The Wiltshire Installs project is delivered by Warm and Safe Wiltshire and has been particularly busy this winter. The scheme aims to provide new boiler/repairs, Fuel and food voucher support to households that can demonstrate that they comply with the strict eligibility criteria: low income, have a health condition, their energy needs are off the mains Gas network and have a prepayment meter. The scheme has supported **209 households** since the beginning of October 2022, through a mixture of prepayment meter and food vouchers, in addition **11 new boilers** have been fitted where households have had a no heating situation.

Support for households that rely on life saving equipment.

Warm and Safe Wiltshire has worked in partnership with both Integrated Care Board and Adult commissioning to identify households that rely on life saving equipment, who are disproportionately affected by the high energy prices. Through November families have been offered support through the provision of food and prepayment meter vouchers, to date **13 families** have been supported.

Community Case Worker

This winter we have increased the ability to support Council, Primary Care, NHS and Voluntary and Charitable organisations with outreach work through the Community Case Worker project (Warm and Safe), which has allowed us to deliver 24 events, outlining the Warm and Safe service and the referral routes available to organisations to allow households ease of access into the service. In addition, this role has allowed us to provide 1 to 1 support and advocacy to people in crisis.

Wiltshire's Wellbeing Hub is available to help advise people through the cost-of-living crisis

As well as specific and general telephone contacts, the Council is making their Wellbeing Hub phone line available for people who may be worried about the cost-of-living crisis and needing some information and advice.

The hub was originally set-up at the start of the pandemic to provide information and advice. Anyone can access the hub and it can provide confidential advice, information, and signposting from the council's friendly team in relation to the current high cost of living.

People can call the hub Monday to Thursday 9am to 5pm and Friday from 9am to 4pm on 0300 003 4576 or email wellbeinghub@wiltshire.gov.uk. The opening hours will continue to be regularly reviewed depending on what the demand is for the service.

Promoting Fundraising Campaigns

As part of our work with our Voluntary, Community and Social Enterprise partners, Wiltshire Council is helping to promote the Wiltshire Community Foundation's [Cost of Living Appeal](#) through our networks.

Building on the work of previous appeals where people who can afford to are encouraged to donate any surplus winter fuel allowances, the wider community is being asked to help generate vital funds to help grassroots voluntary groups and charities in Swindon and Wiltshire who are supporting families and individuals in the face of escalating rent, food, and energy prices.

The money raised through this joint appeal will fund a new grants programme to support projects which are keeping people fed and warm and provide additional practical support and advice to help people cope throughout this period of great hardship.

Police and Crime Commissioner asks for public support to increase precept

A survey to gauge public reaction to a proposal which could see the average police precept rise by up to £15 a year has been launched by Wiltshire's Police and Crime Commissioner.

Residents from across the county are being encouraged to take part in a short survey where PCC Philip Wilkinson explains the current financial situation being faced.

Mr Wilkinson is responsible for ensuring Wiltshire Police has the necessary resources to fight and prevent crime. He holds the entire budget for policing in the county - made up of a grant from government and from the policing part of the precept contained within council tax.

An early indication of a 1% increase in the Government's grant means that if the police precept stays at the current rate of £241.27 for a Band D property, Wiltshire Police would have to make £5.5m worth of savings.

"As with everyone's finances during this time, Wiltshire Police is facing increased financial pressures too," Mr Wilkinson said. "This comes at a time when we really need to be investing in our policing service to keep people safe and prevent crime but also ensure the necessary changes and improvements to bring the Force out of the HMIC Engage process.

"During the last year, communities have reinforced the need for more frontline police officers – and I agree with them. Using your precept support, we will have more visible policing.

"Working with the Chief Constable, and on his operational advice, we are aiming to deliver 40 additional police officers for neighbourhood and volume crime teams by the annual review of the current workforce mix. This means Wiltshire Police will better meet the needs of our communities.

"These additional officers will bolster the Force's work in the community and in crime investigation and are in addition to the Uplift officers who are also coming through the recruitment and training pipeline into our communities, as well as those assigned to specialist roles and the rural crime team for example."

Yesterday afternoon (12 Dec), the Government increased the cap on police precept, without local referendum, so that PCCs can now potentially increase by up to £15 a year for a Band D household.

Originally, Mr Wilkinson could only increase the precept by 4.1% - through the police part of the council tax - and meant an average Band D household would pay an extra £10 a year, 83p a month or £251.47 annually.

Today's announcement means Mr Wilkinson could now increase by up to 6.2% and an average Band D household would be looking at an extra £1.25 a month, or £15 per year, with the total amount being £256.47 annually.

Mr Wilkinson said implications on finances if an average £15 precept increase per Band D household are now being worked upon and will be communicated to the public as soon as he is able.

"I understand any proposed increase, no matter how small, will be felt keenly," Mr Wilkinson added. "And the decision to ask residents for support for an increase has been difficult and one that I would not make if there was an alternative.

"Wiltshire is currently one of the lowest-funded police forces in the UK and the county's residents pay one of the lowest police precepts out of all the south west police forces - even with the proposed increases, this will remain.

"To ensure Wiltshire Police has the best possible financial position we have to consider utilising the increase in precept cap announced today, up to a maximum £15 a year and I will add this information in to my survey for residents to consider too. My financial team is currently working through this scenario and we have more information to support this in January."

More details on what savings and efficiencies will be made and where any precept increase would be invested will be available in the new year once confirmation of the central grant from government is received.

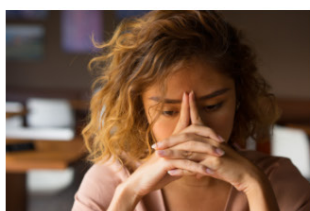

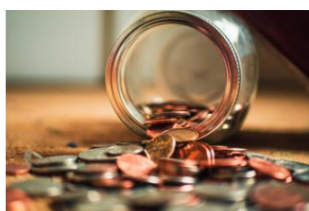

Village Halls Week 2023

Village Halls Week is an annual event organised by Action with Communities in Rural England (ACRE) in celebration of the 10,000+ village halls and community buildings in England. Village Halls Week 2023 will take place between 23rd-29th January and will celebrate how village halls provide warm, welcoming and inclusive spaces for all.

Community First supports 180+ village halls and community buildings in Wiltshire through the Wiltshire Village Halls Association Network (WVHA). We will be promoting Village Halls Week across our channels throughout the week and also encouraging halls and buildings to get involved holding a coffee morning, afternoon tea or soup and roll lunch as a fundraiser or get together. It is hoped that these events will help to showcase events and activities in village halls and community buildings and explain how trustees are working to make their hall warm, welcoming and inclusive. This is especially important as vulnerable members of our communities feel the impact of the current energy crisis.

Warm Spaces (Village Halls)

Impact of Energy Costs on Village Halls

Community First recently surveyed the WVHA network to find out what impact the increase in energy costs is having on halls and buildings locally. 114 member halls and buildings responded to the survey, which represents 61% of membership. Top level findings from the survey suggest that halls and buildings remain resilient despite increased energy costs and wider cost of living pressures. Despite this, there are future challenges ahead with fixed-term energy deals coming to an end and halls who are currently dipping into their reserves to stay afloat.

95% of halls/buildings will stay open throughout the winter, with 5% at risk of full or partial closure. This includes 2 halls who may close completely and 9 halls considering reduced opening hours. The primary motivation behind potential hall closures is the cost of heating the hall, including the cost of oil, electricity costs and other operational costs. 3 halls/buildings in Wiltshire are at permanent risk of closure due to increased costs.

The majority of halls (56%) are unable to offer a Warm Space this winter and whilst the cost of heating is a factor in this decision, many halls said that regular bookings prevent them from offering a warm space for the community. 8 halls/buildings will be offering a warm space (see above) and have been directed to the Wiltshire Council website to register their venue as a warm space. 42 halls/buildings are considering offering a Warm Space but do not yet have definitive plans. Community First will liaise with these halls and buildings should they require any additional advice or support.

Minibus Driver Awareness Training (MiDAS)

MiDAS is a membership-based scheme designed to enhance both driving and safety standards for drivers of minibuses. MiDAS is a nationally recognised standard for the assessment and training of minibus drivers. Community First is now taking new bookings for MiDAS minibus training with our Training Coordinator Martin Carter. Martin is a retired Police Advanced Driver with over 35 years' experience of driving minibuses.

The MiDAS training course includes a session on how to operate a minibus safely. This is followed by a 30-minute multiple choice assessment with 20 questions. Trainees will need to answer 16 questions correctly to pass the theory test. Finally, there will be a practical test which incorporates a driving skills training session and an assessment drive which will last just over an hour, with the assessment taking 30 minutes. Upon completion of the theory and practical test, trainees will receive a certificate which is valid for 4 years.

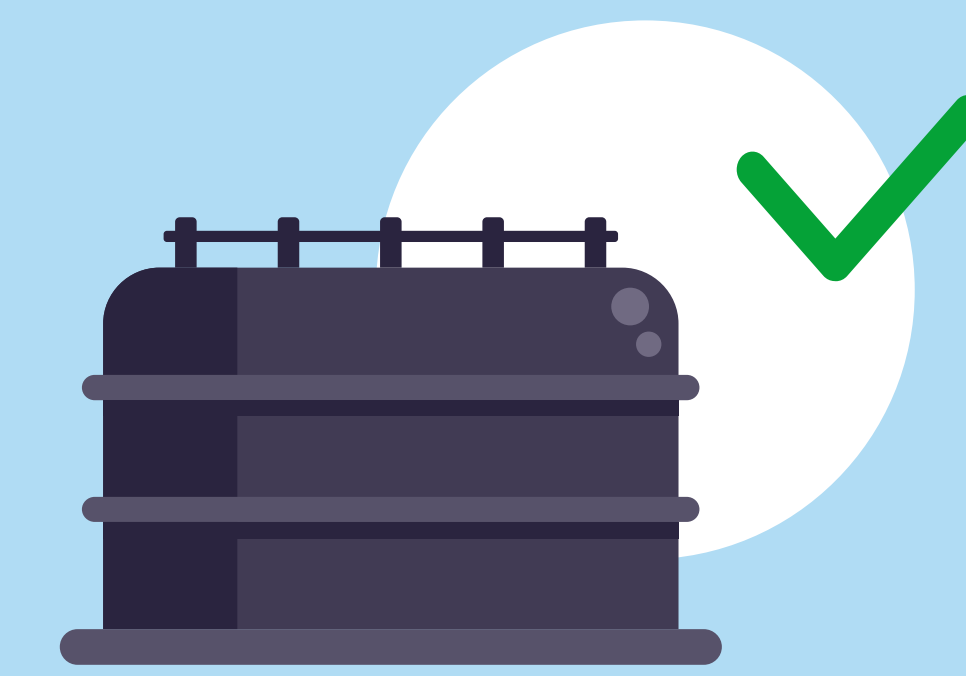

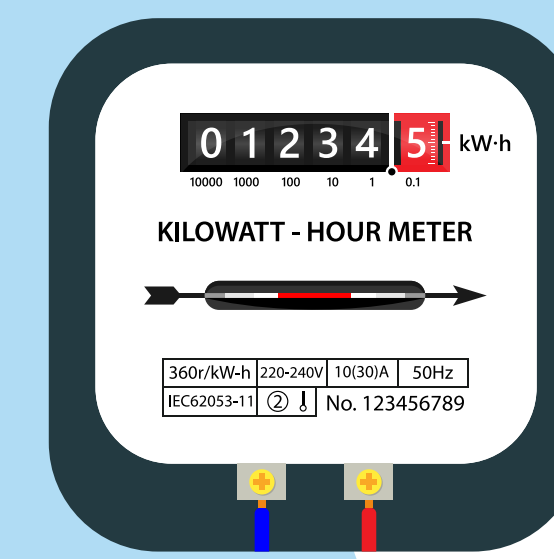
Factors affecting the ability of halls to remain open and viable

Considering *full closure* (2 halls)

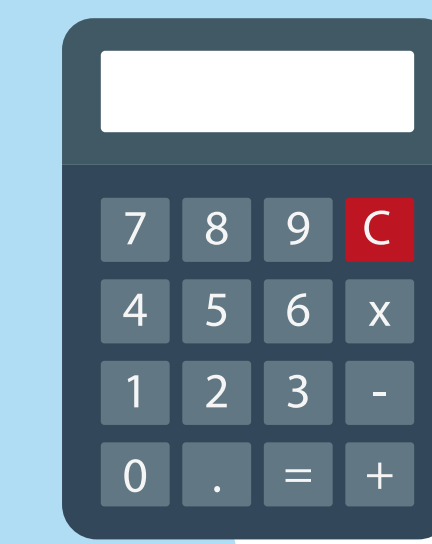

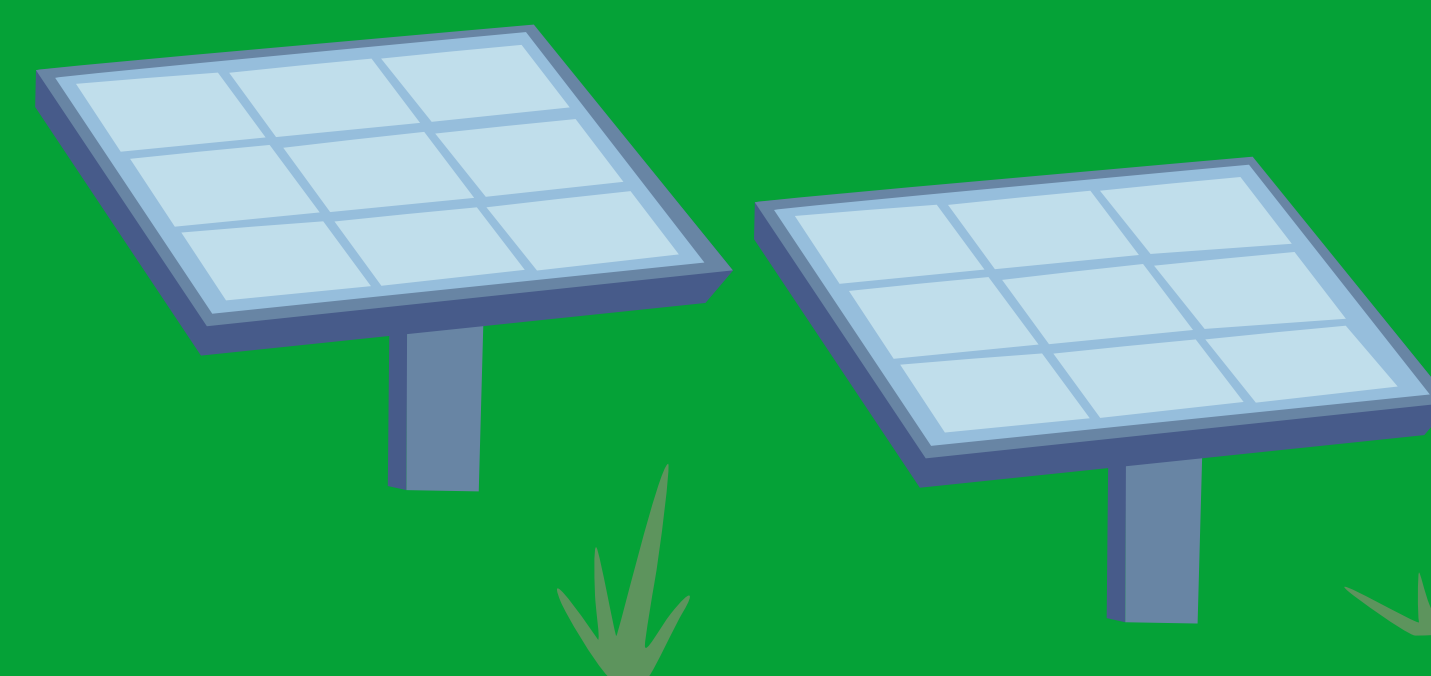

Health & Care Model

Winter Pressures

Members of the public can play their part in easing the pressure on the local NHS over the coming months by choosing the healthcare option most appropriate for their condition.

Many minor illnesses and injuries can be managed safely and effectively at home with rest and over-the-counter medication, while quick help for any person unsure of how to treat a less-urgent condition can also be sought from community pharmacies.

In addition, people can get useful medical information, including symptom details and at-home treatment plans, via their smartphone, tablet or laptop by visiting the NHS website at www.nhs.uk or through NHS 111 online.

Further information on health and care services across Bath and North East Somerset, Swindon and Wiltshire, as well as details of how to access local pharmacies, can be found at www.bsw.icb.nhs.uk.

Covid-19 and flu vaccinations

Any person in Bath and North East Somerset, Swindon and Wiltshire due a flu or Covid-19 vaccine is being encouraged to come forward before Christmas.

Getting vaccinated now or in the next few days will ensure that people's immune systems have enough time to respond to the vaccine and build up a good level of defence against both flu and Covid-19.

Vaccinations for Covid-19 are still available from a wide range of locations across the region, with many people now able to have the jab closer to home, with more community venues now acting as vaccine centres. People can find their nearest vaccination centre through the NHS website or by calling 119.

Flu vaccines are free for all adults over 50 years of age, as well as for some more vulnerable people, including pregnant women, those with a long-term health condition and frontline health and social care workers.

Devizes Health Centre

The new Devizes Health Centre is one of the region's first integrated care centres, this new state of the art facility will enable the delivery of enhanced services in an improved clinical setting for people in and around Devizes.

Patients of the four local GP practices – Lansdowne Surgery, Market Lavington Surgery, St James Surgery and Southbroom Surgery will be able to be referred for same or next-day medical care at the new health centre, making it easier for patients to access the care they need locally.

The healthcare facility will provide primary care services, such as those traditionally found in GP practices, along with hospital outpatient services, physiotherapy, audiology, blood tests, and mental health support. The new centre brings together providers so that patients can be looked after in the most joined-up way possible.

Devizes Health Centre will also lead the field in sustainable design, as one of a small number of net zero health facilities across England. The site will have an energy EPC rating of A+, and will utilise green technology, such as heat pumps and solar panels to enable the site to be self-sufficient.

Silver Salisbury Southern Wiltshire Area Board Feb 2023



Summary

Silver Salisbury reduces social isolation by promoting events and activities where older people will get a warm welcome. In July, 2022 we were awarded a grant of £500 by Southern Wiltshire Area Board. This funding enabled us to develop the work already underway using the £990 Southern Wiltshire Area Board awarded to us in January 2022 and support from The National Lottery Awards For All and Wiltshire Community Foundation. This was initially to undertake an outreach programme to consult with around 80 older people in the Downton area. The older people we met were keen to get out and about again but were often unsure of what was available locally. This was particularly true for people that were not on-line.

Funding from the Southern Wiltshire Area Board helped us print and deliver paper activity guides in the Spring and Autumn InDownton newsletters. We also distributed 5000 copies of Silver Salisbury's 55-page Autumn Programme of activities in Salisbury, Amesbury, Wilton and Downton, including around 500 in the Downton area. We received great feedback from older people who had tried new things and met new friends. Local support services, such as the Wiltshire Council Prevention and Well-being Team and the Social Prescriber at Downton Surgery told us that the guides helped them in their work tackling loneliness and isolation.

How we used our funds in 2022

We carried out a research programme in Downton between February and November 2022.

We designed a questionnaire and visited groups popular with older people such as the Good Companions Club, Lover Repair Café and Fridays to encourage participation. An online version of the questionnaire was also available and advertised through the library and the Downton Surgery. We ran a focus group at Downton library and issued 60 questionnaires with pre-paid envelopes via the Downton Link scheme. There was a useful meeting with an older people's representative from the Lode Hill Travellers' Site. Overall, we printed 200 questionnaires; 56 were completed, giving a completion rate of 28%. There are around 500 over 65-year-olds in the built-up area of Downton so this was a good response.

Our consultation sessions featured group discussions where we shared our knowledge about local activities. This was particularly important in the early days after the lockdowns as many people that weren't on-line weren't aware of what had re-opened.

Transport emerged as a key issue early on. 30% of people said this was preventing them from leading the life they would like to lead. People were unsure of the scope of the local Downton Link scheme. We met with the Link team and were able to let people know that services were back to normal after lockdown, including support for social trips and befriending services.

We researched local clubs and activities. The results were presented in a paper guide to places in Downton where older people would get a warm welcome. We wanted this to reach as many older people as possible, so we contacted the InDownton newsletter team. They were very supportive, and we used some of our funding to pay for a 4-page colour supplement in the InDownton Spring newsletter. The InDownton team delivered this 'cut-out-and-keep' guide, which also included information on the Downton Link scheme, to 1300 local households in March. We also paid for the printing of 150 stand-alone copies of the guide, which were distributed in places like the Lover Repair Café, clubs, shops, and petrol stations. The guide included an offer of afternoon tea deliveries to people that were housebound, but we didn't get any takers for this offer.

The April Silver Salisbury Spring Newsletter, promoting activities further afield in Salisbury, Amesbury and Wilton included a section promoting the Downton guide and other new initiatives in Downton, including the Make a Friend, Be a Friend Scheme and the Friday's Social Group. This was shared through the Downton and mobile libraries, the Wiltshire Council Housing Engagement team, clubs, shops and local older people's groups.

The main Silver Salisbury programme in the Autumn also included a Downton section as well as information on community transport options and Age UK's travel companions' scheme. To help people see what was available locally, we paid for a printed 2-page summary of local events in the InDownton newsletter and promoted this in Downton library.

Our consultation work informed the content and layout of our Autumn Silver Salisbury programme. This was a printed 55-page guide to 59 local regular groups and 36 one-off events that welcomed older people in Salisbury, Amesbury, Wilton and Downton. We researched activities that people wanted to know more about and provided information. This included the re-opening of the Silver Screen cinema session, singing groups, an art group and a support group for bereaved people. Funding from the combined Area Boards enabled us to print 5,000 paper copies of the brochure which were distributed across Salisbury, Amesbury, Wilton and Downton. Around 500 copies were distributed in Downton.

We have provided information to help older people make new connections. Printed brochures and phone numbers made the events accessible to the digitally excluded. One visitor said, *'The paper programme was such a help'*.

Impact of our activities in 2022

- We met two ladies from Downton at a "Senior Youth Club". They'd started going in April and were still attending six months later. They spoke about how they enjoyed the activities including pool, crafts, board games and a hot lunch. They had made new friends, who they met up with outside the club. They'd had no idea about the group until they'd seen our Spring Newsletter but were glad, they'd made the effort to get out and try something new. They picked up another person who didn't get out as much along the way, so all three of them had a regular meet up.
- One lady who'd received the InDownton guide said, *'It was great having everything in one place, so I could sit down with my mum and talk about the things that are on and how she can start getting out and about again. We've stuck it on the fridge to remind us of what she can go to'*.
- Several people have phoned us, and we've been able to help them with information on activities and support services. This included a lady we were able to refer to the Downton Link befriending scheme and a man who was delighted to receive a brochure saying, *'I had no idea there was so much I could go to locally'*.
- We've promoted the work of the local Community transport and Link schemes, raising awareness of the full range of services on offer, including support for social trips and befriending schemes.
- We've built connections with social prescribers; patient leads and members of the Wiltshire Council Prevention and Well-being team. They have told us how our guides and programmes help them in their work improving the well-being of isolated people. One said, *'It's my bible'*, another *'A very useful resource, please let me have the next edition'*.
- Many of the groups we promote are run by older people. We've been pleased to promote the work of more than 150 volunteers. We've also advertised volunteering opportunities for the community transport teams, Arundells and Alzheimer's Support Wiltshire.

- Around 1,000 older people came along to the one-off events in the Autumn programme, which ranged from a jazz social to history talks, to a coffee morning on living with dementia, to visiting historic buildings and taking tea with a pony. There was an ArtCare History Talk in Downton. It is difficult for us to determine how many of the 1,000 attendees came from the Southern Wiltshire Area Board area, but we expect this to be a reasonable number. The organisers of the 59 regular groups featured told us it was difficult to keep track of where new joiners had come from but estimated that at least 64 people attended new regular activities because of the programme.

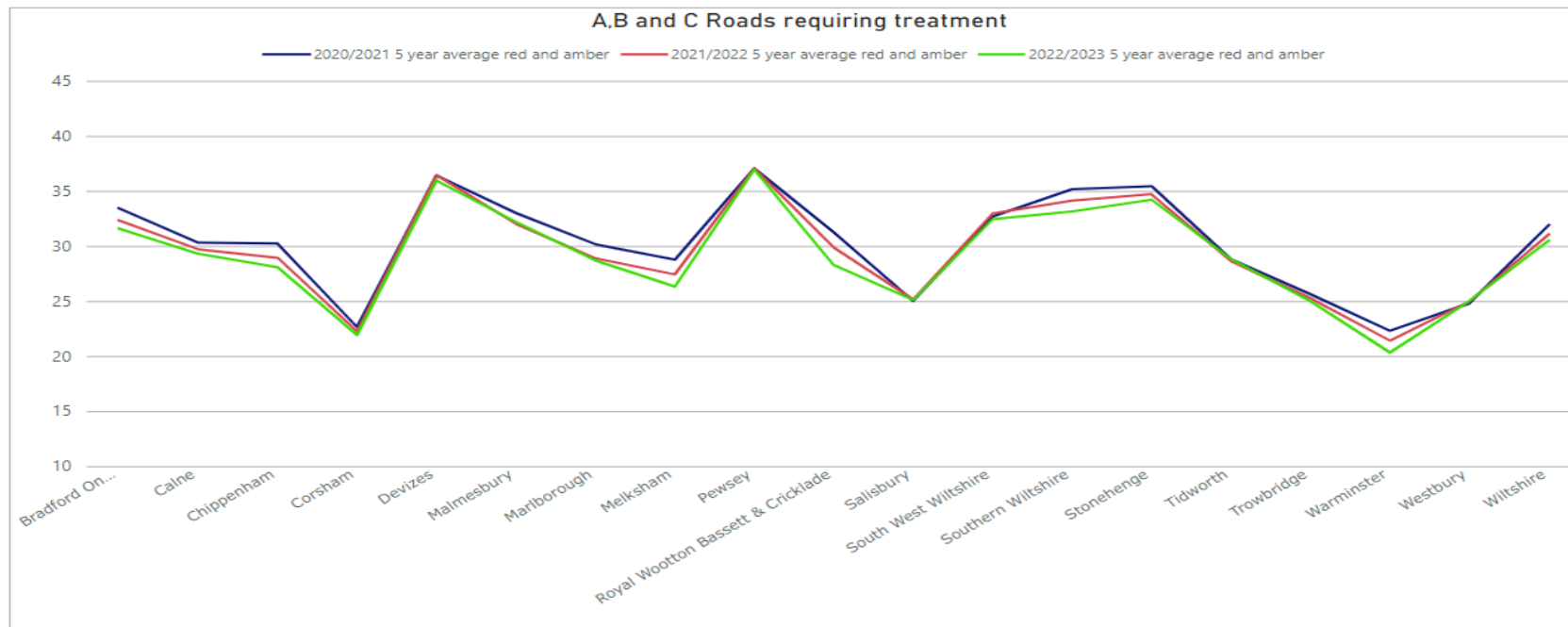

A 5 year average is used to monitor the condition of the network due to the surveying regime of undertaking a 50% network length

The graphs show that even with a deteriorating network the targeted maintenance schemes are generally improving the overall condition of the roads within Wiltshire, a rolling 5 year programme and funding process is designed to allocate resources to those areas with a higher percentage of poor roads based on their network length.

The target is for all area boards to be at the same low level of around 20% of the network requiring some form of maintenance

The current hyperinflation situation following the war in Ukraine has seen unprecedented increases of greater than 20% in the cost of Highways Major Maintenance works over the last year leading to a reduction in the amount of surfacing and surface dressing works that we have been able to undertake. It is anticipated that costs will continue to rise over the next year at least, with no corresponding increase in investment, indeed indications are that a reduction in Central Government funding to Local Highway Authorities may be forthcoming. Wiltshire Highways will continue to work to obtain the best value for money and maintain the highway network under these challenging conditions. The following pages detail the schemes that have been considered in the forward plan in priority order for each treatment type.

Engagement and Partnerships report

The Southern Wiltshire Area Board in May 2022 reviewed available local data and evidence, and integrated this with local knowledge and community conversation to agree the following local priority themes:



- ❖ **Addressing environmental issues**
- ❖ **Youth engagement and rural youth outreach**
- ❖ **Support older people and vulnerable adults' health and wellbeing**

Each priority theme has a series of more specific local actions that the Strategic Engagement and Partnership Manager and Area Board Delivery Officer will work with the Southern Wiltshire Area Board to positively address them. The full action plan can be found at the end of this document.

Two examples of support and change that the Area Board has influenced since last updating in November 2022 are:

Priority

Support older people and vulnerable adults' health and wellbeing

Encouraged Redlynch Parish Council and volunteers in Winterbourne Earls to host 2 silent disco events for older people in early 2023 – following the success of the last silent disco in Downton in October 2022.

Youth engagement and rural youth outreach

Supported a new youth pop up event at Hampton Park Pavilion in Laverstock during the February 2023 half term holiday, and facilitated partnership discussions with the parish council, local faith leaders and youth facilitators from the Bridge Mentoring initiative to develop new youth support in the parish.
