90	Declarations of Interest

91	Chairman's Updates
	The Chairman made the following announcements:
	<ul> <li>The consultation on proposed reforms to the National Planning Policy Framework (NPPF), was due to close at 11.45pm on 24 September.</li> <li>A progress update on National Grid's project to remove pylons from the North Wessex Downs National Landscape was available on pages 13-15 of the agenda pack. The Chairman was a member of the Community Liaison Group and they were due to hold a meeting in the coming weeks. The service road installed during the project would not become a new bypass.</li> </ul>
	• A paper would be presented to Wiltshire Council's Cabinet to consider ways to mitigate the impacts of the cancellation of the A303 Stonehenge scheme by central government.
	<ul> <li>Wiltshire Council were investing an additional £22 million into highways, enabling improvements in road safety.</li> </ul>
	<ul> <li>Traffic lights were due to be installed at Black Dog crossroads on the A360, with work due to begin in 2025, once SSE had installed power on the site.</li> </ul>
	<ul> <li>Following a feasibility scheme, detailed design work was underway on a range of measures to improve road safety on the A361 at Caen Hill including installing traffic lights on the staggered junction with the B3101 at Marsh Lane. There had been a road traffic accident at Caen Hill the previous weekend, showing the importance of the issue.</li> </ul>

	Chief Constable Catherine Roper was due to attend the Area Board's
	next meeting on 18 November 2024.
	Th Vice-Chairman also took the opportunity to give an update about the consultation on the Devizes Public Spaces Protection Order. He was pleased to report that the consultation, which had now closed, had received over 800 responses and around 90 percent of those that had responded were supportive of the proposals. Suggestions about how the scheme could be improved, such as plans for disbursement of individuals causing issues, were being taken onboard. It was planned to implement the scheme within the next two months.

	Wiltshire Road Safety Partnership
	Perry Payne from Wiltshire Road Safety Partnership gave an overview of their work to improve road safety. Points included:

	<ul> <li>They were a multi-agency partnership working across three main workstreams, engineering, education and enforcement.</li> <li>The areas of focus of the different organisations within the partnership were outlined.</li> <li>Wiltshire Police were upgrading the data system used to report road traffic collisions. This data was utilised to undertake "cluster analysis" to identify sites where collision reduction measures might be effective.</li> <li>For every road traffic accident causing a serious injury there were 12 that did not.</li> <li>Town and parish councils could contact the Area Board's Local Highways and Footpaths Improvement Group (LHFIG) to apply for traffic surveys to be undertaken.</li> <li>Education about road safety was key as, in 2017, 27 percent of people that died in cars on the road were not wearing a seatbelt.</li> <li>Dorset and Wiltshire Fire and Rescue Service had helped to deliver the Safe Drive Stay Alive presentation to 5,000 students and the Survive to Drive presentation to 4,500 military personnel.</li> <li>Thanks were given to Community Speed Watch (CSW) volunteers who played a role in educating drivers and informing enforcement activity.</li> <li>Between July 2020 and 22 August 2024 there had been 769 watches carried out leading to 4,021 letters being sent.</li> <li>The Police and Crime Commissioner's office funded three Community Speed Enforcement Officers. Between 1 January 2023 and 22 August 2024, they had been active in 64 locations in the Devizes area and were responsible for sending people on 322 speed awareness courses and sending eight people to court.</li> <li>Wiltshire Police's Road Policing Unit focussed on a number of different aspects of road safety including weight limits, driving without an MOT and tachograph issues (breaches of driver rest time regulations).</li> </ul>
	• Crossing roads whilst looking at 'phone screens was an increasing risk to
	pedestrian safety.
Du	uring the discussion, points included:
	<ul> <li>The Area Board thanked Mr Payne for his update.</li> <li>In response to a query about the enforcement of breaches of the new 20mph speed limit on Victoria Road in Devizes, Acting Inspector Chris Wickham noted that Devizes Neighbourhood Police Team would look into the issue.</li> <li>The importance of using data to inform speed enforcement activity was emphasised.</li> <li>It was possible to submit photographic and video dash cam evidence of speeding incidents through Operation SNAP online.</li> <li>Thanks were given to the police for their swift response in undertaking the traffic survey on Brickley Lane, near Roseland Avenue. It was observed that a similar survey on Windsor Drive had been void and it was requested that local councillors be informed when this happened.</li> </ul>

<ul> <li>Mr Payne noted that information about the void result was available on page 80 of the agenda pack and that the issue could still be pursued through the LHFIG.</li> <li>A query was asked about how data used in cluster analysis could be questioned, as a freedom of information request to South West Ambulance service from Seend Parish Council had revealed that there were accidents that had not been recorded in the analysis undertaken on a crossroads in their parish. Mr Payne noted that the analysis used national guidelines and that they were working to improve coordination with the NHS.</li> <li>The impact of the Safe Drive Stay Alive initiative was praised. Mr Payne noted that Dr Elizabath Box from Road Safety GB had conducted research questioning a fear led educational approach. As a result, the sessions were now less hard hitting with a greater focus on empowerment and developing positive habits.</li> </ul>
Wiltebire Delige Devizes Neighbourboad Team
<u>Wiltshire Police – Devizes Neighbourhood Team</u>
Acting Inspector Wickham gave an update on behalf of the Neighbourhood Team. Points included:
<ul> <li>Inspector Simon Garrett would be taking over leadership of the team from October with Acting Inspector Wickham returning to become Neighbourhood Sergeant.</li> <li>Crime statistics were stable, with a decrease in the number of theft attended</li> </ul>
<ul> <li>offences.</li> <li>Although crimes recorded as "violence against the person" were slightly up on the same period in 2023, they had reduced over the past two months.</li> </ul>
<ul> <li>The percentage of burglary investigations where further action was taken was low nationwide, although Wiltshire was a percentage point higher than comparable forces in July and August.</li> </ul>
<ul> <li>Two adult males had recently been charged in relation to burglaries at a café and fish and chip shop.</li> </ul>
• There had been additional police presence in the centre of Devizes to provide reassurance following an attempted murder on Sidmouth Street on 29 June. A suspect had now been charged and was awaiting trial.
• Three suspects had also been charged in relation to a domestic murder in Easterton, on 3 July, and were due to go to trial in February.
<ul> <li>In both incidents the victims and suspects were known to each other and there was not believed to be any increased threat to the wider public.</li> </ul>
<ul> <li>There had been a recent spike in the number of motorcycle thefts.</li> <li>Business crime continued to be a priority and Devizes had a really good</li> </ul>
<ul> <li>Business crime continued to be a priority and Devizes had a really good Shop Watch programme.</li> </ul>
• The Neighbourhood Team had been conducting lots of community engagements, including a Facebook Live and Acting Inspector Wickham

	appearing on Fantasy FM. They had also been working alongside street wardens funded by the Police and Crime Commissioner.
	During the discussion, points included:
	<ul> <li>The Area Board thanked Acting Inspector Wickham for his update.</li> <li>In response to questions about reoffending rates and the impact of the early release of prisoners, Acting Inspector Wickham explained that he would try to obtain the statistics. He noted that prisoners were only being released slightly earlier than planned and that individuals deemed to be a significant risk were not being released early. He was only aware of two individuals from the Neighbourhood Team's area that were due to be released early. The focus was on safeguarding individual victims and providing reassurance.</li> <li>Thanks were given for the increased visibility of the police.</li> </ul>
	Cllr Philip Whitehead left the meeting at 19:35pm and returned at 19:40pm.
	<u>OpenDoors</u>
	Noel Woolrych referred the Area Board to the report on pages 87 to 92 of the agenda pack. He took the opportunity to thank the charity's supporters. He explained that they were working with the probation service and also trying to arrange for a mental health practitioner to support their guests.
	<u>CCTV</u>
	Noel Woolrych gave an update about upgrades to CCTV cameras in the town's car parks. The new cameras had helped to identify a suspect spraying paint on parking machines, as well as assist the police with other enquiries.
	Fairtrade Devizes
	Jasper from Devizes Fairtrade Gorup reported that Patrick Kaberia, a tea producer from Michimikuru in Kenya, was in Wiltshire spending time in Calne, Corsham and Bradford on Avon to talk about fairtrade and climate change. Mr Kaberia was due to visit Devizes on 19 September to give a speech at 7pm in Devizes Town Hall. Fairtrade refreshments would be available and he would speak with local farmers about their different experiences of the challenges presented by climate change. He encouraged people to attend the event and to do what the could to buy fairtrade goods.
94	Area Board Priorities Updates
	Lead councillors gave updates about the progress that had been made towards their priority areas:

	Addressing Climate Change and Protecting the Environment
	Cllr Tamara Reay thanked members of the Air Quality and Sustainable Transport Group for their support and challenge. She explained that bus routes had been updated and that Demand Responsive Transport routes had been extended to locations such as Marlborough, Hungerford and Tidworth. She also reported that the Devizes Local Cycling and Walking Infrastructure Plans were being progressed to improve cycling and walking routes, including on London Road.
	Improving Opportunities for Children and Young People
	The Vice-Chairman gave an overview of the youth activities that had taken place over the summer, which had been part funded by the Area Board. These included events in Bromham and West Lavington, as well as an event in Waiblingen Way to help highlight Family Hubs. He also reported that the Neighbourhood Collaborative were planning an event in October to help tackle self-harm in young people.
	The Vice-Chairman took the opportunity to praise Wiltshire Youth for Christ who had been running summer pop-up and mentoring sessions.
	Cllr Laura Mayes gave a brief update on the opening of the new Silverwood School at Rowde for up to 400 pupils with Special Educational Needs. She explained that the first pupils had started the previous week and that she was looking forward to making her first visit to the school.
	Supporting Those in Greatest Need to Improve Their Resilience
	The Chairman highlighted the success of the recent community event in Waiblingen Way. In addition, he noted that the Area Board had provided support to foodbanks and in purchasing food vouchers. They had also helped people to purchase items to reduce their energy costs.

97	Air Quality and Sustainable Transport (AQST)
	Cllr Tamara Reay gave an overview of the recent work of the Air Quality and Sustainable Transport Group (AQST) following their meeting on 13 September. Points included:
	<ul> <li>The AQST Group had received an update from Wiltshire Council's Passenger Transport Team about changes to bus services being implemented from September 2024.</li> <li>The £2 bus fare scheme had been continued.</li> <li>An X2 bus would run a faster route between Devizes and Salisbury via Stonehenge.</li> <li>A new Sunday daytime service, the X33, had been launched between Devizes and Chippenham.</li> <li>Extra journeys had been introduced on the number 273 bus between Devizes, Melksham and Bath.</li> <li>A greater number of busses would be available for Demand Responsive Transport by stopping some timetabled services in the middle of the day between Devizes and Marlborough that had attracted a very small number of passengers.</li> <li>Wiltshire Connect Demand Responsive Transport would operate over revised hours, between 8am and 7:30pm, on Saturdays.</li> <li>The number 49 bus would run more frequent journeys in the evening. On Sundays, the bus would run every hour.</li> <li>Initial design work for improvements along London Road, as part of the Local Cycling and Walking Infrastructure Plan (LCWIP), was being considered. Detailed design work was expected to commence in May 2025, with work predicted to take place in 2025/26.</li> <li>A new leaflet about walking and cycling was being produced.</li> <li>ClIr Reay was overseeing the development of Wiltshire's Local Transport</li> </ul>

	Plan 4 (LTP4) strategy covering the period 2025-2039. Once the plans had been developed, they would go out for public consultation in the autumn so that residents could have their say.
98	Area Board Funding
	The Area Board noted the budgets remaining for allocation at the meeting, including that there would only be £3,232.59 available in capital funding for the remainder of the financial year if all the Community Area Grants were awarded in full. They heard from representatives in attendance who gave a brief overview of their projects and answered questions.
	Community Area Grants
	Worton and Marston Village Hall Requesting £5,000 Towards a Kitchen Refit
	The applicant was unable to attend so Cllr Tamara Reay gave an overview of the application. During the discussion, the Area Board spoke of their desire to support the project but also about the importance of retaining funding for future applications later in the financial year.
	On the proposal of the Chairman, seconded by Cllr Reay, it was resolved to make the:
	Decision
	To award Worton and Marston Village Hall £5,000 in principle towards a kitchen refit, with £2,500 being awarded immediately and the remaining funding to be made available at the end of the financial year if sufficient money was left in the budget.
	<u>Reason:</u> The application met Community Area Grant criteria 2024/25. There was insufficient funding remaining to award the funding in full at the meeitng and maintain sufficient funding to support other applications during the course of year.
	West Lavington Village Hall Requesting £3,938 Towards Radiant Heating Installation
	Paul Bryant from West Lavington Village Hall spoke in support of their application. During the discussion, the Area Board stated that they were supportive of the project but also cognisant of the need to balance capital funding throughout the year.
	On the proposal of the Vice-Chairman, seconded by the Chairman, it was resolved to make the:

#### Decision

To award West Lavington Village Hall £3,938 in principle towards radiant heating, with £1,969 being awarded immediately and the remaining funding to be approved at the end of the financial year if sufficient money was left in the budget.

#### ICB updates for Wiltshire Area Board – October 2024

#### New provider of integrated community-based care

People in Bath and North East Somerset, Swindon and Wiltshire will receive more health and social care in or near their homes, in a more joined-up and streamlined way.

HCRG Care Group has been appointed to lead an innovative new community-based care partnership with the NHS, local authorities and charities that will transform the care and support that people get to help them with their health and wellbeing at every stage of their lives.

Traditional community services such as nursing, therapy and personal care will be enhanced as they become part of new integrated neighbourhood teams, working across homes, care homes, clinics, schools and community centres to bring more personalised support to local people.

The aim is to build on the services that are valued by patients and their loved ones, as well as giving people more support in living healthier lives.

Among the benefits local people can expect to see will be:

- A single place or front door to get community-based care, help and support. The new front door will be fully accessible to all, and be available in a face-to-face location, as well as online and over the phone.
- At least £7m a year will be invested in partnerships with VCSE providers to build community capacity to provide early help and support within communities from the end of 2027.
- Inappropriately located or outdated buildings will also be refurbished or phased out.
- Transforming the way that people access care will also reduce the pressure on GP practices and hospitals, which are seeing more people with health problems that could be effectively treated closer to home.

#### Local NHS invests millions to help patients get diagnostic care closer to home

Tens of thousands of patients living in Bath and North East Somerset, Swindon and Wiltshire requiring diagnostic care can now access the services they need sooner and closer to home thanks to a multimillion pound investment by the local NHS.

A £14 million cash injection has enabled three new community diagnostic centres to open across the region, with each of the sites providing the type of diagnostics that once would have only taken place inside a hospital.

Having services such as ultrasounds, echocardiograms and MRI scans based in the community means people awaiting diagnosis, including those with symptoms that could be cancer, can be seen quicker and begin any required treatment sooner.

The first centre opened at the Sulis Hospital in Bath in March 2023, and was followed in March and April of this year by two new sites, with one based at the West Swindon Health Centre and the other at Salisbury Centre Health Clinic.

#### Eligible groups encouraged to get vaccinated against flu and Covid-19

The second phase of the winter vaccination programme has begun for those in Bath and North East Somerset, Swindon and Wiltshire.

Vaccinations against flu and Covid-19 are now available for people aged 65 and over, those with a weakened immune system, carers, care home residents and front-line workers in social care and health care.

Following the initial launch last month, inviting pregnant women and children for their flu vaccinations, from Thursday 3 October anyone eligible for vaccinations can book online at www.nhs.uk, by downloading the NHS App, or by calling 119.

In addition, the NHS will be sending out invitations to those eligible to get their jabs, while GP practices and other local NHS services will also be contacting people to offer the vaccines.

These vaccinations provide vital protection, helping to prevent serious illnesses and reduce hospital admissions during the busy winter months.

#### ICB Non-Executive Director to join mental health trust

Paul Miller, Non-Executive Director at Bath and North East Somerset, Swindon and Wiltshire Integrated Care Board, has been named as the new Chair of Avon and Wiltshire Mental Health Partnership NHS Trust.

Paul will step down from his role at BSW ICB at the end of October 2024 to take up the role of Chair at the mental health, learning disability and autism provider on 1 November 2024.

He has been a non-executive director since the establishment of the integrated care board in July 2022.

Stephanie Elsy, BSW ICB Chair, said: "We are very grateful for Paul's active support in the first two years of our ICB.

"This has been a pivotal time as we have developed the first integrated care plan that outlines the priority areas that we need to tackle to bring the most benefit to local people."

#### Independent investigation of the NHS published

In July 2024, the newly appointed Secretary of State for Health and Social Care, Wes Streeting MP, commissioned Lord Darzi to conduct an immediate and independent investigation of the NHS.

Lord Darzi's report has now been published and provides an expert understanding of the current performance of the NHS across England, as well as the challenges facing the whole health and care system.

Within the report, Lord Darzi used the most recent data and intelligence to assess:

- Patient access to health and care
- The quality of health and care being provided
- The overall performance of the health and care system

#### Busy summer for urgent and emergency care services

Emergency departments in the NHS experienced the busiest summer on record, with around 6.8 million people coming forward for urgent care during June, July and August.

In total, 6,776,150 people attended an emergency department in England during the three-month period, which is an increase of more than 240,000 when compared to the previous year.

Local emergency teams also had a very busy summer, with the region's three hospitals – the Royal United Hospital in Bath, the Great Western Hospital in Swindon and Salisbury District Hospital – seeing a combined attendance of 79,787.

The busiest month of the summer came in July, when the combined attendances for each of the three hospitals totalled more than 27,000.

Professor Sir Stephen Powis, NHS National Medical Director, said: "The NHS has just come out of the busiest summer on record for A&Es across the country, and preparations are already under way for what is expected to be an extremely difficult winter."

#### Cost of Living

As we prepare for winter, there remain some financial pressures on household budgets, and it is anticipated that there will be continuing demand for support and advice.

Overall inflation is relatively stable at 2.2%<sup>1</sup>, which suggests that some cost pressures for the community have reduced. However, for example, under the new energy price cap, gas and electricity prices will rise by 10% in England, Scotland and Wales from October<sup>2</sup>.

The Council, therefore, is continuing to work with partners to deliver interventions that provide advice and support to our communities, including:

- Wiltshire libraries are continuing as warm spaces and as sources of advice.
- We will contact community providers to update our <u>interactive guide</u> to help people find key support to combat fuel and food poverty. In addition, we are creating a page on the directory that gives an interactive advent calendar view of provision/ opportunities over the Christmas period.
- Wiltshire bus users can continue to travel on most routes in the county for just £2 or less for a single fare until the end of December 20243. The fare price reduction has been funded by the Government and is aimed at getting more people to use buses across the country during the current cost of living challenges.
- Ahead of the Government announcement to extend the Household Support Fund by 6 months from the 1<sup>st</sup> of October<sup>4</sup>, we are analysing the impact of schemes delivered under the programme so can further develop our approach to ensure that

those households most in need are targeted for support. A full report is expected at Cabinet in October.

- Pending confirmation of funding, Foodbanks and Community Food Providers will be invited to apply for funding to support their work.
- <u>Our website</u> and media channels offer a range of online support and sign-posting information on topics including council tax/benefits, energy advice and mental health support.
- A dedicated Wiltshire Wellbeing support line to provide advice and guidance, and officers are working with to improve processes to ensure people are directed to right support. Contact details on the phone are: 0300 003 4576, and email is: wellbeinghub@wiltshire.gov.uk
- With change to the eligibility of Winter Fuel Payments<sup>5</sup>, the DWP has been encouraging the take up of Pension Credit<sup>6</sup>. The Council has also been promoting the take-up of Pension Credit to those who may be missing out.

#### FUEL Programme

The Council is pleased to say that, following a successful summer programme that saw more than 1,500 young people make around 2,000 bookings at over 41 locations. Wiltshire Council's Holiday Activity and Food programme (FUEL) will be back during the Christmas school holidays. It is funded by the Department for Education and provides children who are eligible for benefits-related free school meals with free access to activity, food and nutritional education during school holidays. Eligible families will be able to sign up later in the year and details will be promoted through all schools in Wiltshire in due course. #### Wiltshire Director of Public Health Annual Report 2023/24

Health coaches, a boaters' survey and webinars to promote wellbeing in the workplace are some of the key activities Wiltshire Council's public health team has focused on in the past year.

The details and impact of the work is summarised as part of the <u>latest independent</u> annual report on the health of people in Wiltshire.

Wiltshire Council's Director of Public Health, Kate Blackburn, is required to produce an annual report each year to highlight the health of the population, raise awareness of local health issues and make recommendations for change.

Wiltshire's population demographics are detailed in the Joint Strategic Needs Assessment, in summary:

- Current population of 510,400, 51% female and 49% male, expected to increase by 7% to 547,864 by 2040
- Over 65s makes up nearly a fifth of the population, but by 2040 this age group will make up nearly a third of the total population
- Wiltshire is in the least deprived 30% of local authorities nationally

In 2022, the public health team established 10-year Public Health Priorities which included identifying four Public Health Across Boundaries (PHABs) themes.

These are the key themes taken into consideration for all work being planned, delivered or transformed.

A key development in 2023 - 2024 has been targeting the approach to three priority population groups, where the team is working to help reduce inequalities. These groups are:

- Gypsy, Roma, Traveller, and Boater (GRTB) Communities
- Routine and manual workers (where English isn't their first language)
- The 20% most deprived communities (particularly rural areas)

This year's report shares some of the projects that have focused on those priority populations within each of the four themed PHAB areas including:

- Mental health and wellbeing. A recent boaters' survey captured responses to questions across multiple topics, from health and wellbeing to finances, safety, stigma, and facilities. The delivery of the Senior Games, supporting an all-inclusive physical activity programme for older residents in care homes and assisted living.
- Workplace wellbeing. Providing a number of workplace health developments with free webinar sessions to enhance wellbeing in the workplace, online resources on The Enterprise Network website, and a series of care worker events to support the care workforce manage non-COVID infections and support staff wellbeing.
- Children and young people's health. Working with Phunky Foods school and community programme to promote healthy behaviours and arranging a focus group and event for boating families to provide feedback on antenatal pathways and maternity services.
- Smokefree Wiltshire. Recruiting two health coach apprentices in Bemerton Heath to engage their community with behaviour change programmes and the expansion of the council health coaches stop smoking service to now include an option for e-cigarette provision for those seeking to become smokefree.

Kate Blackburn, Wiltshire's Director of Public Health, said: "This year's report shares some great examples of how my Public Health team has used diversity, innovation and passion to improve health and wellbeing and reduce the inequalities in outcomes that we see in the population.

"I'm particularly proud of the boaters' survey and genuine engagement of the team alongside wider council and community partners, which took place along the entire length of the canal in Wiltshire. The engagement and findings will help to shape better services and activities for our boaters.

"In the year ahead, we will be building on our Smokefree Wiltshire work, as smoking remains the leading cause of preventable health inequalities in Wiltshire. Alongside national commitments to the 'Smokefree Generation', I look forward to updating on local developments in the interventions we are offering to help significantly reduce the smoking prevalence across the county in next year's report."

Cllr Ian Blair-Pilling, Cabinet Member for Leisure and Public Health said: "The Public Health team's work over 2023 into 2024 has particularly focused on strengthening relationships and connections across the communities of Wiltshire, demonstrating why trusted local relationships are so very critical.

"The team continue to take an approach to their work that is committed to supporting the council's business plan, and this year's report particularly shows the team's commitment to the whole life approach to prevention, tackling disparities in opportunities that exist across the county and gaining better understanding of our communities to ensure the right services can be provided in the right place at the right time to meet our distinctive local needs." -ends-





#### **Project Summary:**

At our 4 weekly sessions during 2023 we had 250 guests, served 3,923 meals, distributed 1005 items of clothing and provided 195 showers. We support marginalised guests (rough sleeper, homeless or housed) who have longstanding issues and are experiencing social exclusion and come to Opendoors primarily for the benefits of a hot meal (often the only one they will have that day) social interaction and community needs within a setting of safety. We strive to build a relationship of trust to build the confidence they need to enable them to meet their challenges. We have close relationships with multiple specialist agencies whether Housing First, Rough Sleeper team, debt services, Bath hospital, GPs, Wiltshire council prevention and wellbeing team, public health van, Turning Point, Nelson's Trust, Devizes Foodbank, Nationwide, and others that are brought in when guests need and are ready to engage. We contacted them 674 times in 2023. We provide on site minor injury care. We offer one night emergency accommodation in extremis need. This project benefits and improves vulnerable residents health and well being, reducing social isolation and loneliness. As most of our guests come from the local area, we have the window of opportunity to build the necessary long term relationships needed to achieve meaningful change in their lives. This project addresses two of Devizes local priorities namely, valuing and supporting our vulnerable and older people and support those with greatest need and improve their resilience. We have two highly qualified part time members of staff and 50 volunteers. This grant will go towards the salaries of the two staff (Operations Manager and Guest Co-ordinator) who provide vital knowledge and expertise in the delivery of our services. Trevor a 66 year old local man became homeless unexpectedly and was sleeping rough following a painful relationship breakdown. He came to Opendoors for support, 'I was very depressed and worried when I first went to Opendoors for help. But everyone made me feel very welcome and did so much to help me.' He received hot meals, a sleeping bag, clean clothes, access and toiletries for showers, help with paperwork, and internet access. We put him in touch with both Julian House and outreach workers at Wiltshire Council (RST) and gave him hope he would quality for a flat at a rent he could afford. We worked with him to complete the required paperwork needed to be registered for housing and helped him during the bidding process as well as applications to grants and other financial help. In addition, we helped him with Pension Credits and a bus application as he is eligible for free travel and provided him with a postal address for all correspondence whilst he was sleeping rough. He was successful and now volunteers at Opendoors, 'Now I have my flat I feel much more myself again and much less stressed. I enjoy volunteering at Opendoors and doing

my bit to make others feel there is hope and a way to get back on track.' Later that year, Opendoors advised him to see a GP as he suspected he had long covid, 'In the summer I became very ill but once again Opendoors was there to help me.'

#### **Project Summary:**

Omnes ad Unum is the events and fund raising group for St Johns and members of the Devizes community. It makes this application on behalf of the Organ Scholarship and teaching programme which is run for the benefit of particularly the young in Devizes and district A replacement pipe organ is being constructed at St Johns and is scheduled to be commissioned in the spring of 2025. In the interim music scholars and children are taught using an existing digital organ. However this no longer fully functioning and in need of replacement. The replacement pipe organ is a three manual console and of a very high quality. The Scholarship programme is designed to give the opportunity for talented youngster to learn to play this instrument and possibly progress to a career in music. Teaching on the instrument and or to appreciate the organ music will be available to all children in the Area Board Schools supervised by their teachers. - 4. Three funding streams are available to the Area Board, each with an annually awarded amount. These funding streams are as follows:
  - Community Area Grants (capital)
  - Youth Grants (revenue)
  - Older and Vulnerable People Grants (revenue)
- 5. The Area Board will be advised of the funding available prior to their first meeting of each financial year.

## **Main Considerations**

- 6. Councillors need to be satisfied that the applications meet the requirements as set out in the Area Board Funding and Grants Criteria and that the health and wellbeing and young persons funding guidelines have been adhered to.
- 7. Councillors must ensure that the distribution of funding is in accordance with the Scheme of Delegation to Area Boards.
- 8. Councillors need to consider any recommendations made by sub groups of the Area Boards.
