	Cllr Hubbard noted that during the previous Area Board meeting a motion had been raised regarding that TROs affecting Melksham residents should be advertised within the Melksham Evening News. An amendment was however made that this motion be brought back to the next meeting of the Area Board due to timing reasons. Consequently, Cllr Hubbard requested an update on this motion.
	As Cabinet Member for Highways, Street Scene, and Flooding, Cllr Holder stated that he had raised this issue with the Leader of the Council, newly appointed Chief Executive and Director for Place on Monday, with it noted that they had been tasked with reviewing the current process in place with an awareness of the previous issues raised. It was acknowledged that Cllr Hubbard had raised this issue at the October 2023 meeting of Full Council, and that within the written response provided, circulation numbers had been cited, to which work was now being undertaken to ascertain whether such circulation numbers were correct and up to date whilst writing a new policy.

eceived an update from Catherine Roper, Wiltshire Police he update included but was not limited to the following points: ecruitment, Wiltshire Police is a place that people work and ot been this many staff employed since 2014, there was also hasis on retaining staff with skills within the control room. ned that in the summer of 2022, Wiltshire Police had been

	<ul> <li>as not being where they should be, therefore the Chief Constable aimed to improve these areas.</li> <li>Attention was drawn to the report and open letters to the PCC, which could be found fortnightly via the following link: <u>News   Wiltshire Police</u></li> <li>After the update, there was time for the following questions and points to be raised:</li> <li>Wiltshire Police were thanked for the significant improvement that had been made policing speeding in Bowerhill, with residents also noticing improved social media posts from the Police. Further praise was also placed for the arrest made on a local drug dealer in Bowerhill where residents ad felt reassured.</li> <li>Previously villages had stated that they did not see the Police often, however, there has been a marked change in this recently with the mobile police station having visited two villages, demonstrating greater visibility.</li> <li>The importance of sharing these positive experiences was stressed and</li> </ul>
	<ul> <li>The iniportative of sharing these positive experiences was stressed and how this would contribute to bridging the gap of trust and confidence between residents and Wiltshire police.</li> <li>Wiltshire Police were thanked for their work on the CCTV proposal with it cited that being about to speak to the Neighbourhood Policing Team was invaluable.</li> <li>It was questioned whether work could be done to promote the positivity of Community Speed Watch projects and to encourage residents to participate. The PCC stated that there was well over one hundred Community Speed Watch Groups when he arrived in post which had now been placed into structured groupings with leaders who communicate data for collation. It was agreed that work could be done to consider how more volunteers could be recruited.</li> <li>The issue of enforcing speed limits, particularly within 20mph speed limits was discussed.</li> <li>It was suggested that local youth groups would like to do more with the Neighbourhood Policing Team, with it cited that the Chief Constable's national portfolio was focused on children and young people. Therefore, it was agreed that a lot more could be done regarding engagement, education, and interventions.</li> </ul>
82	<u>Wiltshire &amp; Swindon Police and Crime Commissioner</u> The update from Wiltshire & Swindon Police and Crime Commissioner was received directly before the update provided by the Wiltshire Police Chief Constable.
	The Area Board received an update from Phillip Wilkinson, Wiltshire & Swindon Police and Crime Commissioner. The update included but was not limited to the following points:

	<ul> <li>The Commissioner provided the Area Board with an overview of his working background as well as that when he arrived into post, Wiltshire Police was not in a positive position and tended to look inwards with committees rather than providing directional support to the frontline.</li> <li>This had now changed with a new Chief Constable and Chief Officer Group in place as well a defined chain of command with the Chief Constable able to hold staff to account.</li> <li>The Commissioner outlined that his role is to hold the Chief Constable to account on behalf of residents through a set of objectives which are routinely discussed.</li> <li>Wiltshire Police is no longer in special measures; however, it is not complacent and recognises that there are still steps to be taken.</li> <li>The Commissioner outlined that he has the responsibility of creating a new Police and Crime Plan, which could be shaped on the concerns and responsibilities of residents.</li> <li>Looking back on the previous Police and Crime Plan, improvements had been made across all crime types apart from retail crime, however this would be worked on.</li> <li>The example of County Lines was cited, including Operation Scorpion, where the 5 Southwest Police Forces collaborated to focus on aspects of County Lines. As a result, all five forces were not within the top 10 in the country, with Wiltshire being ranked the first performing force.</li> <li>It was outlined that in the Commissioner's first year, 1,324 speeding sanctions had been placed and that in the Melksham area last year 764 sanctions had been placed, representing a huge improvement.</li> </ul>

	<ul> <li>The Area Board received an update from Perry Payne, Wiltshire &amp; Swindon Road Safety Partnership. The update included but was not limited to the following points: <ul> <li>It was outlined that road safety is not the remit of one organisation, therefore the Wiltshire and Swindon Road Safety Partnership allows organisations to work together.</li> <li>The organisations of the Partnership were outlined.</li> <li>The three main workstreams of the Partnership were identified as Engineering, Education and Enforcement.</li> <li>Currently education has a focus on the #Fatal5, which it was explained</li> </ul> </li> </ul>

	<ul> <li>are the five main contributors to road traffic collisions.</li> <li>The education provisions of Wiltshire Council and Dorset &amp; Wiltshire Fire and Rescue Service were outlined.</li> <li>Gratitude was placed towards the work of Community Speed watch teams, with it stressed that these people were volunteers making a significant contribution.</li> <li>Community Speed watch data was provided for Melksham from July 2020 to August 2024, with it noted that 379 watches had been conducted with 2,137 letters sent.</li> <li>Additionally, eleven traffic survey speed assessments had taken place with 7 areas needing Community Speed watch action and 3 requiring speed education.</li> <li>The enforcement aspect of the Partnership was outlined, including the role of Community Speed Enforcement Officers who between 1 January 2023 and 8 May 2024 had been active in 851 locations, issued 10,667 speed awareness courses, 1,450 fines/points and 144 individuals referred to court.</li> <li>The work of the Road Policing Unit was outlined.</li> <li>An emerging trend had been identified of an increase in pedestrians distracted by mobile phones and stepping out into roads.</li> </ul> After the update, there was time for the following questions and points to be raised: <ul> <li>Clarity was sought regarding the use of SIDs as well as the downloading of data, to which it was stated that there are five different types of SID, which download data to Wiltshire Police, which is automatically analysed to allow for data led enforcement. It was suggested that if Speed Watch teams were to interrogate their own data, they could pass it onto the Neighbourhood Policing Team for action.</li> </ul>
84	Artwork Pilot
	The Area Board received a presentation from Caroline LeQuesne, Engagement and Partnerships Lead regarding the process for requesting and deciding whether artwork is legally allowed to be painted on a wall including a request for the Melksham Underpass to be the first pilot in Wiltshire.
	<ul> <li>The presentation covered, but was not limited to, the following points:</li> <li>Reference was drawn to a full report which had been included within the agenda pack.</li> <li>It was acknowledged that graffiti and tagging tends to be unsightly, offensive and of cost to the Council to remove. Locally, artists had been paid in Salisbury and Corsham to produce art on walls which might have been tagged. Furthermore, legal walls were also present in other cities, allowing artists to paint and produce art without being prosecuted.</li> </ul>

	<ul> <li>A legal wall in Chippenham was cited as an example, having decreased the amount of graffiti in parts of the town whilst saving money for circa ten years.</li> <li>The benefits of legal walls were outlined, including increased youth engagement and pride in place, which linked to one of the Area Board priorities, heritage.</li> <li>An overview of the proposed process was outlined, with input to be sought from Wiltshire Council services, Parish Councils and Police. Additionally, there would need to be a clear communications plan and that the legal wall would be monitored and subject to a code of conduct. The Town Council was also looking to extend the CCTV network to where the underpass is located.</li> <li>Reference was drawn to an example code of conduct included with the report appendix.</li> </ul>
	After the presentation, there was time for the following questions and points to be raised:
	<ul> <li>It was stated that there had been a challenge to get the underpass sorted for a number of years and that this established practice could be positive and constructive.</li> <li>Concerns were voiced that though in theory the pilot could be positive, it could lead to an increase of tagging within the town. Assurance had however been provided that there would be a lot of monitoring and if concerns were detected and tagging was taking place elsewhere the project could be terminated.</li> </ul>

	<ol> <li>That the underpass in Melksham situated along the A350 at Bath Road to be put forward as an initial pilot to trial the process.</li> <li>That ongoing monitoring takes place within the trial period and appropriate action, or changes are taken if required.</li> </ol>

	<ul> <li>which included, but was not limited to the following points: <ul> <li>An overview of crime data was provided for the past 6 months, with it noted that there had been a decrease of 9% including reductions in burglary, violence, drug offences, possession of weapons and reported theft.</li> <li>The team were not complacent and recognised that there had been an increase of keyless vehicle thefts.</li> <li>Work had been completed by the team to improve community engagement and visibility, including a drop-in surgery in Melksham Park every 3<sup>rd</sup> Saturday of the month and routine drop ins at the Melksham Chatty Café.</li> <li>Youth engagement has taken place, with staff visiting youth centres on an ad-hoc basis.</li> <li>E-scooters was highlighted as a priority for the next month, with work conducted with the road policing unit and a video soon to follow on the Wiltshire Police social media page.</li> <li>Education work was set to take place to engage and educate people on speed watch. #### Cost of Living

As we prepare for winter, there remain some financial pressures on household budgets, and it is anticipated that there will be continuing demand for support and advice.

Overall inflation is relatively stable at 2.2%<sup>1</sup>, which suggests that some cost pressures for the community have reduced. However, for example, under the new energy price cap, gas and electricity prices will rise by 10% in England, Scotland and Wales from October<sup>2</sup>.

The Council, therefore, is continuing to work with partners to deliver interventions that provide advice and support to our communities, including:

- Wiltshire libraries are continuing as warm spaces and as sources of advice.
- We will contact community providers to update our <u>interactive guide</u> to help people find key support to combat fuel and food poverty. In addition, we are creating a page on the directory that gives an interactive advent calendar view of provision/ opportunities over the Christmas period.
- Wiltshire bus users can continue to travel on most routes in the county for just £2 or less for a single fare until the end of December 20243. The fare price reduction has been funded by the Government and is aimed at getting more people to use buses across the country during the current cost of living challenges.
- Ahead of the Government announcement to extend the Household Support Fund by 6 months from the 1<sup>st</sup> of October<sup>4</sup>, we are analysing the impact of schemes delivered under the programme so can further develop our approach to ensure that

those households most in need are targeted for support. A full report is expected at Cabinet in October.

- Pending confirmation of funding, Foodbanks and Community Food Providers will be invited to apply for funding to support their work.

- With change to the eligibility of Winter Fuel Payments<sup>5</sup>, the DWP has been encouraging the take up of Pension Credit<sup>6</sup>. The Council has also been promoting the take-up of Pension Credit to those who may be missing out.

The Council is pleased to say that, following a successful summer programme that saw more than 1,500 young people make around 2,000 bookings at over 41 locations. Wiltshire Council's Holiday Activity and Food programme (FUEL) will be back during the Christmas school holidays. It is funded by the Department for Education and provides children who are eligible for benefits-related free school meals with free access to activity, food and nutritional education during school holidays. Eligible families will be able to sign up later in the year and details will be promoted through all schools in Wiltshire in due course. #### ICB updates for Wiltshire Area Board – October 2024

#### New provider of integrated community-based care

People in Bath and North East Somerset, Swindon and Wiltshire will receive more health and social care in or near their homes, in a more joined-up and streamlined way.

HCRG Care Group has been appointed to lead an innovative new community-based care partnership with the NHS, local authorities and charities that will transform the care and support that people get to help them with their health and wellbeing at every stage of their lives.

Traditional community services such as nursing, therapy and personal care will be enhanced as they become part of new integrated neighbourhood teams, working across homes, care homes, clinics, schools and community centres to bring more personalised support to local people.

The aim is to build on the services that are valued by patients and their loved ones, as well as giving people more support in living healthier lives.

Among the benefits local people can expect to see will be:

- A single place or front door to get community-based care, help and support. The new front door will be fully accessible to all, and be available in a face-to-face location, as well as online and over the phone.
- At least £7m a year will be invested in partnerships with VCSE providers to build community capacity to provide early help and support within communities from the end of 2027.
- Inappropriately located or outdated buildings will also be refurbished or phased out.
- Transforming the way that people access care will also reduce the pressure on GP practices and hospitals, which are seeing more people with health problems that could be effectively treated closer to home.

#### Local NHS invests millions to help patients get diagnostic care closer to home

Tens of thousands of patients living in Bath and North East Somerset, Swindon and Wiltshire requiring diagnostic care can now access the services they need sooner and closer to home thanks to a multimillion pound investment by the local NHS.

A £14 million cash injection has enabled three new community diagnostic centres to open across the region, with each of the sites providing the type of diagnostics that once would have only taken place inside a hospital.

Having services such as ultrasounds, echocardiograms and MRI scans based in the community means people awaiting diagnosis, including those with symptoms that could be cancer, can be seen quicker and begin any required treatment sooner.

The first centre opened at the Sulis Hospital in Bath in March 2023, and was followed in March and April of this year by two new sites, with one based at the West Swindon Health Centre and the other at Salisbury Centre Health Clinic.

#### Eligible groups encouraged to get vaccinated against flu and Covid-19

The second phase of the winter vaccination programme has begun for those in Bath and North East Somerset, Swindon and Wiltshire.

Vaccinations against flu and Covid-19 are now available for people aged 65 and over, those with a weakened immune system, carers, care home residents and front-line workers in social care and health care.

Following the initial launch last month, inviting pregnant women and children for their flu vaccinations, from Thursday 3 October anyone eligible for vaccinations can book online at www.nhs.uk, by downloading the NHS App, or by calling 119.

In addition, the NHS will be sending out invitations to those eligible to get their jabs, while GP practices and other local NHS services will also be contacting people to offer the vaccines.

These vaccinations provide vital protection, helping to prevent serious illnesses and reduce hospital admissions during the busy winter months.

#### ICB Non-Executive Director to join mental health trust

Paul Miller, Non-Executive Director at Bath and North East Somerset, Swindon and Wiltshire Integrated Care Board, has been named as the new Chair of Avon and Wiltshire Mental Health Partnership NHS Trust.

Paul will step down from his role at BSW ICB at the end of October 2024 to take up the role of Chair at the mental health, learning disability and autism provider on 1 November 2024.

He has been a non-executive director since the establishment of the integrated care board in July 2022.

Stephanie Elsy, BSW ICB Chair, said: "We are very grateful for Paul's active support in the first two years of our ICB.

"This has been a pivotal time as we have developed the first integrated care plan that outlines the priority areas that we need to tackle to bring the most benefit to local people."

#### Independent investigation of the NHS published

In July 2024, the newly appointed Secretary of State for Health and Social Care, Wes Streeting MP, commissioned Lord Darzi to conduct an immediate and independent investigation of the NHS.

Lord Darzi's report has now been published and provides an expert understanding of the current performance of the NHS across England, as well as the challenges facing the whole health and care system.

Within the report, Lord Darzi used the most recent data and intelligence to assess:

- Patient access to health and care
- The quality of health and care being provided
- The overall performance of the health and care system

#### Busy summer for urgent and emergency care services

Emergency departments in the NHS experienced the busiest summer on record, with around 6.8 million people coming forward for urgent care during June, July and August.

In total, 6,776,150 people attended an emergency department in England during the three-month period, which is an increase of more than 240,000 when compared to the previous year.

Local emergency teams also had a very busy summer, with the region's three hospitals – the Royal United Hospital in Bath, the Great Western Hospital in Swindon and Salisbury District Hospital – seeing a combined attendance of 79,787.

The busiest month of the summer came in July, when the combined attendances for each of the three hospitals totalled more than 27,000.

Professor Sir Stephen Powis, NHS National Medical Director, said: "The NHS has just come out of the busiest summer on record for A&Es across the country, and preparations are already under way for what is expected to be an extremely difficult winter."





#### **TEAM FOCUS, ACTION & PRIORITIES:**

**FOCUS-** Melksham has, alongside other towns in Wiltshire and surrounding Forces, suffered a spate of van break ins whereby tools have been stolen. We have focused on the golden hour enquiries to best support any future prosecution once suspects are apprehended. We have carried out crime prevention advice online and in our drop-in surgeries with the handing out of DNA Selecta kits secured through force funding. We have proactively patrolled our areas and are working with a number of teams to pull together evidence and intelligence.



**ACTION-** We have completed three Operations- Op Scorpion, Safer Business Awareness Week and Rural Crime Awareness Week.

For Op Scorpion we targeted criminal transport links with a variety of traffic stops; speed gun duties and patrolling our transport links. We also visited addresses linked to vulnerable people who are at risk of being cuckooed.



For Safer Businesses we have visited our local businesses and invited them to a meeting for each town in our NPT area. This will launch discussions around their needs and expectations and how we can best meet them. We are also liaising with our Neighbourhood Harm Reduction Team to look at ways in which shops can deter, rather than encourage shoplifters with clearer product displays; clear CCTV observation points and moving high value goods to more secure locations.

For Rural Crime Week, we worked alongside the Rural Crime Team and Wiltshire Council to tackle waste disposal offences; checking the legality of our Scrap Metal sites and engaged with our farms to ensure they feel heard and protected.

Each plastic box contains several boxes of tissues, 2 clocks, a carafe, drinking glasses, a security alarm, some cleaning wipes and batteries and some spares. Everything a counsellor and client need so a session.

#### Background

- 3. Area Boards have authority to approve funding under powers delegated to them. Under the Scheme of Delegation Area Boards must adhere to the Area Board Funding and Grants Criteria. This document is available on the council's website.
- 4. Three funding streams are available to the Area Board, each with an annually awarded amount. These funding streams are as follows:
  - Community Area Grants (capital)
  - Youth Grants (revenue)
  - Older and Vulnerable People Grants (revenue)
- 5. The Area Board will be advised of the funding available prior to their first meeting of each financial year.

**Main Considerations** 

- 6. Councillors need to be satisfied that the applications meet the requirements as set out in the Area Board Funding and Grants Criteria and that the health and wellbeing and young persons funding guidelines have been adhered to.
- 7. Councillors must ensure that the distribution of funding is in accordance with the Scheme of Delegation to Area Boards.
- 8. Councillors need to consider any recommendations made by sub groups of the Area Boards.
