1.	<p><u>Chairman's Welcome and Introductions</u></p> <p>The Chairman welcomed everyone to the meeting of the Warminster Area Board and invited members of the board to introduce themselves.</p>
2.	<p><u>Apologies for Absence</u></p> <p>Apologies for absence were received from:</p> <p>Deborah Gogarty – Older People’s Champion</p> <p>Wiltshire & Dorset Fire and Rescue Service</p>
3.	<p><u>Minutes</u></p> <p>Decision</p> <p>The minutes of the previous meeting were agreed as a correct record and signed by the Chairman.</p>
4.	<p><u>Declarations of Interest</u></p> <p>Cllr Jackson declared an interest in the grant application for the Warminster Athenaeum Trust as he was a trustee and would not vote.</p>
5.	<p><u>Chairman's Announcements</u></p> <p>The Chairman made the following announcements:</p> <ul style="list-style-type: none"> • New fly-tipping campaign: We’re Targeting Fly-tippers <p>Wiltshire Council had launched a new reward campaign to prevent fly tipping in the county. The We're Targeting Fly-tippers (WTF) campaign aimed combat the scourge of fly-tipping by offering residents a reward of up to £200 in high street vouchers if they reported information that lead to the successful prosecution of an offender or the payment of a Fixed Penalty Notice (FPN).</p> <ul style="list-style-type: none"> • BT Proposed Payphone Removal Consultation <p>The council had received notification from BT regarding consultation on its current programme of proposed public payphone removals. There were 71 public payphones with low usage levels and BT proposed to remove them following a full consultation. BT had also placed consultation notices in the relevant payphone kiosks.</p>

	<p>BT were offering parish councils and registered charities to *adopt a kiosk for just £1, thereby protecting the heritage of the community.</p> <p>Details about this could be found on BT's website (at http://business.bt.com/phone-services/payphone-services/adopt-a-kiosk/)</p> <p>The consultation period ended on 28 January 2020, and responses by end of business 14 January 2020 to include representations in forming WC return to BT. All responses should be directed to mary.moore@wiltshire.gov.uk - Mary Moore, Economic Development and Planning, who will co-ordinate the response on behalf of the council.</p> <ul style="list-style-type: none"> • Community Governance Review (CGR) <p>It was noted that a CGR was taking place although the Warminster area was not part of the review at this point in time. If the Warminster area was being reviewed residents and town/ parish councils would be made aware.</p> <ul style="list-style-type: none"> • Warm and Safe Wiltshire – help available this winter <p>Warm and Safe Wiltshire was a single point of contact cold homes and energy saving advice service set up specifically to assist the health service in Wiltshire. The service was run by the Centre for Sustainable Energy (CSE), an independent charity, on behalf of Swindon Borough Council and Wiltshire Council.</p> <p>The service provided a range of support both over the phone and through home visits. Wiltshire Community Foundation administered a Surviving Winter grant of £300 per person to help vulnerable residents pay for winter costs and the application period ended on the 13 December and was granted on a first come first serve basis. More information could be found at https://www.warmandsafewiltshire.org.uk/</p> <ul style="list-style-type: none"> • The next meeting of the Warminster AB would focus on ecology, conservation and environmental issue.
6.	<p><u>Updates from Partners</u></p> <p>Some written updates had been received before the meeting and were included in the agenda.</p> <p>Wiltshire Police</p> <p>Dan Green gave a verbal update noting that during the winter months there was generally an increase in poaching with recent incidents involving an increase in thefts of post boxes which was being investigated.</p>

	<p>The last round of training had taken place. The recruitment window had just closed seeing all vacancies filled across all teams.</p> <p>Dorset & Wiltshire Fire and Rescue Service</p> <p>A handout was provided at the meeting highlighting:</p> <ul style="list-style-type: none"> • Safe and Well visits • On-going interaction by the Protection Team members with Local Authorities, Private landlords and tenants regarding fire safety-related matters: external cladding systems; fire detection and warning systems; fire resisting doors (& self-closers); combustibility/fire resistance of construction materials; commercial and residential sprinklers systems and water-mist suppression systems; • Recruitment was on-going for on-call firefighters, more information could be found at www.dwfire.org.uk/working-for-us/on-call-firefighters/ • Reminder of Christmas safety and further tips could be found at https://www.dwfire.org.uk/safety/safety-at-home/christmas-safety/. • Work was underway to develop a Biker Down scheme across Wiltshire, after sponsorship for the coming year was secured. Biker Down was a national road safety initiative targeted at motorcyclists, originally conceived and started by Kent Fire & Rescue Service, and it has recently launched locally; • Christmas day help – The Fire Service was seeking people to help manage the volunteers for the annual Christmas Day lunch held in Trowbridge. The event had grown substantially since it was started at Trowbridge fire station, and was now hosted at County Hall in the town. Anyone who would like to offer their help would need to be at County Hall on Christmas Day and, ideally, have availability in the days beforehand to help with setting up the venue. 7.	<p><u>Local Youth Network Update and Youth Activities Grant Applications</u></p> <p>The Community Engagement Manager, Graeme Morrison, introduced the item noting that a LYN meeting was held prior to the AB meeting which looked at youth issues and discussed the process going forward, taking into consideration their priorities, gaps in provision and set up going forward.</p> <p>Currently the LYN grants funding was underspent and groups were encouraged to apply for funding.</p> <p>There was a presentation on the Warminster Skate Park which noted that:</p>

	<ul style="list-style-type: none"> • The skate park had been a huge success and was well used by residents of Warminster and the surrounding towns. • The skate park took six years to complete and a big event was held for the opening of the park.

Warm and Safe Wiltshire is a single point of contact cold homes and energy saving advice service set up specifically to assist the health service in Wiltshire. The service is run by the Centre for Sustainable Energy (CSE), an independent charity, on behalf of Swindon Borough Council and Wiltshire Council.

The service provides a range of support both over the phone and through home visits. The telephone advice line is available to all residents and provides support which includes information about insulation and heating, guidance on heating systems, advice on understanding energy bills, help with ensuring a client is on the best energy deal, signing residents up to the Priority Services Register and fuel debt support.

Home visits are provided on a case-by-case basis and are especially useful where issues are challenging or difficult to discuss and support over the phone. As a guide, householders should have a vulnerability, such as an older occupant, low-income or health condition(s), to receive a home visit.

Wiltshire Community Foundation administer a Surviving Winter grant of £300 per person to help vulnerable residents pay for winter costs.

Warm and Safe and Age UK are the referral partners who can help clients complete the application form process and compile the necessary evidence for Wiltshire Community Foundation to make their decision.

The grant is administered on a first-come-first-served basis and it is in two rounds this winter. It should be noted that funds are limited.

- Round 1 opened 21 October and is open until 13 December 2019 **(Please note Warm and Safe have allocated all grants in this round but are adding clients to a waiting list for round 2)**
- Round 2 opens 13 January to 20 March 2020

Transforming Maternity Services Together - update

Thank you to everyone who took part in our consultation and shared their views with us. There were many suggestions for how we can improve services and these will help inform our future plans.

Since we started this process in 2017, more than 4,500 mums, families, staff and partners in the community have shared their views and ideas about how to deliver a safe and positive birth and maternity experience for families in B&NES, Swindon and Wiltshire, as well as prepare them to approach parenting with confidence.

Our proposals have been rigorously examined by the South West Clinical Senate and an independent expert panel which included a GP, an obstetrician, representatives of mums and dads, a midwife and a quality improvement lead. We have also consulted with a joint B&NES, Swindon and Wiltshire Health and Overview Scrutiny Committee and worked through the NHS England assurance process.

A final set of recommendations will be submitted to a joint meeting of the BaNES, Swindon and Wiltshire Clinical Commissioning Groups Governing Body on Thursday 16 January 2020 where a decision will be made.

This meeting will be in public and will take place at the Lackham Campus, Wiltshire College from 10am – 12 noon.
