Hi Priyantha, the form that the council has sent is not interactive, so I can't fill it out for you, but I will tell you what to put on there. Firstly, fill in all your personal details that they ask for, then, in the box that asks for reasons for the appeal, type the following:

- 1. The trading hours which I applied for, were based on advice given to me, by your own advisor and I believe they have not been viewed as they were intended. If I am advised by a member of your staff, I do not expect to have my application rejected, outright.
- 2. You give, as a second reason, the fact that someone is already trading in the same goods. We have a monopolies commission in this country and competition is welcomed as a means to achieve better value for customers. You cannot operate your own exclusions in this regard.
- 3.I object that you have retained fees, even though it was your own advisor who assisted me in the application. Incompetence on your behalf is no excuse to retain these fees.
- 4.I object strongly,that although your reasons seem cut and dried (to you),the application was allowed to stand for the full duration allowed by yourselves before being addressed,thereby preventing me from exploring the reasons for refusal AND being able to use monies that should have been returned,in alternative pursuits.
