Project Summary:

TTV focus on young adults in Yr 9 and 10 (GCSE) who are making important life decisions. TTV takes them on a 6 month transition programme, providing personalised tools, techniques and team projects to improve confidence and self-esteem. They work in collaboration with the community to create a project or research which gives the young adult a sense of achievement and belonging. The course begins with a full day/ 'drop down day' and thereafter weekly sessions during the school term (15 weeks) completing with an afternoon of presentations. The team of 2 resilience/leadership coaches, an administrator, one volunteer and a designated teacher. 50 students (from year 10) at Pewsey Vale School, divided into groups to work on a small but impactful community project. TTV proposes to run this twice, depending on funding. The leaders are from thelearntoleadproject.com (organisational psychologist and leadership coach and social worker and school councilor)

Background

- 3. Area Boards have authority to approve funding under powers delegated to them. Under the Scheme of Delegation Area Boards must adhere to the Area Board Funding and Grants Criteria. This document is available on the council's website.
- 4. Three funding streams are available to the Area Board, each with an annually awarded amount. These funding streams are as follows:

 - Older and Vulnerable People Grants (revenue)
