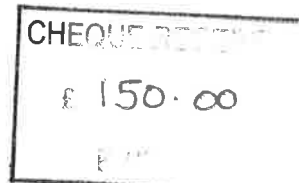

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 9)

The licensed premises are specific to a development aimed at the "retirement market" and their guests. At all times it is anticipated that the provision of alcohol will be to persons of maturity and the supervising staff will be educated to recognise any signs of drunkenness or inappropriate behaviour and to stop serving alcohol.

b) The prevention of crime and disorder

As above. The provision of alcohol is primarily for residents of the "Retirement Village", and it is expected that the same will be "self policing".

c) Public safety

Members of the public will not generally be using the licensed facilities which are primarily for the use of residents of the Retirement Village and as such it is not anticipated that issues of public safety will arise.

d) The prevention of public nuisance

As above. Members of the public will not generally be using the licensed facilities which are primarily for the use of residents of the Retirement Village and as such it is not anticipated that issues of public safety will arise.

e) The protection of children from harm

Any children attending the licensed premises will be in the company of adults and the staff will be trained to ensure that they are in a safe environment at all times.
