Hi Hannah,

I attended At Home at 1845hrs this evening, in company with PC Billington and checked for the Blue Notice, which neither of us could locate.

Later whilst speaking to Louella Adamson (DPS) on the phone, together with the Bar Manager on duty, Jessica Clark, the Blue Notice was identified as being in the window beside the door, but at the very top of the window, i.e. at ceiling level, where it was completely impossible to identify or read.

I told Louella that I was requiring the Bar Manager, Jessica Clark, to relocate it to an eyelevel position beside the door, where members of the public can see it & read it.

Louella stated to me that you were aware of where it was placed and were happy with the position.

I advised her that I considered that statement to be incorrect and that I was aware she had sent a photograph of the Blue Notice, but it was not at all clear where it was positioned. I reiterated that the whole point is that members of the public can read the Notice.



> Who reported this and what has been said? We cannot see evidence of

> officers tone on the phone I feel I am out of the picture with the
> story you've been given it seems to be getting a lot of attention for
> something that really wasn't. What ever happened after they left my
> place is not my responsibility. We did what we could to ensure the
> woman was safe and had a place to sleep, hence the later closing.
> Is this an investigation of the woman and her parenting skills or is
> this a fishing exercise to object my variation? I feel very much the
> power is coming from Weatherspoons who also called Amanda Newberry and
