<p>Project Description: Sing and Breathe has been running online since the start of the pandemic supporting people with lung health conditions and breathing difficulties across south Wiltshire particularly Amesbury and Salisbury. The project has been running face to face since 2017 expanding to Amesbury in 2019. We currently deliver a weekly singing for lung health maintenance group and regular 6-week introductory courses to support people to manage their breath and gain a better quality of life and social support. We currently have two highly trained and experienced facilitators delivering these services and around 25-30 people accessing them on a regular basis. The funding will enable us to continue to run the regular maintenance group whilst encouraging and supporting the members who haven't joined us to be able to do so.</p> <p>Input from Community Engagement Manager: The project will support older and vulnerable people to improve their lung health in the Amesbury area.
