<u>Agenda Item No.</u>	<u>Summary of Issues Discussed and Decision</u>
32	<p><u>Welcome and Introductions</u></p> <p>The Chairman, Councillor Richard Britton, welcomed everyone to first online meeting of the Southern Wiltshire Area Board, which was being broadcast live to the internet.</p>
33	<p><u>Apologies</u></p> <p>There were none.</p>
34	<p><u>Minutes</u></p> <p><u>Decision</u> The minutes of the previous meeting held on 16 June 2020, were agreed as a correct record and would be signed by the Chairman at a later date.</p>
35	<p><u>Declarations of Interest</u></p> <p>There were none.</p>
36	<p><u>Chairman's Announcements</u></p> <p>There were none.</p>
37	<p><u>To note the written reports and updates in the agenda pack</u></p> <p>The Board noted the attached Wiltshire Council updates on Covid-19 and the Connect 5 online sessions.</p> <p>The Chairman drew attention to the Covid update and noted that The Community Engagement Manager, Karen Linaker would address this in more detail, later in the agenda.</p>
38	<p><u>Matters of Community Wide Interest</u></p> <p><u>Wiltshire Council update on Covid 19 response and recovery work to date</u></p> <p>16 voluntary community groups had been set up in the southern Wiltshire community area since the start of Covid. The local village response had been helping the overall council's response, which was primarily through the Wiltshire Wellbeing hub, set up to aid access to goods, services and support where needed.</p> <p>Out of the 352 businesses eligible for a grant within southern Wiltshire community area, a total of 237 were successful in applying and were paid out.</p>

Downton library would be in a final phase of those to reopen. It was hoped to be partially open by November.

Work was ongoing on local outbreak management plans, led by Wiltshire's Public Health team, which was also a key point of contact for any community groups that wish to set back up again.

Cllr Clewer noted that as the council's deputy leader he had also been heavily involved with the response and associated activities. Central Government had stepped in to provide some financial support. He thanked Karen for all she had done in the process.

The Chairman noted how impressed he was with the speed with which a new department had been created at Wiltshire council, to administer the government business loan scheme.

On a more local point, there was a worry that many community groups which had wound down as a response to Covid, may not restart. He urged all Board members and the town and parish councils to encourage the local community groups wherever possible.

Questions and comments included:

- There was a big issue in obtaining prescriptions at the start are we now in more of a stable position with pharmacies delivering?
Answer: Yes, it has improved, however there were some areas where it was still patchy with room for improvement. As part of the recovery structure the council had its health colleagues including pharmacy colleagues working to improve such issues.
Cllr Clewer - There had been lessons learned. Procedures were now in place which would kick in very easily should they be needed.
- I have worked with the Winterslow and Firsdown Covid response group and we have found on the whole the councils response to be very prompt. We have considered the national picture and are starting to gear back up again. Wonder if Wiltshire council may consider posting a reminder out that the support networks are there.

Community Policing – local issues and priorities

Inspector Pete Sparrow highlighted some of the things that have come in over the last 6 months was a new analytical tool which has helped us to look at statistics, to adapt and change the ways we are able to respond.

Crime was at a low level for this time of year. We have developed a new model called the 4 E's: Engaging, Explaining and Encouraging people to follow the

regulations produced by government and then when that has failed, to Enforce.

Staff were doing their best to set an example, wearing a mask where suitable and socially distancing.

Local priorities

Speeding, Antisocial Behaviour in Downton, Rural Crime, Flytipping and Hare coursing this time of year. Please report anything you see that shouldn't be there to us.

In the Laverstock area there had been some issues with rogue trading. The country park at Castle Hill had experienced antisocial behaviour with quad bikes and motorbikes being ridden around.

In Whiteparish there had been antisocial behaviour and additional patrols were being sought for the area.

There had been a double intake of PCs across the county, with five coming to the Salisbury area Policing team.

Questions:

- How long before new officers become qualified for independent patrol?
Answer: Within 10 weeks they should be independent, as the 10 weeks of tutorship gives them the confidence, then they were on probation for 2 years.
- Pleased to see that Wiltshire constabulary had not going overboard with fining people for breaches of the Covid restrictions on gatherings and were advising people without issuing instant fines.

New Divisions for Southern Wiltshire Area Board

An Area Board Boundary Review briefing paper was attached to the agenda. This detailed the consultation on the draft recommendations of the Electoral Review Committee, which would run from 10 September 2020 – 31 October 2020.

If agreed the new Area Board boundaries would take effect from May 2021.

Cllr Clewer set out the process taken and the proposals for Southern Wiltshire Area Board, noting that in some parts of the county the process had been quite simple, however in this area it had been quite different.

Divisional changes:

- Redlynch and Landford - remained the same
- Downton and Ebbel Valley – remained the same
- Alderbury and Whiteparish – Pitton, Farley, West Dean and clarendon park

added.

- Laverstock - Bishopdown Farm and old settlement of Laverstock
- Old Sarum and Lower Bourne Valley – Old Sarum, Longhedge, Ford, Winterbournes and Gomeldon.
- Winterslow and Upper Bourne Valley – Winterslow, Firsdown and Parishes running up the Bourne Valley, from remainder of Idminston to Cholderton.

This was what the Boundary commission had decided and we could not change it, which caused difficulty from an AB point of view.

When we discussed it we felt it was not good to split a parish between 2 boards, so we strongly considered what to do with Laverstock and Old Sarum division and some areas in the Amesbury area.

So we decided to recommend that those areas should remain together in one AB, and as the majority of it sits in Southern AB we felt it should remain there.

We proposed Southern AB would comprises of 6 divisions, which would bring an extra Councillor in that AB. Somewhere in the process, Officers had changed the name from Southern Wiltshire Area Board to South Eastern Area Board.

I am keen to know what the villages inside those three divisions felt about where they should sit?

The Chairman urged people to respond to the consultation, to submit thoughts on the proposals.

Questions and comments:

- Chairman - The change to the title, I can see the argument, however we have lived for 11 years as Southern, we identify with being called Southern Wiltshire.
- Cllr Randall - we have always been Southern, you should never change a name like that without good reason as it would confuse everyone for no good reason.
- Cllr McLennan - thanks to Cllr Clewer for conducting the operation. I am also a part of that Committee. We were able to get to every area of Wiltshire in online meetings. The process was done in an entirely practical way, looking at the facts, history and changes to each area as a result of the boundary review. Laverstock & Ford always felt it belonged in Southern AB community area. It could have ended up in Southern, Salisbury or Amesbury.
- Cllr Devine - Firsdown was cut out from Winterslow, you didn't do a good job. Why not call it South East. I have still not had official notification what the new division will be that incorporates Winterslow. The only place I can see it is on the Boundary Commission website. Answer: You were invited along with every other member involved, who all attended meetings to discuss the

	<p>proposals. We are not able to get the updated boundary maps probably until December time.</p> <ul style="list-style-type: none"> • Elaine Hartford – I am a creature of habit, it has been Southern Wiltshire AB since it first started. People will relate to that, not South Eastern, it would cause confusion. • Inspector Sparrow - I have overlapping AB boundaries with our policing boundaries. There may be scope to align the two. This could be taken forward to the Chief Constable for consideration. • Chairman - I am disappointed that we are not being asked to approve or discuss the proposed name change. <u>Answer</u>: This could be resolved quite easily.
39	<p><u>Now, where were we?!</u></p> <p>Karen Linaker, Community Engagement Manager, gave an update on the work and projects of the Board prior to lockdown.</p> <ul style="list-style-type: none"> • The “Make a friend, be a friend” project had been started and was still intended to go ahead. • Eco Friendly Villages project – work had begun and would be picked back up again with a volunteer in East Grimstead. • Community Safety Directory – Helped by Merv Quick, the directory had been completed and issued to parishes. • We investigated with Inspector Sparrow, a Smartwater project for some parishes, however that hit a stumbling block due to the problems created by parish councils seeming to be ‘trading’. • We also started work on mapping out which groups were already running for older people. • The Board had set aside £3700 to tackle older people’s isolation. • Continued supporting young people’s activities <p>The Chairman noted that although there were a wide range of initiatives going forward, it was frustrating that they had been put on hold due to Covid, and it would be important to try and resurrect them.</p>

Reviewing local priorities

The Chairman noted that when Covid struck, the Board had not received the JSNA data, which set out the statistics for the community area.

Karen explained how the Board would facilitate discussion on the latest 'joint strategic needs assessment' for the Southern Wiltshire Community Area, and how people could get involved in helping to refresh and re-set the local priorities based on the data and in the light of issues that had been brought to bear by the pandemic.

Covid 19 had highlighted areas for consideration:

- Strong neighbourhood support for the vulnerable and more/new people stepping forward to lend a hand during the crisis - How to keep that going for the long term?
- Greater dependence upon online communication, e.g. for home schooling/working, shopping, accessing GP appointments, parish council meetings, area board meetings, etc. - Was this community area's broadband capacity fit for that purpose? How digitally inclusive are we?
- A period where vehicle use was less, and more sustainable modes of transport prevailed - How can we take forward these benefits?
- The impact upon our physical and mental wellbeing - Who amongst us need help?
- The impact upon village and community groups and organisations - Which groups need help and support to re-start?

New data was available to inform the local priorities:

A series of notable findings were presented by Karen under the headings of Health & Wellbeing, Environment, Housing, Transport & Highways, Children & Young People, Deprivation and Community Safety. The slides from the presentation are attached to the minutes.

The next steps:

- Begin to shortlist priorities (based on discussions at the meeting, and a subsequent online survey) by the end of October
- Organise a series of virtual mini events i.e. 'working with our parish councils'; health and wellbeing, young people, housing, environment, between November 2020 and March 2021 to facilitate detailed discussion around these priorities
- Prepare findings and proposals from these events for the new Area Board in May 2021, offering a clear rationale for which priorities should be taken forward, how and by whom.

The Chairman explained that the objective was to formulate some proposals

	<p>and project ideas to present to the new Area Board in May, to give them a running start.</p> <p>It was suggested and agreed that the presentation slides be circulated to parish councils prior to the mini events, to allow them to prepare points to feedback.</p> <p>A number of villages also had Facebook pages which could be another method of inclusion, circulating the data and asking for feedback.</p> <p>The board was asked whether it could request a map of the Wiltshire Council owned land which could be developed for affordable housing.</p> <p>Cllr Clewer noted that in terms of council housing, the council was looking at it with Stone Circle its housing company. There could be a number of reasons why rural sites could be unsuitable.</p> <p>The Chairman agreed to look into obtaining a land map for the area, which indicated the sites for considered by Stone Circle.</p> <p>Steve Bennett was in attendance from a croquet club, he asked that Karen include them in discussion around older people.</p>
41	<p><u>Funding New Youth Activities in 2020/21</u></p> <p>The Area Board noted the report and recommendations for funding as detailed in the papers attached to the agenda.</p> <p>It was noted that there was £15,402 remaining in the youth budget for the financial year. Winterslow youth club had been struggling over the summer, as had most volunteer youth clubs, due to the restrictions in place.</p> <p>The situation at Winterslow was that it was unlikely to survive.</p> <p>In previous years the Area Board had funded youth activities through a number of providers, including District Sports, Boom Satsuma, Anybody Can Cook, and last year it commissioned Bubble Football which was very popular.</p> <p>The Chairman asked whether it was felt that Winterslow YC may be helped by one off activities and if so whether the Board should approach them to offer some provision of that nature.</p> <p>Cllr Devine was in consultation with the YC in Winterslow and advised that he may be able to set up a repeat of a remuneration with the same lady that carried them through once before. He asked that some funding be reserved for that possibility at a future date.</p> <p>Cllr McLennan noted that Old Sarum YC had been able to get going as they had had support from a paid youth worker Youth Action Wiltshire. He suggested that</p>

	<p>this be looked at for others struggling to return.</p> <p>Action – KL to look at some professional assistance from Youth Action Wiltshire for the youth clubs across the area which were struggling to continue.</p> <p>Decision:</p> <p>That the Southern Wiltshire Area Board:</p> <ul style="list-style-type: none"> • Authorised the Community Engagement Manager to finalise arrangements and costs for the provision of activities at Old Sarum Youth Club to a maximum of £1,200. • Investigate one off projects with existing youth clubs • Supported the idea of funds being used to facilitate a series of fun days for the remainder of the financial year, covid-19 arrangements permitting, subject to the details being agreed at the next meeting. • Explore potential new initiatives suggested at this meeting for how the remaining youth budget was used.
42	<p><u>Area Board Funding</u></p> <p>The Board considered the funding requests as detailed in the report attached to the agenda and uploaded as supplement 1 to the agenda.</p> <p>It was noted that £3700 from the current budget had been ring fenced for older people isolation projects.</p> <p><u>Firsdown PC – Play area zip wire upgrade – requested £4000</u> Applicant Mr Rogers was in attendance to present the application.</p> <p>Decision That Firsdown PC be awarded £4000 towards the Play area zip wire upgrade project.</p> <p>Reason <i>The application met the Community Area Grant Criteria for 2020/21.</i></p> <p><u>Hamptworth Croquet Club -Keeping the club open – requested £5000</u> Applicant Mr Bennett was in attendance to present the application.</p> <p>A crowd funding project, £1000 from Persimmons Homes and was backed by Sports England. This had brought in more than was needed for a safe storage facility which would house the equipment. The applicant confirmed that they had no concerns about being able to raise the balance through annual membership</p>

	<p>fees.</p> <p>A suggestion to widen the net on target age of new members, to include a wider range and cater for all was put to the applicant.</p> <p>The Chairman noted that it was the Board’s usual preference to see support and if possible a financial contribution towards projects from the parish council. The applicant advised that he had contacted the PC to introduce himself, however he had not yet put in a request for funding.</p> <p><u>Decision</u> Hamptworth Croquet Club was awarded £5000 towards the purchase of machinery to maintain the lawns with a suggestion that the Club look to expand the range of ages of its membership by targeting younger members to join.</p> <p><i>Reason</i> <i>The application met the Community Area Grant Criteria for 2020/21</i></p> <p><u>Winterslow PC – Barry’s Field Officials Facility – requested £2500</u> The Board was asked to ratify an urgent decision taken in August 2020 under the delegated authority of the Community Engagement Manager.</p> <p><u>Decision</u> The Area Board ratified the award of £2500 to Winterslow PC for the Barry’s Field Officials Facility project, which had been made in August 2020 under CEM Delegated Powers.</p> <p>The application from Phoenix Stars had been withdrawn due to the purchase already having been made and the restrictions on retrospective funding.</p>
43	<p><u>Community Area Transport Group (CATG) Update</u></p> <p>The Board considered a scheme from Redlynch PC to repair street name plates, which had not been discussed at CATG due to missing the deadline.</p> <p><u>Decision</u> The Redlynch PC Street name plate project was allocated £600.</p> <p>The Board also considered the recommendations of the CATG as set out in the report attached to the agenda.</p> <p>Cllr Randall declared a non-pecuniary interest in the Solar Panel application as he was on the Whiteparish PC.</p> <p><u>Decision</u> The Southern Wiltshire Area Board approved the CATG recommendations</p>

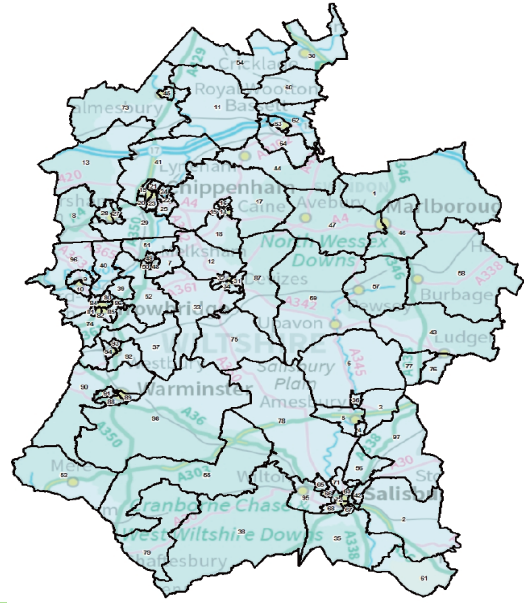

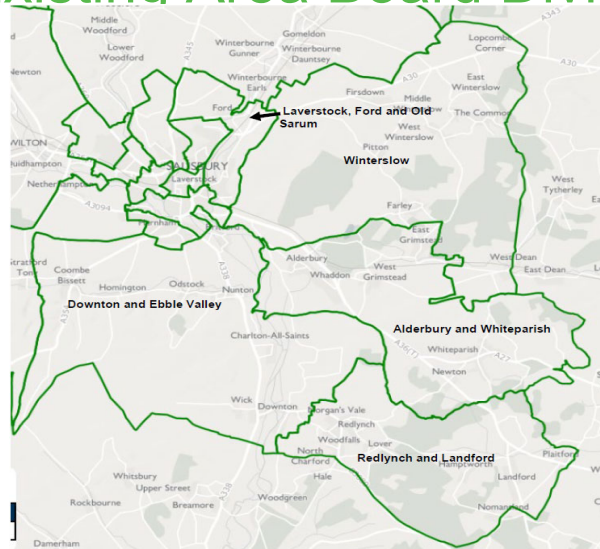

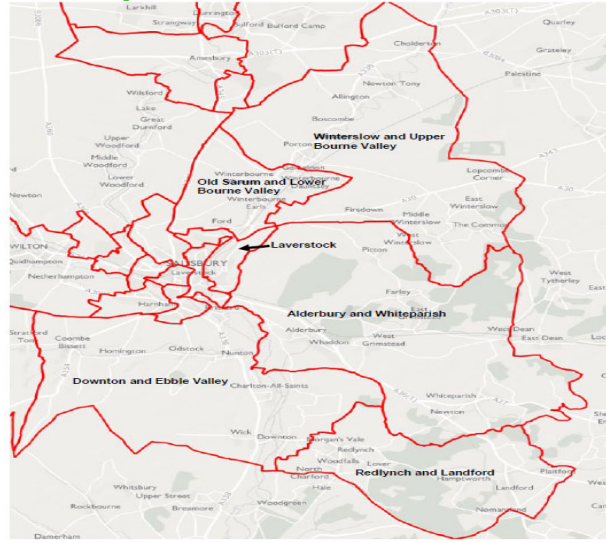
Existing Area Board Divisions

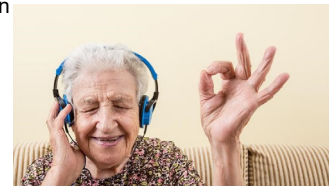



Subject: COVID-19 update

The infection rate in Wiltshire is continuing to rise, in line with the national trend, which is of concern. It is so very important that everyone across our population, no matter what age, is sticking to the regulations, staying at home wherever possible and protecting their families, friends and communities.

The new variant is much more transmissible and that is demonstrated by the large increase of cases. It is crucial that everyone adheres to the latest rules and advice, which means:

- socially distancing if you have to leave your house,
- not meeting up with anyone that's not in your household or in a childcare or support bubble unless it is one other person for your daily exercise,
- keep washing hands regularly,
- wearing a face covering when required,
- booking a test as soon as you develop any COVID-19 symptoms,

Consultation to inform the Wiltshire Local Plan review

Wiltshire Council has to allocate sufficient land to satisfy housing and employment needs up to 2036 in its Local Plan. As such it is seeking the views of local communities and stakeholders to see if the suggested distribution of numbers across the county is correct, as well as which of the proposed sites are most suitable at the county's principal settlements and market towns.

The consultation also invites comments on a planning framework for rural areas to support neighbourhood planning and to address local housing needs, and provides the opportunity to comment on how the council's planning policies can be shaped to address climate change.

Feedback during this review consultation will help to shape the draft Local Plan, which will then be produced, and people will be given another opportunity to take part in a further consultation in late 2021.

As COVID restrictions mean that face-to-face events will not be possible during this consultation, the council is holding a series of online events for people to find out more about what the Local Plan consultation involves and how to comment.

Each event relates to a particular settlement, and there are also two events for rural areas, which include all other Wiltshire villages and settlements that are not covered in the other 15 events.

Gypsies and Travellers Plan

This consultation will help to shape a draft plan, which the council will then prepare and consult on autumn 2021.

Update for Wiltshire Area Boards

January 2021

Coronavirus vaccination

December saw the start of the roll out of the coronavirus vaccination in Wiltshire by our Primary Care Networks. Initially, local vaccination centres were set up in Devizes and Chippenham, with sites in Westbury, Ramsbury, and Melksham vaccinating in the following weeks.

Following government guidance on priorities our first focus is on vaccinations for older residents in care homes, all those over 80 years of age and health and social care workers.

Approval to become an Integrated Care System – BSW Partnership

In December health and care organisations in Bath and North East Somerset, Swindon and Wiltshire (BSW) were confirmed by NHS England and Improvement as meeting the criteria to become an Integrated Care System.

An Integrated Care System (ICS) is a way of working across health and care organisations that allows them to work closer together to take collective responsibility for managing resources, delivering care and improving the health and wellbeing of the population they serve.

The ICSs will integrate:

- primary and specialist care
- physical and mental health services
- health and social care.

Across BSW, hospitals, GP surgeries, community care providers, local authorities, a mental health trust, an ambulance trust and voluntary sector organisations have been working together since 2016 as part of the BSW Sustainability and Transformation Partnership (STP).

Working together as the new BSW Partnership, health and care partners will prioritise issues that matter to local communities as well as managing health and care provision during the ongoing Covid-19 pandemic.

The BSW Partnership is also responsible for setting the strategy and goals for improving health and care in the area and overseeing the quality and safety, decision making, governance and financial management of health and care services. It will also provide clinical and professional leadership for the whole area.

Devizes Integrated Care Centre -update

The Full Business Case for the Devizes Integrated Care Centre will be discussed at the BSW CCG Governing Body meeting on 21 January 2021.

Construction is scheduled to begin in 2021 with the new building opening in 2022.

Trowbridge Integrated Care Centre - update

The Full Business Case for the Trowbridge Integrated Care Centre will be discussed at the BSW CCG Governing Body meeting on 21 January 2021.

Construction is expected to start towards the end of 2021 with the new building opening in 2023.

Medequip retained as provider of community equipment and continence services in Wiltshire

Following a tender process, Medequip has been awarded a new five year contract with Wiltshire Council and the CCG to manage Community Equipment and Continence Services for Wiltshire, continuing a 15 year working relationship in the region.

Medequip is planning significant innovations and service enhancements to further improve community equipment services provision for the people of Wiltshire. The operational site will remain at Calne and will be totally redesigned and extended, implementing a new layout to facilitate increased capacity, throughput and efficiency.

Care in the community - Home First and a new rapid response service

We have seen a significant increase in referrals to the Home First programme over 2020. Home First is an established joint health and social care pathway delivered by Wiltshire Health and Care and the Local Authority. The service aims to speed up the discharge process from hospital, increasing the number of people who need no additional ongoing care and supporting them to regain their independence.

We have agreed to fund an expansion in the Wiltshire Home First capacity to support the increase in referrals and to increase the community capacity for winter. Recruitment is now underway to employ more support workers and therapists.

In addition to the Home First expansion, we are also going to fund a rapid response service across Wiltshire. The service will provide short-term, responsive and reactive interventions for people whose health suddenly deteriorates at home, making sure

they are safe and getting the support they need at home or in community settings to prevent further escalation or hospital admission.

In addition it can respond to a patient who has attended A&E or been seen by an ambulance crew to prevent emergency admission to hospital by providing care in the community setting. Patients should receive services within two hours in a crisis and a two-day referral for reablement care.

The service will be implemented in a phased approach initially boosting response capability within existing community services. The impact of Phase 1 will be reviewed by June 2020 in order to inform future phases of development.

New model for mental health services being developed

We are finalising a new model for mental health services to deliver at pace revolutionary change to the community provision of support for people over 18 years of age across emotional wellbeing and mental illness.

The proposed new model has been co-created across the system, involving people with lived experience, third sector providers and the local authority, and will be based on a Primary Care Network geographical footprint. A total of £10.3million is available for BSW across three years to support delivery which will include investment in the third sector, primary care, community and secondary mental health provision.

We are currently awaiting approval of our plans and will update you further in coming months.



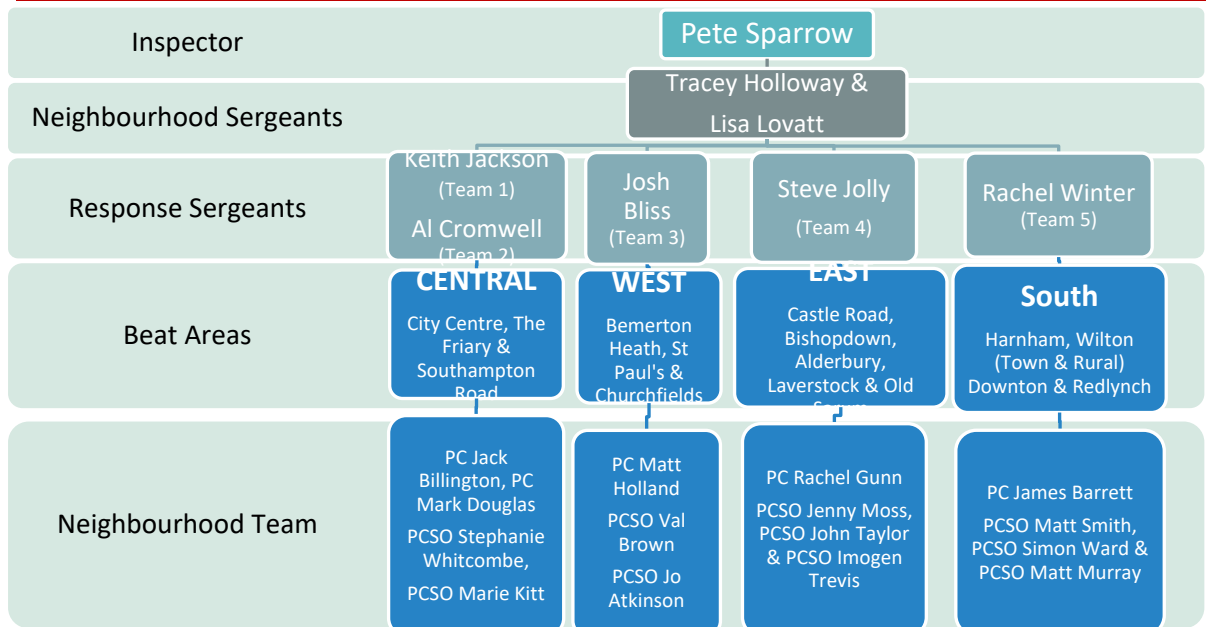
Key Updates

The most significant update since my last report must focus on COVID-19. Lockdown 2 has led into Lockdown 3 as we witness cases, hospital admissions and deaths sadly rising rapidly. No longer are we looking for evidence of the existence of this pandemic as many of us will now have either seen the effects personally or with friends and family. The tragic sudden death of a 36 year of fit male isolating in Salisbury with his brother must serve as a reminder of the dangers of this virus and the need to take this seriously.

This Lockdown has a key message for everyone to 'treat it as though you have it' as the Policing tone changes from Engage, Explain and Encourage towards Enforcement. As I write this, I see reports of parking chaos within our rural community. The direction is to Stay Local. The preference is to walk from your home. This is not always possible, but if you must drive to a local area, common sense must apply where several others have already parked there. Many locations have closed their car parks. That does not mean that you should then park in front of gates – farmers must still have access to their land with their large vehicles.

Not wearing face masks, unnecessary travel or allowing people into your home; it all amounts to additional demand on your Police Service who would prefer to be proactively fighting crime in the more traditional sense. My plea to you is to put effort into following the guidance and not into ways to flex the guidance. What you consider to be acceptable as an excuse to break or bend the rules causes anxiety to others and now is the time to be united. Please Stay Home wherever possible.

The new Salisbury CPT Beat Areas have now been established building better joined up working between the Neighbourhood and Response Teams. Each Response Team has been aligned to a Beat Area to encourage ownership and better Problem-Solving with anticipated increased community visibility and engagement encouraged.

Changes in personnel:

Sgt Lisa Lovatt returns to her Neighbourhood Role with Sgt Steve Jolly returning to leading Team 4 Response. Sgt Rachel Winter has joined Salisbury CPT from the Staff Office to the Assistant Chief Constable.

4 new Student Constables have arrived and are being tutored on Response Teams (PCs Jennie Howells, Hannah Cranham, James Howells & Ben Taylor) with 3 new PCSO (Marie Kitt, Imogen Trevis and Stephanie Whitcombe) joining our Neighbourhood Team. We also see PCSO Simon Nash, LCI Lucy Thompson and Escort Officer Will Hammond leave to start their training as Student Constables – we hope to see them again later this year!

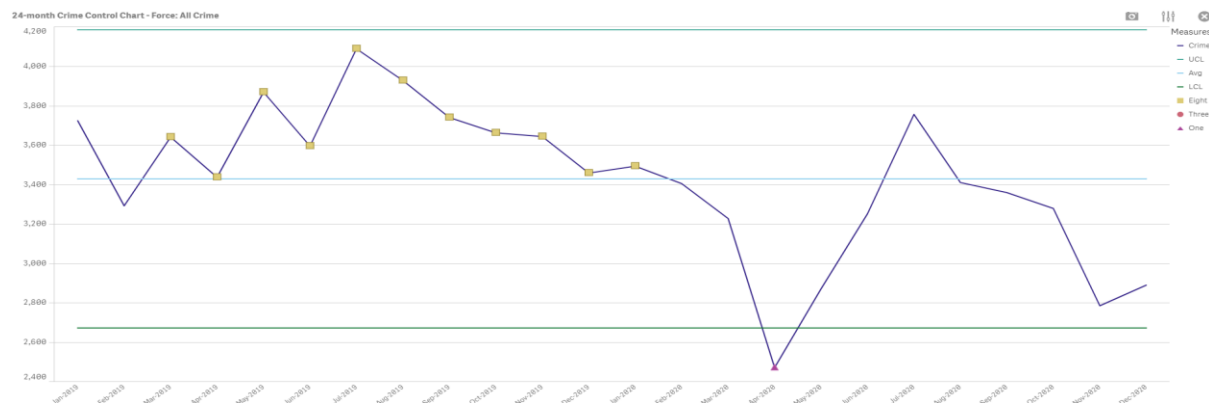
With the uplift in PCSO numbers and following a review of demand, I have increased the PCSO numbers in both East and South areas, which we anticipate will help improve some of the visibility issues, particularly whilst we are managing our response to the Pandemic.

Exception Reporting (Crime Trends)

This is an opportunity to understand crime trends over a 2-year period. This reporting method helps to assess crime trends based on seasonal trends and can assist identifying emerging trends. The central blue line is the 2-year average with the green lines representing the Upper and Lower Control Limits. For the statistically minded the One/Three/Eight markers are where we have consecutive data points that are above or below 1 standard deviation from the mean.

Wiltshire Police:

This chart is provided as a base line to provide context to the performance of Salisbury CPT. It is worth comment on the impact Lockdown 1 & 2 have had upon crime figures. Also of note is that there are seasonal trends where crime is generally highest during the Summer and the Christmas/New Year period. The wider impact of Covid on these charts will have seen that central blue line average lower making the darker blue crime line appear higher. I hope this openness will provide some clarity over perception.



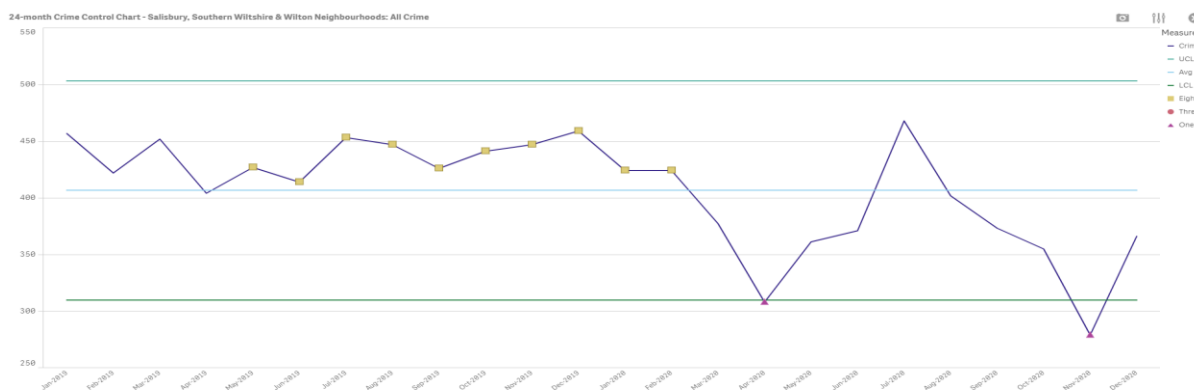

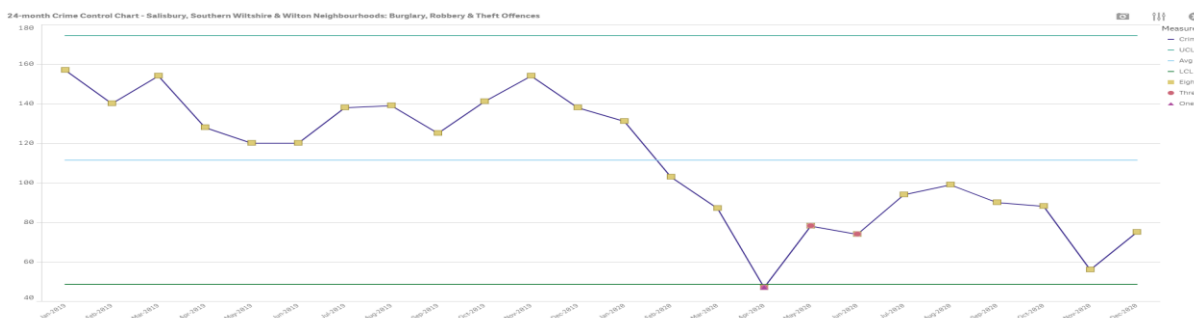


Salisbury CPT:

There are clear comparators between the first 2 charts (Salisbury and Wiltshire), particularly the impact of the Covid Lockdown. The two aspects I will highlight is that Salisbury was the pilot area for Problem Solving during the Summer of 2019 which correlates to the seasonal flattening of demand in the Salisbury area. Although the demands of Crime reporting may have declined during 2020 during the Lockdown periods, our staff remained busy responding to new and changing Covid legislation and guidance. In addition, and continuing to use our performance tools, we continue to promote a Problem-Solving approach to focus on harm, threat and risk to reduce demand. This may account for the improved performance during Lockdown 2 where Salisbury recorded a lower amount of crime than during Lockdown 1.



Acquisitive crime (Burglary, Robbery and Theft Offences) has seen a marked decrease in reporting (burglary in the East and South areas explored later). Closure of shops and more people at home has certainly impacted, but also the proactive efforts of officers to disrupt know criminals operating in our area, based on intelligence, has seen positive results.



Violent Crime reports have also been impacted by Covid. We focus on Safeguarding the Vulnerable, particularly repeat Domestic Abuse victims and there have been reminders that you should not stay home during Lockdown if it is not safe to do so. December saw a sharp rise in of Domestic Abuse reports (below), which is mirrored elsewhere and will explored further to understand any lost opportunities.

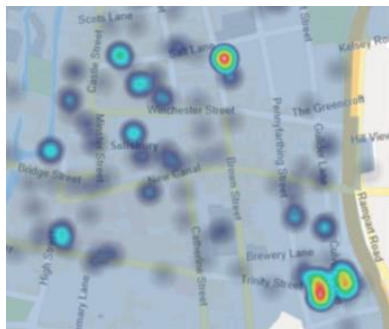

Central (City Centre, The Friary and Southampton Road):



There has been significant focus over the last 6 months on the demand created around Culver Street Car Park, Paynes Hill and Barnard Street resulting in a partnership problem-solving approach being adopted. This reviewed local policies, patrol strategies and best practice from other areas. Funding was secured from Salisbury City Council and the Police Crime Commissioner to move 2 CCTV cameras to key locations, which has assisted in identifying offenders and radio links to CCTV see faster response to ongoing concerns. The below heat maps quickly identified the location of demand. The first map demonstrates calls to the Police for the 3-month period of April-July 2020, whereas the second October to January 2021. The demand reduced significantly to acceptable levels following this work and the demand is now better spread across the City. We will continue to focus our efforts on hot-spots and hope that this again demonstrates the systems available to support officers. Much of this work goes unseen or unreported but benefits communities.

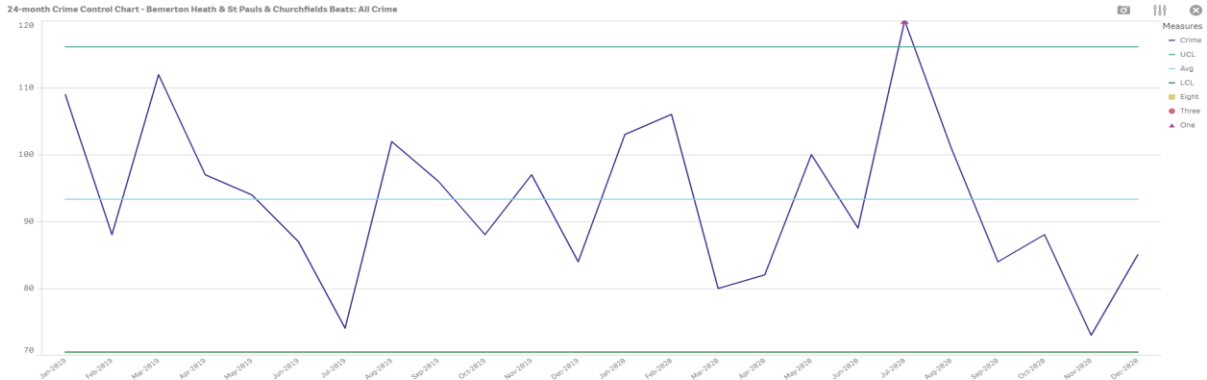

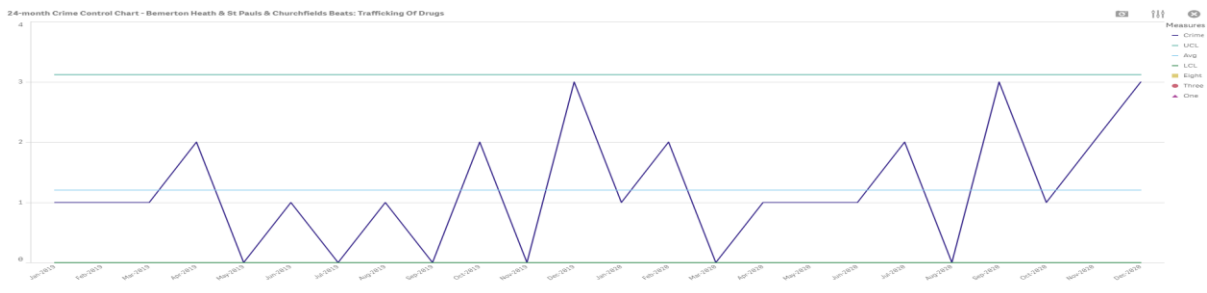

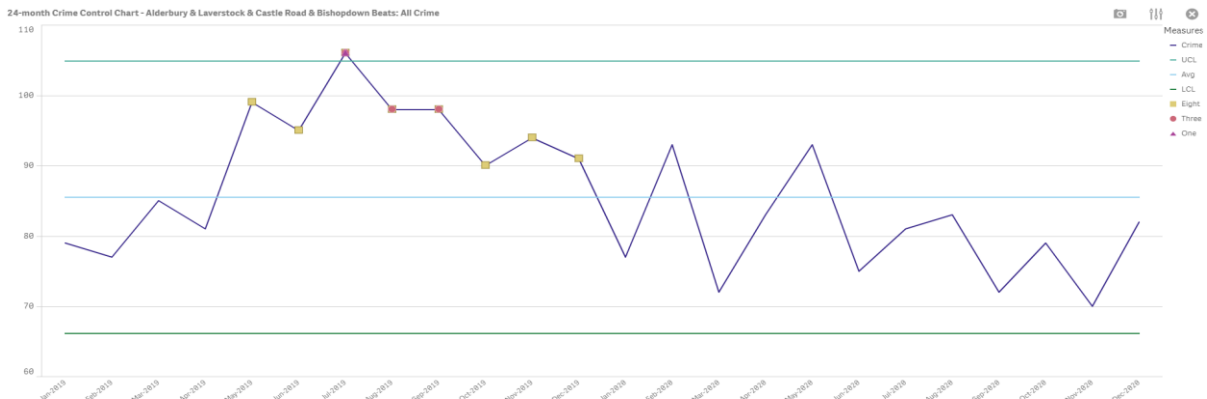
West (Bemerton Heath, St Pauls & Churchfields):



The All Crime 2 year high during the Summer focused on Domestic Abuse cases following Lockdown 1. Since then there has been a fall in offences. There are no 'Exceptions' to crime reporting, although violent crime continues to be monitored (now back below average). We note that there is an increase in the area of trafficking of drugs. This might alarm some, but I believe it is a positive aspect of proactive rather than reactive policing. It also highlights how small numbers can influence such charts. Although we can't speak of many of these cases under investigation, I can say that they are often based on community intelligence and wish to encourage the public to continue to report suspicious activity to help direct future efforts.

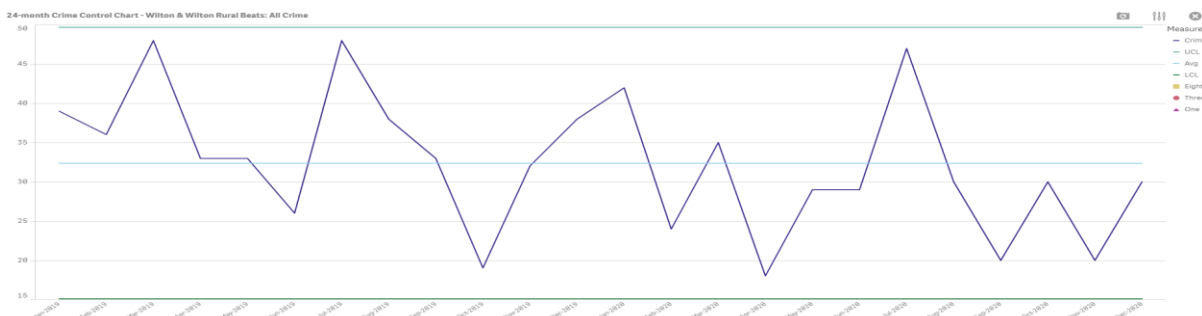
The East area continues to see the fall in crime trend. There are no statistical exceptions but do note there has been lots of debate on social media regarding a recent increase in burglaries. Looking at this as a 2-year profile there has been a short-term rise to being above average and above seasonal expectations. This is being investigated by our Neighbourhood Team with the support of CID and has been a factor in moving a PCSO to this area. We have increased our rural patrols and we continue sharing intelligence with Hampshire and Dorset Police as note that this increase is also seen in the South area.



South:



This is a very large area which crosses over 3 Area Boards and although we staff the area as a whole, it is helpful to break it down further. The consistent theme remains that we remain below average crime in all areas, but there are no statistical exceptions identified.

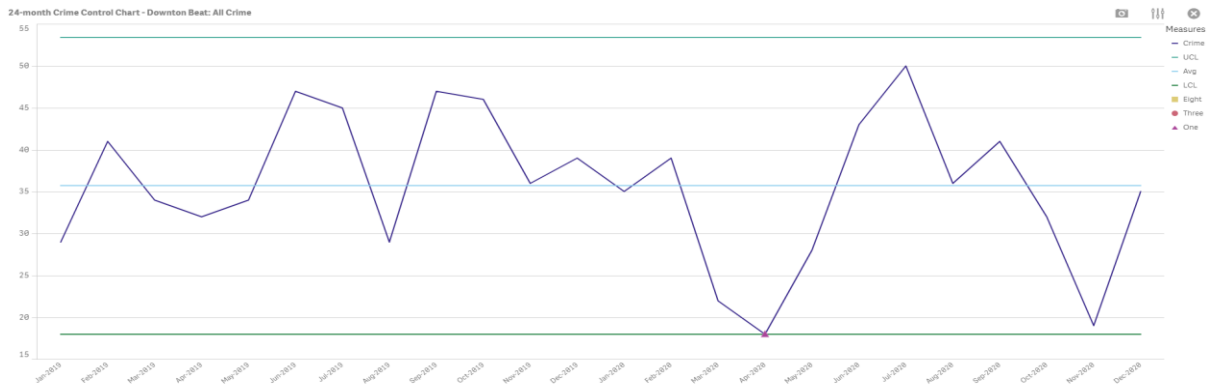
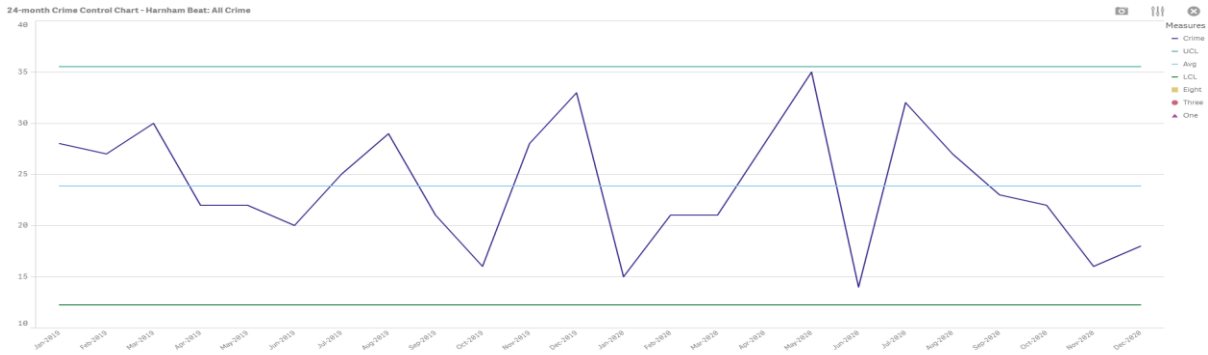

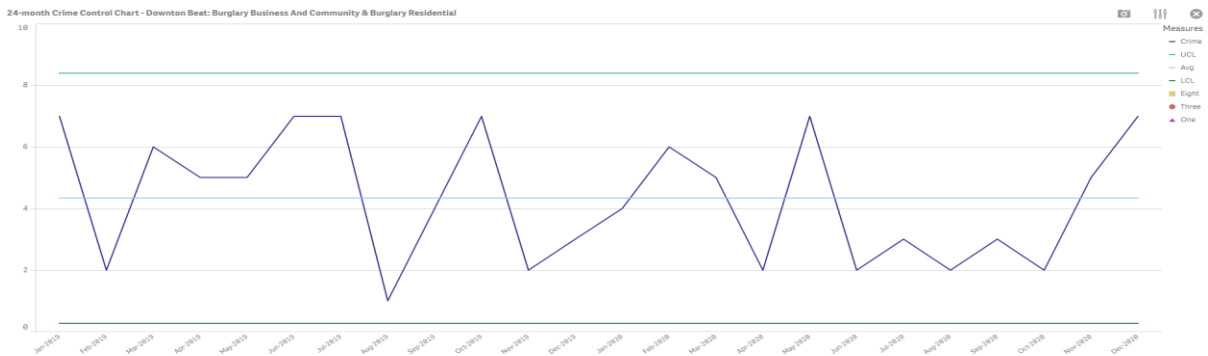

Wilton (above), Harnham (below) and Downton (2 below) remain low crime areas with below average reports and no identified areas or patterns to focus on. It is worth remembering that that smaller the sample the more distorted the image can become.



Although there are no 'exceptions' the Downton area, (which includes Redlynch and parts of the New Forest) it has seen a recent rise in burglaries. This is a factor in moving a PCSO across from the City Centre to the South Area and will help increase visibility. We are working closely with our colleagues in Hampshire and Dorset with our investigation of these offences, which also appear in the East area. This has become a priority and we have increased our patrols of the area to help deter offending.

Highlights around Salisbury

Double Murder

Marcin Zdun, aged 40, was found guilty at Winchester Crown Court of murdering his 40-year-old wife Aneta Zdun and their 18-year-old daughter Nikoleta at their home in Wessex Road, Salisbury on Monday 1 June 2020. This was a traumatic case for everyone involved, but I wish to pay tribute to the members of the public who witnessed and bravely reacted to the events before them and to the initial officers who attended. Their professionalism was surpassed by their acts of humanity and compassion in those final moments. I know they took great comfort from the fact that there was nothing more they could have done to alter the outcome. Zdun was sentenced to Life Imprisonment with a minimum term of 34 years;

a sentence that I hope provides closure to the family, friends and close community of this terrible crime.

Officer Bitten

Mark Archibald, 38, of Salisbury was found guilty of wounding with intent, common assault and assaulting an emergency worker and sentenced to 4 years imprisonment at Bristol Crown Court. The main offence related to biting a young police officer on his arm leaving a wound so severe that required surgery and left permanent scarring. The officer remained professional despite the horrific injury he had just received and remained focused on detaining and calming Archibald on the ground in the middle of Elizabeth Gardens without drawing attention from the families using the park during the Summer. Sadly, this was the officer's last shift for Wiltshire Police as he resigned during his recovery.

Catapults

Mark Day, 33, of Moot Close, Downton, appeared at Gloucester Crown Court and was sentenced to six years and six months imprisonment and fined £170 having pleaded guilty to the following:

- Aggravated taking a vehicle without consent
- Attempted GBH Section 18 on a police officer
- ABH on a police officer

This sentence also took into account a previous assault on 2 Police Officers whilst wearing a knuckle duster and the assault on Police Dog Elvis.

The incident started with a stolen vehicle from Downton and a pursuit that took in parts of Dorset and the New Forest and was recorded by the Police Helicopter. The driving took in speeds in excess of 100mph, a collision with a pony in the New Forest and a foot chase by officers and Police Dog Elvis, where Day fired large metal nuts and stones at close range hitting both officers and dog. One projectile left an officer with a cut to his head, narrowly missing his eye.

The impact of these offences are not just physical and impact on their family and colleagues too. I believe there should be a change in the law restricting the carrying of catapults without a clear lawful purpose. I see far too much crime relates to them.

Bus Burglars

David Clift, 44, from Salisbury and his nephew Josh Clift, 26, from Longhedge, have been sentenced to 2 years and 6 month (David Clift) and 16 months suspended (Josh Clift) for a burglary at Griffin School in Salisbury in September where they stole a safe and the school mini buses.

Dog Thefts

Nationally, Dog thefts have been much commented on during the last year as their value has increased. Responding to correspondence and social media it is important to differentiate between perception and reality with this highly emotive crime. We are Not in the middle of a 'dog theft epidemic' in Wiltshire. That is not to say that this offence does not happen or to undermine the impact of such a crime.

From 23rd December 2019 to 23rd December 2020, Wiltshire Police received just 26 reports that relate to thefts, attempted thefts, and suspicious activity that could be perceived to be a pre-cursor to an attempted theft, of dogs by unknown suspects. Of these 26 reports, 8 of them involved a dog physically being taken, and none of these incidents have any obvious linked patterns to them in terms of suspects, behaviours, breeds of dogs, or locations. 9 of these 26 reports (all suspicious activity) came as a result of a social media release that we made regarding suspicious activity.

What is important is to remain alert and report incident when they happen. This helps us with sharing information to address all sorts of criminal activity.

Poachers

Patrols by Amebury CPT on Salisbury Plain tried to stop a Jeep Cherokee, which failed to stop driving off across country with no lights. Salisbury officers located the vehicle entering Salisbury on the A338 and deployed a 'Stinger' tyre deflator device to stop the car safely.

Five people were arrested for failing to stop for Police, poaching and no insurance with the dogs, equipment and car seized. Wiltshire is a rural county and we will take every opportunity to pursue people who come here to commit offences.

I apologies for a very lengthy report, but I hope I provide you with detail and a flavour of a small percentage of what your Community Policing Team are doing on a daily basis to keep you safe.

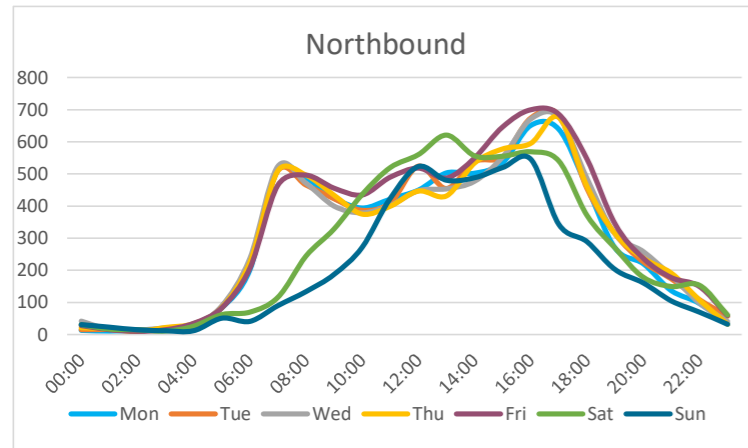

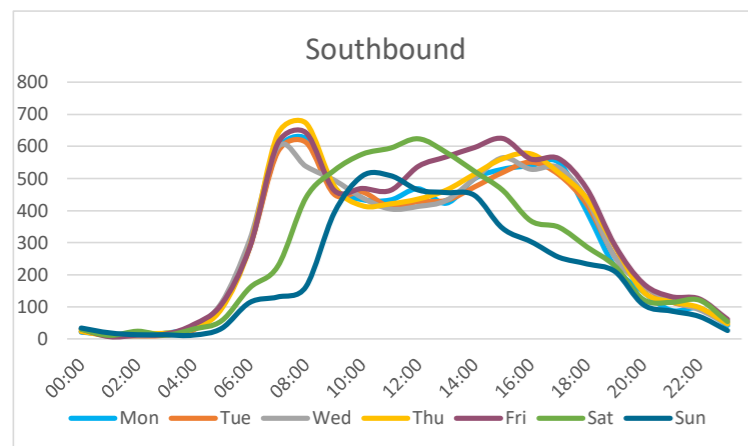
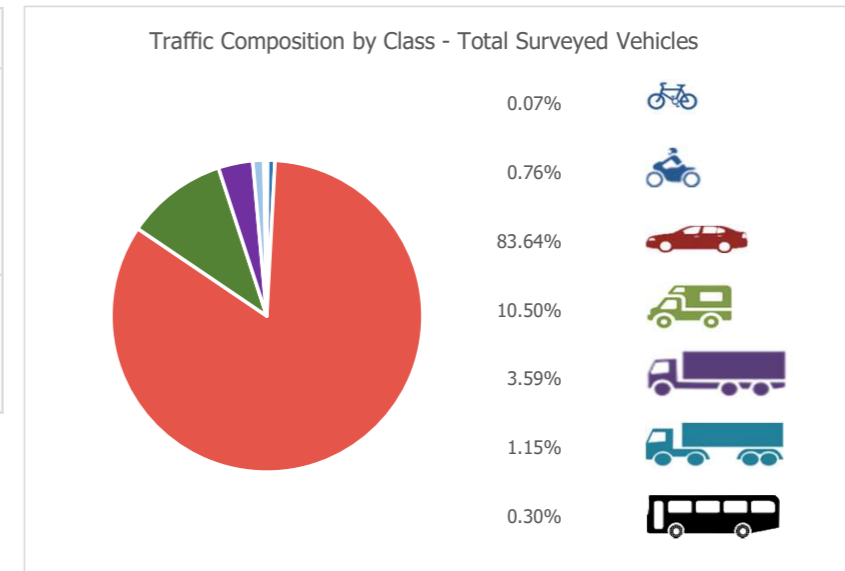

Alabare is a charity supporting vulnerable homeless and marginalised people. Its aim is to help them transform their lives providing accommodation and helping them gain the skills confidence and opportunities to live a fulfilled life. The Garden Centre is part of their Old Sarum Development Centre which offers day activities to adults with learning disabilities autism and poor mental health. The centre also has a fully equipped I.T. suite offering courses to the general public including the ECDL - European Computer Driving Licence. Old Sarum Development Centre is fully accredited to NOCN National Open College Network qualifications. These qualifications help gain the necessary skills to access employment work experience or other educational opportunities. Immediately next door to the Alabare site is Bradbury House. This is a Wiltshire Council run residential care home offering emergency and planned short term respite care for up to 10 people with a learning difficulty some of whom may have additional physical needs. All accommodation is on the ground floor and in single rooms. There are shared recreational rooms and accessible gardens. Old Sarum Development Centre and Bradbury House are 2 miles north of Salisbury and can be accessed via local buses that run from Salisbury and Amesbury. The bus stop is on a large layby immediately outside the Garden Centre and within easy reach of Bradbury House. It is an exposed site on the side of a busy road and with no natural shelter. Both organisations have staff and clients using the bus service and are very happy to support our application. Our intention is to provide a 3 Bay partially enclosed shelter on a concrete hardstanding with a central bench but also plenty of room to accommodate wheelchairs. This supports some of the most vulnerable members of our community whilst contributing to the encouraged use of public transport and all the associated environmental benefits. As well as serving the staff and residents the Garden Centre and Cafe provides a vital source of income for Alabare so anything that encourages visitors to the centre is a welcome source of revenue for them.

Patients will also be given opportunities to co-design content. This will be an invaluable resource for staff to offer patients with dementia as they can utilise the content at any time day or night to reassure and calm as well as using activities to engage patients.

These improved handwashing facilities including hand gel dispenses and increased space for social distancing will provide a more Covid-safe space.

Who will benefit and how:

All Scout Hut users will benefit from gender neutral toilets with improved accessibility handwashing facilities hot water and refillable soap dispensers. The current urinals are extremely water wasteful as they have automatic flushing which occurs every 15 minutes. New toilets with dual flush will reduce our water consumption as well as the volume going into our septic tank. Our plan is to end up with x2 gender-neutral toilets and one accessible one with three handwashing basins. Refurbishing the kitchen to provide hygienic facilities will enable our Scout Group of over 80 young people other local community users and other Scout and Guide groups which use the hut eg during camps in the summer to experience better facilities. The external kitchen and wash-up area will create an outdoor environment where social distancing is possible that can be used during section evenings camps and the suchlike by young people and leaders. It will enable us to cater for events and extend the range of activities that we can organise. It will also allow more young people to use the kitchen and learn the life skills of cooking and food hygiene during Beaver Cubs or Scout meetings. We have a large waiting list and plans were afoot to pilot a second Beaver Colony and Cub Pack just prior to lock-down and we also have plans to develop an Explorer Unit 14-18 years. These are needed as given our relatively rural location there are limited accessible facilities locally for young people and we have also recently seen a rise in anti-social behaviour in the area. During both lockdowns we have managed to deliver a virtual programme to support our young people. When we return to face-to-face Scouting a key focus was and will continue to be working with our young people to support their mental health and well-being

Old people and young people both derive enormous benefit from dogs whether they own a dog or enjoy interacting with dogs they meet. Dog owners and people who interact with dogs are proven to gain both physical and mental benefits. Dogs are deployed as care animals in care homes and for people in suffering for this reason. The majority of dog owners report that dogs have helped them cope with coronavirus lockdown restrictions. Dog owners are the most frequent visitors to parks and the countryside and play an important role in helping to maintain security in greenspaces. Dogs encourage people to explore the natural environment and well behaved dogs are avid watchers and sniffers of wildlife drawing their owners attention to all manner of delights from hedgehogs to frogs. Dog ownership is booming as people increasingly look towards staycations as the holiday option of choice. Local dog owners persuaded to exercise their pets on

routes from their houses will help reduce traffic by not driving to alternative locations further afield. The negative impacts of dogs on wildlife and livestock are well documented as are issues with dog mess presenting health hazards for livestock and people. Our project aims to provide opportunities for dog owners to exercise their pets build a stronger bond between person and dog and also enjoy the rich natural heritage of Laverstock and surrounding Parishes. We own 55 Acres of watermeadows which are bordered by a chalk stream and full of wildlife. We want dog walkers to enjoy enhanced managed access through our watermeadows and also through the urban parks country park open down land and farmed countryside in the local area. This project will help dog walkers find new routes to exercise their dogs enhance facilities for dog owners in the local area and encourage more dog owners to visit dog friendly cafes and pubs and stay at dog friendly holiday accommodation in Southern Wiltshire. The Devenish Bradshaw Trust is a new landholding charity set up in 2018. Our charitable objectives are 1 to preserve conserve and protect the land known as the water meadows in Laverstock the water meadows and its chalk valley riverine habitats 2 to advance the education of the community in Laverstock and the surrounding areas in agriculture horticulture and environmentally-based educational projects concerning the preservation conservation and management of the water meadows 3 to provide or assist in the provision of facilities for recreation or other leisure time occupation for the benefit of the public in the interest of their social welfare 4 to advance promote or carry out such other charitable purposes as the charity trustees in their absolute discretion from time to time think fit.

All Scout Hut users will benefit from gender neutral toilets with improved accessibility handwashing facilities hot water and refillable soap dispensers. The current urinals are extremely water wasteful as they have automatic flushing which occurs every 15 minutes. New toilets with dual flush will reduce our water consumption as well as the volume going into our septic tank. Our plan is to end up with x2 gender-neutral toilets and one accessible one with three handwashing basins. Refurbishing the kitchen to provide hygienic facilities will enable our Scout Group of over 80 young people other local community users and other Scout and Guide groups which use the hut eg during camps in the summer to experience better facilities. The external kitchen and wash-up area will create an outdoor environment where social distancing is possible

that can be used during section evenings camps and the suchlike by young people and leaders. It will enable us to cater for events and extend the range of activities that we can organise. It will also allow more young people to use the kitchen and learn the life skills of cooking and food hygiene during Beaver Cubs or Scout meetings. We have a large waiting list and plans were afoot to pilot a second Beaver Colony and Cub Pack just prior to lock-down and we also have plans to develop an Explorer Unit 14-18 years. These are needed as given our relatively rural location there are limited accessible facilities locally for young people and we have also recently seen a rise in anti-social behaviour in the area. During both lockdowns we have managed to deliver a virtual programme to support our young people. When we return to face-to face Scouting a key focus was and will continue to be working with our young people to support their mental health and well-being.

8. How will you monitor this?

The project will be reported on in our Trustees Annual Report. We can seek feedback and testimonials from the young people themselves Section Leaders and other Scout Hut users. We will also monitor the number of events that are held at the Scout Hut each year in particular the number of users outside Downton Scout Group. We hope having better facilities will enable us to market the Scout Hut and obtain a small income from letting it.

It is the Policy of The Scouts to safeguard the welfare of all children young people and adults at risk by protecting them from neglect and from physical sexual and emotional harm.
