#### SALISBURY CITY COUNCIL'S REQUEST FOR THE RELEASE OF DEVELOPER OFF SITE CONTRIBUTIONS

## 1. Purpose of the Report

1.1. To seek Area Board approval of Salisbury City Council's request for release of £95,000 of developer contribution money held by Wiltshire Council for the refurbishment of the children's play area at Queen Elizabeth Garden's.

## 2. Background

- 2.1. Salisbury District Council on the 25<sup>th</sup> July 2006 approved a play area scheme for Hudson's Field costing £95,000 to be funded from developer contributions.
- 2.2. Salisbury City Council has requested that this money be reallocated to fund the refurbishment of the children's play area at Queen Elizabeth Gardens, Salisbury. The scheme will include disabled play equipment provision.
- 2.3. The proposed play area scheme is a new scheme and needs a new approval.
- 2.4. As the request is for more than £30,000 the area board are requested to approve the application.

# 3. Main Considerations

- 3.1. Sufficient developer contribution money was transferred to Wiltshire Council to fund the commitments made by Salisbury District Council including this one. The Developer Contribution money is held in a ring fenced account.
- 3.2. The developer contribution money is not sufficient to fund the whole scheme. Salisbury City Council has additional funding available which has to be spent by the end of the financial year 2010/11.
- 3.3. To achieve this, the order must be placed in the next couple of weeks.
- 3.4. If this additional funding is lost the scheme will not be able to proceed in its present form.
- 3.5. The proposed use of the contribution money to refurbish the children's play area at Queen Elizabeth Gardens complies with the requirements of the Planning Policy R2 under which the contribution money was obtained.

The money is ring fenced and will not affect Wiltshire Council revenue or capital budgets.

Failure to complete the project before the end of the financial year will result in the loss of £25,000 funding to Salisbury City Council meaning that the scheme would not proceed in its present form.

Thank you for your time yesterday and the information you were able to share with Steve Ibbetson and myself we found very useful and informative.

Just to confirm that we have no concerns over the transfer of funds from Hudson Field to the Queen Elizabeth Gardens scheme, and Steve will prepare the report to authorise this change. You gave us a breakdown of how you will proceed and estimated times for tenders to sent to contractors/suppliers within 4/6 weeks and you then hoped to award the contract early in September. We would request that you make a formal application for the release of the funds prior to the awarding of the contract, this will enable us to create an audit trail and this would then require copies of all the tender doc's, quotes and order placed etc
