Date: 14 Signature:\* X if witness evidence is visually recorded (Supply witness details on rear) I am the Sergeant for the Neighbourhood Policing team and I am based at Trowbridge police station. My role is to over see the running of the Wiltshire Police policy on Neighbourhood policing. As part of this responsibility one of the beats under my supervision the Trowbridge Town centre of which management of its night time economy is a very integral part. This has a firm focus of reducing Alcohol related anti social behaviour and violent crime. I will also try to identify potential causes of this crime offering both educational and enforcement solutions. I have become aware over the last couple of years or so of regular reporting of Disorder outside and inside an establishment known to me as Favourite Chicken, Market street Trowbridge. These have ranged from drunken arguments to some quite disturbing public order incidents in which people have been jailed for their part. Since 01/01/2010 there have been 56 police logs created 26 of them occurring after 0400 in the morning at this location. If a comparison of police storm log incidents is made against two Late night refreshment premises also operating within Trowbridge centre. (These are licensed until 04.00 hours and 04.30 hours on Friday & Saturday nights, both closing at 03.00 hours on other days) together both these premises have created 9 police logs over the same period and only 1 was after 0400. I have concerns that this establishment is becoming a pinch point for violence and public order and that valuable Police resources are being committed to dealing with the aftermath of these incident and therefore not in a position to respond to other emergencies around Trowbridge.On Friday and Saturday nights resources are pushed to the limits. I am aware that following some incidents in the past collection of CCTV has been an issue at the premises and thus potentially important evidence has been lost. My fears are not only for the disturbances but for the staff in the premises who are potentially being put at risk from Alcohol related violence. I hold a regular press conference on a Tuesday Morning and provide them with what they call News in Brief articles. They are so used to information about arrests and disturbances attended to by the police at these premises that they are asking for any incidents from Favourite Chicken if there is little other news. My concerns centre around managing and protecting those out on a night in Trowbridge and as often as not officers are being called to inside and outside the premises as is their duty. I would like all sides to be able to manage this situation and reduce the risk of violence to those making use of Trowbridge town centre Signature: Signature witnessed by:
