Dear Adrian and Jackie

Having been made aware of the objections to the plans for Farm Shop, and in particular to the plans to extend to the shop the same licence terms as currently operate for the pub, we would like to express our support for your plans for the shop, and are happy for this letter to be shared with local representatives or the planing committee.

Having lived in Edington for over 11 years we have been concerned for some time at the loss of amenities from the village, and knock-on effects such as loss of local employment. When the Lamb Inn (as it was then called) was closed by Enterprise Inns this took away one of the key focal points for our community, and so we were delighted when it was re-launched as the Three Daggers. The further development of the shop and microbrewery is particularly pleasing as it further reinstates lost amenities, renews community focal points and brings new local employment.

Our property is a couple of hundred yards along the road from the pub and shop and although we recognise that there will be some additional traffic and people, it has always been our wish, as it has for most of those we know in the village, that it should be a vibrant local community and not a stuffy, unwelcoming place that has been "preserved in aspic". Since the pub re-opened as the Three Daggers we have not experienced any nuisance from noise or light pollution and would not anticipate the licence application for the Farm Shop changing this significantly. Thus far there has been a sensitivity to the risk of local disturbance arising from the Three Daggers' operations, and we would hope and expect this to continue with the new development.

We were actively involved in the development of the current Parish Plan, and I (Neil) was one of the authors. The plan was careful to reflect the views of the majority of those living in the village (a survey was carried out of all households) and a particular outcome of this was strong support for appropriate local development, business and employment. 62% of those surveyed wished there to be further employment opportunities within the village, and a particular theme within the plan is to support the development of existing businesses (e.g. The Three Daggers) to create more jobs. The lack of any shop, and the loss of community venues particularly in the Tinhead end of the village were two specific concerns raised in the plan which we hope that the farm shop development may assist in easing.

As you will know, we are regulars at the pub, and are actively involved in a range of local community and charity activities. As long-standing residents who work closely with many others in the village, we know that the overwhelming majority support the developments at the Three Daggers, and for our part we can confirm that support.

If you would like us to communicate our support directly to the planning authorities we would be pleased to do so.

These objectors clearly come from the school of "not in my back yard"

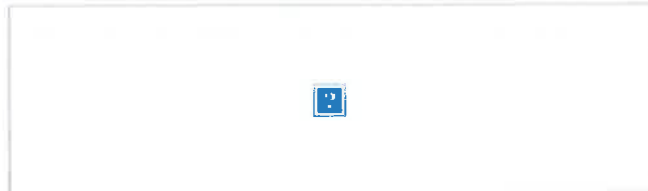
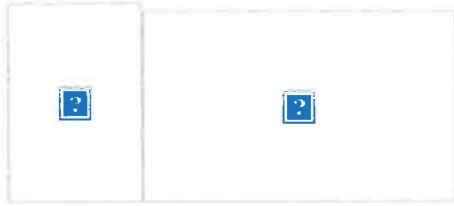

Petition In Support Of Edington Farm Shop and Micro Brewery Licensing Application

The Issue

The new village Farm Shop and Micro Brewery has applied for a licence to sell alcohol until 11pm – the same as the Three Daggers pub. Three objections to the application have been lodged which means the decision will now have to go before a licensing hearing rather than simply being approved by the committee.

The objectors believe that granting a licence will encourage anti-social behaviour, create public nuisance, prejudice public safety and create potential harm to children. They also claim that the licence will have a detrimental impact on the locality causing light pollution, noise pollution, traffic congestion and litter.

The shop and brewery is seeking a licence to ensure that there is the flexibility within the business to conduct tours and tastings during the evenings and to host occasional functions. It does not mean the shop will be open selling alcohol every evening until 11pm or that there will be a bar running every night at the brewery in competition to the Three Daggers.

To refuse the licence could put many aspects of the functionality of the premises at risk with a potential impact on local employment and on the ability of the community to take full advantage of the social and recreational facilities the venture offers.

We would like to show our support for this new venture and we ask you to help us by signing this petition.
