Dear Miss Hould,

In relation to the Police objection of the application for a premises licence at the National Trust Avebury police have conducted enquires into the background of the proposed site. Over a period of the last 12 months there have been no recorded instances of crime or disorder related to the premises.

Further discussions have taken place with both the applicant and their legal representative around the four licensing objectives which had not been fully addressed in the original submission of the application.

Thank you for your very helpful email.

I have taken further instructions on this and can confirm that there is no intention at present to have any live music events of the type mentioned, but the flexibility to do so in the future would be very much appreciated. Anything that is held is likely to be low-key because of the NT's over-riding priorities of conservation.

With that in mind, we can agree that the application should be modified to include :

- Only 2 outdoor amplified live music events will take place in a calendar year, with at least a 60 day interval between each event
- The distance between the stage/ Front of House(FOH) mixing desk and any residential property will be maximised
- A maximum of 1000 patrons will be permitted attend any such event
- A site plan clearly indicating the proposed stage/FOH position, will be submitted to the Licensing Authority, along with the proposed scheduling of the event, at least 3 calendar months before any event

- The total 'on-time' for live music will not exceed 4 hrs and will cease by 23:00hrs.
- Noise monitoring will be carried out during the event, based on any predicted noise levels provided by the Environmental Health Authority to the Licence Holder
- The organisers of any event will be available during the event to deal with any complaints and act accordingly.

Please note the minor amendments to clean up the wording that you have provided. We will of course present this to the hearing next week as a combined document with the Police conditions.

In copy to Licensing, with this in place and the agreement with the Police, we understand that both Environmental Health and the Police are now withdrawing their representation. I am sure that the relevant officers will confirm this by return.
