The Rise trust Youth have been working with Chippenham Borough Land Charity and have secure the old Oak Furniture Land premises free for 6 months as a dedicated youth centre. However, the building is completely empty. CBLC have also given a seed fund to pay for bills and additional youth work in the building. Rise Trust are reaching out to Area Board for capital support to fund tables, chairs, sofas, and other equipment for young people.
