Performance - 12 months to May 2021

Force

- Wiltshire Police has had a decrease in the volume of recorded crime by 9.8% in the 12 months to May 2021 and continues to have one of the lowest crime rates in the country.
- Wiltshire Police has seen a 16% reduction in vehicle crime and a reduction of 39.2% in residential burglaries in the 12 months to May 2021.
- Our service delivery remains consistently good.
- In May 2021, we received:
- 9,044 '999' calls, (answered within 9 seconds on average);
- 11,292 '101' calls, (answered within 13 seconds on average);
- 11,415 'CRIB' calls, (answered within 1 minute and 29 seconds on average).
- In May 2021, we also attended 1,610 emergency incidents within 9 minutes and 23 seconds on average.

Stop and Search information for Chippenham CPT

During the 12 months leading to April 2021, 185 stop and searches were conducted in the Chippenham area of which 82.7% related to a search for controlled drugs.

During 76.8% of these searches, no object was found. In 22.2% of cases, an object was found. The remaining 1% did not have this information recorded.

Of these cases 79.5% resulted in a no further action disposal; 19.4% resulted in police action being taken; 5.9% resulted in an arrest.

Of the stop and search subjects who defined their ethnicity:

- White 162 stop and searches.
- Mixed Ethnicity 6 stop and searches
- Black or Black British 6 stop and searches
- Asian or Asian British 1 stop and searches



Local Priorities & Updates

Priority	Update
COVID	With lockdown restrictions easing, focus remains on local public houses to ensue they are COVID compliant. Any breaches of legislation will be dealt with and/or reported to the licensing team
Speeding (all sectors)	Officers are conducting speed checks at various locations across the sector. The locations are predominantly chosen based on intelligence and complaints received from members of the public at our recent community consultations. Locations in Calne identified as London Rd, Stockley Lane, Quemerford, North St and Curzon St. CPTN will target these areas and any others identified to us.
Tackling the supply of drugs	CPT has been, and is currently, targeting local drug dealers within our area. In the last 18 months we have executed 20 warrants. We have seized over £100k worth of drugs and thousands of pounds in cash. A local male from Calne has recently been arrested twice for possession with intent to supply Class A. The four warrant executed in Calne have resulted in £30-35k of drugs being seized.
ASB	There had been an increase in ASB reports around The Pippin and The Rec which coincides with the lifting of COVID restrictions. A local youth is currently being dealt with by CPTN for damaging flowers in The Pippin, CPTN are working with YOT to address the behaviour. High visibility patrols are being conducted to target ASB

Local Priorities & Updates Continued

Priority	Update

High Level Updates: Force

- **COVID-19:** From Monday 19 July, it is expected that the COVID Regulations will be amended further as part of the final stage of the Government roadmap. We have sought throughout the pandemic to take a proportionate response, working with our communities and we continue to see high levels of compliance with the regulations across the County.
- Police Officer Uplift: As part of the Govenrment plan to recruit an additional 20,000 officers in England and Wales via the Uplift programme we have exceeded our first year allocation; recruiting 60 officers funded by Uplift by March 2021 (compared to a target of 49). We have recently closed our PC recruitment campaign – receiving 400 applications within 48 hours of recruitment opening.
- **Surge Demand:** We know that once lockdown restrictions lift, certain areas of our operational demand will rise. We will be launching a public engagement initiative to coincide with the lifting of COVID restrictions to inform the public of what this demand will look like and the part they can play in helping us manage it. Look out for this summer-long campaign launching next month.



Reconnecting Support Group Meetings

These meetings were set up last summer following the first lockdown and held in the Pocket Park. The purpose was to bring people together safely to reconnect with friends and make new ones. The Town Council then kindly granted us free use of the Town Hall enabling us to meet over the winter as long as restrictions allowed. Calne Area Board also gave us funding to pay for us to continue using the Town Hall every Tuesday from April 2021 until the end of this year with funding also for refreshments and entertainment. We now have 25 members who attend regularly enjoying not only the social side but quizzes, word searches, bingo, fun exercise sessions, watching Celebrating Age concerts on YouTube. For some members this is still their only outing and contact with others. As a support group, regulations would allow up to 30 members plus volunteers. Risk Assessments are in place and all guidelines followed.

In January with the help of volunteers, 70 Afternoon teas were sent out to Older People in the community along with greetings cards from Calne School Pupils. An amazing 140 cards were made and delivered.

Petting Zoo. Chloe's Petting Zoo has been booked for 20th July in the Pocket Park from 10.30-12pm. This has been a favourite activity of members of the Reconnecting Group Members

Celebrating Age has been actively working with our community by providing on line concerts for those who have access to computers.

Also following the success before Christmas of the short outside garden concerts for people either isolating or unable to leave their homes, two more successful days this year saw performances in Derry Hill, Hilmarton, Calne and Compton Bassett. These included visits not only to Individuals but also to our two Sheltered Housing Schemes and local Care Homes. Another day is planned for 19th August.

Also an outdoor musical concert by Mary Lou is planned for 29th July in the Pocket Park from 10.30-12pm. Weather permitting.

All this can only happen with the support received from the Volunteers.

Many of the Activities and Clubs for Older People have still not opened, including Day Care. Information still needs to be gathered re the need for these and if changes need to be made, as the needs of Older People and Carers may have changed over this last year.

Project Description:

Calne Cricket Club are seeking grant money to replace the club's 17 year old pedestrian Dennis Mower and much needed cricket equipment to enable the club to continue to cut and maintain the cricket square and to meet the league requirements. The club is also applying for a replacement boundary rope, a winder and replacement covers.

Input from Community Engagement Manager:

Calne Cricket Club have been offering cricket activities to the community of Calne for more than 100 years and are proud to have 11 teams playing cricket ranging from under 7s to adults every season. Last year saw the introduction of a ladies cricket team for the club. The club membership has been able to grow with the vigorous and thriving youth section. The 1st team is part of the West of England cricket pyramid whilst the 2nd 3rd XI play in the Wiltshire County league. If the club were successful with the grant the club can continue providing cricket activities to the community and to comply with the league requirements for maintaining the cricket square to the Grounds Maintenance Association Standards.

Calne Cricket Club are using some of the club's funds to purchase some of the replacement equipment that is needed for this coming cricket season. The bulk of the other match funding is being contributed by Hills Trust Ltd.

Project Summary:

To continue to provide twice weekly detached street-based and weekly place based youth work in Calne. This will provide young people with opportunities to engage with professional youth workers for support advice and mentoring. A safe youth space was introduced in May 2021 in partnership with Calne Town Council using space at Calne Town Hall.
