Wiltshire Council needs to recruit foster carers of all types, including specialisms. Foster carers are needed in all areas of the county, although it is recognised that the main priority is to recruit in the main towns to the north and west of the county (Chippenham and Trowbridge) and to the south (Salisbury). Most looked after children come from these areas and so generally local foster carers are needed to support children continuing at school and college and to facilitate family contact more easily.

Foster carers are ordinary people and so they are likely to be living in any part of the county, in any community. To become an approved Wiltshire foster carer you need to:

- Be at least 21 years old (although they can apply from the age of 18)
- Have a spare bedroom big enough for a child or young person to use
- Be a full-time resident in the UK or have leave to remain
- Be able to give the time to care for a child or young person on a full or part-time basis

Foster Carers are paid an allowance based on the age of the child they look after and a Skill Fee dependent upon their skills and experience.

Recent research carried out at Bristol University with children in care shows how important it is that children have someone they can trust, who is interested in them and that:

"Living with someone that you have a good and trustful relationship with is the key to a happy and effective placement"

<u>Saving Grace</u> is the story of a young person who was fostered, and the positive impact fostering had on her life, and on the life of her foster family.

Wiltshire Council and Salisbury City Council are proud to be hosting the grand final of the elite cycling OVO Energy Tour Series on May 31 as part of the recovery of the city. This exciting free event is the first major event of the recovery programme and will showcase Salisbury to the world as the ITV4 programmes are broadcast to more than 100 countries. A dedicated webpage providing up to date information on what is happening in Salisbury has been set up at www.wiltshire.gov.uk/salisbury.

Changes have been made to the free parking provision in Salisbury and came into effect on May 14. These changes were made following feedback from the city's community and businesses. Shoppers and visitors will continue to be able to park free of charge in Wiltshire Council's car parks from midday Monday to Friday and all day on Saturday and Sunday. Parking continues to be free at the five park and ride sites.

The recovery is moving fast and we are reiterating that Salisbury is safe for residents and visitors outside of the cordoned off areas. It's important to emphasise that no further reports of illness have been reported since the incident on Sunday March 4. The city is recovering and getting back to normal.

The clean-up stage of the recovery is well underway. Nine sites have been identified as potentially contaminated. These are Bourne Hill, Salisbury Ambulance Station, Amesbury Ambulance Station, Maltings Park, the Mill pub, Zizzi restaurant, Ashley Wood Car Recovery Centre, Mr Skripal's house and the police officer's home.

Work to clean each site involves testing, removing any potentially contaminated items, chemical cleaning and re-testing. Sites will not be released until tests have been reviewed and approved. This work could take several months and the priorities are Bourne Hill, the two ambulance stations and The Maltings. They will be followed by The Mill pub and Zizzi restaurant. We will keep the community updated as the work progresses. The recovery is being overseen by the Recovery Coordinating Group (RCG) which is made up of local and national agencies.

Corsham Community Policing Report Area Board – 31st May 2018

Hello and welcome to this Community Policing Team report.

There is an ongoing improvement programme in place which relates to 101 and the Contact Centre and it is being headed up by Superintendent Minty of Wiltshire Police. The graphical information below relates to this improvement plan.


We are continually recruiting, so far in 2018 we have recruited

- o 16 people in Feb
- o 16 people in April
- o 15/17 due to start in July

We have carried out an indepth review of demand in 2017 to understand changes, this has led to

- o A new shift pattern for full time and part time staff
- o These patterns came into operation in April 2018
- An large investment of money by the PCC and Chief to recruit additional staff

The graphs below relates to all the Crime Recording Incident Bureau (CRIB) stages, so that is after the initial 101 being answered. It has been identified that it is always at the CRIB stage is where the problems lie.



As you can see we are answering the phone more swiftly.

The below graph shows the percentage of calls that are abandoned (ie – they put the phone down before the Police answer it)



Again there is an improvement to the data last summer.

Demand will increase from the end of May to the beginning of September and it is highly likely that it will take us slightly longer to answer the call, that is why it is important that people understand what the police can and should deal with and not to call us for those issues that should be directed to places for example the Council or if it isn't a police matter.

COMMUNITY MESSAGING

We are constantly reviewing our visibility and how we can develop this and work with our communities. We cannot physically be everywhere all of the time and we want to ensure consistent information with our communities and to be able to provide the information that matters to you when you need it. There has been some good feedback from our new way of working using Community Messaging so please sign up and use it. https://www.wiltsmessaging.co.uk/

Our CPT priority: Corsham Community Campus and Springfield Recreation Ground. Also persistent offenders and ongoing issues affecting the Community in line with our Force Control Strategy. Priority Offenders are established at a weekly Sector meeting, as a result priorities and taskings are raised as a way to effectively manage live intelligence and priorities that are developing in the northern hub.

I am pleased to report that since the last Area Board meeting, there has been no further complaints involving the Campus and the Policing objectives have been achieved both in the community and within the Campus. This continues to be subject to the weekly Sector Priority meeting and remains a priority for the Community Policing Teams.

CONTROL STRATEGY

Every year, the Force assesses its operational priorities for the year. Through a combination of research and consultation, the Intelligence team identify the areas of criminality that present the biggest threat, harm and risk to our communities as well as the areas where we most need to fill gaps in terms of our understanding, intelligence or capability.

The resulting document is known as the Control Strategy and this week we signed off the 2018/19 edition which I wanted to share with you all.

This year our Control Strategy outlines the following operational priorities:

- Modern Slavery & Human Exploitation (including Criminal Exploitation of the Vulnerable)
- Child Sexual Abuse (including Child Sexual Exploitation)
- Organised Criminality (including County Lines)
- Domestic Abuse
- Youth Offending and Emerging Gang Culture

As has been the case in previous iterations of the Control Strategy, there are clear themes running through all the priority areas — 'Cyber Capabilities' and 'Vulnerability and Exploitation'. Digital technology is used to carry out offending in all the above areas. And, at the heart of all the above there are vulnerable victims, witnesses or offenders that are often being exploited.

Below is our control strategy for your reference. This focuses on where how we conduct our operational Policing based on the Police & Crime Plan. We will continue to align our resources with the threat/harm/risks presented in line with the control strategy.

Officers from our Community Tasking Team attended Bath Police station and joined up with A&S Police who was also dealing with a burglary series. Wiltshire Police arrested and interviewed two males on suspicion of a number of burglaries, after a very long day, they were charged with the Burglary at Barnett Brothers and the other burglaries at the Co-op in Box, Corsham and other areas nearby, were 'Taken into Consideration' (TIC'd), this essentially means that they were interviewed for the offences and admitted involvement which is a detection for these cases.

23/04/2018 17:00 - 24/04/2018 08:30 Unknown suspect has broken both wing-mirrors off white Mercedes Sprinter van parked outside Rosemary Houses, Lacock.

 $23/04/2018\ 16:00 - 24/04/2018\ 12:00$ Unknown suspect has climbed onto the roof of a workshop in Ashley and has removed the lead and made a hole in the roof, it is believed the unknown suspect has attempted to break into the workshop but no entry gained. <u>Other</u> – The second IAG (Independent Advisory Group) meeting took place on the 10th April followed by another meeting on the 25th April at Monkton Park Council offices, Chippenham. During this meeting a Chairperson was appointed and further direction was given to those who attended on how they can support the Police (CPT) and how this is a great opportunity for some really constructive critical feedback to be given about how we police in Wiltshire and what really matters within your communities.

Corsham Area Board - Report 31st May 2018

Be a good neighbour

Dorset & Wiltshire Fire and Rescue Service is urging local people to consider the safety of friends and neighbours, following a recent episode of the Channel 4 programme '999 What's Your Emergency' #999WYE.

The episode highlighted isolation issues and the Service is renewing its request to the public to look in on friends and neighbours they feel might be at risk, and not just from fire.

Dorset & Wiltshire Fire and Rescue offers free Safe and Well visits to those most at risk within our communities. We can visit you in your home, at a convenient time, to see what we can do together to make you safer. We can also have a conversation with you around improving your health and well-being. The Service will fit free smoke alarms where required and offer advice to make you and your family safer and healthier in your home.

The appointment normally lasts about one hour and covers topics such as:

- Using electricity safely
- Cooking safely
- Making an escape plan
- What to do if there is a fire
- Keeping your family safe
- Good practice night time routine and other points relevant to you
- Identifying and discussing any further support you may need if necessary

Kitchen Safety

North Wiltshire residents are being reminded to take care when cooking, due to the high percentage of accidental fires in the area starting in the kitchen.

Within North Wiltshire, the Fire & Rescue Service attended **43** accidental fires in the home during 2017-18, **23** of these were directly attributed to cooking. The figures for the Corsham area are 5 out of 9 accidental fires in the home last year being caused by cooking.

Amongst the top tips for kitchen safety are:

- Keep the oven, hob and grill clean as a build-up of fat or grease can catch fire when hot.
- Keep tea towels and cloths away from the cooker and hob, and take care if you're wearing loose clothing.
- Make sure children are never left alone in the kitchen when you're cooking.





- Saucepan handles left sticking out create a danger there's a risk they could be caught, leading to the pans being knocked off the hob.
- Use spark devices to light gas cookers as they are safer than matches and lighters.
- Wherever possible, never leave cooking unattended. If you do have to leave, set a timer – on the cooker or through your phone or watch – so that you don't lose track of time.
- Keep electrical leads and appliances away from water.
- Rather than use a chip pan, use a thermostatically controlled deep fat fryer, which can't overheat.
- Avoid cooking if you are tired, have been drinking alcohol or are taking medication that leaves you drowsy.
- If you're going to the pub and think you'll want something to eat afterwards, get a takeaway!
- Make sure you have working smoke alarms and test them weekly. If you do have a
 fire, get out, stay out, and call 999.

Don't let hay fever spoil your summer!

Spring and summer are wonderful seasons, filled with blossoming flowers, sunshine and warmth and many more of us will be spending time outdoors. But for hay fever suffers, this time of year can cause worry and discomfort.



Hay fever is a common allergy and can affect up to one in five people at some point in their life, and is mainly caused by grass pollen.

The good news is you don't need to see your GP for hay fever treatment. Wiltshire Clinical Commissioning Group is urging residents of Wiltshire to consider buying their own hay fever treatment, instead of getting it on prescription.

Hay fever and seasonal allergy treatments such as tablets, eye drops and nasal sprays are all easily available from your local pharmacy, and you don't need a prescription from your GP.

As pollen count increases, hay fever suffers dread the oncoming symptoms, which include a runny nose, itchy eyes and sneezing. That's why it's always good to be prepared. The symptoms of hay fever can be really unpleasant and the best way to control them is with antihistamines, which are inexpensive and can be bought from many shops and pharmacies on the high street.

By going to the pharmacy you'll be saving yourself time and money, freeing up GP appointments for people with more urgent needs as well as doing your bit to help save the NHS money on unnecessary prescription costs. Your pharmacist will also be able to offer you advice on how to avoid triggers.

There is currently no cure for hay fever, and you technically can't avoid it, however, there are ways to help reduce the effects including:

- Wearing wraparound sun glasses when outdoors to protect the eyes
- Showering and changing your clothes after being outdoors will help stop the spread of pollen through vour home
- Putting a small amount of petroleum jelly in your nose helps to trap pollen grains
- Keeping an eye on the weather forecasts and staying indoors to avoid going out when the pollen count is high

Self-care is an important part of keeping well and having a well-stocked medicine cabinet can help you treat minor illnesses, such as hay fever, and injuries at home without the need to see a GP.



Area Board Update: May 2018

Five ways to give feedback to help shape local health and care services in Wiltshire

Share your experiences of local health and care services and make it better for everyone - that's the message from the county's independent health and care watchdog Healthwatch Wiltshire as it celebrated its fifth birthday on 1 April.

Healthwatch Wiltshire, along with 147 other healthcare organisations in England, was set up in 2013 as a result of the Health and Social Care Act 2012. Its role is to listen to the views of the public on local health and care services. They then use this feedback to help influence decision-making at a local level, shaping services for the better.

In the last year, the Melksham-based organisation has regularly visited all corners of the county and collected 2495 individual views and experiences. Overall, 46 per cent of feedback was positive, with 424 comments praising the quality of services.

More than 60 volunteers also took part in over 500 activities over the last year and helped to collect feedback from the public.

Lucie Woodruff, Healthwatch Wiltshire Manager, said: "On our fifth birthday, we are really proud of what we have achieved so far in the county. Our staff and volunteers continue to meet the community to listen to what people have to say about local health and care services.

"Everyone who uses health and care services has the right to expect a high standard. In order to help organisations achieve these standards, we need the public's help. That's why we actively encourage and welcome feedback.

"No matter how big or small the issue, we want local people to share their stories with us, so that we can share these ideas with those with the power to make change happen."

Headlines/Key successes

- At May's Town Council Meeting, Cllr Steve Abbott was elected Chairman of the Town Council following Cllr Ruth Hopkinson's decision to stand down as Chairman after five years. Ruth will continue as Vice Chairman for this Council year.
- The new Parkour (free running) facility at Springfield Rec is now installed and open to use. There will be an official opening on Saturday 9 June, 10am-1pm (tbc) with demonstrations of parkour, expert advice, etc, etc. Installation of the new outdoor gym is due to start w/c 9 July.
- The consultation on Corsham's draft Neighbourhood Plan ended on 25 May. We are now awaiting confirmation of the appointment of our independent examiner ahead, it is hoped, of a referendum later this year.

Projects

- The Town Council is working with a number of stakeholders, including Wiltshire Council, Springfield Campus and Corsham Youth Zone, on a project to provide Street Sports for the 14+ age-group, starting this summer. Corsham Youth Council is also working on an anti-bullying campaign, including a survey and poster competition.
- Corsham in Bloom is back, with the annual in-town competitions, including for Best Garden and Best Allotment. Schools are also being encouraged to take part in South West in Bloom's 'It's a Bug's Life' painting competition.
- Work continues on the commemorations for the end of the WW1 centenary. Plans
 include another 'Plastic Fantastic' creation, featuring doves and poppies made from
 recyclable plastic; sponsoring a Royal British Legion Silent Soldier silhouette; taking
 part in the There But Not There art project, and recreating the day peace was declared
 in Corsham.

Project Description:

The Corsham High Street Project CHSP has the potential to be one of the most interesting and significant projects ever to be undertaken in Corsham. In the famous Pevsner Architectural Guides to the Buildings of England there is a volume on Wiltshire but Corsham is summarised in just a few pages although Sir Nicolaus Pevsner asserted that Corsham has no match in Wiltshire for wealth of good houses and there are a few of really high merit. The main aim of the project is to record as many buildings as possible in the High Street - their architecture fabric and building techniques - through photography documentary research sketches and surveyed drawings and archaeological investigation eg dendrochronological tree ring dating by taking core samples of selective timbers if appropriate and permitted. The objectives are to produce records of individual buildings an archive which will be curated at the Wiltshire and Swindon History Centre and eventually a publication which will be of interest and use to local people schools historical groups Corsham Town Council etc. The project is being promoted by the Corsham Civic Society in collaboration with Wiltshire Buildings Record who will provide advice training and some specialist services. The involvement of local volunteers and their training is an important element of the project and we have had encouragement from the Heritage Lottery Fund HLF in submitting a grant application. Meanwhile start-up funding is available through Corsham Civic Society. The project committee comprises local people who have expertise that the HLF recognises. The Honorary Chairman Julian Orbach is the editor of the forthcoming updated edition of the Wiltshire volume of the Buildings of England. The PatronTom Brakspear is a conservation architect living in Pickwick Manor Corsham from a dynasty of architects including the famous Sir Harold Brakspear KCVO 1870 1934 a noted restoration architect and archaeologist. Internal recording of buildings will be undertaken strictly as agreed beforehand with owners such work will be supervised at all times copies of insurance and HS documentation including Risk Assessment forms will be provided. The aim is to

record only internal features of historic significance modern alterations and additions are not of interest and will not be noted. In every sense it is intended that such work is non-intrusive. The launch of the project will take place on 12 April 2018. The CHSP committee will ensure that every owner taking part will be provided with a free illustrated copy of their buildings record and acknowledgement in the WSHC archives and the publication.

Input from Community Engagement Manager:

- The project has the potential to benefit the Corsham area in many ways including through volunteering and learning opportunities, strengthening communities, increased tourism, fostering a sense of place and so on.
- The project meets the grants criteria and can be considered for funding
