Youth candidates prepare to take their seats following successful election campaign

Forty one young people from across Wiltshire are preparing to take their seats on the first ever Wiltshire Youth Council following a successful election campaign.

89 candidates from 21 schools and the local community took part in the election process with almost 5,000 votes cast across the county. The elections ran from 31 January to 4 February and young people voted online via their school to selected their preferred candidate.

The successful candidates were informed this week and now are being advised of the next steps to having their say in local democracy. A total of 4972 student voted across the county.

Wiltshire Youth Councillors will:

- Meet up with Wiltshire Council leaders and have their say on local decisions.
- Work with area boards to ensure funding for youth projects has the right impact for them and their peers.
- Inspect services to ensure they represent young people's best interests.
- Communicate with their peers so young people's views are properly represented.
- Opportunity to shadow council leaders as a shadow youth cabinet member for a particular area of interest.

Youth councillors will be asked to commit one evening per month to attend a full youth council meeting, which will focus on issues important to the young people. They will also be expected to talk to their peers about the issues and represent their views. There will also be training to support them in their roles, covering topics including debating, running a youth inspection and delivering presentations.

Wiltshire Youth Council has also recruited Special Advisors, these are young people that ensure that the views of the underrepresented are heard. There will be Special

Advisors that champion different causes such as young carers, children in care, LGBTQ+ young people and military families.

Cllr Laura Mayes, Cabinet Member for Children's Services said: "Congratulations to everyone who took part in this process and well done to those who were successfully appointed. Having your voice to champion causes which are important to you and your peers is key to our work and I look forward to working with you in the future."

Lily and Dennis are the Wiltshire Youth Councillors for John of Gaunt School in Trowbridge.

Lily, aged 13, said she'd wanted to put herself forward to campaign for a number of areas including equality and environmental issues. She said: "I'm very happy to be selected. I'm most looking forward to helping people in my new role."

Dennis, aged 11 said: "There are so many problems in the community and I wanted to do something about them instead of waiting for someone else to do something. I didn't expect to win the election because I don't know many people the same age as me going for election so I was surprised but happy to be successful."

Cabinet approves Climate Strategy and Natural Environment Plan

Wiltshire Council's Cabinet has today (Tuesday 1 February) approved the council's Climate Strategy and Green & Blue Infrastructure Strategy, Wiltshire's Natural Environment Plan - two documents that will help to shape the next five years of the council's carbon reduction and environmental plans.

Pending approval by Full Council on 15 February, both documents will now be used as frameworks for all forthcoming council policies and plans, to ensure the council is on track to meet its pledge to make Wiltshire Council carbon neutral by 2030, and its ambition to make the county of Wiltshire carbon neutral.

Cllr Nick Botterill, Cabinet Member for Climate Change, said: These two strategies show just how seriously we are taking the climate emergency and the need to safeguard Wiltshire's countryside and support nature's recovery.

We know that we have much more to do, but these strategies will help to guide us as we ensure that environmental considerations and carbon reduction are at the core of everything we do.

But we can't do this alone, and I'd urge our town, parishes and communities to get involved and make changes that will help us to reduce carbon emissions across Wiltshire as we aim to make the county carbon neutral.

At the same meeting, Cabinet also received an update on the council's progress on carbon reduction over the past six months. Some of the highlights include:

- A new green energy contract for schools so they can access green energy at a competitive rate; 128 schools have signed up so far.
- Thanks to sustained investment in solar panels, in 2020/21 the council generated 450,135 kWh renewable electricity on its own estate, a 39% increase on the previous financial year.
- Two successful grant applications to Natural England totalling £10,000 to support the development of a Local Nature Recovery Strategy, plus evidence mapping for habitats across Wiltshire and Swindon.
- All eight household recycling centres (HRCs) operated by FCC now provide separate labelled walk-in containers where residents and site staff can store good-quality items suitable for reuse or refurbishment, such as furniture. Many of these items are made available to charities, which refurbish and re-sell them or donate to families in need. Between April and September 2021. 90 tonnes of items were reused.
- An action planning day was held for town and parish councils to empower them to make practical changes in their communities.
- A new solar panel bulk buying scheme that will enable Wiltshire residents to get high quality solar panels at a lower cost.

- The ongoing #WiltsCanDoThis behaviour change social media campaign has been seen more than 1.1 million times.
- The launch of a scheme that enables Wiltshire households with an income of £30,000 or less, and living in a property that is rated D, E, F or G for energy efficiency, the chance to access up to £10,000 for improvements such as insulation, solar panels and double glazing.
- So far 57 council homes have been retrofitted to improve their energy efficiency rating, with measures such as intelligent hot water cylinders, solar panels and high heat retaining storage heaters.
- The council's first Electric Vehicle Charging Infrastructure Plan has been approved, and funding has been identified and approved for a number of electric vehicle charging points in the county.
- The council is replacing several vehicles, with many of them anticipated to be electric.
- An order for new electric and non-electric bikes for council staff has been placed with a local bike charity to help reduce car miles and carbon emissions.

Take part in the Great British Spring Clean this March and April in Wiltshire

Wiltshire Council is encouraging local groups and organisations to take part in the Great British Spring Clean this year, from 25 March-10 April.

Groups across the county are urged to sign up on the Great British Spring Clean website and join in to help clean up the county from unsightly litter. Though please note that litter picks in the Salisbury area are not encouraged - here, the advice from the UK Health Security Agency (UKHSA) remains 'if you didn't drop it, then don't pick it up'.

Litter picking equipment has been provided by Wiltshire Council to town and parish councils and local community groups across the county, so people should contact their local town or parish council see if they have any equipment to borrow and if they are hosting a clean-up event to support.

Where possible, volunteers should dispose of bagged waste in their usual household black bins or a public litter bin that has sufficient capacity.

For large events that could collect more than 10 bags black bags full of waste, the council can arrange single collection following the event. To arrange this, people should email streetscene@wiltshire.gov.uk a minimum of 10 days before the event with as much information about the event as possible and contact details of the event organiser. Any large items or suspected fly-tips should be left where they are and reported to the council on the MyWilts app.

Cllr Dr Mark McClelland, Cabinet Member for Transport and Waste, said: The Great British Spring Clean is a fantastic opportunity for our communities to get involved in making a difference in their area.

We have provided more than 1,500 litter pickers and 1,500 pairs of gloves to local town and parish councils, so people should go there to borrow the equipment for their event. They can also sign up on the Great British Spring Clean website, so others can join in on the picks in their community.

It would also be great if people shared photos of their events on social media using the hashtag #GBSCWilts - and we'll share the best.

We'd ask that groups in the Salisbury area adhere to the latest UKSHA advice and not take part in litter picks; but people can get involved in every other area of the county to help keep Wiltshire clean.

I hope that community groups from around the county can take part and help to keep Wiltshire beautiful.

For the Salisbury area, a UKHSA spokesperson said: As a precaution, UKHSA continues to advise the public not to pick up any items. The advice remains 'if you didn't drop it, then don't pick it up'.

The Queen's Platinum Jubilee celebrations

1. Purpose

1.1 To update Area Boards on arrangements to support communities to celebrate the Queen's Platinum Jubilee.

2. Background

- In 2022, Her Majesty the Queen will become the first British Monarch to celebrate a Platinum Jubilee (70 years of service) having acceded to the throne in February 1952.
- 2.2 An extended Bank Holiday, from Thursday 02 June Sunday 05 June 2022 will provide an opportunity for communities and people throughout the United Kingdom to come together to celebrate the historic milestone by means of community street parties.
- 2.3 These four days of celebration will include public events and community activities, as well as national moments of reflection on the Queen's 70 years of service.
- 2.4 Similar events took place in 2012 for The Queen's Diamond Jubilee, with many communities holding street parties, barbeques and tea parties in honour of the milestone. Wiltshire Council have specified previous guidance and relevant officers will follow the same process as used in 2012.









3. Procedure and management of applications

- 3.1 Wiltshire Council has a robust and straightforward system in place to ensure that communities wishing to celebrate the Queen's Platinum Jubilee are signposted to the council's web page where they will find the appropriate tools, support and guidance to apply to hold a street party. See here – Platinum Jubilee celebrations – useful information and guidance
- 3.2 The application process will be a combined departmental effort, as with previous events of this nature.
- 3.3 The council's Traffic Orders, and Highways teams will need time to ensure that all road closure notices and provisions are in place to allow for a safe and enjoyable event for all guests, while maintaining and facilitating access for emergency services at all times. A minimum of eight weeks' notice is required to process applications if a road closure order is required.
- 3.4 The council is committed to managing this process utilising a cross departmental approach. Such departments will include the Community Engagement Managers, Traffic Orders, Communications, Highways, Streetscene, Wiltshire Police and Waste.

4. Conclusion

- 4.1 Relevant council departments are aware of the importance that street parties are to the residents of Wiltshire to celebrate the Platinum Jubilee.
- 4.2 Planning in preparation to support these activities is well underway to ensure communities will have what they need to celebrate this unique occasion.

Support for Ukraine

Our thoughts go out to everyone affected by the utterly heartbreaking scenes we are seeing in Ukraine, following the country's invasion by Russia.

We'd like to thank everyone locally who is doing what they can to provide support and rallying behind the people of Ukraine, letting them know they are not alone.

There are a number of options locally and nationally for you to provide support and ensure it can benefit those directly affected by the ongoing conflict.

This page lists some of the ways that you can provide support. Although not an exhaustive list, we will look to keep it updated as much as possible with further support routes as and when we are made aware of them.

As well as donating funding, we are hearing in particular that people that are stuck at the borders need the likes of medication, plasters, and other medical materials to cover wounds, medication for children, power banks and thermal blankets. More information can be found below.

As a council we are in regular contact with central Government and are ready to provide any support that we can, and although it's too early to say what that might be at this stage, we'll update when we can.

The Ukraine Disaster Emergency Committee Crisis Appeal

The Ukraine Disaster Emergency Committee Appeal is providing urgent humanitarian aid including food, water, shelter, healthcare and protection.

Donating to the Disaster Emergency Committee Appeal ensures the people of Ukraine get the support they need and that donations go to those directly affected by the conflict.

Disaster emergency committee charities are in Ukraine and neighbouring countries working hard to meet the needs of all refugees and displaced people. All donations will be gratefully received and below are some examples of how charities say the money could be spent:

- £30 could provide essential hygiene supplies for three people for one month
- £50 could provide blankets for four families
- £100 could provide emergency food for two families for one month

New cycling and walking facility will link Hilperton and Melksham on mostly traffic-free route

Wiltshire Council is starting work on a new cycling and walking facility later this month that will enable people to walk or cycle between Hilperton and Melksham on a mostly traffic-free route.

The route will begin at Devizes Road, Hilperton, where cyclists can head down this lightly trafficked, quiet road, before joining the existing shared use path from Devizes Road to the access to byway HILP21, by Trowbridge Rugby Club. This byway is being upgraded to provide extra space for cyclists and pedestrians, as well as improving access to and from the shared use path for cycles.

The route then follows the byways HILP21, HILP22 and SEMI9A to meet St George's Road in Semington. All of the byways will be resurfaced using a surface dressing that is suitable for cyclists, pedestrians and horse-riders. The drainage on the byways will also be improved, but to minimise the impact on local wildlife, the byways will not be lit.

From St George's Road in Semington, the route will continue through High Street and Semington Road, where it will link with the Toucan crossing on the A350, which will be upgraded and access will be improved.

Cllr Mark McClelland, Cabinet Member for Transport, said: "This new cycling and walking facility will make it easier and safer for people to travel between Hilperton and Melksham without using a car.

"The new route also meets some of our key business plan priorities, helping to create better connected, heathier communities, and reducing carbon emissions.

"Of course, we recognise that some cyclists will still choose to use the A350 to commute between Hilperton and Melksham, but for those that don't wish to do so, this new scheme will provide a safer, quieter route – particularly for families.

"We know that this route is popular with horse riders, and that's why we've taken steps to ensure the byways are suitable for them as well as cyclists and pedestrians.


"We're looking forward to this new facility opening in the summer."

The work is due to start on Monday 28 March and will be split into four phases. The first phase will see work on Devizes Road and A361 Hilperton until 22 April, with Devizes Road towards the A361 roundabout closed to traffic from 28 March to 9 April, and two-way signals in place on the A361 from 4-22 April.

Phase two will see work on the byways from 26 April to 13 May, and the byways will be closed during this time. The third phase will see work on Semington Road from 13 May to 3 June, with the road closed during this time. The final phase will see works on the A350 Western Way Toucan crossing from 6 June to 1 July, with lane closures and a temporary reduced speed limit on the A350, plus some evening road closures for carriageway resurfacing.

The Chairman thanked Sergeant Twyford for his update. 40 Fire & Rescue Update The written update contained in the agenda pack was noted. 41 Christie Miller Demolition Cllr Phil Alford advised that: Facilities Management at WC were currently procuring the contractor for the demolition. The detail of the method and approach would be finalised with the successful contractor once they had been appointed. There was likely to be some occasional disruption to the operation of the Household Recycling Centre but Wiltshire Council were liaising with the waste team to minimise this and to ensure timely and appropriate communications goes out to the community as and when necessary. Once demolished, the site would be left vacant until such time as it was redeveloped, at which point all of the normal processes (e.g. planning

process, consideration by Area Board etc) would take place.

- The demolition removed the holding costs such as NNDR (rates), utilities etc.
- The cost of the demolition was off-set by the increase in capital value of the site.

42 <u>A350 Bypass Update</u>

Steve Wilson - Major Highways Project Engineer, Wiltshire Council gave an update on the A350 Bypass.

Points made included:

That the Wiltshire Council Cabinet had received a report on the Melksham A350 improvement scheme at its meeting on 30 November 2021. Cabinet resolved that:

- The response to the second public consultation and the views of the town and local parish councils and others were noted and taken into account in the scheme development.
- In view of the comments made in response to the consultations the route variants should be the subject of further investigation and consultation as appropriate after the OBC had been approved.
- The possibility of improving walking and cycling facilities in the area in conjunction with the scheme or separately should continued to be explored.
- That further consideration should be given to the scheme when the results of National Highways' M4 to Dorset Connectivity study and the DfT's comments on the OBC were available.

Second non-statutory consultation Key findings / messages

- Divergence of opinion between those who support the need for an improvement to the A350 and those who do not.
- Concerns regarding potential impacts on countryside habitats and the environment. Also carbon and climate change implications.
- Concerns regarding noise and air quality impacts.
- Concerns regarding impacts on wildlife.

- Importance held by local communities regarding access to the countryside.
- Concerns regarding impacts on mental and physical well being.
- Alternative route suggestions.

Second non-statutory consultation route variations

- North suggestions for alternative "pylon route".
- East suggestions to move route further from Redstocks
- South suggestions for route to be moved further from Bowerhill with screening.
- Further consultation needed.

Wilts and Berks Canal - restoration update

Paul Lenaerts & Ian Britton - Wilts & Berks Canal Trust gave an update on plans to re-instate the Wilts & Berks Canal through the Melksham Community area.

Consultation had been carried out with the community in Berryfield on a masterplan and the canal alignment, where most respondents favoured a route through Berryfield itself rather than to bypass it to the west.

Understandably nobody wanted hundreds of new houses, but it was felt that new housing would probably be inevitable at some point in the future so it was better to gain as much community benefit as possible.

All thought about what they considered as being needed most in the area and rated the elements of the masterplan with the most popular items as follows:

- Doctors' Surgery
- School
- Children's Play Area
- Pub
- Recreation Ground

Other ideas:

- Shops, particularly a convenience store
- Dentist
- Care Home
- Camping/glamping site
- Hotel

There were also discussions about what other things were important to residents and how to soften the impact of any new housing in the area, and also where they would prefer to see some of the elements of the masterplan.

Residents liked: The idea of overlooking green spaces, canal or marina (rather than new housing) Being able to continue going for walks in local green spaces in addition to the new canal walk. The idea of visiting the wetland area Position of elements close to or in Berryfield: Children's Play area Doctor Position of elements close to the bulk of the new housing area: School Recreation Ground Pub Shop Care Home The Chairman thanked Paul Lenaerts & Ian Britton for their update. - Wiltshire Police recorded crime has been stable with a slight increase by 2.2% in the 12 months to December 2021 and continues to have one of the lowest crime rates in the country.
- Wiltshire Police has seen a 12.7% reduction in vehicle crime and a reduction of 11.2% in residential burglaries in the 12 months to December 2021.
- Our service delivery remains consistently good.
- In November 2021, we received:
- 8,787 '999' calls, (answered within 8 seconds on average);

Stop and Search information for Trowbridge CPT

During the 12 months leading to November 2021, 258 stop and searches were conducted in the Trowbridge area of which 67.4% related to a search for controlled drugs.

During 67.4% of these searches, no object was found. In 32.6% of cases, an object was found. Of these cases 72.9% resulted in a no further action disposal; 33.1% resulted in police action being taken; 8.5% resulted in an arrest.

- White 224 stop and searches.


- Hate Crime across force in December has reported a



On Call Recruitment

Have you always wondered if you could join the fire service, but haven't had the opportunity to find out more? Have you found yourself seeking your next challenge, keen to give back to the local community or wanting to learn new skills including leadership and teamwork? Then becoming an on-call firefighter is for you.

As a paid position, on-call firefighters commit anywhere between 40 to 120 hours per week, during which time they must be able to respond to the station immediately.

Many have 'normal' jobs during the day, then upon their return home make themselves available overnight or during the weekends. Some of our crew respond from their workplaces during the day, and we are very grateful to their employers for releasing them to perform their vital duties.

Anyone over 18 years old can apply (although you can also apply once you are 17½) you must be able to respond and attend the fire station within 5-8 minutes, you have a good standard of physical fitness (i.e. you are generally active), and you must have the right to work in the UK.

Electric blanket safety

With colder weather now kicking in, we've been reminding people about the best ways to stay safe and warm. The recent cold snap will have led people to get heaters and electric blankets out of storage. However, there has already been at least one fire involving an electric blanket this winter, so please follow this advice if you're intending to warm your bed this way:

- Folding up electric blankets damages the internal wiring, so store them flat or rolled up instead.
- Check the wiring and plug on your blanket before using it, to make sure there is no fraying or damage.
- Unplug blankets before you get into bed, unless they have a thermostat control for safe all-night use.
- Never use hot water bottles in the same bed as an electric blanket, even if the blanket is switched off.
- Make sure you have smoke alarms fitted on every level of your home, and test them regularly.

Waste site fire near Devizes

It took more than two and a half days to extinguish a fire involving some 300 tonnes of residual waste at a recycling centre on the outskirts of Devizes, which started on 17 November.

Firefighters worked through the night to contain the fire, supported by on-site staff who used loading shovel machinery to create fire breaks in the pile of waste.

Because of the size of the waste heap affected, the cause of the fire remains unknown.







Motorcycle safety focus of fire station display

Firefighters at Stratton fire station are again supporting the Christmas road safety campaign with a dramatic visual display.

This year's road traffic collision reconstruction, at the fire station in Highworth Road, involves a car and a motorbike, kindly provided by Grist Environmental. There is also a banner that says: "Don't get smashed – don't drink and drive".



Dorset & Wiltshire Fire and Rescue Service runs Biker Down Wiltshire, which is a free course available to motorcyclists and motorcycle clubs in Wiltshire and Swindon. A similar programme is available in the Dorset area, organised by the DocBike project.

Whether you ride your motorbike with a group of friends or on your own, there may be a time when you are the first person at the scene of a fallen biker. Injured motorcyclists need to be dealt with in a specific manner as it can be easy to cause them further injury, particularly by removing a crash helmet unnecessarily, or in the wrong way.



3. Introductions

All briefly introduced themselves.

4. Carers and Caring

The Chairman introduced David Walker who has been appointed by the Area Board as "Carers Champion for Melksham".

David talked movingly about his personal journey of caring for 12 years for his wife who had early-onset Alzheimers, about trying to navigate the myriad care support

networks and about the loneliness and endless patience required for a 24/7 unpaid caring role. Also about the deep sense of emptiness in life when your loved one passes away and the emotional, physical and financial impacts of loss. David's slides are appended with this note of the meeting.

David will be discussing his role with stakeholders to agree a small number of targetted activities in support of carers. He will publicise his work through the local press and will make himself available to speak to local groups about his experiences. Quick wins might include the establishment of a "carers café" and information events around Carers Week in June.

The Chairman reminded the group that the Melksham Area Board has agreed to fund an event for Young Carers as a "thank you" for their important work, much of which goes unnoticed. It is hoped to hold the event at the new Community Campus in October half term this year, hopefully offering free use of the sporting facilities. The funds will also pay for Agency staff to cover the time duration of the event, so that the young person can relax for few hours in the knowledge that the person they care for is in good hands. Local businesses will be approached to see if any of them are prepared to provide sponsorship for a gift for each of the young carers.

ACTION: Melksham Area Board to agree a focus for the Carers Champion role at its forthcoming meeting on 9 March

ACTION: Further discussions with stakeholders to be held around the proposed Young Carers event, including with young carers themselves

5. Groups and Activities for Older People in Melksham

Moira Conroy shared a listing that she has compiled of groups and activities for older people in Melksham which includes lunch clubs, day centres, friendship groups, church groups, dementia support, fitness, singing, walking and other social activities. This mostly covers the town, but not most of the villages, and provides a constantly evolving record from which to build a local directory.

Moira, Jackie and other "social prescribing" colleagues often bring elderly and vulnerable clients along to these sessions and report the transformative impact on their health and wellbeing of having human contact and the chance to develop new friendships.

A recurring issue that is reported, however, is the lack of transport to take the old and vulnerable to attend these local activities.

ACTION: Discussions to be held with LINK and the community bus to publicise the community transport options available.

ACTION: Peter Dunford, with others, to keep the directory up to date and to include activities and services in the villages local to Melksham

6. Melksham and Bradford on Avon Primary Care Network

Dr Claire Rigby and Amanda Brookes provided an update on the work of the PCN which covers 48,000 patients registered with the primary care practices at Spa and Giffords surgeries in Melksham and in Bradford on Avon.

A fantastic service continues to be delivered under very trying circumstances, including delivery of 90,000 vaccines at the clinic at the Spencers Sports and Social Club. The combined pressures of COVID, staff shortages and population growth in the local area has resulted in a 40% rise in demand for doctor appointments. New "social prescribing", "health and wellbeing" and "carers champions" posts have been created as a response to a growing focus on delivering care in the community.

A review of the NHS estate has been delayed but is underway with decisions expected soon on plans for new capacity at doctors surgeries as well as the future of hospital sites at Chippenham and at Melksham being determined. Cllr Holder has spoken to Simon Yeo, NHS Estates Manager, who has agreed to come to present the new plans to the group once these are in the public domain.

ACTION: Simon Yeo and NHS locality lead, Elizabeth Disney, to be invited to speak to a future meeting.

7. Celebrating Age Wiltshire

Rebecca Seymour gave an update on the delivery of a programme of lottery-funded arts, music and theatre in the Melksham area. Events over the past year have had to be mostly outdoor and socially distanced: "doorstep concerts" for elderly and vulnerable clients; a Christmas concert at the Riverside Club; 1-2-1 "creative conversations"; and "noticing nature" art classes held at That Meeting Space. A programme of Spring outdoor concerts is coming, as is a theatre afternoon with afternoon tea at the Riverside Club on 29 March.

Jonathon Seed asked for more activities to be held in the villages.

ACTION: Rebecca Seymour to discuss opportunities for delivery of events in village halls and other more rural settings.

8. That Meeting Space

John Firth described how the Good News Church had taken on the lease of the former Art House Café and set it up as a space for use by the church and the community. In addition to religious activities, in a short space of time the centre has helped to facilitate a number of community events: drop-in socials for older people; "tech savvy" sessions for IT support; bereavement counselling; a singalong group; a book club; and "noticing nature" art sessions.

Future plans include a memory café in association with Alzheimers Support and a drop-in for ex-military personnel.

ACTION: Discuss possible grant funding from the Area Board, including for piloting a "Carers Café"

9. Health and Wellbeing Grant application:

Melksham Free Dining requesting £1,700 for the "Coming Together to Dine With Us" project to support the costs of free lunches and after-meal social activities for the elderly and vulnerable

Louisa Lewis and Dee McLeod outlined their bid for financial support to provide a free two course nutritious lunch to Melksham residents and the surrounding areas, with the option to stay after the meal and join in the social activities, interact with others and ask for advice on personal matters. Grant support will help with consumables, catering equipment, transportation and communication costs.

The charity, which is awaiting accreditation with the Charities Commission, is focused on addressing food poverty, loneliness and social isolation among the vulnerable elderly population, delivering its lunches at Bowerhill Village Hall every Wednesday. As well as providing a nutritious meal and social activities, its DBS-checked volunteers provide a support network with signposting and aftercare services to its clients.

Meals are provided free of charge with no donations taken and all staff work without pay as volunteers. The average attendance is 42 people per lunch session. The cost price is £3 per person per meal which means that this grant application would provide for approximately 12 weeks service.

Grants and sponsorship have been, or are being, secured from the Town Council, Parish Council, Happy Circle Day Centre, Almshouses Trust and from private individuals. Sponsorship in kind has come from the Reefa Tandoori.

Cllrs Seed and Sankey were very supportive of the initiative and suggested that a larger grant might be appropriate in order to guarantee a longer term sustainability for the service.


Cllr Holder asked about the needs assessment of those attending and whether they were genuinely vulnerable and in food poverty. Dee confirmed that no checks are carried out but that "we know our clients and it finds its own level, with those who can afford to buy their own lunch soon doing so elsewhere".

After questions all members declared themselves supportive of the application.

RECOMMENDATION: The Melksham Health and Wellbeing Group recommends that Melksham Free Dining be awarded £1,700 for the "Coming Together to Dine With Us" project to support the costs of free lunches and after-meal social activities for the elderly and vulnerable



Project Summary:

New Scout minibus. In 2019 the group applied for a grant for a £9,000.00 minibus. Our last application was for support in purchasing a replace minibus, requesting £4,500 at the end of 2019. Unfortunately, there was not enough money in the pot but were kindly awarded £1,900. Sadly, we were then thrown into the grips of lockdowns, pandemics, school closures and massive disruption. Thankfully the group started up again in May 2021 but with no activity for over a year and zero subs/funding, we have struggled to gain momentum. As of the end of 2021, we now have four sections up and running covering ages from 6-18. We still have the £1,900 grant issued in 2019 as we were unable to buy or sell without knowing the future of youth activities in the post (are we post yet) pandemic. The original project we were embarking on was to create a fund of £9,00.00 to purchase a second hand 17-seater minibus. As secondhand vehicles seem to have a higher premium these days, the project may now be out of date and undervalued. This coupled with a lack of funds and group fundraising during lockdown leaves us short of our goal.

1. Background

Area Boards have authority to approve funding under powers delegated to them. Under the Scheme of Delegation Area Boards must adhere to the Area Board Funding and Grants Criteria. This document is available on the council's website.

Three funding streams are available to the Area Board, each with an annually awarded amount. These funding streams are as follows:

- Community Area Grants (capital)
- Young People (revenue)
- Health and Wellbeing (revenue)

The Area Board will be advised of the funding available prior to their first meeting of each financial year.

2. Main Considerations

- 2.1. Councillors need to be satisfied that the applications meet the requirements as set out in the Area Board Funding and Grants Criteria and that the health and wellbeing and young persons funding guidelines have been adhered to.
- 2.2. Councillors must ensure that the distribution of funding is in accordance with the Scheme of Delegation to Area Boards.
- 2.3. Councillors need to consider any recommendations made by sub groups of the Area Boards.

3. Environmental & Community Implications

Grant funding will contribute to the continuance and/or improvement of cultural, social and community activity and wellbeing in the community area, the extent of which will be dependent upon the individual project.

Update for Wiltshire Area Boards

February 2022

Covid-19 vaccinations

As at 9 February 2022, more than 2.1 million Covid-19 vaccinations have been given out at sites across Bath and North East Somerset. Swindon and Wiltshire.

Since the beginning of 2022, more than 3,000 adults have come forward for their first vaccination. This is partly due to the innovative ways in which the vaccination offer has been taken to the heart of people's communities. Pop-up vaccine clinics have taken place in sports clubs, community centres, places of worship and even pubs thus removing previous barriers to uptake including inconvenience and proximity to a site.

Children aged between five and 11-years-old, who are deemed to be clinically extremely vulnerable, can now get a single dose of the Covid-19 vaccine from more than a dozen venues across the region. Efforts to make settings as comfortable as possible for this audience are being offered including 'Superhero' themed child environments at Salisbury City Hall, that also have therapy dogs for the children to cuddle and play with.

More than 30,000 secondary school children have received a first dose of the Covid-19 vaccine, and more than 10,000 have had a second. This means the Bath and North East Somerset, Swindon and Wiltshire area is leading the way in vaccinating 12 to 15-year-olds, with current uptake being the highest in the south west. Children in this age group are being offered the vaccine in school but can also get the jab at evenings and weekends from venues such as Salisbury City Hall.

Walk-in vaccination appointments are still available at a number of sites. Pre-booking at many venues is no longer a requirement. It is hoped that by removing the booking process, people who may have been putting off getting vaccinated, perhaps due to work, home or other commitments, will find it easier to get protected.

All vaccination centres, including those that offering walk-ins, are listed on NHS England's national Find My Nearest Walk-in Vaccination service.

Those using the online tool will be able to see a list of the vaccination centres closest to them by entering their postcode in the search box.

Current pressures on local health and care system

The health and care system in Bath and North East Somerset, Swindon and Wiltshire continues to face enormous pressure. A main contributing cause is Care Home capacity issues as a result of Covid-19 which directly impacts on discharge flow for Wiltshire patients out of hospitals.

A number of initiatives have been implemented to alleviate pressure and help with flow through Salisbury hospital by discharging patients who are well enough to go home. These include:

- The commissioning of 7 beds at South Newton Hospital for admissions until the end of March 2022.
- Supporting the wider CCG system to open and effectively use additional capacity in Bath, including a Care Hotel and opening additional capacity on a community ward at St Martin's Hospital in Bath.
- Working with the provider, Abicare, to maximise the use of additional Live In Carers.
- Collaboration with Wiltshire Council and Wiltshire Health and Care on several initiatives including the provision of two CCG colleagues to the Wiltshire Flow Hub and an area-wide call-to-arms to support additional domiciliary care provision as part of the Council's Support at Home service.

Appeals to the public to support services during this difficult time are ongoing. The main messages being for people to use our health services appropriately, support hospitals by collecting loved ones as soon as they are ready to go home, using our pharmacies for help and support wherever possible and using the online 111 service in the first instance.

Wiltshire Link Schemes

Wiltshire Link Schemes are community-based, volunteer run charities which aim to improve the quality of life for disadvantaged, elderly or infirm people by providing transport and 'good neighbour' services.

Link schemes help to keep local communities connected to vital services, by connecting volunteer drivers (using their own cars), with passengers who have limited access to transport. Depending on volunteer availability, this can involve taking someone to a medical appointment, taking them shopping or providing 'good neighbour' services like prescription collection.

There are currently 42 schemes in Wiltshire supported by 1,567 volunteers. Together in 2021 alone, they completed over 23,136 everyday tasks and offered over 81,000 hours of support. The economic value of the schemes in 2021 was over £1million pounds.

Our Shaping a Healthier Future – Health and Care Model Consultation

Our Shaping a Healthier Future public engagement programme to seek local people's views on our developing health and care model concluded in mid-December. The model sets out what health and care services will be like for people in the next ten years and will provide a framework to ensure we take a coordinated approach to how we design and plan services across our partner organisations.

People across BSW have shared their thoughts and opinions by taking part in a short survey online and by attending in-person engagement events. Around 750 people completed our survey and almost than 1,200 people attended workshops and interviews.

The completed findings and recommendations will be presented at a forthcoming BSW Partnership Board on 25 February 2022 that will be held in Public, with supporting papers being available on the CCG website on the 18 February. Oximetry

The oximetry service in Bath and North East Somerset, Swindon and Wiltshire CCG is going from strength to strength. The service enables clinically vulnerable patients with Covid-19 who are isolating at home to measure their own oxygen levels and send data into local hospitals for monitoring.

If clinicians spot any early warning signs in terms of low blood oxygen levels – which can lead to complications and poor outcomes – the patient can then be admitted to hospital where they can receive treatment.

The remote home oximetry service is supported through collaboration between a number of health and care partners including hospitals, Medvivo and the West of England Academic Health Science Network.

Annual Health Checks for people with Severe Mental Illness (SMI) and learning disability

The Bath and North East Somerset, Swindon and Wiltshire CCG are launching new initiatives to encourage people to come forward for their Annual Health Check (AHC). The AHC is offered to people with learning disabilities and also those living with Severe Mental Illness (SMI) as a recognised, evidenced method of improving their health. They are vital to ensure that these patients remain safe and clinically well, and also to inform the review and update of the patients' health action plan.

People living with severe mental illness (SMI)1 face one of the greatest health inequality gaps in England. The life expectancy for people with SMI is 15–20 years lower than the general population. This disparity in health outcomes is partly due to physical health needs being overlooked. Smoking is the largest avoidable cause of premature death, with more than 40% of adults with SMI smoking. Individuals with SMI also have double the risk of obesity and diabetes, three times the risk of hypertension and metabolic syndrome, and five times the risk of dyslipidaemia (imbalance of lipids in the bloodstream) than the general population.

Poor uptake for health checks is proven to lead to earlier diagnoses of life limiting conditions and leave individuals with poorer health outcomes should they succumb to COVID-19.

In response, First Option Healthcare have been commissioned to support local GP surgeries with AHCs and have already completed over 1300 health checks since they started in February 2021. The BSW team are leading a focused effort in reaching children and young people, working with Special Schools across Wiltshire to be able to extend the offer and offer AHCs in school settings. The initiatives form part of the operational plan for 45% of eligible individuals to have completed their AHC by March 2022 and further work to drive awareness of the importance of having and access to AHCs is being planned.

Devizes Health Centre

The construction of the Devises Health Centre has now passed the half way point and is on track to open later this summer. Devizes Health Centre will be one of the region's first integrated care centres with several organisations coming together to provide a range of health services from one building. Healthwatch Wiltshire are currently conducting a survey to collect thoughts on service provision covering aspects such as opening times and what services would be desired at the centre. Integrated Care Board

As we move towards the establishment of the Integrated Care System (ICS) on a statutory footing on 1 July 2022, we welcomed Sue Harriman to the CCG in February 2022 as Chief Executive Designate of the BSW Integrated Care Board (BSW ICB) and are making good progress with the recruitment to other roles on the Integrated Care Board.

Sue brings a wealth of NHS experience. She joins from the Solent NHS Trust where she was Chief Executive for eight years. Whilst at Solent she took up a six-month

secondment at Chief Operating Officer for the national Covid-19 vaccination deployment programme.

Following more than 16 years of clinical experience gained from working as a nurse in the Royal Navy, Sue joined the NHS in 2002 as a nurse consultant in infection prevention. Since that time, Sue has held various executive roles within the NHS, including as a Director of Nursing and Allied Health Professions, Chief Operating Officer and Managing Director before becoming Chief Executive at Solent NHS Trust. Under her leadership, Solent NHS Trust achieved an improved Care Quality Commission (CQC) rating, from 'requires improvement' to good overall with outstanding in the caring domain.

Sue was appointed to the Chief Executive Designate position last November and has now officially started her new job which will see her work with health and care partner organisations and VCSE groups across BSW to improve outcomes in population health and healthcare; tackle health inequalities in patient outcomes, experience and access; enhance productivity and value for money and support broader social and economic in the local area.

As regards other roles for the ICS, recruitment for four of the five the Non-Executive roles has also completed. Appointments are in the process of being finalised for the Non-Executive Director roles covering Audit, Public & Community Engagement, Quality and Remuneration & People. Further information on the appointments will be made available shortly. An appointment was not made for the role covering Finance and this will be re-advertised.

Recruitment for the Integrated Care Board Director positions for Medical, Planning & Performance, Strategy & Transformation and Chief Nurse is also underway with the closing date for applications being the 28 February. Recruitment for the Director of Place roles will commence at the start of March.
